**MONUMENTATION BOND**

WHEREAS, the Board of Supervisors of the County of Orange, State of California, and Lennar Homes of California, LLC, a California Limited Liability Company, (hereinafter designated as "PRINCIPAL) have entered into an Agreement whereby PRINCIPAL agrees to install and complete certain designated public improvements, which said Agreement dated and identified as project: Tract Map 17341 - Monumentation is hereby referred to and made a part of hereof; and

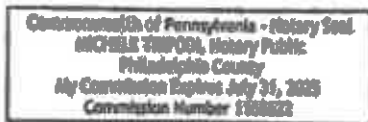
