### AMENDMENT ONE TO CONTRACT MA-063-20010411 WITH LLOYD STAFFING, INC.

This Amendment (referred to as "Amendment One") is made and entered into as of the date fully executed by and between the County of Orange, Social Services Agency (SSA), a political subdivision of the State of California with place of business at 500 N. State College Blvd., Orange, CA 92868-1673 (referred to as "County"), and Lloyd Staffing, Inc., with a place of business at 1800 Studebaker Rd., Suite 700 Cerritos, CA 90703-2684 (referred to as "Contractor"), for HR Temporary Help Services. County and Contractor may be individually referred to as "Party", or collectively referred to as "Parties"..."

WHEREAS, the County and Contractor entered into a Subordinate Agreement MA-063-16010167 (referred to as "Contract"), in the amount of \$1,273,251 effective February 1, 2016 through January 31, 2017 per the terms, conditions and pricing of Regional Cooperative Agreement MA-017-16010881 incorporated herein by this reference (referred to as "RCA") effective February 1, 2016 through January 31, 2021; and

WHEREAS, both Parties agreed to renew the Contract for a second term as Contract MA-063-17010751, in the amount of \$1,273,251 effective February 1, 2017 through January 31, 2018 per RCA; and

WHEREAS, both Parties agreed to renew the Contract for a third term as Contract MA-063-18010749, in the amount of \$797,951 effective February 1, 2018 through January 31, 2019 per RCA; and

WHEREAS, both Parties agreed to renew the Contract for a fourth term as Contract MA-063-19010289, in the amount of \$398,308 effective February 1, 2019 through January 31, 2020 per RCA; and

WHEREAS, both Parties agreed to renew the Contract for a fifth term as Contract MA-063-20010411, in the aggregate amount of \$1,561,142 effective February 1, 2020 through January 31, 2021 per RCA; and

WHEREAS, both Parties agree to <u>amend the issue Amendment One to</u> Contract to <u>renewextend</u> for <u>one</u> (1)<u>an</u> additional <u>one-year termsix (6) month term, per the extended RCA effective through July 31, 2021; and</u>

NOW THEREFORE, the Parties agree as follows:

 Renew<u>Extend</u> Contract MA-063-<u>1601016720010411 by \$490,000</u> for a fifth one-yearan additional six (6) month term effective February 1, <u>20202021</u> through <u>JanuaryJuly</u> 31, 2021 as <u>Contract MA-063-20010411</u> for an aggregate amount for a total not to exceed \$1,561amount of \$2,051,142.

All terms and conditions, amendments/modifications of the RCA are hereby incorporated herein by this reference into the <u>renewedextended</u> Contract MA-063-20010411. This Amendment modifies the Contract only as expressly set forth above. This Amendment does not modify, alter or amend the Contract in any other way whatsoever.
