**AMENDMENT No. 1  
TO AGREEMENT NUMBER MA-074-15011958  
FOR ARMORED CAR SERVICES CONTRACT**

This Amendment No. 1, hereinafter referred to as "Amendment" is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California; hereinafter referred to as "County," and Dunbar Armored, Inc., with a place of business at 50 Schilling Road, Hunt Valley, MD 21031; hereinafter referred to as "Contractor," with County and Contractor sometimes referred to as "Party", or collectively as "Parties."

**RECITALS**

**WHEREAS**, Contractor responded to a Request for Proposal ("RFP") for providing armored car services; and

**WHEREAS**, the Contractor responded and represented that its proposed services shall meet or exceed the requirements and specifications of the RFP; and

**WHEREAS**, County and Contractor entered into Contract number MA-074-15011958, hereinafter referred to as ("Contract"), for Armored Car Services, effective August 1, 2015 through and including July 31, 2018;

**WHEREAS**, the Parties now desirous to amend the Contract to renew contract for one two-year term; and

**NOW, THEREFORE**, in consideration of the mutual obligations set forth herein, both County and Contractor agree to amend the Contract as follows:

**ARTICLES**

1. Contract MA-074-15011958 is extended for one two-year term, commencing on August 1, 2018 through and including July 31, 2020 in an amount not to exceed \$420,000
2. This Amendment modifies the Original Contract only as expressly set forth above. This Amendment does not modify, alter or amend the Contract in any other way whatsoever. Except as otherwise expressly set forth herein, all terms and conditions, amendments/modifications are incorporated by this reference and shall remain unchanged
