RESOLUTION OF THE BOARD OF SUPERVISORS OF ORANGE COUNTY, CALIFORNIA

WHEREAS, California Government Code section 26227 ("Section 26227") authorizes the Board of Supervisors to expend money from the general fund of the County to establish County programs deemed by the Board of Supervisors to be necessary to meet the social needs of the population of the county, including but not limited to, the areas of health, law enforcement, public safety, rehabilitation, welfare, education, and legal services, and the needs of physically, mentally and financially handicapped persons and aged persons; and

WHEREAS, Section 26227 further authorizes officers and employees to use County resources to carry out any such program established by the Board of Supervisors; and

WHEREAS, the County, through the Health Care Agency ("HCA") and CEO Real Estate, working in conjunction with a coalition of behavioral health stakeholders, both in the private and public sectors, including CalOptima, hospitals (Memorial Care, and Kaiser Permanente, collectively, "Hospitals"), non-profit, academic and faith-based organizations, have developed a strategy for the planning, construction, entitlement, operation, maintenance and management of a behavioral health service system on County-owned property located at 7800, 7820, 7850, 7880, 7900 and 7950 Marine Way, Irvine ("Project"); and

WHEREAS, the Project is intended to provide the following services and uses, among others, to the public: Wellness and Social Services; Crisis and Stabilization Unit; Substance Use Disorder Intake and Referral; Withdrawal Management; Crisis Residential; and Substance Use Disorder and Co-Occurring Residential Treatment; and

WHERAS, on September 15, 2020, the Board of Supervisors approved an Option to

Lease with Mind OC, a 501(c)(3) nonprofit formed by the Hospitals, relating to the construction,

entitlement, operation, maintenance and management of the Project; and
