

**AMENDMENT NUMBER FIVE (5)  
TO CONTRACT NUMBER MA-012-16011609  
WITH IGI'S LANDSCAPE SERVICES LLC  
FOR WEED ABATEMENT FUEL MODIFICATION SERVICES**

This Amendment to Contract MA-012-16011609, herein referred to as "Amendment", is made and entered into upon execution of all necessary signatures between the County of Orange, OC Community Resources, OC Parks, a political subdivision of the State of California, hereinafter referred to as "County" and Igi's Landscape Services, LLC, with a place of business at 313 S Andres Place, Santa Ana, CA 92704-1120, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

**RECITALS**

**WHEREAS**, County and Contractor entered into Contract MA-012-16011609, hereinafter referred to as "Contract", for Weed Abatement and Fuel Modification Services, commencing on April 13, 2016 through and including April 12, 2017, in an amount not to exceed \$450,000.00; and

**WHEREAS**, Parties executed Amendment One (1) to renew Contract for one additional year effective April 13, 2017 through and including April 12, 2018, in an amount not to exceed \$450,000.00; and

**WHEREAS**, Parties executed Amendment Two (2) to renew Contract for one additional year effective April 13, 2018 through and including April 12, 2019, in an amount not to exceed \$450,000.00; and

**WHEREAS**, Parties executed Amendment Three (3) to revise Contract terms and conditions and renew Contract for one additional year effective April 13, 2019 through and including April 12, 2020, in an amount not to exceed \$450,000.00; and

**WHEREAS**, Parties executed Amendment Four (4) to increase Contract amount for the period of April 13, 2019 through April 12, 2020, in an amount not to exceed \$500,000.00; and

**WHEREAS**, Parties executed Amendment Four (4) to increase Contract amount and renew Contract for one additional year effective April 13, 2020 through and including April 12, 2021, in an amount not to exceed \$600,000.00; and

**WHEREAS**, Pursuant to Resolution Number 20-158 of the Board of Supervisors of Orange County, California, Authorizing COVID-19 Emergency Contracting Authority effective November 17, 2020, County now desires to extend Contract for one (1) additional year;

**NOW THEREFORE**, in consideration of the mutual obligations set forth herein, the Parties mutually agree as follows:

1. Contract shall be extended for its sixth-year term effective from April 13, 2021 through and including April 12, 2022, in an amount not to exceed \$600,000.00.
2. Except as otherwise expressly set forth herein, all terms and conditions contained in the Original Contract, including any amendments/modifications, are hereby incorporated herein by this reference as if fully set forth herein and shall remain in full force and effect.
