



**AMENDMENT THREE
TO CONTRACT MA-063-18010245
WITH
BIT CALIFORNIA, LLC DBA DOCUMENT FULFILLMENT SERVICES**

This Amendment (referred to as "Amendment Three") is made and entered into as of the date fully executed by and between the County of Orange, Social Services Agency (SSA), a political subdivision of the State of California with place of business at 500 N. State College Blvd., Orange, CA 92868-1673 (referred to as "County"), and BIT California, LLC DBA Document Fulfillment Services, with a place of business at 2930 Ramona Ave., Suite 100, Sacramento, CA 95826-3838 (referred to as "Contractor"), for CalWIN Client Correspondence Printing, Postage and Mailing Services. County and Contractor may be individually referred to as "Party," or collectively as "Parties."

WHEREAS, the County and Contractor entered into a Subordinate Contract MA-063-18010245 (referred to as "Contract"), in the amount of \$18,131,675 effective November 1, 2017 through October 31, 2020 per the County of Sacramento contract #DHA-DFS-01-18 terms and conditions, incorporated herein by this reference (referred to as "Cooperative Contract") effective September 1, 2017 through December 31, 2023; and

WHEREAS, both Parties agreed to issue Amendment One to renew the Contract by \$3,950,000 for the second term, effective November 1, 2020, through October 31, 2021, for a total not to exceed amount of \$22,081,675; and

WHEREAS, both Parties agreed to issue Amendment Two to renew the Contract by \$6,200,000 for the third term, effective November 1, 2021, through December 31, 2023, for a total not to exceed amount of \$28,281,675; and

WHEREAS, both Parties agree to issue Amendment Three to Contract to increase by \$1,300,000, per the Cooperative Contract for a consecutive term; and

NOW THEREFORE, the Parties agree as follows:

1. Increase Contract by \$1,300,000, for a cumulative total not to exceed amount of \$29,581,675.

All terms and conditions, amendments/modifications of the initial Contract are hereby incorporated by this reference into the subsequent Contract MA-063-18010245. This Amendment modifies the Contract only as expressly set forth above. This Amendment does not modify, alter or amend the Contract in any other way whatsoever.
