This AMENDMENT NUMBER ~~ONE~~ TWO to agreement Number MA-060-19011528 (hereinafter "AMENDMENT NUMBER ~~ONE~~ TWO") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY"), and Praeses LLC ("CONTRACTOR") with a place of business at 330 Marshall St., Suite 800, Shreveport, LA 71101 is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and Praeses LLC executed a Contract for Consultant Services for Inmate Telephone System on April 23, 2019, as Contract Number MA-060-19011528 (hereinafter "ORIGINAL CONTRACT") for a one (1) year term of April 23, 2019 through and including April 22, 2020, renewable for four (4) additional one-year terms upon mutual agreement of both parties; and

WHEREAS, COUNTY and CONTRACTOR ~~desires to renew~~ renewed the ORIGINAL CONTRACT on April 23, 2020 as Contract Number MA-060-20010904 for a one (1) year term of April 23, 2020 through and including April 22, 2021 ~~and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT~~ (hereinafter "AMENDMENT NUMBER ONE"); and

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term of April 23, 2021 through and including April 22, 2022 and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

a. Additional Terms and Conditions, Section 2, Term of Contract of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 4/23/19 through and including ~~4/22/21~~ 4/22/22, unless otherwise terminated by COUNTY. The 4/23/19 through and including 4/22/20 shall be known as Contract Number MA-060-19011528. The period

of 4/23/20 through and including ~~4/22/21~~ 4/22/22 shall be known as Contract Number MA-060-20010904, unless otherwise terminated by County. ~~This Contract may be renewed for three (3) additional one-year terms by mutual written agreement of both Parties. The County does not have to give a reason if it elects not to renew.~~

b. Additional Terms and Conditions, Section 3 – Renewals, of the ORIGINAL CONTRACT is amended in its entirety as follows:

3. Renewal: This Contract may be renewed by mutual written agreement of both Parties for two (2) additional one-year terms. The County does not have to give reason if it elects not to renew. Renewal periods may be subject to approval by the County of Orange Board of Supervisors.
2. A true and correct copy of the ORIGINAL CONTRACT (~~Contract Number MA-060-19011528~~) is attached hereto as Exhibit A and incorporated by this reference.
3. A true and correct copy of AMENDMENT NUMBER ONE is attached hereto as Exhibit B and incorporated by this reference.
4. All other provisions of the ORIGINAL CONTRACT, and AMENDMENT NUMBER ONE except as amended herein and to the extent they are not inconsistent with this AMENDMENT NUMBER ~~ONE~~ TWO, remain in full force and effect.
