This Amendment Number One (“Amendment”) to Contract Number MA-026-25011217 is made and entered into as of the date fully executed by and between Rancho Santiago Community College District DBA Santa Ana College (“Contractor”) and the County of Orange, a political subdivision of the State of California, for the Office of the District Attorney – Public Administrator (“County”), which are sometimes referred to individually as a “Party” or collectively referred to as the “Parties.”

RECITALS

WHEREAS, County and Contractor entered into Contract MA-026-25011217 (“Contract”) for Deferred Entry of Judgment Program Services commencing on May 1, 2025, and expiring on April 30, 2026; and

WHEREAS, County and Contractor desire to extend the Contract for an additional year through and including April 30, 2027;

NOW, THEREFORE, in consideration of the mutual obligation set forth herein, the Parties agree as follows:

1. Contract Section 2 – Term of Contract shall be deleted its entirety and replaced with the following:
Section 2 – Term of Contract: The term of this Contract shall be effective May 1, 2025, and continue through April 30, 2027.
2. Except as expressly amended herein, all other terms and conditions of the Contract shall remain unchanged and in full force and effect.
3. **Signature in Counterparts:** The Parties agree that separate copies of this Amendment may be signed by each of the Parties, and this Amendment will have the same force and effect as if the original had been signed by all the Parties.


