

# AMENDMENT NO. 1-2 TO CONTRACT MA-017-20011143 FOR AGENDA MANAGEMENT SYSTEM BETWEEN COUNTY OF ORANGE AND

# PRIME GOVERNMENT SOLUTIONS INC. GRANICUS, LLC.

This Amendment No. 24 to Contract MA-017-20011143 (hereinafter "Amendment No. 24") is made and entered into as of the date fully executed by and between the County of Orange (hereinafter "County"), a political subdivision of the State of California, and Prime Government Solutions Inc. (hereinafter "Contractor"), with a place of business at 3429 Derry St. Harrisburg, PA 17111 Granicus, LLC, with a place of business at 408 St. Peter St., Suite 600, St. Paul, MN 55102, ("Contractor"), with County and Contractor sometimes individually referred to as "Party" or collectively as "Parties".

# RECITALS

**WHEREAS**, County and Contractor Prime Government Solutions Inc. ("PGS") executed Contract MA-017-20011143 (hereinafter "Contract") for Agenda Management System, effective May 7, 2020 through and including May 6, 2023 in an amount not to exceed \$232,000; and

WHEREAS, County and PGS executed Amendment No.1 to update the Contractors address as reflected in the Contract preamble, the Contractors federal tax classification and to replace Table III of Attachment B – Cost Compensation; and

WHEREAS, in about March 2021, Rock Solid Technology, Inc. ("Rock Solid"), a Texas corporation, purchased all the assets of PGS; and

WHEREAS, in about October 2022, Contractor purchased all of the assets of Rock Solid; and

WHEREAS, Paragraph I, Assignment, of the Contract requires County's express written consent to any assignment of the Contract and Contractor has requested County's consent of the assignment of the Contract to Contractor; and

WHEREAS, Contractor agrees to be bound by all the terms and conditions of the Contract, as amended as if it had been an original signatory to the Contract; and

WHEREAS, County desires to amend the Contract to update the Contractors address as reflected in the Contract preamble, the Contractors federal tax classification and to replace Table III of Attachment B—Cost Compensation; and

WHEREAS, Contractor has agreed to continue to provide an Agenda Management System in accordance with the terms herein.

WHEREAS, County desires to amend the Contract to renew the Contract for one (1) additional year, to revise Paragraph 44, Notice, and to incorporate the Assignment, and Consent Agreement into the Contract; and

**NOW THEREFORE,** for and in consideration of the mutual promises and covenants contained herein, the receipt, sufficiency and adequacy of which is hereby acknowledged, the Parties, intending to be legally bound, hereby contract and agree as follows:

1. Contract shall be amended to delete and replace the preamble with the following:

"This Contract to provide an Agenda Management System (Agenda system) for the County of Orange ("Contract") is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California, acting through the County Executive Office/Office of Information Technology, ("County") and Prime Government Solutions Inc., with a place of business at 3429 Derry St. Harrisburg, PA 17111 ("Contractor"). County and Contractor may be referred to individually as "Party" or collectively as "Parties"."

 Contract shall be amended to delete Table III of Attachment B — Cost Compensation and replaced with the following:

#### ARTICLES

- 1. Amend Contract MA-017-20011143 to change Contractor from Prime Government Solutions, Inc. to Granicus LLC per Exhibit 1, entitled "Assignment and Consent Agreement".
- The Contract is renewed for a period of two (2) years, effective May 7, 2023 through May 6, 2025, in an amount not to exceed \$125,400 for this renewal period, unless otherwise terminated by County under the term of the Contract; on the amended terms and conditions.

  - **44.
