AMENDMENT NUMBER THREE TO CONTRACT NUMBER MA-012-22010183 WITH MERCHANTS LANDSCAPE SERVICES, INC. FOR LANDSCAPE MAINTENANCE SERVICES

THIS Amendment to Contract MA-012-22010183 ("Amendment") is made and entered into upon execution of all necessary signatures between the County of Orange, a political subdivision of the State of California on behalf of OC Community Resources, OC Parks ("County") and Merchants Landscape Services, Inc. ("Contractor"), a California Stock Corporation, with a place of business at 1510 S. Lyon St., Santa Ana, CA 92705-4613, with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

RECITALS

WHEREAS, County and Contractor entered into Contract Number MA-012-22010183 ("Contract") for Landscape Maintenance Services, commencing on November 1, 2021, through and including October 31, 2024, in an amount not to exceed \$2,549,800.00 annually; \$7,649,400.00 cumulative; and

WHEREAS, County and Contractor executed Amendment No. 1 to increase and amend Attachments A, B, and C and Exhibit 12; and,

WHEREAS, the County and Contractor executed Amendment No. 2 to renew for two years effective November 1, 2024, through October 31, 2026, with a new total contract not to exceed the amount of \$13,505,964.92.

WHEREAS, the Parties now desire to amend the contract to reduce the scope of work covered under the original contract and incorporate new location: Roger Stanton Park and update the scope of work and pricing

NOW, THEREFORE, the Parties agree as follows:

AMENDMENT TO CONTRACT ARTICLES

- 1. In Attachment A ("Scope of Work"), "Turfgrass Maintenance Requirements-Routine", Article 2 ("Mowing"), the following Sub article "N" shall be appended:
 - N. Effective September 23, 2024, and as a result of construction to expand the area of Mile Square Regional Park beginning at that time, the area to be maintained at Mile Square Regional Park is reduced consistent with the map, found in **Exhibit 11**, entitled "Mile Square Regional Park Expansion Area Construction." Pursuant to this reduction, the acreage of turfgrass requiring mowing at Mile Square Regional Park is reduced from approximately 84.47 Acres to approximately 40 Acres, with associated turf edge reduced from approximately 39,967 linear feet to approximately 19,625 linear feet.



 - G. Roger Stanton Park 14900 Park Lane, Midway City, CA
 - i. **Turfgrass** 18,000 FT²
 - ii. Landscape Planters 3,100 FT²
 - iii. Sidewalk + Misc. Paved Areas 5,000 FT²
 - iv. **Parking Lot** 18,360 FT²
- 6. In Attachment A ("Scope of Work"), "General Work Requirements", Section 12 ("Work Schedule"), Subsection A. shall be amended and replaced in its entirety as follows:
 - **A.** Workdays shall be seven (7) days per week Monday-Sunday depending on the task for all work sites, except Roger Stanton Park. As to Roger Stanton Park, workdays shall be Two (2) days per week Monday and Friday depending on the task.
- 7. In Attachment A ("Scope of Work"), "Turfgrass Maintenance Requirements-Routine", Section 2 ("Mowing"), Subsection A, Subsection i, the following Subsection 7. shall be appended:
 - 7. Roger Stanton Park Friday
- 8. In Attachment A ("Scope of Work"), "Irrigation System Maintenance Requirements Routine", Section 3 ("Irrigation Personnel"), Subsection D, the following Subsection vii. shall be appended:
 - vii. Roger Stanton Park- Minimum quantity of Irrigation Technician(s) required to be onsite one (1) time per week Monday or Friday. One (1) Irrigation Technician available Monday–Friday for unplanned Irrigation repairs as identified in addition to meeting all performance on schedule expectations as detailed in "Irrigation System Maintenance Requirements-Routine" of this contract below.
- 9. In Attachment A ("Scope of Work"), "Facility Maintenance Requirements Routine", Section 1 ("General Amenity Care"), Subsection (B)(vi)(2)(b), the follow Subsection iv shall be appended:
 - iv. Special Requirement- As to Roger Stanton Park, Contractor shall patrol and visually two (2) days per week including holidays. Trash Inspection/Pickup shall occur on Monday and Friday two (2) days per week. The trash inspection/pickup schedule described above is the minimum number of trash pickups required per week. Trash receptacles shall never be allowed to overflow and go unattended for any unreasonable length of time regardless of day or time. Contractor shall always provide appropriate staffing levels for this service in consultation with OC Park's Representative. Performance on Schedule failures shall be remedied by following the protocol listed in "General Requirements 17. Deficient Performance Procedures."
