AMENDMENT NO. 8

TO CONTRACT NO. MA-042-19010252 FOR

RECOVERY RESIDENCE SERVICES

This Amendment ("Amendment No. 8") to Contract No. MA-042-19010252 for Recovery Residence Services is made and entered into on July 1, 2022 ("Effective Date") between Clean Path Recovery, LLC ("Contractor"), with a place of business at 929 South Townsend, Units 1-8, Santa Ana, California 92704, and the County of Orange, a political subdivision of the State of California ("County"), through its Health Care Agency, with a place of business at 405 W. 5th St., Ste. 600, Santa Ana, CA 92701. Contractor and County may sometimes be referred to individually as "Party" or collectively as "Parties".

RECITALS

WHEREAS, the Parties executed Contract No. MA-042-19010252 for Recovery Residence Services, effective July 1, 2018 through June 30, 2021, in an aggregate amount not to exceed \$2,400,000, renewable for two additional one-year periods ("Contract"); and

WHEREAS, the Parties executed Amendment No. 1, effective May 1, 2020, to increase the Period Two Aggregate Maximum Obligation and the Period Three Aggregate Maximum Obligation by \$400,000 each, for a revised cumulative aggregate amount not to exceed \$3,200,000; and

WHEREAS, the Parties executed Amendment No. 2, effective June 1, 2020, to exercise the 10% cost contingency to increase the Period Two Aggregate Maximum Obligation by \$80,000, for a revised cumulative aggregate amount not to exceed \$3,280,000, and to amend various provisions of the Contract; and

WHEREAS, the Parties executed Amendment No. 3, effective November 19, 2020, to modify the addresses where Services are performed; and

WHEREAS, the Parties executed Amendment No. 4, effective March 1, 2021, to modify the addresses where Services are performed; and

WHEREAS, the Parties executed Amendment No. 5, effective July 1, 2021, to amend various provisions of the Contract and Exhibit A and to renew the Contract for one year, effective July 1, 2021 through June 30, 2022, in an amount not to exceed \$1,500,000, for a revised cumulative aggregate amount not to exceed \$4,780,000; and

WHEREAS, the Parties executed Amendment No. 6, effective October 8, 2021, to modify the addresses where Services are performed; and

WHEREAS, the Parties executed Amendment No. 7, effective November 1, 2021, to amend Exhibit A to increase the bed day rate set forth in the Contract; and

WHEREAS, the Parties now desire to enter into this Amendment No. 8 to amend various provisions of the Contract and Exhibit A and to renew the Contract for one year for County to continue receiving and Contractor to continue providing the services set forth in the Contract.

NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

- 1. The Contract is renewed for a term of one (1) year, effective July 1, 2022 through June 30, 2023, in an aggregate amount not to exceed \$1,500,000 for this renewal term, for a revised cumulative aggregate amount not to exceed \$6,280,000; on the amended terms and conditions.
- 2. Page 4, Referenced Contract Provisions, Master Agreement Term provision and Aggregate Maximum Obligation provision, of the Contract are deleted in their entirety and replaced with the following:

"Master Agreement Term: July 1, 2018 through June 30, 2023

Period One means the period from July 1, 2018 through June 30, 2019 Period Two means the period from July 1, 2019 through June 30, 2020 Period Three means the period from July 1, 2020 through June 30, 2021 Period Four means the period from July 1, 2021 through June 30, 2022 Period Five means the period from July 1, 2022 through June 30, 2023

5. Paragraph IV. Compliance, subparagraph B. (but not including subparagraphs B.1 through B.7), of the Contract is deleted in its entirety and replaced with the following:

"B. SANCTION SCREENING – CONTRACTOR must screen all Covered Individuals employed or retained to provide services related to this Agreement to ensure that they are not designated as Ineligible Persons, as pursuant to this Agreement. Screening must be conducted against the Social Security Administration's Death Master File at the date of employment. Screening must be conducted monthly against the General Services Administration's Excluded Parties List System or System for Award Management, the Health and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the California Medi-Cal Suspended and Ineligible Provider List, and/or any other list or system as identified by ADMINISTRATOR."

6. Paragraph VI. Cost Report, subparagraph A. (but not including subparagraphs A.1 through A.3), of the Contract is deleted in its entirety and replaced with the following:

"A. CONTRACTOR shall submit separate Cost Reports for each Period or for a portion thereof, to COUNTY no later than forty-five (45) days following termination of this Agreement. CONTRACTOR shall prepare the Cost Report in accordance with all applicable federal, state and COUNTY requirements, GAAP and the Special Provisions Paragraph of this Agreement. CONTRACTOR shall allocate direct and indirect costs to and between programs, cost centers, services, and funding sources in accordance with such requirements and consistent with prudent business practice, which costs and allocations shall be supported by source documentation maintained by CONTRACTOR, and available at any time to ADMINISTRATOR upon reasonable notice."

7. Paragraph XIII. Licenses and Laws of the Contract is deleted in its entirety and replaced with the following:

"XIII. LICENSES AND LAWS

A. CONTRACTOR, its officers, agents, employees, affiliates, and subcontractors shall, throughout the term of this Agreement, maintain all necessary licenses, permits, approvals, certificates, accreditations, waivers, and exemptions necessary for the provision of the services hereunder and required by the laws, regulations and requirements of the United States, the State of California, COUNTY, and all other applicable governmental agencies. CONTRACTOR shall notify ADMINISTRATOR immediately and in writing of its inability to obtain or maintain, irrespective of the pendency of any hearings or appeals, permits, licenses, approvals, certificates, accreditations, waivers and exemptions. Said inability shall be cause for termination of this Agreement.

B. ENFORCEMENT OF CHILD SUPPORT OBLIGATIONS

1. CONTRACTOR certifies it is in full compliance with all applicable federal and State reporting requirements regarding its employees and with all lawfully served Wage and Earnings Assignment Orders and Notices of Assignments and will continue to be in compliance throughout the term of the Agreement with the County of Orange. Failure to comply shall constitute a material breach of the Agreement and failure to cure such breach within sixty (60) calendar days of notice from the COUNTY shall constitute grounds for termination of the Agreement.

C. CONTRACTOR shall comply with all applicable governmental laws, regulations, and requirements as they exist now or may be hereafter amended or changed. These laws, regulations, and requirements shall include, but not be limited to, the following:

- 8. Paragraph XV. Maximum Obligation, subparagraph A. of the Contract is deleted in its entirety and replaced with the following:

"A. The Aggregate Maximum Obligation of COUNTY for services provided in accordance with all agreements for Recovery Residence Services during each Period are as specified in the Referenced Contract Provisions of this Agreement. This specific Agreement with CONTRACTOR is only one of several agreements to which this Aggregate Maximum Obligation applies. It therefore is understood by the parties that reimbursement to CONTRACTOR will be only a fraction of these Aggregate Maximum Obligations."

9. Paragraph XIX. Notification of Death, subparagraph D. is added to the Contract as follows:

"D. All death reports must be verified by the coroner's office. The information should include date of the death as well as the cause of death."

10. Exhibit A, Section VI. Services, subparagraph A., but not including A.1., of the Contract is deleted in its entirety and replaced with the following:

"A. FACILITY – CONTRACTOR shall provide Recovery Residence Services described herein at an Orange County Sheriff Certified Recovery Residence facility. Unless otherwise authorized in writing by ADMINISTRATOR, CONTRACTOR shall maintain regularly scheduled service hours, seven (7) days a week, twenty-four (24) hours per day throughout the year. Services shall be provided at the following locations, or at any other location approved in advance, in writing, by ADMINISTRATOR:

11. Exhibit A, Section VI. Services, subparagraph D.4., of the Contract is deleted in its entirety and replaced with the following:

"4. <u>HOUSE RULES</u> – CONTRACTOR shall establish house rules for standards of conduct for Residents that shall include mandatory participation in a recovery service such as a COUNTY-approved outpatient treatment program and/or the Day Reporting Center (DRC). Said house rules shall be enforced by CONTRACTOR's house manager and/or director, other paid staff, intern(s) or volunteer(s), as designated by CONTRACTOR's house manager and/or director."

12. Exhibit A, Section VI. Services, subparagraph D.10., of the Contract is deleted in its entirety and replaced with the following:

"10. <u>ALCOHOL AND/OR DRUG SCREENING</u> – CONTRACTOR shall perform random drug and/or alcohol testing on Resident(s) suspected of using substances or at minimum of one (1) time per-month. Testing supplies shall be provided by CONTRACTOR. In the event that a Resident receives a drug screening test result indicating any substance use, CONTRACTOR shall formulate and implement a plan of corrective action, which may include discharge, and shall be documented in the Resident's record, and shall notify Probation and COUNTY of said test result indicating any substance use within one (1) business day. CONTRACTOR shall:

a. Establish procedures that protect against the falsification and/or contamination of any body specimen sample collected for drug screening.

- b. Ensure all urine specimen collection is observed by sex congruent staff.
- c. Document results of the drug screening in the Resident's record."
- 13. Exhibit A, Section VI. Services, subparagraph D.19., of the Contract is deleted in its entirety and replaced with the following:

"19. <u>OPIOID OVERDOSE EMERGENCY TREATMENT</u> – CONTRACTOR shall have available at each program site at minimum two (2) Naloxone doses for the treatment of known or suspected opioid overdose. A House manager and residents shall be trained in administering the Naloxone. Naloxone is not a substitute for emergency medical care. CONTRACTOR shall always seek emergency medical assistance in the event of a suspected, potentially life-threatening opioid emergency."

14. Exhibit A, Section VII. Staffing, subparagraphs C.1.e. and f., of the Contract are deleted in their entirety.

This Amendment No. 8 modifies the Contract, including all previous amendments, only as expressly set forth herein. Wherever there is a conflict in the terms or conditions between this Amendment No. 8 and the Contract, including all previous amendments, the terms and conditions of this Amendment No. 8 prevail. In all other respects, the terms and conditions of the Contract, including all previous amendment No. 8 remain in full force and effect.

2	A. COMPLIANCE PROGRAM – ADMINISTRATOR has established a Compliance Program for
3	the purpose of ensuring adherence to all rules and regulations related to federal and state health care

24	within thirty (30) calendar days of execution of this Agreement a signed acknowledgement that
25	CONTRACTOR shall comply with ADMINISTRATOR's Compliance Program and Code of Conduct.
26	4. If CONTRACTOR elects to have its own Compliance Program, Code of Conduct and any
27	Compliance related policies and procedures review by ADMINISTRATOR, then CONTRACTOR shall

Upon written confirmation from ADMINISTRATOR's Compliance Officer that the CONTRACTOR's compliance program, code of conduct and any Compliance related policies and procedures contain all required elements, CONTRACTOR shall ensure that all Covered Individuals relative to this Agreement are made aware of CONTRACTOR's compliance program, code of conduct, related policies and procedures and contact information for the ADMINISTRATOR's Compliance Program.

B. SANCTION SCREENING CONTRACTOR shall screen all Covered Individuals employed or
 retained to provide services related to this Agreement monthly to ensure that they are not designated as
 Ineligible Persons, as pursuant to this Agreement. Screening shall be conducted against the General
 Services Administration's Excluded Parties List System or System for Award Management, the Health
 and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the California
 Medi-Cal Suspended and Ineligible Provider List, the Social Security Administration's Death Master File
 at date of employment, and/or any other list or system as identified by ADMINISTRATOR.

B. SANCTION SCREENING - CONTRACTOR must screen all Covered Individuals employed or 14 retained to provide services related to this Agreement to ensure that they are not designated as Ineligible 15 Persons, as pursuant to this Agreement. Screening must be conducted against the Social Security 16 Administration's Death Master File at the date of employment. Screening must be conducted monthly 17 against the General Services Administration's Excluded Parties List System or System for Award 18 Management, the Health and Human Services/Office of Inspector General List of Excluded 19 Individuals/Entities, and the California Medi-Cal Suspended and Ineligible Provider List, and/or any other 20 list or system as identified by ADMINISTRATOR. 21

For purposes of this Compliance Paragraph, Covered Individuals includes all employees,
 interns, volunteers, contractors, subcontractors, agents, and other persons who provide health care items
 or services or who perform billing or coding functions on behalf of ADMINISTRATOR.
 CONTRACTOR shall ensure that all Covered Individuals relative to this Agreement are made aware of
 ADMINISTRATOR's Compliance Program, Code of Conduct and related policies and procedures (or
 CONTRACTOR's own compliance program, code of conduct and related policies and procedures if
 CONTRACTOR has elected to use its own).

2. An Ineligible Person shall be any individual or entity who:

a. is currently excluded, suspended, debarred or otherwise ineligible to participate in federal
and state health care programs; or

b. has been convicted of a criminal offense related to the provision of health care items or
services and has not been reinstated in the federal and state health care programs after a period of
exclusion, suspension, debarment, or ineligibility.

5. Covered Individuals shall be required to disclose to CONTRACTOR immediately any
debarment, exclusion or other event that makes the Covered Individual an Ineligible Person.
CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual providing services
directly relative to this Agreement becomes debarred, excluded or otherwise becomes an Ineligible
Person.

6. CONTRACTOR acknowledges that Ineligible Persons are precluded from providing federal
and state funded health care services by contract with COUNTY in the event that they are currently
sanctioned or excluded by a federal or state law enforcement regulatory or licensing agency. If
CONTRACTOR becomes aware that a Covered Individual has become an Ineligible Person,
CONTRACTOR shall remove such individual from responsibility for, or involvement with, COUNTY
business operations related to this Agreement.

7. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual or
entity is currently excluded, suspended or debarred, or is identified as such after being sanction screened.
Such individual or entity shall be immediately removed from participating in any activity associated with
this Agreement. ADMINISTRATOR will determine appropriate repayment from, or sanction(s) to
CONTRACTOR for services provided by ineligible person or individual. CONTRACTOR shall promptly
return any overpayments within forty-five (45) business days after the overpayment is verified by
ADMINISTRATOR.

C. GENERAL COMPLIANCE TRAINING – ADMINISTRATOR shall make General Compliance
 Training available to Covered Individuals.

CONTRACTORS that have acknowledged to comply with ADMINISTRATOR's
 Compliance Program shall use its best efforts to encourage completion by all Covered Individuals;
 provided, however, that at a minimum CONTRACTOR shall assign at least one (1) designated

Failure to comply with the obligations stated in this Paragraph IV (COMPLIANCE) shall constitute a breach of the Agreement on the part of CONTRACTOR and ground for COUNTY to terminate the Agreement. Unless the circumstances require a sooner period of cure, CONTRACTOR shall have thirty (30) calendar days from the date of the written notice of default to cure any defaults grounded on this Paragraph IV (COMPLIANCE) prior to ADMINISTRATOR's right to terminate this Agreement on the basis of such default.

V. CONFIDENTIALITY

A. CONTRACTOR shall maintain the confidentiality of all records, including billings and any audio
 and/or video recordings, in accordance with all applicable federal, state and county codes and regulations,
 including 42 USC §290dd-2 (Confidentiality of Records), as they now exist or may hereafter be amended
 or changed.

B. Prior to providing any services pursuant to this Agreement, all members of the Board of Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns of the CONTRACTOR shall agree, in writing, with CONTRACTOR to maintain the confidentiality of any and all information and records which may be obtained in the course of providing such services. This Agreement shall specify that it is effective irrespective of all subsequent resignations or terminations of CONTRACTOR members of the Board of Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns.

VI. COST REPORT

A. CONTRACTOR shall submit separate Cost Reports for Period one, Period two, Period Three, 23 and Period Four or for a portion thereof, to COUNTY no later than forty-five (45) days following 24 termination of this Agreement. CONTRACTOR shall prepare the Cost Report in accordance with all 25 applicable federal, state and COUNTY requirements, GAAP and the Special Provisions Paragraph of this 26 Agreement. If CONTRACTOR fails to submit an accurate and complete Cost Report within the time
 period specified above, ADMINISTRATOR shall have sole discretion to impose one or both of the

a. CONTRACTOR may be assessed a late penalty of five hundred dollars (\$500) for each business day after the above specified due date that the accurate and complete Cost Report is not submitted. within one hundred and eighty (180) calendar days following the termination of this Agreement, and
CONTRACTOR has not entered into a subsequent or new agreement for any other services with
COUNTY, then all amounts paid to CONTRACTOR by COUNTY during the term of the Agreement
shall be immediately reimbursed to COUNTY.

B. The Cost Report shall be the final financial and statistical report submitted by CONTRACTOR
to COUNTY, and shall serve as the basis for final settlement to CONTRACTOR. CONTRACTOR shall
document that costs are reasonable and allowable and directly or indirectly related to the services to be
provided hereunder. The Cost Report shall be the final financial record for subsequent audits, if any.

C. E. If the Cost Report indicates the actual and reimbursable costs of services provided pursuant to

3 payment does not exceed the Maximum Obligation of COUNTY.

F. All Cost Reports shall contain the following attestation, which may be typed directly on or

VII. DELEGATION, ASSIGNMENT AND SUBCONTRACTS

A. CONTRACTOR may not delegate the obligations hereunder, either in whole or in part, without prior written consent of COUNTY. CONTRACTOR shall provide written notification of CONTRACTOR's intent to delegate the obligations hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to the effective date of the delegation. Any attempted assignment or delegation in derogation of this paragraph shall be void.

B. CONTRACTOR may not assign the rights hereunder, either in whole or in part, without the prior
written consent of COUNTY.

1. If CONTRACTOR is a nonprofit organization, any change from a nonprofit corporation to
any other corporate structure of CONTRACTOR, including a change in more than fifty percent (50%) of
the composition of the Board of Directors within a two (2) month period of time, shall be deemed an
assignment for purposes of this paragraph, unless CONTRACTOR is transitioning from a community
clinic/health center to a Federally Qualified Health Center and has been so designated by the Federal
Government. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

2. If CONTRACTOR is a for-profit organization, any change in the business structure,
including but not limited to, the sale or transfer of more than ten percent (10%) of the assets or stocks of
CONTRACTOR, change to another corporate structure, including a change to a sole proprietorship, or a

1 || change in fifty percent (50%) or more of Board of Directors of CONTRACTOR at one time shall be

subparagraph shall be void.

11 hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to

5. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization,
CONTRACTOR shall provide written notification within thirty (30) calendar days to ADMINISTRATOR
when there is change of less than fifty percent (50%) of Board of Directors or any governing body of
CONTRACTOR at one time.

C. CONTRACTOR's obligations undertaken pursuant to this Agreement may be carried out by
 means of subcontracts, provided such subcontracts are approved in advance, in writing by
 ADMINISTRATOR, meet the requirements of this Agreement as they relate to the service or activity
 under subcontract, and include any provisions that ADMINISTRATOR may require.

After approval of a subcontract, ADMINISTRATOR may revoke the approval of a
 subcontract upon five (5) calendar days written notice to CONTRACTOR if the subcontract subsequently
 fails to meet the requirements of this Agreement or any provisions that ADMINISTRATOR has required.

24 2. No subcontract shall terminate or alter the responsibilities of CONTRACTOR to COUNTY
25 pursuant to this Agreement.

ADMINISTRATOR may disallow, from payments otherwise due CONTRACTOR, amounts
 claimed for subcontracts not approved in accordance with this paragraph.

4. This provision shall not be applicable to service agreements usually and customarily entered
into by CONTRACTOR to obtain or arrange for supplies, technical support, and professional services
provided by consultants.

VIII. EMPLOYEE ELIGIBILITY VERIFICATION

CONTRACTOR warrants that it shall fully comply with all federal and state statutes and regulations regarding the employment of aliens and others and to ensure that employees, subcontractors, and consultants performing work under this Agreement meet the citizenship or alien status requirement set forth in federal statutes and regulations. CONTRACTOR shall obtain, from all employees, subcontractors, and consultants performing work hereunder, all verification and other documentation of

employment eligibility status required by federal or state statutes and regulations including, but not limited
to, the Immigration Reform and Control Act of 1986, 8 USC §1324 et seq., as they currently exist and as
they may be hereafter amended. CONTRACTOR shall retain all such documentation for all covered
employees, subcontractors, and consultants for the period prescribed by the law.

IX. EQUIPMENT

A. Unless otherwise specified in writing by ADMINISTRATOR, Equipment is defined as all 7 property of a Relatively Permanent nature with significant value, purchased in whole or in part by 8 ADMINISTRATOR to assist in performing the services described in this Agreement. "Relatively 9 Permanent" is defined as having a useful life of one year or longer. Equipment which costs \$5,000 or 10 over, including freight charges, sales taxes, and other taxes, and installation costs are defined as Capital 11 Assets. Equipment which costs between \$600 and \$5,000, including freight charges, sales taxes and other 12 taxes, and installation costs are defined as Controlled Equipment. Controlled Equipment includes, but is 13 not limited to audio/visual equipment, computer equipment, and lab equipment. The cost of Equipment 14 purchased, in whole or in part, with funds paid pursuant to this Agreement shall be depreciated according 15 to GAAP. 16

B. CONTRACTOR shall obtain ADMINISTRATOR's prior written approval to purchase any
Equipment with funds paid pursuant to this Agreement. Upon delivery of Equipment, CONTRACTOR
shall forward to ADMINISTRATOR, copies of the purchase order, receipt, and other supporting
documentation, which includes delivery date, unit price, tax, shipping and serial numbers.
CONTRACTOR shall request an applicable asset tag for said Equipment and shall include each purchased
asset in an Equipment inventory.

C. Upon ADMINISTRATOR's prior written approval, CONTRACTOR may expense to COUNTY
the cost of the approved Equipment purchased by CONTRACTOR. To "expense," in relation to
Equipment, means to charge the proportionate cost of Equipment in the fiscal year in which it is purchased.
Title of expensed Equipment shall be vested with COUNTY.

D. CONTRACTOR shall maintain an inventory of all Equipment purchased in whole or in part with funds paid through this Agreement, including date of purchase, purchase price, serial number, model and type of Equipment. Such inventory shall be available for review by ADMINISTRATOR, and shall include the original purchase date and price, useful life, and balance of depreciated Equipment cost, if any.

E. CONTRACTOR shall cooperate with ADMINISTRATOR in conducting periodic physical
 inventories of all Equipment. Upon demand by ADMINISTRATOR, CONTRACTOR shall return any
 or all Equipment to COUNTY.

F. CONTRACTOR must report any loss or theft of Equipment in accordance with the procedure approved by ADMINISTRATOR and the Notices Paragraph of this Agreement. In addition, CONTRACTOR must complete and submit to ADMINISTRATOR a notification form when items of

1 || Equipment are moved from one location to another or returned to COUNTY as surplus.

G. Unless this Agreement is followed without interruption by another agreement between the parties
for substantially the same type and scope of services, at the termination of this Agreement for any cause,
CONTRACTOR shall return to COUNTY all Equipment purchased with funds paid through this
Agreement.

H. CONTRACTOR shall maintain and administer a sound business program for ensuring the proper use, maintenance, repair, protection, insurance, and preservation of COUNTY Equipment.

X. FACILITIES, PAYMENTS AND SERVICES

10 CONTRACTOR agrees to provide the services, staffing, facilities, and supplies in accordance with 11 Exhibit A to this Agreement. COUNTY shall compensate, and authorize, when applicable, said services. 12 CONTRACTOR shall operate continuously throughout the term of this Agreement with at least the 13 minimum number and type of staff which meet applicable federal and state requirements, and which are 14 necessary for the provision of the services hereunder.

XI. INDEMNIFICATION AND INSURANCE

A. CONTRACTOR agrees to indemnify, defend with counsel approved in writing by COUNTY, 17 and hold COUNTY, its elected and appointed officials, officers, employees, agents and those special 18 districts and agencies for which COUNTY's Board of Supervisors acts as the governing Board 19 ("COUNTY INDEMNITEES") harmless from any claims, demands or liability of any kind or nature, 20including but not limited to personal injury or property damage, arising from or related to the services, 21 products or other performance provided by CONTRACTOR pursuant to this Agreement. If judgment is 22 entered against CONTRACTOR and COUNTY by a court of competent jurisdiction because of the 23 concurrent active negligence of COUNTY or COUNTY INDEMNITEES, CONTRACTOR and 24 COUNTY agree that liability will be apportioned as determined by the court. Neither Party shall request 25 a jury apportionment. 26

B. Prior to the provision of services under this Agreement, CONTRACTOR agrees to purchase all required insurance at CONTRACTOR's expense, including all endorsements required herein, necessary to satisfy COUNTY that the insurance provisions of this Agreement have been complied with. CONTRACTOR agrees to keep such insurance coverage, Certificates of Insurance (COI), and endorsements on deposit with COUNTY during the entire term of this Agreement. In addition, all subcontractors performing work on behalf of CONTRACTOR pursuant to this Agreement shall obtain insurance subject to the same terms and conditions as set forth herein for CONTRACTOR.

C. CONTRACTOR shall ensure that all subcontractors performing work on behalf of CONTRACTOR pursuant to this Agreement shall be covered under CONTRACTOR's insurance as an Additional Insured or maintain insurance subject to the same terms and conditions as set forth herein for CONTRACTOR. CONTRACTOR shall not allow subcontractors to work if subcontractors have less than the level of coverage required by COUNTY from CONTRACTOR under this Agreement. It is the
obligation of CONTRACTOR to provide notice of the insurance requirements to every subcontractor and
to receive proof of insurance prior to allowing any subcontractor to begin work. Such proof of insurance
must be maintained by CONTRACTOR through the entirety of this Agreement for inspection by
COUNTY representative(s) at any reasonable time.

D. All SIRs shall be clearly stated on the COI. Any SIR in an amount in excess of fifty thousand
dollars (\$50,000) shall specifically be approved by the CEO/Office of Risk Management upon review of
CONTRACTOR's current audited financial report. If CONTRACTOR's SIR is approved,
CONTRACTOR, in addition to, and without limitation of, any other indemnity provision(s) in this
Agreement, agrees to all of the following:

In addition to the duty to indemnify and hold the COUNTY harmless against any and all
 liability, claim, demand or suit resulting from CONTRACTOR's, its agents, employee's or
 subcontractor's performance of this Agreement, CONTRACTOR shall defend the COUNTY at its sole
 cost and expense with counsel approved by Board of Supervisors against same; and

15 2. CONTRACTOR's duty to defend, as stated above, shall be absolute and irrespective of any

3. The provisions of California Civil Code Section 2860 shall apply to any and all actions to

8. <u>Recovery Residence</u> housing means transitional housing services that are provided to

9. <u>Substance Use Disorder (SUD)</u> means condition in which the use of one or more substances
leads to a clinically significant impairment or distress per the Diagnostic and Statistical Manual of Mental
Disorders, Fifth Edition (DSM-5)

10. <u>Unit of Service</u> means one (1) calendar day during which services are provided to a Resident
pursuant to this Agreement. A day in which a Resident is absent for a CONTRACTOR -sanctioned
overnight pass may also be included as a unit of service.

10 11. MAT Services means the use of Federal Drug Administration-approved medications in
 11 combination with behavioral therapies to provide a whole Client approach to treating substance use

B. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the
Common Terms and Definitions Paragraph of this Exhibit A to the Agreement.

II. PAYMENTS

A. BASIS FOR REIMBURSEMENT - As compensation to CONTRACTOR for services provided 17 pursuant to the Agreement, COUNTY shall pay CONTRACTOR monthly in arrears at \$55.00 per bed 18 day served at CONTRACTOR's facility for all Recovery Residence Services for substance users, 19 provided however, that the total of all such payments to CONTRACTOR and all other COUNTY contract 20 providers for all Recovery Residence Services shall not exceed COUNTY's Aggregate Maximum 21 Obligation as set forth in the Referenced Contract Provisions of the Agreement; and provided further, that 22 CONTRACTOR's costs are allowable pursuant to applicable county, federal, and state regulations. a. CONTRACTOR must report Breaches of Unsecured PHI in accordance with Subparagraph E below and
as required by 45 CFR § 164.410.

6. CONTRACTOR agrees to ensure that any Subcontractors that create, receive, maintain, or
transmit PHI on behalf of CONTRACTOR agree to the same restrictions and conditions that apply through
this Business Associate Contract to CONTRACTOR with respect to such information.

7. CONTRACTOR agrees to provide access, within fifteen (15) calendar days of receipt of a
written request by COUNTY, to PHI in a DRS, to COUNTY or, as directed by COUNTY, to an Individual
in order to meet the requirements under 45 CFR § 164.524. If CONTRACTOR maintains an EHR with
PHI, and an individual requests a copy of such information in an electronic format, CONTRACTOR shall
provide such information in an electronic format.

8. CONTRACTOR agrees to make any amendment(s) to PHI in a DRS that COUNTY directs
or agrees to pursuant to 45 CFR § 164.526 at the request of COUNTY or an Individual, within thirty (30)
calendar days of receipt of said request by COUNTY. CONTRACTOR agrees to notify COUNTY in
writing no later than ten (10) calendar days after said amendment is completed.

9. CONTRACTOR agrees to make internal practices, books, and records, including P&Ps,
relating to the use and disclosure of PHI received from, or created or received by CONTRACTOR on
behalf of, COUNTY available to COUNTY and the Secretary in a time and manner as determined by
COUNTY or as designated by the Secretary for purposes of the Secretary determining COUNTY's
compliance with the HIPAA Privacy Rule.

10. CONTRACTOR agrees to document any Disclosures of PHI COUNTY discloses to
CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY,
and to make information related to such Disclosures available as would be required for COUNTY to
respond to a request by an Individual for an accounting of Disclosures of PHI in accordance with

13. If CONTRACTOR receives Social Security data from COUNTY provided to COUNTY by
a state agency, upon request by COUNTY, CONTRACTOR shall provide COUNTY with a list of all
employees, subcontractors, and agents who have access to the Social Security data, including employees,
agents, subcontractors, and agents of its subcontractors.

14. CONTRACTOR will notify COUNTY if CONTRACTOR is named as a defendant in a 10 criminal proceeding for a violation of HIPAA. COUNTY may terminate the Agreement, if 11 CONTRACTOR is found guilty of a criminal violation in connection with HIPAA. COUNTY may 12 terminate the Agreement, if a finding or stipulation that CONTRACTOR has violated any standard or 13 requirement of the privacy or security provisions of HIPAA, or other security or privacy laws are made 14 in any administrative or civil proceeding in which CONTRACTOR is a party or has been joined. 15 COUNTY will consider the nature and seriousness of the violation in deciding whether or not to terminate 16 the Agreement. 17

Upon 29 COUNTY's request, CONTRACTOR agrees to promptly enter into negotiations with COUNTY 30 concerning an amendment to this Business Associate Contract embodying written assurances consistent 31 with the standards and requirements of HIPAA, the HITECH Act, the HIPAA regulations or other 32 applicable laws. COUNTY may terminate the Agreement upon thirty (30) days written notice in the event: 33 a. CONTRACTOR does not promptly enter into negotiations to amend this Business 34 Associate Contract when requested by COUNTY pursuant to this Subparagraph C; or 35

b. CONTRACTOR does not enter into an amendment providing assurances regarding the
safeguarding of PHI that COUNTY deems are necessary to satisfy the standards and requirements of

CONTRACTOR shall retain each person's written confidentiality statement for COUNTY inspection for
a period of six (6) years following the termination of the Agreement.

d. Background Check. Before a member of the workforce may access PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY, a background screening of that worker must be conducted. The screening should be commensurate with the risk and magnitude of harm the employee could cause, with more thorough screening being done for those employees who are authorized to bypass significant technical and operational security controls. The CONTRACTOR shall retain each workforce member's background check documentation for a period of three (3) years.

2. Technical Security Controls

a. Workstation/Laptop encryption. All workstations and laptops that store PHI COUNTY

d. Removable media devices. All electronic files that contain PHI COUNTY discloses to
CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY
must be encrypted when stored on any removable media or portable device (i.e. USB thumb drives,
floppies, CD/DVD, Blackberry, backup tapes etc.). Encryption must be a FIPS 140-2 certified algorithm
which is 128bit or higher, such as AES. Such PHI shall not be considered "removed from the premises"
if it is only being transported from one of CONTRACTOR's locations to another of CONTRACTOR's locations.

e. Antivirus software. All workstations, laptops and other systems that process and/or store

f. Patch Management. There 18 must be a documented patch management process which determines installation timeframe based on risk 19 assessment and vendor recommendations. At a maximum, all applicable patches must be installed within 20 thirty (30) calendar or business days of vendor release. Applications and systems that cannot be patched 21 due to operational reasons must have compensatory controls implemented to minimize risk, where 22 possible. 23

g. User IDs and Password Controls. All users must be issued a unique user name for 24 accessing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, 25 or transmits on behalf of COUNTY. Username must be promptly disabled, deleted, or the password 26 changed upon the transfer or termination of an employee with knowledge of the password, at maximum 27 within twenty-four (24) hours. Passwords are not to be shared. Passwords must be at least eight characters 28 and must be a non-dictionary word. Passwords must not be stored in readable format on the computer. 29 Passwords must be changed every ninety (90) calendar or business days, preferably every sixty (60) 30 calendar or business days. d. Removal of Data. PHI COUNTY discloses to CONTRACTOR or CONTRACTOR 1 2 creates, receives, maintains, or transmits on behalf of COUNTY must not be removed from the premises of the CONTRACTOR except with express written permission of COUNTY. 3

e. Faxing. Faxes containing PHI COUNTY discloses to CONTRACTOR or 4 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall not be left 5 unattended and fax machines shall be in secure areas. Faxes shall contain a confidentiality statement 6 notifying persons receiving faxes in error to destroy them. Fax numbers shall be verified with the intended 7 recipient before sending the fax. 8

f. Mailing. Mailings containing PHI COUNTY discloses to CONTRACTOR or 9 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall be sealed and 10 secured from damage or inappropriate viewing of PHI to the extent possible. Mailings which include five 11 hundred (500) or more individually identifiable records containing PHI COUNTY discloses to 12 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY in 13 a single package shall be sent using a tracked mailing method which includes verification of delivery and 14 receipt, unless the prior written permission of COUNTY to use another method is obtained. 15

F. BREACH DISCOVERY AND NOTIFICATION

1. Following the discovery of a Breach of Unsecured PHI, CONTRACTOR shall notify 17 COUNTY of such Breach, however both parties agree to a delay in the notification if so advised by a law 18 enforcement official pursuant to 45 CFR § 164.412. 19

a. A Breach shall be treated as discovered by CONTRACTOR as of the first day on which 20 such Breach is known to CONTRACTOR or, by exercising reasonable diligence, would have been known 21 to CONTRACTOR. 22

b. CONTRACTOR shall be deemed to have knowledge of a Breach, if the Breach is known, or by exercising reasonable diligence would have known, to any person who is an employee, officer, or 24 other agent of CONTRACTOR, as determined by federal common law of agency. 25

2. CONTRACTOR shall provide the notification of the Breach immediately to the COUNTY 26 Privacy Officer. CONTRACTOR's notification may be oral, but shall be followed by written notification 27 within 24 hours of the oral notification. 28

3. CONTRACTOR's notification shall include, to the extent possible:

a. The identification of each Individual whose Unsecured PHI has been, or is reasonably 30 believed by CONTRACTOR to have been, accessed, acquired, used, or disclosed during the Breach; 31

b. Any other information that COUNTY is required to include in the notification to 32 Individual under 45 CFR §164.404 (c) at the time CONTRACTOR is required to notify COUNTY or 33 promptly thereafter as this information becomes available, even after the regulatory sixty (60) calendar or 34 business day period set forth in 45 CFR § 164.410 (b) has elapsed, including: 35

1) A brief description of what happened, including the date of the Breach and the date 36 37 || of the discovery of the Breach, if known;

A description of the types of Unsecured PHI that were involved in the Breach (such as whether full name, social security number, date of birth, home address, account number, diagnosis, disability code, or other types of information were involved);

4 3) Any steps Individuals should take to protect themselves from potential harm 5 resulting from the Breach;

4) A brief description of what CONTRACTOR is doing to investigate the Breach, to
7 mitigate harm to Individuals, and to protect against any future Breaches; and

8 5) Contact procedures for Individuals to ask questions or learn additional information,
9 which shall include a toll-free telephone number, an e-mail address, Web site, or postal address.

with respect to health care providers participating in the program, and statutes or regulations that require
 the production of information, including statutes or regulations that require such information if payment
 is sought under a government program providing public benefits.

10. "Security Incident" means the attempted or successful unauthorized access, use, disclosure,
modification, or destruction of PI, or confidential data utilized in complying with this Agreement; or
interference with system operations in an information system that processes, maintains or stores Pl.

B. TERMS OF AGREEMENT

8 1. Permitted Uses and Disclosures of DHCS PI and PII by CONTRACTOR. Except as
9 otherwise indicated in this Exhibit, CONTRACTOR may use or disclose DHCS PI only to perform
10 functions, activities, or services for or on behalf of the COUNTY pursuant to the terms of the Agreement
11 provided that such use or disclosure would not violate the CIPA if done by the COUNTY.

2. Responsibilities of CONTRACTOR

13 CONTRACTOR agrees:

a. Nondisclosure. Not to use or disclose DHCS PI or PII other than as permitted or required
by this Personal Information Privacy and Security Contract or as required by applicable state and federal
law.

b. Safeguards. To implement appropriate and reasonable administrative, technical, and 17 physical safeguards to protect the security, confidentiality and integrity of DHCS PI and PII, to protect 18 against anticipated threats or hazards to the security or integrity of DHCS PI and PII, and to prevent use 19 or disclosure of DHCS PI or PII other than as provided for by this Personal Information Privacy and 20 Security Contract. CONTRACTOR shall develop and maintain a written information privacy and security 21 program that include administrative, technical and physical safeguards appropriate to the size and 22 complexity of CONTRACTOR's operations and the nature and scope of its activities, which incorporate 23 the requirements of Subparagraph (c), below. CONTRACTOR will provide COUNTY with its current 24 policies upon request. 25

c. Security. CONTRACTOR shall ensure the continuous security of all computerized data
systems containing DHCS PI and PII. CONTRACTOR shall protect paper documents containing DHCS
Pl and PII. These steps shall include, at a minimum:

29 1) Complying with all of the data system security precautions listed in Subparagraph
30 E of the Business Associate Contract, Exhibit B to the Agreement; and

2) Providing a level and scope of security that is at least comparable to the level and
scope of security established by the Office of Management and Budget in OMB Circular No. A-130,
Appendix III-Security of Federal Automated Information Systems, which sets forth guidelines for
automated information systems in Federal agencies.

3) If the data obtained by CONTRACTOR from COUNTY includes PII,
36 CONTRACTOR shall also comply with the substantive privacy and security requirements in the CMPPA
37 Agreement between the SSA and the CHHS and in the Agreement between the SSA and DHCS, known

as the IEA. The specific sections of the IEA with substantive privacy and security requirements to be 1 complied with are Sections E, F, and G, and in Attachment 4 to the IEA, Electronic Information Exchange 2 Security Requirements, Guidelines and Procedures for Federal, State and Local Agencies Exchanging 3 Electronic Information with the SSA. CONTRACTOR also agrees to ensure that any of 4 CONTRACTOR's agents or subcontractors, to whom CONTRACTOR provides DHCS PII agree to the 5 same requirements for privacy and security safeguards for confidential data that apply to CONTRACTOR 6 with respect to such information. 7

d. Mitigation of Harmful Effects. To mitigate, to the extent practicable, any harmful effect 8 that is known to CONTRACTOR of a use or disclosure of DHCS PI or PII by CONTRACTOR or its 9 subcontractors in violation of this Personal Information Privacy and Security Contract. 10

e. CONTRACTOR's Agents and Subcontractors. To impose the same restrictions and 11 conditions set forth in this Personal Information and Security Contract on any subcontractors or other 12 agents with whom CONTRACTOR subcontracts any activities under the Agreement that involve the 13 disclosure of DHCS PI or PII to such subcontractors or other agents. 14

15 f. Availability of Information. To make DHCS PI and PII available to the DHCS and/or COUNTY for purposes of oversight, inspection, amendment, and response to requests for records, 16 injunctions, judgments, and orders for production of DHCS PI and PII. If CONTRACTOR receives DHCS 17 PII, upon request by COUNTY and/or DHCS, CONTRACTOR shall provide COUNTY and/or DHCS 18 with a list of all employees, contractors and agents who have access to DHCS PII, including employees, 19 contractors and agents of its subcontractors and agents. 20

g. Cooperation with COUNTY. With respect to DHCS PI, to cooperate with and assist the 21 COUNTY to the extent necessary to ensure the DHCS's compliance with the applicable terms of the CIPA 22 including, but not limited to, accounting of disclosures of DHCS PI, correction of errors in DHCS PI, 23 production of DHCS PI, disclosure of a security Breach involving DHCS PI and notice of such Breach to 24 the affected individual(s). 25

h. Breaches and Security Incidents. During the term of the Agreement, CONTRACTOR 26 agrees to implement reasonable systems for the discovery of any Breach of unsecured DHCS PI and PII 27 or security incident. CONTRACTOR agrees to give notification of any beach of unsecured DHCS PI and 28 PII or security incident in accordance with Subparagraph F, of the Business Associate Contract, Exhibit 29 B to the Agreement. 30

i. Designation of Individual Responsible for Security. CONTRACTOR shall designate an individual, (e.g., Security Officer), to oversee its data security program who shall be responsible for 32 carrying out the requirements of this Personal Information Privacy and Security Contract and for 33 communicating on security matters with the COUNTY. 34

9	Preface
10	The COUNTY as a political subdivision of the State of California, is mandated by state and federal law
11	to provide certain services to all County residents. In addition, the COUNTY provides certain other non-
12	mandated services to enhance the well-being and quality of life for its residents. The COUNTY is
13	committed to ensuring positive relations through this Good Neighbor Policy in the neighborhoods and
14	communities in which its Residential Program contractors provide services to its residents.
15	
16	Following effective date of this Agreement, but no later than thirty (30) days after the start of services,
17	CONTRACTOR shall conduct reasonable outreach to cities, neighborhoods and communities that could
18	be affected by services provided by CONTRACTOR.
19	
20	Good Neighbor Policy
21	This Policy applies only to the extent CONTRACTOR provides direct services to County clients pursuant
22	to this Agreement. The intent of this Policy is to identify community impacts and measures to mitigate
23	those impacts to be an integral part of the neighborhood and community the COUNTY serves.
24	
25	CONTRACTOR shall establish a policy that includes all of the following elements:
26	• Ensure staff and clients conduct themselves in a manner that demonstrates respect for the
27	community and consideration of neighbors when entering/exiting the facility or outdoors.
28	• Establish and maintain early communication with cities, neighborhoods and communities as a
29	way to identify potential impacts to neighborhoods and mitigate as needed.
30	• Establish cooperative relationships with cities, neighborhoods and communities where services
31	are being rendered and mitigate impact as needed.
32	• Collaborate with cities, neighborhoods and communities as a way to promote integration of
33	facilities into the community and determine the effectiveness of established good neighbor practices.
34	Develop written procedures to track, respond and mitigate neighborhood complaints. Procedures
35	should include identification of a contact person for complaint resolution and identification of COUNTY
36	contact if complaint is not adequately resolved. The procedures must also identify how these incidents
37	will be reported to the appropriate COUNTY contact in a timely manner.
