25			IV. <u>COMPLIANCE</u>

A. COMPLIANCE PROGRAM – ADMINISTRATOR has established a Compliance Program for the purpose of ensuring adherence to all rules and regulations related to federal and state health care programs.

1. ADMINISTRATOR shall provide CONTRACTOR with a copy of the policies and procedures relating to ADMINISTRATOR's Compliance Program, Code of Conduct and access to General Compliance and Annual Provider Trainings.

2. CONTRACTOR has the option to provide ADMINISTRATOR with proof of its own
Compliance Program, Code of Conduct and any Compliance related policies and procedures.
CONTRACTOR's Compliance Program, Code of Conduct and any related policies and procedures shall
be verified by ADMINISTRATOR's Compliance Department to ensure they include all required elements
by ADMINISTRATOR's Compliance Officer as described in in this Paragraph IV (COMPLIANCE).
These elements include:

- a. Designation of a Compliance Officer and/or compliance staff.
- b. Written standards, policies and/or procedures.
- c. Compliance related training and/or education program and proof of completion.
- d. Communication methods for reporting concerns to the Compliance Officer.
- e. Methodology for conducting internal monitoring and auditing.
- f. Methodology for detecting and correcting offenses.
- g. Methodology/Procedure for enforcing disciplinary standards.

3. If CONTRACTOR does not provide proof of its own Compliance program to ADMINISTRATOR, CONTRACTOR shall acknowledge to comply with ADMINISTRATOR's Compliance Program and Code of Conduct, the CONTRACTOR shall submit to the ADMINISTRATOR within thirty (30) calendar days of execution of this Agreement a signed acknowledgement that CONTRACTOR shall comply with ADMINISTRATOR's Compliance Program and Code of Conduct.

4. If CONTRACTOR elects to have its own Compliance Program, Code of Conduct and any Compliance related policies and procedures review by ADMINISTRATOR, then CONTRACTOR shall submit a copy of its compliance Program, code of Conduct and all relevant policies and procedures to ADMINISTRATOR within thirty (30) calendar days of execution of this Agreement. ADMINISTRATOR's Compliance Officer, or designee, shall review said documents within a reasonable time, which shall not exceed forty five (45) calendar days, and determine if CONTRACTOR's proposed compliance program and code of conduct contain all required elements to the ADMINISTRATOR's satisfaction as consistent with the HCA's Compliance Program and Code of Conduct. ADMINISTRATOR shall inform CONTRACTOR of any missing required elements and CONTRACTOR shall revise its compliance program and code of conduct to meet ADMINISTRATOR's required elements within thirty (30) calendar days after ADMINISTRATOR's Compliance Officer's determination and resubmit the same for review by the ADMINISTRATOR.

5. Upon written confirmation from ADMINISTRATOR's Compliance Officer that the CONTRACTOR's compliance program, code of conduct and any Compliance related policies and procedures contain all required elements, CONTRACTOR shall ensure that all Covered Individuals relative to this Agreement are made aware of CONTRACTOR's compliance program, code of conduct, related policies and procedures and contact information for the ADMINISTRATOR's Compliance Program.

B. SANCTION SCREENING CONTRACTOR shall screen all Covered Individuals employed or
 retained to provide services related to this Agreement monthly to ensure that they are not designated as
 Ineligible Persons, as pursuant to this Agreement. Screening shall be conducted against the General
 Services Administration's Excluded Parties List System or System for Award Management, the Health
 and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the California
 Medi-Cal Suspended and Ineligible Provider List, the Social Security Administration's Death Master File
 at date of employment, and/or any other list or system as identified by ADMINISTRATOR.

B. SANCTION SCREENING - CONTRACTOR must screen all Covered Individuals employed or 1 2 retained to provide services related to this Agreement to ensure that they are not designated as Ineligible Persons, as pursuant to this Agreement. Screening must be conducted against the Social Security 3 Administration's Death Master File at the date of employment. Screening must be conducted monthly 4 against the General Services Administration's Excluded Parties List System or System for Award 5 Management, the Health and Human Services/Office of Inspector General List of Excluded 6 Individuals/Entities, and the California Medi-Cal Suspended and Ineligible Provider List, and/or any other 7 list or system as identified by ADMINISTRATOR. 8

1. For purposes of this Paragraph IV (COMPLIANCE), Covered Individuals includes all 9 employees, interns, volunteers, contractors, subcontractors, agents, and other persons who provide health 10 care items or services or who perform billing or coding functions on behalf of ADMINISTRATOR. 11 Notwithstanding the above, this term does not include part-time or per-diem employees, contractors, 12 subcontractors, agents, and other persons who are not reasonably expected to work more than one hundred 13 sixty (160) hours per year; except that any such individuals shall become Covered Individuals at the point 14 15 when they work more than one hundred sixty (160) hours during the calendar year. CONTRACTOR shall ensure that all Covered Individuals relative to this Agreement are made aware of ADMINISTRATOR's 16 Compliance Program, Code of Conduct and related policies and procedures (or CONTRACTOR's own 17 compliance program, code of conduct and related policies and procedures if CONTRACTOR has elected 18 19 to use its own).

2. An Ineligible Person shall be any individual or entity who:

a. is currently excluded, suspended, debarred or otherwise ineligible to participate in federal and state health care programs; or

b. has been convicted of a criminal offense related to the provision of health care items or services and has not been reinstated in the federal and state health care programs after a period of exclusion, suspension, debarment, or ineligibility.

3. CONTRACTOR shall screen prospective Covered Individuals prior to hire or engagement. CONTRACTOR shall not hire or engage any Ineligible Person to provide services relative to this Agreement.

4. CONTRACTOR shall screen all current Covered Individuals and subcontractors semiannually to ensure that they have not become Ineligible Persons. CONTRACTOR shall also request that its subcontractors use their best efforts to verify that they are eligible to participate in all federal and State of California health programs and have not been excluded or debarred from participation in any federal or state health care programs, and to further represent to CONTRACTOR that they do not have any Ineligible Person in their employ or under contract.

5. Covered Individuals shall be required to disclose to CONTRACTOR immediately any
debarment, exclusion or other event that makes the Covered Individual an Ineligible Person.
CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual providing services

directly relative to this Agreement becomes debarred, excluded or otherwise becomes an Ineligible
 Person.

6. CONTRACTOR acknowledges that Ineligible Persons are precluded from providing federal and state funded health care services by contract with COUNTY in the event that they are currently sanctioned or excluded by a federal or state law enforcement regulatory or licensing agency. If CONTRACTOR becomes aware that a Covered Individual has become an Ineligible Person, CONTRACTOR shall remove such individual from responsibility for, or involvement with, COUNTY business operations related to this Agreement.

7. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual or entity is currently excluded, suspended or debarred, or is identified as such after being sanction screened. Such individual or entity shall be immediately removed from participating in any activity associated with this Agreement. ADMINISTRATOR will determine appropriate repayment from, or sanction(s) to CONTRACTOR for services provided by ineligible person or individual. CONTRACTOR shall promptly return any overpayments within forty–five (45) business days after the overpayment is verified by ADMINISTRATOR.

C. GENERAL COMPLIANCE TRAINING – ADMINISTRATOR shall make General Compliance Training available to Covered Individuals.

1. CONTRACTORS that have acknowledged to comply with ADMINISTRATOR's Compliance Program shall use its best efforts to encourage completion by all Covered Individuals; provided, however, that at a minimum CONTRACTOR shall assign at least one (1) designated representative to complete the General Compliance Training when offered.

2. Such training will be made available to Covered Individuals within thirty (30) calendar days of employment or engagement.

3. Such training will be made available to each Covered Individual annually.

4. ADMINISTRATOR will track training completion while CONTRACTOR shall provide copies of training certification upon request.

5. Each Covered Individual attending a group training shall certify, in writing, attendance at compliance training. ADMINISTRATOR shall provide instruction on group training completion while CONTRACTOR shall retain the training certifications. Upon written request by ADMINISTRATOR, CONTRACTOR shall provide copies of the certifications.

D. SPECIALIZED PROVIDER TRAINING – ADMINISTRATOR shall make Specialized Provider Training, where appropriate, available to Covered Individuals.

1. CONTRACTOR shall ensure completion of Specialized Provider Training by all Covered Individuals relative to this Agreement.

4. ADMINISTRATOR will track online completion of training while CONTRACTOR shall provide copies of the certifications upon request.

5. Each Covered Individual attending a group training shall certify, in writing, attendance at compliance training. ADMINISTRATOR shall provide instructions on completing the training in a group setting while CONTRACTOR shall retain the certifications. Upon written request by ADMINISTRATOR, CONTRACTOR shall provide copies of the certifications.

E. MEDICAL BILLING, CODING, AND DOCUMENTATION COMPLIANCE STANDARDS

1. CONTRACTOR shall take reasonable precaution to ensure that the coding of health care claims, billings and/or invoices for same are prepared and submitted in an accurate and timely manner and are consistent with federal, state and county laws and regulations. This includes compliance with federal and state health care program regulations and procedures or instructions otherwise communicated by regulatory agencies including the Centers for Medicare and Medicaid Services or their agents.

2. CONTRACTOR shall not submit any false, fraudulent, inaccurate and/or fictitious claims for payment or reimbursement of any kind.

3. CONTRACTOR shall bill only for those eligible services actually rendered which are also fully documented. When such services are coded, CONTRACTOR shall use proper billing codes which accurately describes the services provided and must ensure compliance with all billing and documentation requirements.

4. CONTRACTOR shall act promptly to investigate and correct any problems or errors in coding of claims and billing, if and when, any such problems or errors are identified.

5. CONTRACTOR shall promptly return any overpayments within forty-five (45) business days after the overpayment is verified by the ADMINISTRATOR.

6. CONTRACTOR shall meet the HCA MHP Quality Management Program Standards and participate in the quality improvement activities developed in the implementation of the Quality Management Program.

6. CONTRACTOR shall meet the HCA Quality Assessment and Performance Improvement Standards established by Authority and Quality Improvement Services (AQIS) and participate in the quality improvement activities developed in the implementation of the DMC-ODS Quality Management Program. CONTRACTOR shall establish an internal Quality Management program and appoint designated Quality Improvement (QI) staff consisting of at least one dedicated QI coordinator/professional to participate in QI activities with ADMINISTRATOR and to ensure service delivery and support program staff implement QI initiatives and requirements appropriately at the program site.

7. CONTRACTOR shall comply with the provisions of the ADMINISTRATOR's Cultural
Competence Plan submitted and approved by the State. ADMINISTRATOR shall update the Cultural
Competence Plan and submit the updates to the State for review and approval annually. (CCR, Title 9,
§1810.410.subds. (c)-(d).)

F. Failure to comply with the obligations stated in this Paragraph IV (COMPLIANCE) shall constitute a breach of the Agreement on the part of CONTRACTOR and ground for COUNTY to terminate the Agreement. Unless the circumstances require a sooner period of cure, CONTRACTOR shall have thirty (30) calendar days from the date of the written notice of default to cure any defaults grounded on this Paragraph IV (COMPLIANCE) prior to ADMINISTRATOR's right to terminate this Agreement on the basis of such default.

V. CONFIDENTIALITY

A. CONTRACTOR shall maintain the confidentiality of all records, including billings and any audio and/or video recordings, in accordance with all applicable federal, state and county codes and regulations, including 42 USC §290dd–2 (Confidentiality of Records), as they now exist or may hereafter be amended or changed.

B. Prior to providing any services pursuant to this Agreement, all members of the Board of Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns of the CONTRACTOR shall agree, in writing, with CONTRACTOR to maintain the confidentiality of any and all information and records which may be obtained in the course of providing such services. This Agreement shall specify that it is effective irrespective of all subsequent resignations or terminations of CONTRACTOR members of the Board of Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns.

C. CONTRACTOR shall have in effect a system to protect patient records from inappropriate disclosure in connection with activity funded under this Agreement. This system shall include provisions for employee education on the confidentiality requirements, and the fact that disciplinary action may occur upon inappropriate disclosure. CONTRACTOR agrees to implement administrative, physical, and technical safeguards that reasonably and appropriately protect the confidentiality, integrity, and availability of all confidential information that it creates, receives, maintains or transmits. CONTRACTOR shall provide ADMINISTRATOR with information concerning such safeguards.

D. CONTRACTOR agrees to mitigate, to the extent practicable, any harmful effect that is known to CONTRACTOR, or its subcontractors or agents in violation of the applicable state and federal regulations regarding confidentiality.

E. CONTRACTOR shall monitor compliance with the above provisions on confidentiality and security, and shall include them in all subcontracts.

F. CONTRACTOR shall notify ADMINISTRATOR within twenty–four (24) hours during a work week, of any suspected or actual breach of its computer system.

VI. COST REPORT

A. CONTRACTOR shall submit an individual and/or consolidated Cost Report for each Period or for a portion thereof to COUNTY no later than forty–five (45) calendar days following the period for

which they are prepared or termination of this Agreement. CONTRACTOR shall prepare the individual 1 and/or consolidated Cost Report in accordance with all applicable federal, state and COUNTY 2 requirements, GAAP and the Special Provisions Paragraph of this Agreement. CONTRACTOR shall 3 allocate direct and indirect costs to and between programs, cost centers, services, and funding sources in 4 accordance with such requirements and consistent with prudent business practice, which costs and 5 allocations shall be supported by source documentation maintained by CONTRACTOR, and available at 6 any time to ADMINISTRATOR upon reasonable notice. In the event CONTRACTOR has multiple 7 Agreements for mental health services that are administered by HCA, consolidation of the individual Cost 8 Reports into a single consolidated Cost Report may be required, as stipulated by ADMINISTRATOR. 9 CONTRACTOR shall submit the consolidated Cost Report to COUNTY no later than five (5) business 10 days following approval by ADMINSTRATOR of all individual Cost Reports to be incorporated into a 11 consolidated Cost Report. 12

1. If CONTRACTOR fails to submit an accurate and complete Cost Report within the time period specified above, ADMINISTRATOR shall have sole discretion to impose one or both of the following:

a. CONTRACTOR may be assessed a late penalty of five hundred dollars (\$500) for each business day after the above specified due date that the accurate and complete Cost Report is not submitted. Imposition of the late penalty shall be at the sole discretion of the ADMINISTRATOR. The late penalty shall be assessed separately on each outstanding Cost Report due COUNTY by CONTRACTOR.

b. ADMINISTRATOR may withhold or delay any or all payments due CONTRACTOR pursuant to any or all agreements between COUNTY and CONTRACTOR until such time that the accurate and complete Cost Report is delivered to ADMINISTRATOR.

2. CONTRACTOR may request, in advance and in writing, an extension of the due date of the Cost Report setting forth good cause for justification of the request. Approval of such requests shall be at the sole discretion of ADMINISTRATOR and shall not be unreasonably denied.

3. In the event that CONTRACTOR does not submit an accurate and complete Cost Report within one hundred and eighty (180) calendar days following the termination of this Agreement, and CONTRACTOR has not entered into a subsequent or new agreement for any other services with COUNTY, then all amounts paid to CONTRACTOR by COUNTY during the term of the Agreement shall be immediately reimbursed to COUNTY.

B. The individual and/or consolidated Cost Report prepared for each period shall be the final financial and statistical report submitted by CONTRACTOR to COUNTY, and shall serve as the basis for final settlement to CONTRACTOR for that period. CONTRACTOR shall document that costs are reasonable and allowable and directly or indirectly related to the services to be provided hereunder. The Cost Report shall be the final financial record for subsequent audits, if any.

C. Final settlement shall be based upon the actual and reimbursable costs for services hereunder, less

applicable revenues and any late penalty, not to exceed the negotiated rate as specified in the Agreement.
CONTRACTOR shall not claim expenditures to COUNTY which are not reimbursable pursuant to
applicable federal, state and COUNTY laws, regulations and requirements. Any payment made by
COUNTY to CONTRACTOR, which is subsequently determined to have been for an unreimbursable
expenditure or service, shall be repaid by CONTRACTOR to COUNTY in cash, or other authorized form
of payment, within thirty (30) calendar days of submission of the Cost Report or COUNTY may elect to
reduce any amount owed CONTRACTOR by an amount not to exceed the reimbursement due COUNTY.

D. Costs of Medi-Cal services shall not exceed the negotiated rate as specified in this Agreement.

E. If the Cost Report indicates the actual and reimbursable costs of services provided pursuant to this Agreement, less applicable revenues and any late penalty, are higher than the aggregate of interim monthly payments to CONTRACTOR, then COUNTY shall pay CONTRACTOR the difference, provided such payment does not exceed the COUNTY's Total Maximum Obligation Amount Not To Exceed and separate non-Medi-Cal Maximum Obligation Amount Not To Exceed.

F. All Cost Reports shall contain the following attestation, which may be typed directly on or attached to the Cost Report:

"I HEREBY CERTIFY that I have executed the accompanying Cost Report and supporting documentation prepared by ______ for the cost report period beginning ______ and ending ______ and that, to the best of my knowledge and belief, costs reimbursed through this Agreement are reasonable and allowable and directly or indirectly related to the services provided and that this Cost Report is a true, correct, and complete statement from the books and records of (provider name) in accordance with applicable instructions, except as noted. I also hereby certify that I have the authority to execute the accompanying Cost Report.

VII. DEBARMENT AND SUSPENSION CERTIFICATION

A. CONTRACTOR certifies that it and its principals:

Are not presently debarred, suspended, proposed for debarment, declared ineligible, or

A. CONTRACTOR may not delegate the obligations hereunder, either in whole or in part, without prior written consent of COUNTY. CONTRACTOR shall provide written notification of CONTRACTOR's intent to delegate the obligations hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to the effective date of the delegation. Any attempted assignment or delegation in derogation of this paragraph shall be void.

B. CONTRACTOR may not assign the rights hereunder, either in whole or in part, without the prior written consent of COUNTY.

1. If CONTRACTOR is a nonprofit organization, any change from a nonprofit corporation to any other corporate structure of CONTRACTOR, including a change in more than fifty percent (50%) of the composition of the Board of Directors within a two (2) month period of time, shall be deemed an

assignment for purposes of this paragraph, unless CONTRACTOR is transitioning from a community
 clinic/health center to a Federally Qualified Health Center and has been so designated by the Federal
 Government. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

2. If CONTRACTOR is a for-profit organization, any change in the business structure, including but not limited to, the sale or transfer of more than ten percent (10%) of the assets or stocks of CONTRACTOR, change to another corporate structure, including a change to a sole proprietorship, or a change in fifty percent (50%) or more of Board of Directors or any governing body of CONTRACTOR at one time shall be deemed an assignment pursuant to this paragraph. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

3. If CONTRACTOR is a governmental organization, any change to another structure, including a change in more than fifty percent (50%) of the composition of its governing body (i.e. Board of Supervisors, City Council, School Board) within a two (2) month period of time, shall be deemed an assignment for purposes of this paragraph. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

4. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization, CONTRACTOR shall provide written notification of CONTRACTOR's intent to assign the obligations hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to the effective date of the assignment.

5. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization, CONTRACTOR shall provide written notification within thirty (30) calendar days to ADMINISTRATOR when there is change of less than fifty percent (50%) of Board of Directors or any governing body of CONTRACTOR at one time.

C. CONTRACTOR's obligations undertaken pursuant to this Agreement may be carried out by means of subcontracts, provided such subcontracts are approved in advance, in writing by ADMINISTRATOR, meet the requirements of this Agreement as they relate to the service or activity under subcontract, and include any provisions that ADMINISTRATOR may require.

1. After approval of a subcontract, ADMINISTRATOR may revoke the approval of a subcontract upon five (5) calendar days' written notice to CONTRACTOR if the subcontract subsequently fails to meet the requirements of this Agreement or any provisions that ADMINISTRATOR has required.

2. No subcontract shall terminate or alter the responsibilities of CONTRACTOR to COUNTY pursuant to this Agreement.

3. ADMINISTRATOR may disallow, from payments otherwise due CONTRACTOR, amounts claimed for subcontracts not approved in accordance with this paragraph.

4. This provision shall not be applicable to service agreements usually and customarily entered into by CONTRACTOR to obtain or arrange for supplies, technical support, and professional services provided by consultants.

IX. EMPLOYEE ELIGIBILITY VERIFICATION

CONTRACTOR warrants that it shall fully comply with all federal and state statutes and regulations regarding the employment of aliens and others and to ensure that employees, subcontractors, and consultants performing work under this Agreement meet the citizenship or alien status requirements set forth in federal statutes and regulations. CONTRACTOR shall obtain, from all employees, subcontractors, and consultants performing work hereunder, all verification and other documentation of employment eligibility status required by federal or state statutes and regulations including, but not limited to, the Immigration Reform and Control Act of 1986, 8 USC §1324 et seq., as they currently exist and as they may be hereafter amended. CONTRACTOR shall retain all such documentation for all covered employees, subcontractors, and consultants for the period prescribed by the law.

X. EQUIPMENT

A. Unless otherwise specified in writing by ADMINISTRATOR, Equipment is defined as all property of a Relatively Permanent nature with significant value, purchased in whole or in part by ADMINISTRATOR to assist in performing the services described in this Agreement. "Relatively Permanent" is defined as having a useful life of one year or longer. Equipment which costs \$5,000 or over, including freight charges, sales taxes, and other taxes, and installation costs are defined as Capital Assets. Equipment which costs between \$600 and \$5,000, including freight charges, sales taxes and other taxes, and installation costs, or electronic equipment that costs less than \$600 but may contained PHI or PII, are defined as Controlled Equipment. Controlled Equipment, and lab equipment. The cost of Equipment purchased, in whole or in part, with funds paid pursuant to this Agreement shall be depreciated according to GAAP.

B. CONTRACTOR shall obtain ADMINISTRATOR's prior written approval to purchase any Equipment with funds paid pursuant to this Agreement. Upon delivery of Equipment, CONTRACTOR shall forward to ADMINISTRATOR, copies of the purchase order, receipt, and other supporting documentation, which includes delivery date, unit price, tax, shipping and serial numbers. CONTRACTOR shall request an applicable asset tag for said Equipment and shall include each purchased asset in an Equipment inventory.

C. Upon ADMINISTRATOR's prior written approval, CONTRACTOR may expense to COUNTY the cost of the approved Equipment purchased by CONTRACTOR. To "expense," in relation to Equipment, means to charge the proportionate cost of Equipment in the fiscal year in which it is purchased. Title of expensed Equipment shall be vested with COUNTY.

D. CONTRACTOR shall maintain an inventory of all Equipment purchased in whole or in part with funds paid through this Agreement, including date of purchase, purchase price, serial number, model and type of Equipment. Such inventory shall be available for review by ADMINISTRATOR, and shall include the original purchase date and price, useful life, and balance of depreciated Equipment cost, if || any.

E. CONTRACTOR shall cooperate with ADMINISTRATOR in conducting periodic physical inventories of all Equipment. Upon demand by ADMINISTRATOR, CONTRACTOR shall return any or all Equipment to COUNTY.

F. CONTRACTOR must report any loss or theft of Equipment in accordance with the procedure approved by ADMINISTRATOR and the Notices Paragraph of this Agreement. In addition, CONTRACTOR must complete and submit to ADMINISTRATOR a notification form when items of Equipment are moved from one location to another or returned to COUNTY as surplus.

G. Unless this Agreement is followed without interruption by another agreement between the parties for substantially the same type and scope of services, at the termination of this Agreement for any cause, CONTRACTOR shall return to COUNTY all Equipment purchased with funds paid through this Agreement.

H. CONTRACTOR shall maintain and administer a sound business program for ensuring the proper use, maintenance, repair, protection, insurance, and preservation of COUNTY Equipment.

XI. FACILITIES, PAYMENTS AND SERVICES

CONTRACTOR agrees to provide the services, staffing, facilities, and supplies in accordance with this Agreement. COUNTY shall compensate, and authorize, when applicable, said services. CONTRACTOR shall operate continuously throughout the term of this Agreement with at least the minimum number and type of staff which meet applicable federal and state requirements, and which are necessary for the provision of the services hereunder.

XII. INDEMNIFICATION AND INSURANCE

A. CONTRACTOR agrees to indemnify, defend with counsel approved in writing by COUNTY, and hold COUNTY, its elected and appointed officials, officers, employees, agents and those special districts and agencies for which COUNTY's Board of Supervisors acts as the governing Board ("COUNTY INDEMNITEES") harmless from any claims, demands or liability of any kind or nature, including but not limited to personal injury or property damage, arising from or related to the services, products or other performance provided by CONTRACTOR pursuant to this Agreement. If judgment is entered against CONTRACTOR and COUNTY by a court of competent jurisdiction because of the concurrent active negligence of COUNTY or COUNTY INDEMNITEES, CONTRACTOR and COUNTY agree that liability will be apportioned as determined by the court. Neither Party shall request a jury apportionment.

B. Prior to the provision of services under this Agreement, CONTRACTOR agrees to purchase all
 required insurance at CONTRACTOR's expense, including all endorsements required herein, necessary
 to satisfy COUNTY that the insurance provisions of this Agreement have been complied with.
 CONTRACTOR agrees to keep such insurance coverage, Certificates of Insurance, and endorsements on

D. All SIRs shall be clearly stated on the COI. Any SIR in an amount in excess of fifty thousand dollars (\$50,000) shall specifically be approved by the CEO/Office of Risk Management upon review of CONTRACTOR's current audited financial report. If CONTRACTOR's SIR is approved, CONTRACTOR, in addition to, and without limitation of, any other indemnity provision(s) in this Agreement, agrees to all of the following:

1. In addition to the duty to indemnify and hold COUNTY harmless against any and all liability, claim, demand or suit resulting from CONTRACTOR's, its agents, employee's or subcontractor's performance of this Agreement, CONTRACTOR shall defend COUNTY at its sole cost and expense with counsel approved by Board of Supervisors against same; and

2. CONTRACTOR's duty to defend, as stated above, shall be absolute and irrespective of any duty to indemnify or hold harmless; and

3. The provisions of California Civil Code Section 2860 shall apply to any and all actions to which the duty to defend stated above applies, and CONTRACTOR's SIR provision shall be interpreted as though CONTRACTOR was an insurer and COUNTY was the insured.

E. If CONTRACTOR fails to maintain insurance acceptable to COUNTY for the full term of this Agreement, COUNTY may terminate this Agreement.

F. QUALIFIED INSURER

1. The policy or policies of insurance must be issued by an insurer with a minimum rating of A-(Secure A.M. Best's Rating) and VIII (Financial Size Category as determined by the most current edition of the Best's Key Rating Guide/Property-Casualty/United States or ambest.com). It is preferred, but not mandatory, that the insurer be licensed to do business in the state of California (California Admitted Carrier).

2. If the insurance carrier does not have an A.M. Best Rating of A-/VIII, the CEO/Office of 35 Risk Management retains the right to approve or reject a carrier after a review of the company's 36 performance and financial ratings. 37

CONTRACTOR shall notify COUNTY in writing within thirty (30) calendar days of any policy cancellation and within ten (10) calendar days for non-payment of premium and provide a copy of the cancellation notice to COUNTY. Failure to provide written notice of cancellation shall constitute a breach of CONTRACTOR's obligation hereunder and ground for COUNTY to suspend or terminate this Agreement.

N. If CONTRACTOR's Professional Liability and/or Network Security & Privacy Liability are
"Claims -Made" policies, CONTRACTOR shall agree to maintain coverage for two (2) years following
the completion of the Agreement.

O. The Commercial General Liability policy shall contain a "severability of interests" clause also known as a "separation of insureds" clause (standard in the ISO CG 0001 policy).

P. Insurance certificates should be forwarded to the agency/department address listed on the solicitation.

S. COUNTY shall notify CONTRACTOR in writing of changes in the insurance requirements. If

CONTRACTOR does not deposit copies of acceptable Certificate of Insurance and endorsements with COUNTY incorporating such changes within thirty (30) calendar days of receipt of such notice, this Agreement may be in breach without further notice to CONTRACTOR, and COUNTY shall be entitled to all legal remedies.

T. The procuring of such required policy or policies of insurance shall not be construed to limit CONTRACTOR's liability hereunder nor to fulfill the indemnification provisions and requirements of this Agreement, nor act in any way to reduce the policy coverage and limits available from the insurer.

U. SUBMISSION OF INSURANCE DOCUMENTS

9

The COI and endorsements shall be provided to COUNTY as follows:

- a. Prior to the start date of this Agreement.
- b. No later than the expiration date for each policy.

c. Within thirty (30) calendar days upon receipt of written notice by COUNTY regarding changes to any of the insurance requirements as set forth in the Coverage Subparagraph above.

2. The COI and endorsements shall be provided to COUNTY at the address as specified in the Referenced Contract Provisions of this Agreement.

3. If CONTRACTOR fails to submit the COI and endorsements that meet the insurance provisions stipulated in this Agreement by the above specified due dates, ADMINISTRATOR shall have sole discretion to impose one or both of the following:

a. ADMINISTRATOR may withhold or delay any or all payments due CONTRACTOR pursuant to any and all Agreements between COUNTY and CONTRACTOR until such time that the required COI and endorsements that meet the insurance provisions stipulated in this Agreement are submitted to ADMINISTRATOR.

b. CONTRACTOR may be assessed a penalty of one hundred dollars (\$100) for each late COI or endorsement for each business day, pursuant to any and all Agreements between COUNTY and CONTRACTOR, until such time that the required COI and endorsements that meet the insurance provisions stipulated in this Agreement are submitted to ADMINISTRATOR.

c. If CONTRACTOR is assessed a late penalty, the amount shall be deducted from CONTRACTOR's monthly invoice.

4. In no cases shall assurances by CONTRACTOR, its employees, agents, including any insurance agent, be construed as adequate evidence of insurance. COUNTY will only accept valid COIs and endorsements, or in the interim, an insurance binder as adequate evidence of insurance coverage.

XIII. INSPECTIONS AND AUDITS

A. ADMINISTRATOR, any authorized representative of COUNTY, any authorized representative of the State of California, the Secretary of the United States Department of Health and Human Services, the Comptroller General of the United States, or any other of their authorized representatives, shall have access to any books, documents, and records, including but not limited to, financial statements, general

1 ledgers, relevant accounting systems, medical and client records, of CONTRACTOR that are directly 2 pertinent to this Agreement, for the purpose of responding to a beneficiary complaint or conducting an 3 audit, review, evaluation, or examination, or making transcripts during the periods of retention set forth 4 in the Records Management and Maintenance Paragraph of this Agreement. Such persons may at all 5 reasonable times inspect or otherwise evaluate the services provided pursuant to this Agreement, and the 6 premises in which they are provided.

B. ADMINISTRATOR shall inform providers and CONTRACTOR, at the time they enter into a contract, of the following:

1. Beneficiary grievance, appeal, and fair hearing procedures and timeframes as specified in 42 CFR 438.228 and 42 CFR 438.400 through 42 CFR. 438.424.

2. The beneficiary's right to file grievances and appeals and the requirements and timeframes for filing.

3. The availability of assistance to the beneficiary with filling grievances and appeals.

4. The beneficiary's right to request continuation of benefits that the ADMINISTRATOR seeks to reduce or terminate during an appeal or state fair hearing filing, if filed within the allowable timeframes, although the beneficiary may be liable for the cost of any continued benefits while the appeal or state fair hearing is pending if the final decision is adverse to the beneficiary.

5. Random reviews to ensure beneficiaries are being notified in a timely manner.

19 C. CONTRACTOR shall make all of its premises, physical facilities, equipment, books, records, documents, contracts, computers, or other electronic systems pertaining to Medi-Cal/Drug Medi-Cal 20 enrollees, Medi-Cal/Drug Medi-Cal-related activities, services and activities furnished under the terms of 21 the Agreement or determinations of amounts payable available at any time for inspection, examination of 22 copying by the State, CMS, HHS Inspector General, the Unites States Comptroller General, their 23 designees, and other authorized federal and state agencies. (42 CFR §438.3(h)) This audit right will exist 24 for ten (10) years from the final date of the contract period or from the date of completion of any audit, 25 whichever is later. D. CONTRACTOR shall actively participate and cooperate with any person specified in Subparagraph A. above in any evaluation or monitoring of the services provided pursuant to this Agreement, and shall provide the above-mentioned persons adequate office space to conduct such evaluation or monitoring.

E. AUDIT RESPONSE

Following an audit report, in the event of non-compliance with applicable laws and
 regulations governing funds provided through this Agreement, COUNTY may terminate this Agreement
 as provided for in the Termination Paragraph or direct CONTRACTOR to immediately implement
 appropriate corrective action. A plan of corrective action shall be submitted to ADMINISTRATOR in

1 || writing within thirty (30) calendar days after receiving notice from ADMINISTRATOR.

2. If the audit reveals that money is payable from one Party to the other, that is, reimbursement by CONTRACTOR to COUNTY, or payment of sums due from COUNTY to CONTRACTOR, said funds shall be due and payable from one Party to the other within sixty (60) calendar days of receipt of the audit results. If reimbursement is due from CONTRACTOR to COUNTY, and such reimbursement is not received within said sixty (60) calendar days, COUNTY may, in addition to any other remedies provided by law, reduce any amount owed CONTRACTOR by an amount not to exceed the reimbursement due COUNTY.

F. CONTRACTOR shall retain a licensed certified public accountant, who will prepare an annual Single Audit as required by 31 USC 7501 – 7507, as well as its implementing regulations under 2 CFR Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards. CONTRACTOR shall forward the Single Audit to ADMINISTRATOR within fourteen (14) calendar days of receipt.

G. CONTRACTOR shall forward to ADMINISTRATOR a copy of any audit report within fourteen (14) calendar days of receipt. Such audit shall include, but not be limited to, management, financial, programmatic or any other type of audit of CONTRACTOR's operations, whether or not the cost of such operation or audit is reimbursed in whole or in part through this Agreement.

XIV. LICENSES AND LAWS

A. CONTRACTOR, its officers, agents, employees, affiliates, and subcontractors shall, throughout the term of this Agreement, maintain all necessary licenses, permits, approvals, certificates, accreditations, waivers, and exemptions necessary for the provision of the services hereunder and required by the laws, regulations and requirements of the United States, the State of California, COUNTY, and all other applicable governmental agencies. CONTRACTOR shall notify ADMINISTRATOR immediately and in writing of its inability to obtain or maintain, irrespective of the pendency of any hearings or appeals, permits, licenses, approvals, certificates, accreditations, waivers and exemptions. Said inability shall be cause for termination of this Agreement. In addition, all treatment providers shall be DMC certified by the State DHCS. Drug Medi–Cal providers must be certified as such, and must meet any additional requirements established by COUNTY as part of this certification.

B. ENFORCEMENT OF CHILD SUPPORT OBLIGATIONS

D. CONTRACTOR shall be required that the Agreement be governed by, and construed in accordance with, all laws and regulations, and all contractual obligations under this Agreement.

XV. LITERATURE, ADVERTISEMENTS, AND SOCIAL MEDIA

A. Any written information or literature, including educational or promotional materials, distributed by CONTRACTOR to any person or organization for purposes directly or indirectly related to this Agreement must be approved at least thirty (30) days in advance and in writing by ADMINISTRATOR before distribution. For the purposes of this Agreement, distribution of written materials shall include, but not be limited to, pamphlets, brochures, flyers, newspaper or magazine ads, and electronic media such as the Internet.

B. Any advertisement through radio, television broadcast, or the Internet, for educational or promotional purposes, made by CONTRACTOR for purposes directly or indirectly related to this Agreement must be approved in advance at least thirty (30) days and in writing by ADMINISTRATOR.

C. If CONTRACTOR uses social media (such as Facebook, Twitter, YouTube or other publicly available social media sites) in support of the services described within this Agreement, CONTRACTOR shall develop social media policies and procedures and have them available to ADMINISTRATOR upon reasonable notice. CONTRACTOR shall inform ADMINISTRATOR of all forms of social media used to either directly or indirectly support the services described within this Agreement. CONTRACTOR shall comply with COUNTY Social Media Use Policy and Procedures as they pertain to any social media developed in support of the services described within this Agreement. CONTRACTOR shall also include any required funding statement information on social media when required by ADMINISTRATOR.

D. Any information as described in Subparagraphs A. and B. above shall not imply endorsement by COUNTY, unless ADMINISTRATOR consents thereto in writing.

E. CONTRACTOR shall also clearly explain through these materials that there shall be no unlawful use of drugs or alcohol associated with the services provided pursuant to this Agreement, as specified in HSC, §11999–11999.3.

XVI. MAXIMUM OBLIGATION AMOUNT NOT TO EXCEED

A. The Total Maximum Obligation Amount Not To Exceed of COUNTY for services provided in accordance with this Agreement, and the separate Maximum Obligations Amounts Not to Exceed for each period under this Agreement, are as specified in the Referenced Contract Provisions of this Agreement, except as allowed for in Subparagraph B. below.

B. ADMINISTRATOR may amend the Maximum Obligation <u>Amount Not To Exceed</u> by an amount not to exceed ten percent (10%) of Period One funding for this Agreement.

XVII. MINIMUM WAGE LAWS

A. Pursuant to the United States of America Fair Labor Standards Act of 1938, as amended, and State of California Labor Code, §1178.5, CONTRACTOR shall pay no less than the greater of the federal or California Minimum Wage to all its employees that directly or indirectly provide services pursuant to this Agreement, in any manner whatsoever. CONTRACTOR shall require and verify that all its contractors or other persons providing services pursuant to this Agreement on behalf of CONTRACTOR also pay their employees no less than the greater of the federal or California Minimum Wage.

B. CONTRACTOR shall comply and verify that its contractors comply with all other federal and State of California laws for minimum wage, overtime pay, record keeping, and child labor standards pursuant to providing services pursuant to this Agreement.

C. Notwithstanding the minimum wage requirements provided for in this clause, CONTRACTOR, where applicable, shall comply with the prevailing wage and related requirements, as provided for in accordance with the provisions of Article 2 of Chapter 1, Part 7, Division 2 of the Labor Code of the State of California (§§1770, et seq.), as it now exists or may hereafter be amended.

XVIII. NONDISCRIMINATION

A. EMPLOYMENT

1. During the term of this Agreement, CONTRACTOR and its Covered Individuals shall not unlawfully discriminate against any employee or applicant for employment because of his/her race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender expression, age, sexual orientation, or military and veteran status. Additionally, during the term of this Agreement, CONTRACTOR and its Covered Individuals shall require in its subcontracts that subcontractors shall not unlawfully discriminate against any employee or applicant for employment because of his/her race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender expression, age, sexual orientation, or military and veteran status.

2. CONTRACTOR and its Covered Individuals shall not discriminate against employees or applicants for employment in the areas of employment, promotion, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rate of pay or other forms of compensation; and selection for training, including apprenticeship.

3. CONTRACTOR shall not discriminate between employees with spouses and employees with domestic partners, or discriminate between domestic partners and spouses of those employees, in the provision of benefits.

4. CONTRACTOR shall post in conspicuous places, available to employees and applicants for
 employment, notices from ADMINISTRATOR and/or the United States Equal Employment Opportunity
 Commission setting forth the provisions of the Equal Opportunity clause.

5. All solicitations or advertisements for employees placed by or on behalf of CONTRACTOR and/or subcontractor shall state that all qualified applicants will receive consideration for employment without regard to race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender expression, age, sexual orientation, or military and veteran status. Such requirements shall be deemed fulfilled by use of the term EOE.

3. Restricting a client in any way in the enjoyment of any advantage or privilege enjoyed by others receiving any service or benefit.

4. Treating a client differently from others in satisfying any admission requirement or condition, or eligibility requirement or condition, which individuals must meet in order to be provided any service or benefit.

5. Assignment of times or places for the provision of services.

C. COMPLAINT PROCESS – CONTRACTOR shall establish procedures for advising all clients through a written statement that CONTRACTOR's and/or subcontractor's clients may file all complaints alleging discrimination in the delivery of services with CONTRACTOR, subcontractor, and ADMINISTRATOR or the U.S. Department of Health and Human Services' OCR.

Whenever possible, problems shall be resolved informally and at the point of service.
 CONTRACTOR shall establish an internal informal problem resolution process for clients not able to
 resolve such problems at the point of service. Clients may initiate a grievance or complaint directly with
 CONTRACTOR either orally or in writing.

2. Within the time limits procedurally imposed, the complainant shall be notified in writing as to the findings regarding the alleged complaint and, if not satisfied with the decision, may file an appeal.

D. PERSONS WITH DISABILITIES – CONTRACTOR and/or subcontractor agree to comply with the provisions of §504 of the Rehabilitation Act of 1973, as amended, (29 USC 794 et seq., as implemented in 45 CFR 84.1 et seq.), and the Americans with Disabilities Act of 1990 as amended (42 USC 12101 et seq.; as implemented in 29 CFR 1630), as applicable, pertaining to the prohibition of discrimination against qualified persons with disabilities in all programs or activities; and if applicable, as implemented in Title 45, CFR, §84.1 et seq., as they exist now or may be hereafter amended together with succeeding legislation.

E. RETALIATION – Neither CONTRACTOR nor subcontractor, nor its employees or agents shall intimidate, coerce or take adverse action against any person for the purpose of interfering with rights secured by federal or state laws, or because such person has filed a complaint, certified, assisted or otherwise participated in an investigation, proceeding, hearing or any other activity undertaken to enforce rights secured by federal or state law.

F. In the event of non–compliance with this paragraph or as otherwise provided by federal and state law, this Agreement may be canceled, terminated or suspended in whole or in part and CONTRACTOR or subcontractor may be declared ineligible for further contracts involving federal, state or county funds.

XIX. <u>NOTICES</u>

A. Unless otherwise specified, all notices, claims, correspondence, reports and/or statements authorized or required by this Agreement shall be effective:

1. When written and deposited in the United States mail, first class postage prepaid and addressed as specified in the Referenced Contract Provisions of this Agreement or as otherwise directed by ADMINISTRATOR;

- 2. When faxed, transmission confirmed;
- 3. When sent by Email; or

4. When accepted by U.S. Postal Service Express Mail, Federal Express, United Parcel Service, or any other expedited delivery service.

B. Termination Notices shall be addressed as specified in the Referenced Contract Provisions of this
 Agreement or as otherwise directed by ADMINISTRATOR and shall be effective when faxed,
 transmission confirmed, or when accepted by U.S. Postal Service Express Mail, Federal Express, United
 Parcel Service, or any other expedited delivery service.

37 C. CONTRACTOR shall notify ADMINISTRATOR, in writing, within twenty–four (24) hours of

becoming aware of any occurrence of a serious nature, which may expose COUNTY to liability. Such occurrences shall include, but not be limited to, accidents, injuries, or acts of negligence, or loss or damage 2 to any COUNTY property in possession of CONTRACTOR. 3

D. For purposes of this Agreement, any notice to be provided by COUNTY may be given by ADMINISTRATOR.

XX. NOTIFICATION OF DEATH

A. Upon becoming aware of the death of any person served pursuant to this Agreement, CONTRACTOR shall immediately notify ADMINISTRATOR.

B. All Notifications of Death provided to ADMINISTRATOR by CONTRACTOR shall contain the name of the deceased, the date and time of death, the nature and circumstances of the death, and the name(s) of CONTRACTOR's officers or employees with knowledge of the incident.

1. TELEPHONE NOTIFICATION – CONTRACTOR shall notify ADMINISTRATOR by telephone immediately upon becoming aware of the death due to non-terminal illness of any person served pursuant to this Agreement; provided, however, weekends and holidays shall not be included for purposes of computing the time within which to give telephone notice and, notwithstanding the time limit herein specified, notice need only be given during normal business hours.

2. WRITTEN NOTIFICATION

a. NON-TERMINAL ILLNESS - CONTRACTOR shall hand deliver, fax, and/or send via encrypted email to ADMINISTRATOR a written report within sixteen (16) hours after becoming aware of the death due to non-terminal illness of any person served pursuant to this Agreement.

b. TERMINAL ILLNESS - CONTRACTOR shall notify ADMINISTRATOR by written report hand delivered, faxed, sent via encrypted email, and/or postmarked and sent via U.S. Mail within forty-eight (48) hours of becoming aware of the death due to terminal illness of any person served pursuant to this Agreement.

C. If there are any questions regarding the cause of death of any person served pursuant to this Agreement who was diagnosed with a terminal illness, or if there are any unusual circumstances related to the death, CONTRACTOR shall immediately notify ADMINISTRATOR in accordance with this Notification of Death Paragraph.

D. All death reports must be verified by the coroner's office. The information should include date of the death as well as the cause of death.

XXI. NOTIFICATION OF PUBLIC EVENTS AND MEETINGS

A. CONTRACTOR shall notify ADMINISTRATOR of any public event or meeting funded in whole or in part by the COUNTY, except for those events or meetings that are intended solely to serve clients or occur in the normal course of business.

B. CONTRACTOR shall notify ADMINISTRATOR at least thirty (30) business days in advance of

XXII. RECORDS MANAGEMENT AND MAINTENANCE

A. CONTRACTOR, its officers, agents, employees and subcontractors shall, throughout the term of this Agreement, prepare, maintain and manage records appropriate to the services provided and in accordance with this Agreement and all applicable requirements, which include but are not limited to:

1. California Code of Regulations Title 22, §§70751(c), 71551(c), 73543(a), 74731(d), 75055(a), 75343(a), and 77143(a).

2. State of California, Department of Health Care Services ASRS Manual.

3. State of California, Department of Health Care Services DPFS Manual.

4. California Health and Safety Code §123145.

5. Title 45 CFR, 164.501; 164.524; 164.526; 164.530(c) and (j).

B. CONTRACTOR shall implement and maintain administrative, technical and physical safeguards to ensure the privacy of PHI and prevent the intentional or unintentional use or disclosure of PHI in violation of the HIPAA, federal and state regulations and/or CHPP. CONTRACTOR shall mitigate to the extent practicable, the known harmful effect of any use or disclosure of PHI made in violation of federal or state regulations and/or COUNTY policies.

C. CONTRACTOR's participant, client, and/or patient records shall be maintained in a secure manner. CONTRACTOR shall maintain participant, client, and/or patient records and must establish and implement written record management procedures.

D. CONTRACTOR shall retain all financial records for a minimum of ten (10) years from the commencement of the contract, unless a longer period is required due to legal proceedings such as litigations and/or settlement of claims.

E. CONTRACTOR shall make records pertaining to the costs of services, participant fees, charges, billings, and revenues available at one (1) location within the limits of the County of Orange.

F. CONTRACTOR shall ensure all HIPAA (DRS) requirements are met. HIPAA requires that clients, participants and/or patients be provided the right to access or receive a copy of their DRS and/or request addendum to their records. Title 45 CFR §164.501, defines DRS as a group of records maintained by or for a covered entity that is:

1. The medical records and billing records about individuals maintained by or for a covered health care provider;

34 2. The enrollment, payment, claims adjudication, and case or medical management record
35 systems maintained by or for a health plan; or

3. Used, in whole or in part, by or for the covered entity to make decisions about individuals.

G. CONTRACTOR may retain client, and/or patient documentation electronically in accordance

with the terms of this Agreement and common business practices. If documentation is retained
 electronically, CONTRACTOR shall, in the event of an audit or site visit:

1. Have documents readily available within forty–eight (48) hour notice of a scheduled audit or site visit.

2. Provide auditor or other authorized individuals access to documents via a computer terminal.

3. Provide auditor or other authorized individuals a hardcopy printout of documents, if requested.

H. CONTRACTOR shall ensure compliance with requirements pertaining to the privacy and security of PII and/or PHI. CONTRACTOR shall notify COUNTY immediately by telephone call plus email or fax upon the discovery of a Breach of unsecured PHI and/or PII.

I. CONTRACTOR may be required to pay any costs associated with a Breach of privacy and/or security of PII and/or PHI, including but not limited to the costs of notification. CONTRACTOR shall pay any and all such costs arising out of a Breach of privacy and/or security of PII and/or PHI.

J. CONTRACTOR shall retain all client and/or patient medical records for ten (10) years following discharge of the client and/or patient, with the exception of non-emancipated minors for whom records must be kept for at least one (1) year after such minors have reached the age of eighteen (18) years, or for ten (10) years after the last date of service, whichever is longer.

K. CONTRACTOR shall obtain an NPI for each site identified as a location for providing contractual services. Provider's site NPIs must be submitted to the ADMINISTRATOR prior to rendering services to clients. Contractors providing direct or indirect services for State reporting must also submit rendering (individual) provider NPIs to ADMINISTRATOR for each staff member providing Medi–Cal billable services. Contractor reimbursement will not be processed unless NPIs are on file with ADMINISTRATOR in advance of providing services to clients. It is the responsibility of each contract provider site and individual staff member that bills Medi–Cal to obtain an NPI from the NPPES. Each contract site, as well as every staff member that provides billable services, is responsible for notifying the NPPES within thirty (30) calendar days of any updates to personal information, which may include, but is not limited to, worksite address, name changes, taxonomy code changes, etc.

XXIII. RESEARCH AND PUBLICATION

CONTRACTOR shall not utilize information and/or data received from COUNTY, or arising out of, or developed, as a result of this Agreement for the purpose of personal or professional research, or for publication.

XXIV. <u>REVENUE</u>

A. CLIENT FEES – CONTRACTOR shall not charge a fee to DMC beneficiaries to whom services are provided pursuant to this Agreement, their estates and/or responsible relatives, unless a Share of Cost is determined per Medi-Cal eligibility.

B. THIRD-PARTY REVENUE – CONTRACTOR shall make every reasonable effort to obtain all available third-party reimbursement for which persons served pursuant to this Agreement may be eligible. Charges to insurance carriers shall be on the basis of CONTRACTOR's usual and customary charges. An Assignment of Benefits must be present in a Participant's file when applicable.

C. PROCEDURES – CONTRACTOR shall maintain internal financial controls which adequately ensure proper billing and collection procedures. CONTRACTOR's procedures shall specifically provide for the identification of delinquent accounts and methods for pursuing such accounts. CONTRACTOR shall provide ADMINISTRATOR, monthly, a written report specifying the current status of fees which are billed, collected, transferred to a collection agency, or deemed by CONTRACTOR to be uncollectible.

XXV. <u>SEVERABILITY</u>

If a court of competent jurisdiction declares any provision of this Agreement or application thereof to any person or circumstances to be invalid or if any provision of this Agreement contravenes any federal, state or county statute, ordinance, or regulation, the remaining provisions of this Agreement or the application thereof shall remain valid, and the remaining provisions of this Agreement shall remain in full force and effect, and to that extent the provisions of this Agreement are severable.

XXVI. SPECIAL PROVISIONS

A. CONTRACTOR shall not use the funds provided by means of this Agreement for the following purposes:

1. Making cash payments to intended recipients of services through this Agreement.

2. Lobbying any governmental agency or official. CONTRACTOR shall file all certifications and reports in compliance with this requirement pursuant to Title 31, USC, §1352 (e.g., limitation on use of appropriated funds to influence certain federal contracting and financial transactions).

3. Fundraising.

4. Purchase of gifts, meals, entertainment, awards, or other personal expenses for CONTRACTOR's staff, volunteers, or members of the Board of Directors or governing body.

5. Reimbursement of CONTRACTOR's members of the Board of Directors or governing body for expenses or services.

6. Making personal loans to CONTRACTOR's staff, volunteers, interns, consultants, subcontractors, and members of the Board of Directors or governing body, or its designee or authorized agent, or making salary advances or giving bonuses to CONTRACTOR's staff.

7. Paying an individual salary or compensation for services at a rate in excess of the current Level I of the Executive Salary Schedule as published by the OPM. The OPM Executive Salary Schedule may be found at www.opm.gov.

- 8. Severance pay for separating employees.
- 9. Paying rent and/or lease costs for a facility prior to the facility meeting all required building

17	1. Funding travel or training (excluding mileage or parking).
18	2. Making phone calls outside of the local area unless documented to be directly for the purpose

XXVIII. TERM

A. This specific Agreement with CONTRACTOR is only one of several agreements to which the term of this Agreement applies. This specific Agreement shall commence as specified in the Reference Contract Provisions of this Agreement or the execution date, whichever is later. This specific Agreement shall terminate as specified in the Referenced Contract Provisions of this Agreement, unless otherwise sooner terminated as provided in this Agreement; provided, however, CONTRACTOR shall be obligated to perform such duties as would normally extend beyond this term, including but not limited to, obligations with respect to confidentiality, indemnification, audits, reporting and accounting.

B. Any administrative duty or obligation to be performed pursuant to this Agreement on a weekend or holiday may be performed on the next regular business day.

XXIX. TERMINATION

A. Either Party may terminate this Agreement, without cause, upon ninety (90) calendar days' written notice given the other Party.

B. Unless otherwise specified in this Agreement, COUNTY may terminate this Agreement upon five (5) calendar days' written notice if CONTRACTOR fails to perform any of the terms of this Agreement. At ADMINISTRATOR's sole discretion, CONTRACTOR may be allowed up to thirty (30) calendar days for corrective action.

C. COUNTY may terminate this Agreement immediately, upon written notice, on the occurrence of any of the following events:

- 1. The loss by CONTRACTOR of legal capacity.
- 2. Cessation of services.

3. The delegation or assignment of CONTRACTOR's services, operation or administration to another entity without the prior written consent of COUNTY.

4. The neglect by any physician or licensed person employed by CONTRACTOR of any duty required pursuant to this Agreement.

5. The loss of accreditation or any license required by the Licenses and Laws Paragraph of this Agreement.

6. The continued incapacity of any physician or licensed person to perform duties required
pursuant to this Agreement.

7. Unethical conduct or malpractice by any physician or licensed person providing services
 pursuant to this Agreement; provided, however, COUNTY may waive this option if CONTRACTOR
 removes such physician or licensed person from serving persons treated or assisted pursuant to this

1	Agreement.
2	D. CONTINGENT FUNDING
3	1. Any obligation of COUNTY under this Agreement is contingent upon the following:
4	a. The continued availability of federal, state and county funds for reimbursement of
5	COUNTY's expenditures, and

32	CONTRACTOR shall submit a written plan for settlement of all outstanding liabilities and all claims

35	9. Provide written notice of termination of services to each client being served under this

Waiver by COUNTY of any default by CONTRACTOR shall not be considered a waiver of any subsequent default. Waiver by COUNTY of any breach by CONTRACTOR of any provision of this Agreement shall not be considered a waiver of any subsequent breach. Waiver by COUNTY of any default or any breach by CONTRACTOR shall not be considered a modification of the terms of this Agreement.

B. PAYMENT METHOD – COUNTY shall pay CONTRACTOR monthly in arrears provided,
 however, that the total of such payments shall not exceed the COUNTY's Maximum Obligation Amount
 <u>Not To Exceed</u>. CONTRACTOR's invoices shall be on a form approved or provided by
 ADMINISTRATOR and shall provide such information as is required by ADMINISTRATOR. Invoices

C. Monthly payments are interim payments only, and subject to Final Settlement in accordance with the Cost Report Paragraph of this Agreement. Invoices received after the due date may not be paid in accordance with Subparagraph II.B of this Exhibit B to the Agreement.

D. All invoices to COUNTY shall be supported, at CONTRACTOR's facility, by source documentation including, but not limited to, ledgers, books, vouchers, journals, time sheets, payrolls, appointment schedules, schedules for allocating costs, invoices, bank statements, canceled checks, receipts, receiving records, and records of services provided.

E. ADMINISTRATOR may withhold or delay any payment if CONTRACTOR fails to comply with any provision of this Agreement.

F. COUNTY shall not reimburse CONTRACTOR for services provided beyond the expiration and/or termination of this Agreement.

G. In conjunction with Subparagraph II.A above, CONTRACTOR shall not enter Units of Service into the COUNTY IRIS system for services not rendered. If such information has been entered, CONTRACTOR shall make corrections within ten (10) calendar days from notification by ADMINISTRATOR. Additionally, to assist in the protection of data integrity, CONTRACTOR shall create a procedure to ensure separation of duties between the individual performing direct services (LPHA, clinicians, counselors, etc.), and the clerical staff who enter information into the IRIS system. Clerical staff shall enter data into IRIS using the chart information provided by the direct service staff.

H. CONTRACTOR shall ensure compliance with all DMC billing and documentation requirements when entering Units of Service into COUNTY IRIS system. ADMINISTRATOR shall withhold payment for non-compliant Units of Service, and may reduce, withhold or delay any payment associated with noncompliant billing practices.

I. CONTRACTOR may be required to have an audit conducted in accordance with federal OMB Circular A-133. CONTRACTOR shall be responsible for complying with any federal audit requirements within the reporting period specified by OMB Circular A-133.

J. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the Payments Paragraph of this Exhibit B to the Agreement.

34	copies of literature in multiple languages and formats, as appropriate; and descriptions of measures taken

Information on self-help meetings. AA, NA, and non-12 step meetings shall be included. 21 G. NO PROSELYTIZING POLICY - CONTRACTOR shall not conduct any proselytizing 22 23 activities, regardless of funding sources, with respect to any person who has been referred to CONTRACTOR by COUNTY under the terms of this Agreement. Further, CONTRACTOR agrees that 24 the funds provided hereunder shall not be used to promote, directly or indirectly, any religion, religious 25 creed or cult, denomination or sectarian institution, or religious belief. 26 H. AUTHORITY - CONTRACTOR shall recognize the authority of OCPD as officers of the court, 27 and shall extend cooperation to OCPD within the constraints of CONTRACTOR's program of substance 28 use disorder residential services. 29 I. NON-SMOKING POLICY - CONTRACTOR shall establish a written non-smoking policy 30 which shall be reviewed and approved by ADMINISTRATOR. At a minimum, the non-smoking policy 31 shall specify that the facility is "smoke free" and that designated smoking areas are outside the visiting 32 areas at the facility. 33 J. 3. Requirement for all Clients to notify the program of any change in his/her schedule.

K. GOOD NEIGHBOR POLICY – ADMINISTRATOR has established a Good Neighbor Policy for the purpose of identifying community impacts and measures to mitigate those impacts. The Good Neighbor Policy is a set of principles and activities designed to provide a consistent means of communication between facilities that provide client services and their respective neighbors. The Good Neighbor Policy is applicable for Residential Programs when CONTRACTOR provides service to County residents and the services have a potential impact including but not limited to community safety, cleanliness, and security in the surrounding neighborhood(s).

a. ADMINISTRATOR shall provide CONTRACTOR with a copy of the Good Neighbor Policy, attached hereto as Exhibit D.

b. CONTRACTOR agrees to adhere to the Good Neighbor Policy to the fullest extent possible. In addition, each facility shall develop a written procedure for the handling of neighborhood complaints which shall be approved by ADMINISTRATOR. Approved procedure must be available onsite, readily accessible upon request, and include ADMINISTRATOR's contact information as provided.

c. Non-compliance with this Paragraph and Exhibit D shall constitute a material breach of this
 Agreement and constitute cause for immediate termination of this Agreement.

L. VISITATION POLICY – CONTRACTOR shall establish a written Visitation Policy, which shall be reviewed and approved by ADMINISTRATOR, which shall include, but not be limited to, the following:

1. Sign in logs;

2. Visitation hours; and

3. Designated visiting areas at the Facility.

M. TRANSGENDER POLICY – CONTRACTOR shall establish a written Transgender Policy, which shall be reviewed and approved by ADMINISTRATOR. The policy shall include, but not limited to, the following:

N. MEDICATION POLICY CONTRACTOR shall establish a written Medication Policy, which

 address Medications that are prescribed for substance and mental health disorders and medications
 disallowed by CONTRACTOR. Clients shall be allowed to have Medications during their stay with the
 program, and/or to have the ability to get refill(s).

36 O. OPIOID OVERDOSE EMERGENCY TREATMENT CONTRACTOR shall have available at
 37 each program site at minimum one (1) Naloxone Nasal Spray for the treatment of known or suspected

opioid overdose. At least one (1) staff per shift shall be trained in administering the Naloxone Nasal 1 Spray. Naloxone Nasal Spray is not a substitute for emergency medical care. CONTRACTOR shall 2 always seek emergency medical assistance in the event of a suspected, potentially life-threatening opioid 3 emergency. 4 N. ADULT RESIDENTIAL TREATMENT SERVICES 11 A. FACILITY - CONTRACTOR shall operate a DHCS licensed substance use disorder residential 12 treatment facility in accordance with the standards established by COUNTY and the State within the 13 specifications stated below, unless otherwise authorized by the ADMINISTRATOR. Program shall have 14 DMC certification and must be designated by DHCS as capable of delivering care consistent with ASAM 15 treatment criteria. Residential services may be provided in facilities with no bed capacity limit. The 16 environment shall be healthy and safe and the facility shall be clean and in good repair. Unless otherwise 17 authorized in writing by ADMINISTRATOR, CONTRACTOR shall maintain regularly scheduled service 18 19 hours, seven (7) days a week, twenty-four (24) hours per day, three hundred sixty-five (365) days a year. The facility will have, at a minimum: a kitchen, dining room, and laundry facilities, with enough space 20 for leisure time and group activities. Services shall be provided at the following locations, or at any other 21 location approved in advance, in writing, by ADMINISTRATOR: 22 23 1207 E. Fruit Street, Santa Ana, CA 92701 24 25 **B.** LENGTH OF STAY 26 27 1. Adults, ages twenty one (21) and over, may receive no more than (2) residential treatment episodes per three hundred sixty-five (365) day period. A residential treatment episode is defined as one 28 (1) residential stay in a DHCS licensed facility for a maximum of ninety (90) days if medically necessary 29 per three hundred sixty-five (365) day period. An adult Client may receive one thirty (30) day extension, 30 with prior authorization, if that extension is medically necessary, per three hundred sixty-five (365) day 31 period. 32 -Adolescents, under the age of twenty-one (21), shall receive continuous residential services 33 for a maximum of thirty (30) days. Adolescent beneficiaries may receive up to a thirty (30) day extension 34 if that extension is determined to be medically necessary by Medical Director or LPHA. Adolescent 35 beneficiaries are limited to one extension per year. Adolescent beneficiaries receiving 36 residential treatment shall be stabilized as soon as possible and moved down to a less intensive level of 37

11	B. LENGTH OF STAY – Length of stay is based on medical necessity as determined by a Licensed

13	calendar day average in the residential level of care.
14	1. At CONTRACTOR'S discretion, CONTRACTOR may hold a Client's bed during a
15	temporary absence. A temporary absence will be seven (7) calendar days or less during which the Client
16	is absent from the program due to a brief hospitalization for physical or mental health condition including
17	detoxification, family death or emergency, or flash incarceration. A temporary absence bed day hold is
18	not reimbursed by ADMINISTRATOR. Client's readmission does not count as a new treatment episode
19	and will not necessitate a new treatment authorization or CalOMS admission. Documentation timelines
20	must adhere to original admission date.
21	C. PERSONS TO BE SERVED In order to receive services through the DMC-ODS, the Client
22	must be enrolled in Medi-Cal, reside in Orange County, and meet medical necessity criteria, as outlined
23	below.
24	
25	1. CONTRACTOR must verify the Medicaid eligibility determination of potential Clients. The
26	verification shall be reviewed and approved by the ADMINISTRATOR prior to payment for services,
27	unless the individual is eligible to receive services from tribal health programs operating under the Indian
28	Self Determination and Education Assistance Act (ISDEAA Pub.L 93-638, as amended) and urban
29	Indian organizations operating under Title V of the IHCIA. If the individual is eligible to receive services
30	from tribal health programs operating under the ISDEAA, then the determination shall be conducted as
31	set forth in the Tribal Delivery System Attachment BB to the STCs.
32	2. The initial medical necessity determination for an individual to receive a DMC-ODS benefit
33	must be performed through a face-to-face review or telehealth by a LPHA. After establishing a diagnosis,
34	the ASAM Criteria shall be applied by the diagnosing individual to determine placement into the level of
35	assessed services. In residential treatment the ASAM criteria will be reapplied at thirty (30) days after
36	admission and sixty (60) days after admission to reassess for appropriate level of care. It shall also be
37	used to justify a treatment extension request if appropriate.

3. Medical necessity for an adult [an individual age twenty-one (21) and over] is determined 1 2 using the following criteria: 3 a. The individual must have received at least one diagnosis from the DSM for Substance-Related and Addictive Disorders with the exception of Tobacco-Related Disorders and Non-Substance-4 **Related Disorders:** 5 b. The individual must meet the ASAM Criteria definition of medical necessity for services 6 7 based on the ASAM Criteria. - Individuals under age twenty-one (21) are eligible to receive Medicaid services pursuant to 8 the EPSDT mandate. Under the EPSDT mandate, beneficiaries under the age twenty-one (21) are eligible 9 to receive all appropriate and medically necessary services needed to correct and ameliorate health 10 conditions that are coverable under section 1905(a) Medicaid authority. 11 5. Medical necessity for an adolescent individual [an individual under the age of twenty-one 12 (21)] is determined using the following criteria: 13 a. The adolescent individual must be assessed to be at risk for developing a SUD; and 14 b. The adolescent individual must meet the ASAM adolescent treatment criteria. 15 C. PERSONS TO BE SERVED - In order to receive services through the DMC-ODS, the Client 16 must be enrolled in Medi-Cal or plan to enroll in Medi-Cal, reside in Orange County, and meet medical 17 necessity criteria, as outlined below. 18 D. MEDI-CAL ELIGIBILITY- MEDICAL NECESSITY 19 1. CONTRACTOR must verify the Medi-Cal eligibility determination of potential Clients. 20 2. ADMINISTRATOR will reimburse up to 30 days of treatment for unfunded clients with 21 realignment funding while CONTRACTOR assists client in applying for benefits or transferring Medi-22 Cal benefits to Orange County. Exceptions to the 30-day maximum must be approved by 23 ADMINISTRATOR. The Heath plan in IRIS will be assigned as "Self Pay". When applying for Medi-24 Cal, client shall request that Medi-Cal coverage is retroactively applied to date of admission. If current 25 Medi-Cal is assigned to a different county (not Orange County) client must initiate transfer within ten (10) 26 27 days of admission. If county of responsibility is other than Orange County and county of residence in Medical Eligibility Data System is Orange County and Medi-Cal transfer has been initiated, 28 CONTRACTOR shall enter Health plan as "Medi-Cal" in IRIS. These claims will be accepted by the 29 State. If both county of responsibility and county of residence are other than Orange County, Contractor 30 shall assign the Health plan as "Self-Pay". CONTRACTOR shall review Self Pay Health Plan claims 31 from the previous month and recheck eligibility status. If claims dates are covered by Medi-Cal contractor 32 shall update the Health Plan and these claims will be automatically credited and re-dropped by the IRIS 33 system. 34 3. Medical necessity for an adult [an individual age twenty-one (21) and over] is determined 35

19	1. CONTRACTOR shall accept any person with Orange County Medi-Cal; and who is

21	include persons with a concurrent diagnosis of mental illness, i.e., those identified as having a co-
22	occurring diagnosis. Persons with co-occurring disorders and others who require prescribed medication
23	shall not be precluded from acceptance or admission solely based on their licit use of prescribed
24	medications.
25	2. Beneficiaries may contact CONTRACTOR directly to request services. Beneficiaries may
26	also be referred to CONTRACTOR by the 24/7 Beneficiary Access Line, network providers, and other
27	access points determined by ADMINISTRATOR. CONTRACTOR shall enter data regarding request for
28	service into an access log established by ADMINISTRATOR.
29	3. CONTRACTOR shall have policies and procedures in place to screen for emergency medical
30	conditions and immediately refer beneficiaries to emergency medical care.
31	4. CONTRACTOR shall have a policy that requires a Client who shows signs of any
32	communicable disease or through medical disclosure during the intake process admits to a health related
33	problem that would put others at risk, to be cleared medically before services are provided.
34	5. Admission Policy CONTRACTOR shall establish and make available to the public a
35	written Admission Policy. ADMINISTRATOR may revise Admission Policy due to funding. Admission
36	Policy shall include, but not be limited to the following treatment priorities:
37	a. First priority for admission shall be given to pregnant injection drug users.

10	6. If it is determined at the time of brief screening or after assessing the beneficiary that the
11	medical necessity criteria, pursuant to DMC ODS STCs 128 (e), has not been met, then a written Notice
12	of Adverse Benefit Determination shall be issued in accordance with 42 CFR 438.404 and 42 CFR Part
13	431, subpart E.
14	7. Upon admission or within three (3) calendar days of admission, upon verifying ASAM level
15	of care, CONTRACTOR will FAX and email via secure email to RPC:
16	a. A copy of a legible individualized treatment authorization request with DSM diagnosis
17	indicated,
18	
19	
20	8. The RPC will make a determination for admission authorization within twenty-four (24)
21	hours of the request. In those instances, authorization will be provided the following business day.
22	9. CONTRACTOR shall have a County-approved process in place to ensure standards for
23	timely access to care and services are met, considering the urgency of the service needed. Medical
24	attention for emergency and crisis medical conditions must be addressed immediately.
25	10. If the RPC denies admission to residential services, the Client will be referred by the RPC,
26	to an appropriate level of care to support the Client's engagement in treatment.
27	F. RESIDENTIAL TREATMENT AUTHORIZATION
28	1. Beneficiaries will be authorized and referred to CONTRACTOR by the ART Team.
29	Beneficiaries who contact CONTRACTOR directly to request services shall be referred by
30	CONTRACTOR to the ART Team. If Beneficiary is pregnant or an intravenous drug user who meets
31	medical necessity for Residential Treatment, CONTRACTOR may admit to treatment bypassing the ART
32	Team if provider has available bed slot. In this instance, CONTRACTOR will complete a SUD
33	assessment and establish medical necessity for residential level of care. Assessment and authorization
34	request must be submitted to the ART team for authorization within seventy-two (72) hours of beneficiary
35	admission. CONTRACTOR shall enter data regarding request for service into IRIS access log established
36	by ADMINISTRATOR for these beneficiaries who access provider directly and bypass the ART team. If
37	it is determined after assessing the beneficiary that the medical necessity criteria, pursuant to DMC-ODS

STCs 128 (e), has not been met, then a written Notice of Adverse Benefit Determination shall be issued in accordance with 42 CFR 438.404 and 42 CFR Part 431, subpart E.

G. INFORMING MATERIALS – CONTRACTOR is responsible to distribute informing materials and provider lists that meet the content requirements of 42 CRF 438.100 to beneficiaries when they first access SUD services through the DMC-ODS and on request. Informing materials will be provided by ADMINISTRATOR.

H. INTERIM SERVICES – All persons who are not admitted into RTS shall be referred to Interim Services by CONTRACTOR. Interim Services shall be provided until an individual is admitted to residential treatment program. The purposes of the services are to reduce the adverse health effects of such abuse, promote the health of the individual, and reduce the risk of transmission of disease. At a minimum, Interim Services include counseling and education about HIV and TB, about the risks of needle-sharing, the risks of transmission to sexual partners and infants, and about steps that can be taken to ensure that HIV and TB transmission does not occur, as well as referral for HIV or TB treatment services if necessary. CONTRACTOR shall provide Clients, especially opiate users, with drug overdose education/information. For pregnant women, Interim Services include counseling on the effects of alcohol and drug use on the fetus, as well as referrals for prenatal care. Provision of Interim Services shall be documented on the DATAR and reported monthly to the State.

SERVICES - CONTRACTOR shall provide a non-institutional, twenty-four (24) hour non-18 19 medical, short-term residential program that provides rehabilitation services to beneficiaries in accordance with an individualized treatment plan. These services are intended to be individualized to treat the 20 functional deficits identified in the ASAM Criteria. In the residential treatment environment, an 21 individual's functional cognitive deficits may require treatment that is primarily slower paced, more 22 23 concrete and repetitive in nature. The daily regimen and structured patterns of activities are intended to restore cognitive functioning and build behavioral patterns within a community. Each Client shall live on 24 the premises and shall be supported in their efforts to restore, maintain and apply interpersonal and 25 independent living skills and access community support systems. CONTRACTORs and residents work 26 27 collaboratively to define barriers, set priorities, establish goals, create treatment plans, and solve problems. Goals include sustaining abstinence, preparing for relapse triggers, improving personal health and social 28 functioning, and engaging in continuing care. Residential Treatment program shall consist of the 29 following: 30

1. Intake: The process of determining that a Client meets the medical necessity criteria and a Client is admitted into a substance use disorder treatment program. Intake includes the evaluation or analysis of substance use disorders; the diagnosis of substance use disorders; and the assessment of treatment needs to provide medically necessary services. Intake may include a physical examination and laboratory testing necessary for substance use disorder treatment.

2. Individual Counseling: Contacts between a Client and a therapist or counselor.

3. Group Counseling: Face-to-face contacts in which one or more therapists or counselors treat

1	two or more Clients at the same time with a maximum of twelve (12) in the group, focusing on the needs
2	of the individuals served.
3	4. Family Therapy: Family members can provide social support to the Client, help motivate
4	their loved one to remain in treatment, and receive help and support for their own family recovery as well.
5	4. Family Therapy: When clinically appropriate, family members can provide social support to
6	the Client, help motivate their loved one to remain in treatment, and receive help and support for their
7	own family recovery as well.
8	5. Client Education: Provide research based education on addiction, treatment, recovery and
9	associated health risks.
10	6. Medication Storage: Facilities will store all Client medication and facility staff members will
11	oversee resident's self-administration of medication.
12	7. Collateral Services: Sessions with therapists or counselors and significant persons in the life
13	of the Client, focused on the treatment needs of the Client in terms of supporting the achievement of the
14	Client's treatment goals. Significant persons are individuals that have a personal, not official or
15	professional, relationship with the Client.
16	8. Crisis Intervention Services: Contact between a therapist or counselor and a Client in crisis.
17	Services shall focus on alleviating crisis problems. "Crisis" means an actual relapse or an unforeseen event
18	or circumstance which presents to the Client an imminent threat of relapse. Crisis intervention services
19	shall be limited to the stabilization of the Client's emergency situation.
20	9. Treatment Planning: The CONTRACTOR shall prepare an individualized written treatment
21	plan, based upon information obtained in the intake and assessment process. The treatment plan will be
22	completed within ten (10) days of admission and then updated every subsequent ninety (90) days unless
23	there is a change in treatment modality or significant event that would then require a new treatment plan.
24	The treatment plan shall include:
25	a. A statement of problems to be addressed;
26	b. Goals to be reached which address each problem;
27	c. Action steps which will be taken by the CONTRACTOR and/or Client to accomplish
28	identified goals;
29	d. Target dates for accomplishment of action steps and goals, and a description of services
30	including the type of counseling to be provided and the frequency thereof;
31	e. Treatment plans have specific quantifiable goal/treatment objectives related to the
32	Client's substance use disorder diagnosis and multidimensional assessment;
33	f. The treatment plan will identify the proposed type(s) of interventions/modality that
34	includes a proposed frequency and duration; and
35	g. The treatment plan will be consistent with the qualifying diagnosis and will be signed by
36	the Client and the LPHA.
37	10. Structured Therapeutic Activities: Residential Treatment Services shall consist of a

1 || minimum of twenty (20) hours of structured activity per week.

11. EBPs: CONTRACTORs will implement at least two of the following EBPs. The two EBPs are per CONTRACTOR per service modality. The required EBP include:

a. Motivational Interviewing: A Client-centered, empathetic, but directive counseling strategy designed to explore and reduce a person's ambivalence toward treatment. This approach frequently includes other problem-solving or solution-focused strategies that build on Clients' past successes.

b. Cognitive-Behavioral Therapy: Based on the theory that most emotional and behavioral reactions are learned and that new ways of reacting and behaving can be learned.

c. Relapse Prevention: A behavioral self-control program that teaches individuals with substance addiction how to anticipate and cope with the potential for relapse. Relapse prevention can be used as a stand-alone substance use treatment program or as an aftercare program to sustain gains achieved during initial substance use treatment.

d. Trauma-Informed Treatment: Services must take into account an understanding of trauma, and place priority on trauma survivors' safety, choice and control.

e. Psycho-Education: Psycho-educational groups are designed to educate Clients about substance abuse, and related behaviors and consequences. Psycho-educational groups provide information designed to have a direct application to Clients' lives; to instill self-awareness, suggest options for growth and change, identify community resources that can assist Clients in recovery, develop an understanding of the process of recovery, and prompt people using substances to take action on their own behalf.

12. Case Management or Care Coordination: Case Management or Care Coordination services 21 may be provided by a LPHA or registered/ certified counselor and will be provided based on the frequency 22 23 documented in the individualized treatment plan. Case management or Care Coordination shall provide advocacy and care coordination to physical health, mental health, transportation, housing, vocational, 24 educational, and transition services for reintegration into the community. CONTRACTOR shall provide 25 Case Management or Care Coordination services for the Client during treatment, transition to other levels 26 27 of care and follow ups, to encourage the Client to engage and participate in an appropriate level of care or Recovery Services after discharge. Case Management or Care Coordination becomes the responsibility 28 of the next treating provider after successful transition to a different level of care. Contractor shall ensure 29 that Case Management or Care Coordination services focus on coordination of SUD care, integration 30 around primary care especially for beneficiaries with a chronic SUD, and interaction with the criminal 31 justice system, if needed. Case Management services may be provided face-to-face, by telephone, or by 32 telehealth with the Client and may be provided anywhere in the community.

13. MAT: CONTRACTORs will have procedures for linkage/integration for beneficiaries requiring MAT. CONTRACTOR staff will regularly communicate with physicians of Clients who are prescribed these medications in compliance with 42 CFR part 2.

13. Medication Assisted Treatment - MAT services may be provided onsite with approval for

Incidental Medical Services from DHCS. Medically necessary MAT services must be provided in
 accordance with an individualized treatment plan determined by a licensed physician or LPHA working
 within their scope of practice.
 a. MAT services must be provided in compliance with Policy and Procedures submitted to
 DHCS for IMS designation. CONTRACTOR must ensure ability to continue MAT after discharge
 through linkage to appropriate prescriber. MAT shall include the assessment, treatment planning,
 ordering, prescribing, administering, and monitoring of all medications for SUDs.

8 b. Contractor shall provide administration of buprenorphine, naltrexone (oral and injectable),
 9 acamprosate, disulfiram, and vivitrol. Other approved medications in the treatment of SUDs may also be
 10 prescribed and administered, as medically necessary.

c. CONTRACTOR must provide care coordination with treatment and ancillary service providers and facilitate transitions between levels of care. Beneficiaries may simultaneously participate in MAT services and other ASAM LOCs.

d. CONTRACTOR must participate in the ADMINISTRATOR'S Medication Monitoring practices process as a quality assurance measure. Medication Monitoring is to assure the appropriateness of medication prescriptions for Mental Health and Recovery (MHRS) clients and to establish practices for monitoring the safety and effectiveness of medication practices in MHRS.

14. Care Coordination for Mental and Physical Health: Programs must screen for mental health issues and provide or refer for needed services. CONTRACTOR shall notify Client's medical home provider of Client's admission to treatment within seven (7) days of admission and request medical records/ physical exam. If Client does not have a medical home, identifying one shall be on the treatment plan.

15. Physician Consultation: Physician Consultation Services include DMC physicians' consulting with addiction medicine physicians, addiction psychiatrists or clinical pharmacists. Physician consultation services are designed to assist DMC physicians by allowing them to seek expert advice with regards to designing treatment plans for specific DMC-ODS beneficiaries. Physician consultation services may address medication selection, dosing, side effect management, adherence, drug interactions, or level of care considerations. ADMINISTRATOR will provide one or more physicians or pharmacists to provide consultation services.

16. Discharge Services: The process to prepare the Client for referral into another level of care, 30 post treatment return or reentry into the community, and/or the linkage of the individual to essential 31 community treatment, housing and human services. CONTRACTOR shall provide or arrange for 32 transportation of Clients to aftercare destination. CONTRACTOR shall begin discharge planning 33 immediately after enrollment. CONTRACTOR shall develop a formal discharge plan with the Client no 34 later than fourteen (14) calendar days prior to Client's successful completion of the program. The exit 35 plan shall be completed and signed by CONTRACTOR staff and Client. The exit plan shall be 36 documented in the Client's chart. 37

1	16. Discharge Services: The process to prepare the Client for referral into another level of care,
2	post treatment return or reentry into the community, and/or the linkage of the individual to essential
3	community treatment, housing and human services. CONTRACTOR shall provide or arrange for
4	transportation of Clients to aftercare destination. CONTRACTOR shall begin discharge planning
5	immediately after enrollment.
6	a. Discharge Plan – CONTRACTOR shall develop a formal discharge plan within fourteen
7	(14) calendar days prior to Client's planned discharge from the program. A discharge plan is to be
8	completed for each Client, except a Client with whom the provider loses contact. The discharge plan shall
9	be completed and signed by the LPHA or counselor and the Client. A copy of the discharge plan shall be
10	provided to the Client and retained in the Client's record. The discharge plan shall include, but not be
11	limited to, all of the following:
12	1) A description of each of the Client's relapse triggers;
13	2) A plan to assist the Client to avoid relapse when confronted with each trigger;
14	<u> </u>
15	4) Goals identified in the treatment plan; and
16	5) Referrals and linkages to appropriate resources.
17	b. Discharge Summary – The discharge summary is to be completed by the LPHA or
18	counselor within thirty (30) calendar days of the date of the last face-to-face treatment contact with the
19	Client. The discharge summary shall include all of the following:
20	1) The duration of the Client's treatment as determined by the dates of admission and
21	discharge from treatment;
22	2) The reason for discharge, including whether the discharge was voluntary or
23	involuntary and whether the Client successfully completed the program;
24	3) A narrative summary of the treatment episode;
25	4) The Client's prognosis;
26	5) Current alcohol and/or drug usage;
27	6) Vocational and educational achievements;
28	<u> </u>
29	8) Linkages and referrals made;
30	9) Client's comments; and
31	10) A description of the Client's goals and achievement towards those goals as described
32	in the Client's treatment plan.
33	17. Recovery Services: Clients may access recovery services after completing their course of
34	treatment to prevent relapse. Recovery services may be provided face-to-face, by telephone, or by
35	telehealth with the Client and may be provided anywhere in the community. Recovery services shall be
36	made available to DMC-ODS beneficiaries when a Medical Director or LPHA has determined that
37	recovery services are medically necessary in accordance with their individualized treatment plan. The

1	components of Recovery Services are:
2	a. Outpatient counseling services in the form of individual or group counseling to stabilize
3	the Client and then reassess if the Client needs further care;
4	b. Recovery Monitoring: Recovery coaching, monitoring via telephone and internet;
5	c. Substance Abuse Assistance: Peer-to-peer services and relapse prevention;
6	d. Education and Job Skills: Linkages to life skills, employment services, job training, and
7	education services;
8	e. Family Support: Linkages to childcare, parent education, child development support
9	services, family/marriage education;
10	f. Support Groups: Linkages to self-help and support, spiritual and faith-based support;
11	g. Ancillary Services: Linkages to housing assistance, transportation, case management,
12	individual services coordination.
13	18. Food and Other Services: CONTRACTOR shall provide a clean, safe environment, toiletries,
14	clean linen, and food service.
15	19. Support Services: CONTRACTOR shall provide housekeeping, which may be done by
16	Clients; laundry access; and maintenance.
17	20. Health, Medical, Psychiatric and Emergency Services – CONTRACTOR shall ensure that all
18	persons admitted for Residential Treatment services have a health questionnaire completed using form
19	DHCS 5103 form, or may develop their own form provided it contains, at a minimum, the information
20	requested in the DHCS 5103 form.
21	a. The health questionnaire is a Client's self-assessment of his/her current health status and
22	shall be completed by Client.
23	1) CONTRACTOR shall review and approve the health questionnaire form prior to
24	Client's admission to the program. The completed health questionnaire shall be signed and dated by
25	CONTRACTOR and Client, prior to admission.
26	2) A copy of the questionnaire shall be filed in the Client's record.
27	b. CONTRACTOR shall, based on information provided by Client on the health
28	questionnaire form, refer Client to licensed medical professionals for physical and laboratory
29	examinations as appropriate.
30	1) CONTRACTOR shall obtain a copy of Client's medical clearance or release prior to
31	Client's admission to the program when applicable.
32	2) A copy of the referral and clearance shall be filed in the Client's file.
33	3) CONTRACTOR shall provide directly or by referral: HIV education, voluntary, HIV
34	antibody testing and risk assessment and disclosure counseling.
35	4) The programs shall have written procedures for obtaining medical or psychiatric
36	evaluation and emergency and non-emergency services.
37	5) The programs shall post the name, address, and telephone number for the fire

department, a crisis program, local law enforcement, and ambulance service. 1 6) CONTRACTOR shall provide TB services to the Clients by referral to the COUNTY 2 or another appropriate provider. TB services shall be provided within seven (7) calendar days of 3 admission. These TB services shall consist of the following: 4 a) Counseling with respect to TB; 5 b) Testing to determine whether the individual has been infected and to determine 6 the appropriate form of treatment; 7 c) Provision for, or referral of, infected Clients for medical evaluation, treatment 8 and clearance. CONTRACTOR shall ensure that a TB-infected Client is medically cleared prior to 9 commencing treatment. 10 21. Transportation Services 11 a. Non-Emergency Transportation - CONTRACTOR shall transport Client to locations 31 that are considered necessary and/or important to the Client's recovery plan including, but not limited to, 32 Social Security Administration offices for Supplemental Security Income benefits and for non-emergency 33 medical or mental health services not identified in Subparagraph 22.a. above, that require treatment at a 34 physician office, urgent care, or emergency room when an ambulance provider is not necessary or required 35 for transportation based on the level of severity and/or services required by the Client. 36 J. RESIDENTIAL LEVELS OF CARE - CONTRACTOR shall provide services in accordance 37

17	living skills;
18	f. Recovery support services, including support for the affected family; and
19	g. Addiction pharmacotherapy
20	K. PERFORMANCE OUTCOMES
21	1. CONTRACTOR shall achieve performance objectives, tracking and reporting Performance
22	Outcome Objective statistics in monthly programmatic reports, as appropriate. ADMINISTRATOR
23	recognizes that alterations may be necessary to the following services to meet the objectives, and,
24	therefore, revisions to objectives and services may be implemented by mutual agreement between
25	CONTRACTOR and ADMINISTRATOR.
26	2. Performance Outcome Objectives
27	a. <u>Objective 1:</u> CONTRACTOR shall provide effective residential substance abuse
28	assessment, treatment, and counseling to Clients with identified alcohol and/or drug problems as measured
29	by Retention and Completion Rates:
30	1) Retention Rates shall be calculated by using the number of Clients currently enrolled
31	in or successfully completing the treatment program divided by the total number of Clients served during
32	the evaluation period.
33	2) Completion Rates shall be calculated by using the number of Clients successfully
34	completing the treatment program divided by the total number of Clients discharged during the evaluation
35	period. Fifty percent (50%) of Clients will complete residential treatment program.
36	b. <u>Objective 2:</u> CEST scores at midpoint and completion will be higher than national norms

for treatment readiness and desire for help will exceed national norms and will be equal to or higher than 1 2 CESI scores at intake; c. Objective 3: Ninety percent (90%) of Clients who complete satisfaction survey will 3 agree or strongly agree that they are "overall satisfied with the services received" and ninety percent (90%) 4 or Clients surveyed will agree or strongly agree that they would recommend the program to someone they 5 know; and 6 d. Objective 4: Upon successful completion of treatment, seventy-five percent (75%) of 7 Clients will report at thirty (30) days that their life is more manageable than it was when they entered 8 9 treatment. c. Linkage rates 12 for Clients who discharge will include all CalOMS standard discharge dispositions. All CalOMS 13 administrative discharge dispositions will be excluded. 14 L. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the Adult 15 Residential Treatment Services paragraph of this Exhibit C to the Agreement. 16 17 **II. STAFFING** 18 19 A. CONTRACTOR shall provide twenty-four (24) hour supervision with at least one (1) staff member on-site at all times. Residential programs shall require twenty-four (24)-hour awake supervision. 20 B. CONTRACTOR shall make its best effort to provide services pursuant to the Agreement in a 21 manner that is culturally and linguistically appropriate for the population(s) served. CONTRACTOR shall follow COUNTY's process for credentialing and re-credentialing of 32 network providers and shall ensure that all registered, licensed or certified staff who deliver Medi-Cal 33 covered services are properly credentialed by COUNTY before delivering any Medi-Cal covered services. 34 C. Professional staff shall be licensed, registered, certified or recognized under California scope of 35 practice statutes. Professional staff shall provide services within their individual scope of practice and 36 receive supervision required under their scope of practice laws. 37

The Medical Director's responsibilities shall, at a minimum include all of the following: a. Ensure that medical care provided by physicians, registered nurse practitioners, and 20 physician assistants meets the applicable standard of care; 21 b. Ensure that physicians do not delegate their duties to non-physician personnel; 22 23 c. Develop and implement medical policies and standards for the provider; d. Ensure that physicians, registered nurse practitioners, and physician assistants follow the 24 provider's medical policies and standards; 25 e. Ensure that the medical decisions made by physicians are not influenced by fiscal 26 27 considerations; f. CONTRACTOR shall provide 18 supervision to volunteers as specified in the respective job descriptions or work contracts. Volunteer or 19 student intern services may not comprise more than twenty percent (20%) of the services provided, unless 20 approved in advance by ADMINISTRATOR. 21 J. VOLUNTEERS/INTERNS - CONTRACTOR may augment the above paid staff with volunteers 22 23 or part-time student interns. Unless waived by ADMINISTRATOR, prior to providing services pursuant to this Agreement, interns shall be Master's Candidates in Counseling or Social Work or have a Bachelor's 24 Degree in a related field or be participating in any state recognized counselor certification program. 25 Additionally, volunteers or student interns must be AOD registered or certified. CONTRACTOR shall 26 27 provide supervision of work by interns or consistent with school or licensing Board requirements. CONTRACTOR shall provide supervision to volunteers as specified in the respective job descriptions or 28 work contracts. Volunteer or student intern services may not comprise more than twenty percent (20%) 29 of the services provided, unless approved in advance by ADMINISTRATOR. 30 K. STAFF CONDUCT - CONTRACTOR shall establish written Policies and Procedures for 31 employees, volunteers, interns, and members of the Board of Directors which shall include, but not be 32 limited to, standards related to the use of drugs and/or alcohol; staff-Client relationships; prohibition of 33 sexual conduct with Clients; prohibition of forging or falsifying documents or drug tests; and real or 34 perceived conflict of interest. Situations that may be perceived as a conflict of interest shall be brought 35 to the ADMINISTRATOR's attention prior to the occurrence. Prior to providing any services pursuant 36 to this Agreement all employees, volunteers, and interns shall agree in writing to maintain the standards 37

set forth in the said Policies and Procedures. A copy of the said Policies and Procedures shall be posted
 in writing in a prominent place in the treatment facility and updated annually by the Board of Directors.

L. STAFF/VOLUNTEER/INTERN SCREENING – CONTRACTOR shall provide preemployment "live scan" screening of any staff person providing services pursuant to this Agreement. All new staff, volunteers, and interns shall pass a one-time "live scan" finger printing background check prior to employment. All staff shall be subject to sanction screening as referenced in the Compliance paragraph. All staff shall also be screened by Megan's Law, OC Courts and OC Sheriff's Department on an annual basis. The results of the fingerprint checks will be sent directly from the Department of Justice to CONTRACTOR. Results must remain in staff file.

a. No person shall have been convicted of a sex offense for which the person is required to register as a sex offender under PC section 290;

14	committed to ensuring positive relations through this Good Neighbor Policy in the neighborhoods and
15	communities in which its Residential Program contractors provide services to its residents.

17	Following effective date of this Agreement, but no later than thirty (30) days after the start of services,
18	CONTRACTOR shall conduct reasonable outreach to cities, neighborhoods and communities that could
19	be affected by services provided by CONTRACTOR.
20	
21	Good Neighbor Policy
22	This Policy applies only to the extent CONTRACTOR provides direct services to County clients pursuant
23	to this Agreement. The intent of this Policy is to identify community impacts and measures to mitigate
24	those impacts to be an integral part of the neighborhood and community the COUNTY serves.
25	
26	CONTRACTOR shall establish a policy that includes all of the following elements:
27	• Ensure staff and clients conduct themselves in a manner that demonstrates respect for the
28	community and consideration of neighbors when entering/exiting the facility or outdoors.
29	• Establish and maintain early communication with cities, neighborhoods and communities as a
30	way to identify potential impacts to neighborhoods and mitigate as needed.
31	• Establish cooperative relationships with cities, neighborhoods and communities where services
32	are being rendered and mitigate impact as needed.
33	• Collaborate with cities, neighborhoods and communities as a way to promote integration of
34	facilities into the community and determine the effectiveness of established good neighbor practices.
35	• Develop written procedures to track, respond and mitigate neighborhood complaints. Procedures
36	should include identification of a contact person for complaint resolution and identification of COUNTY
37	contact if complaint is not adequately resolved. The procedures must also identify how these incidents

1	will be reported to the appropriate COUNTY contact in a timely manner.
2	• Establish generalized good neighbor practices for services and facility(ies) that include:
3	- Adequate parking
4	- Adequate waiting and visiting areas
5	- Adequate restroom facilities
6	- Property maintenance and appearance
7	- Community safety
8	- Congregation guidelines
9	- Security provisions

The parties agree that the terms used, but not otherwise defined in the Common Terms and 13 Definitions Paragraph of Exhibit B to the Agreement or in Subparagraph B below, shall have the same 14 15 meaning given to such terms under HIPAA, the HITECH Act, and their implementing regulations at 45 CFR Parts 160 and 164 (the HIPAA regulations) as they may exist now or be hereafter amended. 16 2. The parties agree that a business associate relationship under HIPAA, the HITECH Act, and 17 the HIPAA regulations between the CONTRACTOR and COUNTY arises to the extent that 18 19 CONTRACTOR performs, or delegates to subcontractors to perform, functions or activities on behalf of COUNTY pursuant to, and as set forth in, the Agreement that are described in the definition of "Business 20 Associate" in 45 CFR § 160.103. 21 3. The COUNTY wishes to disclose to CONTRACTOR certain information pursuant to the 22 23 terms of the Agreement, some of which may constitute PHI, as defined below in Subparagraph B.10, to be used or disclosed in the course of providing services and activities pursuant to, and as set forth, in the 24 Agreement. 25 4. The parties intend to protect the privacy and provide for the security of PHI that may be 26 created, received, maintained, transmitted, used, or disclosed pursuant to the Agreement in compliance 27 with the applicable standards, implementation specifications, and requirements of HIPAA, the HITECH 28 Act, and the HIPAA regulations as they may exist now or be hereafter amended. 29 5. The parties understand and acknowledge that HIPAA, the HITECH Act, and the HIPAA 30 regulations do not pre-empt any state statutes, rules, or regulations that are not otherwise pre-empted by 31 other Federal law(s) and impose more stringent requirements with respect to privacy of PHI. 32 6. The parties understand that the HIPAA Privacy and Security rules, as defined below in 33 Subparagraphs B.9 and B.14, apply to the CONTRACTOR in the same manner as they apply to the 34 covered entity (COUNTY). CONTRACTOR agrees therefore to be in compliance at all times with the 35 terms of this Business Associate Contract, as it exists now or be hereafter updated with notice to 36 CONTRACTOR, and the applicable standards, implementation specifications, and requirements of the 37

Privacy and the Security rules, as they may exist now or be hereafter amended, with respect to PHI and 1 2 electronic PHI created, received, maintained, transmitted, used, or disclosed pursuant to the Agreement.

B. DEFINITIONS

1. "Administrative Safeguards" are administrative actions, and policies and procedures, to manage the selection, development, implementation, and maintenance of security measures to protect electronic PHI and to manage the conduct of CONTRACTOR's workforce in relation to the protection of that information.

2. "Breach" means the acquisition, access, use, or disclosure of PHI in a manner not permitted under the HIPAA Privacy Rule which compromises the security or privacy of the PHI.

a. Breach excludes:

1) Any unintentional acquisition, access, or use of PHI by a workforce member or person acting under the authority of CONTRACTOR or COUNTY, if such acquisition, access, or use was made in good faith and within the scope of authority and does not result in further use or disclosure in a manner not permitted under the Privacy Rule.

2) Any inadvertent disclosure by a person who is authorized to access PHI at CONTRACTOR to another person authorized to access PHI at the CONTRACTOR, or organized health care arrangement in which COUNTY participates, and the information received as a result of such disclosure is not further used or disclosed in a manner not permitted under the HIPAA Privacy Rule.

Except as provided in paragraph (a) of this definition, an acquisition, access, use, or 22 disclosure of PHI in a manner not permitted under the HIPAA Privacy Rule is presumed to be a breach unless CONTRACTOR demonstrates that there is a low probability that the PHI has been compromised 24 based on a risk assessment of at least the following Factors:

1) The nature and extent of the PHI involved, including the types of identifiers and the likelihood of re-identification;

- 2) The unauthorized person who used the PHI or to whom the disclosure was made;
- 3) Whether the PHI was actually acquired or viewed; and
- 4) The extent to which the risk to the PHI has been mitigated.

3. "Data Aggregation" shall have the meaning given to such term under the HIPAA Privacy Rule in 45 CFR § 164.501.

4. "DRS" shall have the meaning given to such term under the HIPAA Privacy Rule in 45 CFR § 164.501.

5. "Disclosure" shall have the meaning given to such term under the HIPAA regulations in 45 35 CFR § 160.103. 36 37 //

6. "Health Care Operations" shall have the meaning given to such term under the HIPAA

8. "Physical Safeguards" are physical measures, policies, and procedures to protect CONTRACTOR's electronic information systems and related buildings and equipment, from natural and environmental hazards, and unauthorized intrusion.

9. "The HIPAA Privacy Rule" shall mean the Standards for Privacy of Individually Identifiable Health Information at 45 CFR Part 160 and Part 164, Subparts A and E.

10. "PHI" shall have the meaning given to such term under the HIPAA regulations in 45 CFR § 160.103.

11. "Required by Law" shall have the meaning given to such term under the HIPAA Privacy Rule in 45 CFR § 164.103.

12. "Secretary" shall mean the Secretary of the Department of Health and Human Services or his or her designee.

13. "Security Incident" means attempted or successful unauthorized access, use, disclosure, modification, or destruction of information or interference with system operations in an information system. "Security incident" does not include trivial incidents that occur on a daily basis, such as scans, "pings", or unsuccessful attempts to penetrate computer networks or servers maintained by CONTRACTOR.

14. "The HIPAA Security Rule" shall mean the Security Standards for the Protection of ePHI at 45 CFR Part 160, Part 162, and Part 164, Subparts A and C.

15. "Subcontractor" shall have the meaning given to such term under the HIPAA regulations in 45 CFR § 160.103.

16. "Technical safeguards" means the technology and the policy and procedures for its use that protect ePHI and control access to it.

17. "Unsecured PHI" or "PHI that is unsecured" means PHI that is not rendered unusable, unreadable, or indecipherable to unauthorized individuals through the use of a technology or methodology specified by the Secretary of HHS in the guidance issued on the HHS Web site.

18. "Use" shall have the meaning given to such term under the HIPAA regulations in 45 CFR § 160.103.

C. OBLIGATIONS AND ACTIVITIES OF CONTRACTOR AS BUSINESS ASSOCIATE:

1. CONTRACTOR agrees not to use or further disclose PHI COUNTY discloses to CONTRACTOR other than as permitted or required by this Business Associate Contract or as required by law.

CONTRACTOR agrees to use appropriate safeguards, as provided for in this Business
 Associate Contract and the Agreement, to prevent use or disclosure of PHI COUNTY discloses to
 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY
 other than as provided for by this Business Associate Contract.

3. CONTRACTOR agrees to comply with the HIPAA Security Rule at Subpart C of 45 CFR Part 164 with respect to electronic PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY.

4. CONTRACTOR agrees to mitigate, to the extent practicable, any harmful effect that is known to CONTRACTOR of a Use or Disclosure of PHI by CONTRACTOR in violation of the requirements of this Business Associate Contract.

5. CONTRACTOR agrees to report to COUNTY immediately any Use or Disclosure of PHI not provided for by this Business Associate Contract of which CONTRACTOR becomes aware. CONTRACTOR must report Breaches of Unsecured PHI in accordance with Subparagraph E below and as required by 45 CFR § 164.410.

6. CONTRACTOR agrees to ensure that any Subcontractors that create, receive, maintain, or transmit PHI on behalf of CONTRACTOR agree to the same restrictions and conditions that apply through this Business Associate Contract to CONTRACTOR with respect to such information.

7. CONTRACTOR agrees to provide access, within fifteen (15) calendar days of receipt of a written request by COUNTY, to PHI in a DRS, to COUNTY or, as directed by COUNTY, to an Individual in order to meet the requirements under 45 CFR § 164.524. If CONTRACTOR maintains an EHR with PHI, and an individual requests a copy of such information in an electronic format, CONTRACTOR shall provide such information in an electronic format.

8. CONTRACTOR agrees to make any amendment(s) to PHI in a DRS that COUNTY directs or agrees to pursuant to 45 CFR § 164.526 at the request of COUNTY or an Individual, within thirty (30) calendar days of receipt of said request by COUNTY. CONTRACTOR agrees to notify COUNTY in writing no later than ten (10) calendar days after said amendment is completed.

9. CONTRACTOR agrees to make internal practices, books, and records, including P&Ps, relating to the use and disclosure of PHI received from, or created or received by CONTRACTOR on behalf of, COUNTY available to COUNTY and the Secretary in a time and manner as determined by COUNTY or as designated by the Secretary for purposes of the Secretary determining COUNTY's compliance with the HIPAA Privacy Rule.

10. CONTRACTOR agrees to document any Disclosures of PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY, and to make information related to such Disclosures available as would be required for COUNTY to respond to a request by an Individual for an accounting of Disclosures of PHI in accordance with 45 CFR § 164.528.

 11. CONTRACTOR agrees to provide COUNTY or an Individual, as directed by COUNTY, in a time and manner to be determined by COUNTY, that information collected in accordance with the Agreement, in order to permit COUNTY to respond to a request by an Individual for an accounting of Disclosures of PHI in accordance with 45 CFR § 164.528.

12. CONTRACTOR agrees that to the extent CONTRACTOR carries out COUNTY's obligation under the HIPAA Privacy and/or Security rules CONTRACTOR will comply with the requirements of 45 CFR Part 164 that apply to COUNTY in the performance of such obligation.

13. If CONTRACTOR receives Social Security data from COUNTY provided to COUNTY by a state agency, upon request by COUNTY, CONTRACTOR shall provide COUNTY with a list of all employees, subcontractors, and agents who have access to the Social Security data, including employees, agents, subcontractors, and agents of its subcontractors.

14. CONTRACTOR will notify COUNTY if CONTRACTOR is named as a defendant in a criminal proceeding for a violation of HIPAA. COUNTY may terminate the Agreement, if CONTRACTOR is found guilty of a criminal violation in connection with HIPAA. COUNTY may terminate the Agreement, if a finding or stipulation that CONTRACTOR has violated any standard or requirement of the privacy or security provisions of HIPAA, or other security or privacy laws are made in any administrative or civil proceeding in which CONTRACTOR is a party or has been joined. COUNTY will consider the nature and seriousness of the violation in deciding whether or not to terminate the Agreement.

15. CONTRACTOR shall make itself and any subcontractors, employees or agents assisting CONTRACTOR in the performance of its obligations under the Agreement, available to COUNTY at no cost to COUNTY to testify as witnesses, or otherwise, in the event of litigation or administrative proceedings being commenced against COUNTY, its directors, officers or employees based upon claimed violation of HIPAA, the HIPAA regulations or other laws relating to security and privacy, which involves inactions or actions by CONTRACTOR, except where CONTRACTOR or its subcontractor, employee, or agent is a named adverse party.

16. The Parties acknowledge that federal and state laws relating to electronic data security and privacy are rapidly evolving and that amendment of this Business Associate Contract may be required to provide for procedures to ensure compliance with such developments. The Parties specifically agree to take such action as is necessary to implement the standards and requirements of HIPAA, the HITECH Act, the HIPAA regulations and other applicable laws relating to the security or privacy of PHI. Upon COUNTY's request, CONTRACTOR agrees to promptly enter into negotiations with COUNTY concerning an amendment to this Business Associate Contract embodying written assurances consistent with the standards and requirements of HIPAA, the HITECH Act, the HIPAA regulations or other applicable laws. COUNTY may terminate the Agreement upon thirty (30) days written notice in the event:

a. CONTRACTOR does not promptly enter into negotiations to amend this Business Associate Contract when requested by COUNTY pursuant to this Subparagraph F; or

b. CONTRACTOR does not enter into an amendment providing assurances regarding the safeguarding of PHI that COUNTY deems are necessary to satisfy the standards and requirements of HIPAA, the HITECH Act, and the HIPAA regulations.

17. CONTRACTOR shall work with COUNTY upon notification by CONTRACTOR to COUNTY of a Breach to properly determine if any Breach exclusions exist as defined in Subparagraph B.2.a above.

D. SECURITY RULE

1. CONTRACTOR shall comply with the requirements of 45 CFR § 164.306 and establish and maintain appropriate Administrative, Physical and Technical Safeguards in accordance with 45 CFR § 164.308, § 164.310, and § 164.312, with respect to electronic PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY. CONTRACTOR shall develop and maintain a written information privacy and security program that includes Administrative, Physical, and Technical Safeguards appropriate to the size and complexity of CONTRACTOR's operations and the nature and scope of its activities.

2. CONTRACTOR shall implement reasonable and appropriate policies and procedures to comply with the standards, implementation specifications and other requirements of 45 CFR Part 164, Subpart C, in compliance with 45 CFR § 164.316. CONTRACTOR will provide COUNTY with its current and updated policies upon request.

3. CONTRACTOR shall ensure the continuous security of all computerized data systems containing electronic PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY. CONTRACTOR shall protect paper documents containing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY. These steps shall include, at a minimum:

a. Complying with all of the data system security precautions listed under Subparagraphs
E, below;

b. Achieving and maintaining compliance with the HIPAA Security Rule, as necessary in conducting operations on behalf of COUNTY;

5. CONTRACTOR shall report to COUNTY immediately any Security Incident of which it
 becomes aware. CONTRACTOR shall report Breaches of Unsecured PHI in accordance with
 Subparagraph E below and as required by 45 CFR § 164.410.

6. CONTRACTOR shall designate a Security Officer to oversee its data security program who shall be responsible for carrying out the requirements of this paragraph and for communicating on security matters with COUNTY.

E. DATA SECURITY REQUIREMENTS

1. Personal Controls

a. Employee Training. All workforce members who assist in the performance of functions or activities on behalf of COUNTY in connection with Agreement, or access or disclose PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY, must complete information privacy and security training, at least annually, at CONTRACTOR's expense. Each workforce member who receives information privacy and security training must sign a certification, indicating the member's name and the date on which the training was completed. These certifications must be retained for a period of six (6) years following the termination of Agreement.

b. Employee Discipline. Appropriate sanctions must be applied against workforce members who fail to comply with any provisions of CONTRACTOR's privacy P&Ps, including termination of employment where appropriate.

c. Confidentiality Statement. All persons that will be working with PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must sign a confidentiality statement that includes, at a minimum, General Use, Security and Privacy Safeguards, Unacceptable Use, and Enforcement Policies. The statement must be signed by the workforce member prior to access to such PHI. The statement must be renewed annually. The CONTRACTOR shall retain each person's written confidentiality statement for COUNTY inspection for a period of six (6) years following the termination of the Agreement.

d. Background Check. Before a member of the workforce may access PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY, a background screening of that worker must be conducted. The screening should be commensurate with the risk and magnitude of harm the employee could cause, with more thorough screening being done for those employees who are authorized to bypass significant technical and operational security controls. The CONTRACTOR shall retain each workforce member's background check documentation for a period of three (3) years.

2. Technical Security Controls

a. Workstation/Laptop encryption. All workstations and laptops that store PHI COUNTY
 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of

is 128bit or higher, such as AES. The encryption solution must be full disk unless approved by the 1 COUNTY. 2

b. Server Security. Servers containing unencrypted PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must have sufficient administrative, physical, and technical controls in place to protect that data, based upon a risk assessment/system security review.

c. Minimum Necessary. Only the minimum necessary amount of PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY required to perform necessary business functions may be copied, downloaded, or exported.

d. Removable media devices. All electronic files that contain PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must be encrypted when stored on any removable media or portable device (i.e. USB thumb drives, floppies, CD/DVD, Blackberry, backup tapes etc.). Encryption must be a FIPS 140–2 certified algorithm which is 128bit or higher, such as AES. Such PHI shall not be considered "removed from the premises" if it is only being transported from one of CONTRACTOR's locations to another of CONTRACTOR's locations.

e. Antivirus software. All workstations, laptops and other systems that process and/or store PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must have installed and actively use comprehensive anti-virus software solution with automatic updates scheduled at least daily.

f. Patch Management. All workstations, laptops and other systems that process and/or store PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must have critical security patches applied, with system reboot if necessary. There must be a documented patch management process which determines installation timeframe based on risk assessment and vendor recommendations. At a maximum, all applicable patches must be installed within thirty (30) days of vendor release. Applications and systems that cannot be patched due to operational reasons must have compensatory controls implemented to minimize risk, where possible.

g. User IDs and Password Controls. All users must be issued a unique user name for accessing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY. Username must be promptly disabled, deleted, or the password changed upon the transfer or termination of an employee with knowledge of the password, at maximum within twenty-four (24) hours. Passwords are not to be shared. Passwords must be at least eight characters and must be a non-dictionary word. Passwords must not be stored in readable format on the computer. Passwords must be changed every ninety (90) days, preferably every sixty (60) days. Passwords must be 34 changed if revealed or compromised. Passwords must be composed of characters from at least three (3) of the following four (4) groups from the standard keyboard:

h. Data Destruction. When no longer needed, all PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must be wiped using the Gutmann or US DoD 5220.22–M (7 Pass) standard, or by degaussing. Media may also be physically destroyed in accordance with NIST Special Publication 800–88. Other methods require prior written permission by COUNTY.

i. System Timeout. The system providing access to PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must provide an automatic timeout, requiring re–authentication of the user session after no more than twenty (20) minutes of inactivity.

j. Warning Banners. All systems providing access to PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must display a warning banner stating that data is confidential, systems are logged, and system use is for business purposes only by authorized users. User must be directed to log off the system if they do not agree with these requirements.

k. System Logging. The system must maintain an automated audit trail which can identify the user or system process which initiates a request for PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY, or which alters such PHI. The audit trail must be date and time stamped, must log both successful and failed accesses, must be read only, and must be restricted to authorized users. If such PHI is stored in a database, database logging functionality must be enabled. Audit trail data must be archived for at least three (3) years after occurrence.

1. Access Controls. The system providing access to PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must use role based access controls for all user authentications, enforcing the principle of least privilege.

m. Transmission encryption. All data transmissions of PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY outside the secure internal network must be encrypted using a FIPS 140–2 certified algorithm which is 128bit or higher, such as AES. Encryption can be end to end at the network level, or the data files containing PHI can be encrypted. This requirement pertains to any type of PHI in motion such as website access, file transfer, and E–Mail.

n. Intrusion Detection. All systems involved in accessing, holding, transporting, and
protecting PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains,
or transmits on behalf of COUNTY that are accessible via the Internet must be protected by a
comprehensive intrusion detection and prevention solution.

3. Audit Controls

a. System Security Review. CONTRACTOR must ensure audit control mechanisms that record and examine system activity are in place. All systems processing and/or storing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must have at least an annual system risk assessment/security review which provides assurance that administrative, physical, and technical controls are functioning effectively and providing adequate levels of protection. Reviews should include vulnerability scanning tools.

b. Log Reviews. All systems processing and/or storing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must have a routine procedure in place to review system logs for unauthorized access.

c. Change Control. All systems processing and/or storing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must have a documented change control procedure that ensures separation of duties and protects the confidentiality, integrity and availability of data.

4. Business Continuity/Disaster Recovery Control

a. Emergency Mode Operation Plan. CONTRACTOR must establish a documented plan to enable continuation of critical business processes and protection of the security of PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY kept in an electronic format in the event of an emergency. Emergency means any circumstance or situation that causes normal computer operations to become unavailable for use in performing the work required under this Agreement for more than twenty-four (24) hours.

b. Data Backup Plan. CONTRACTOR must have established documented procedures to backup such PHI to maintain retrievable exact copies of the PHI. The plan must include a regular schedule for making backups, storing backup offsite, an inventory of backup media, and an estimate of the amount of time needed to restore DHCS PHI or PI should it be lost. At a minimum, the schedule must be a weekly full backup and monthly offsite storage of DHCS data. BCP for contractor and COUNTY (e.g. the application owner) must merge with the DRP.

5. Paper Document Controls

a. Supervision of Data. PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY in paper form shall not be left unattended at any time, unless it is locked in a file cabinet, file room, desk or office. Unattended means that information is not being observed by an employee authorized to access the information. Such PHI in paper form shall not be left unattended at any time in vehicles or planes and shall not be checked in baggage on commercial airplanes.

b. Escorting Visitors. Visitors to areas where PHI COUNTY discloses to CONTRACTOR
or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY is contained shall be
escorted and such PHI shall be kept out of sight while visitors are in the area.

c. Confidential Destruction. PHI COUNTY discloses to CONTRACTOR or
 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must be disposed of
 through confidential means, such as cross cut shredding and pulverizing.

d. Removal of Data. PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must not be removed from the premises of the CONTRACTOR except with express written permission of COUNTY.

e. Faxing. Faxes containing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall not be left unattended and fax machines shall be in secure areas. Faxes shall contain a confidentiality statement notifying persons receiving faxes in error to destroy them. Fax numbers shall be verified with the intended recipient before sending the fax.

f. Mailing. Mailings containing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall be sealed and secured from damage or inappropriate viewing of PHI to the extent possible. Mailings which include five hundred (500) or more individually identifiable records containing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY in a single package shall be sent using a tracked mailing method which includes verification of delivery and receipt, unless the prior written permission of COUNTY to use another method is obtained.

F. BREACH DISCOVERY AND NOTIFICATION

1. Following the discovery of a Breach of Unsecured PHI, CONTRACTOR shall notify COUNTY of such Breach, however both parties agree to a delay in the notification if so advised by a law enforcement official pursuant to 45 CFR § 164.412.

a. A Breach shall be treated as discovered by CONTRACTOR as of the first day on which such Breach is known to CONTRACTOR or, by exercising reasonable diligence, would have been known to CONTRACTOR.

b. CONTRACTOR shall be deemed to have knowledge of a Breach, if the Breach is known, or by exercising reasonable diligence would have known, to any person who is an employee, officer, or other agent of CONTRACTOR, as determined by federal common law of agency.

2. CONTRACTOR shall provide the notification of the Breach immediately to the COUNTY Privacy Officer. CONTRACTOR's notification may be oral, but shall be followed by written notification within twenty-four (24) hours of the oral notification.

3. CONTRACTOR's notification shall include, to the extent possible:

a. The identification of each Individual whose Unsecured PHI has been, or is reasonably believed by CONTRACTOR to have been, accessed, acquired, used, or disclosed during the Breach;

b. Any other information that COUNTY is required to include in the notification to
Individual under 45 CFR §164.404 (c) at the time CONTRACTOR is required to notify COUNTY or
promptly thereafter as this information becomes available, even after the regulatory sixty (60) day period

|| set forth in 45 CFR § 164.410 (b) has elapsed, including:

2 1) A brief description of what happened, including the date of the Breach and the date
3 of the discovery of the Breach, if known;

2) A description of the types of Unsecured PHI that were involved in the Breach (such as whether full name, social security number, date of birth, home address, account number, diagnosis, disability code, or other types of information were involved);

3) Any steps Individuals should take to protect themselves from potential harm resulting from the Breach;

4) A brief description of what CONTRACTOR is doing to investigate the Breach, to mitigate harm to Individuals, and to protect against any future Breaches; and

5) Contact procedures for Individuals to ask questions or learn additional information, which shall include a toll–free telephone number, an e–mail address, Web site, or postal address.

4. COUNTY may require CONTRACTOR to provide notice to the Individual as required in 45 CFR § 164.404, if it is reasonable to do so under the circumstances, at the sole discretion of the COUNTY.

5. In the event that CONTRACTOR is responsible for a Breach of Unsecured PHI in violation of the HIPAA Privacy Rule, CONTRACTOR shall have the burden of demonstrating that CONTRACTOR made all notifications to COUNTY consistent with this Subparagraph F and as required by the Breach notification regulations, or, in the alternative, that the acquisition, access, use, or disclosure of PHI did not constitute a Breach.

6. CONTRACTOR shall maintain documentation of all required notifications of a Breach or its risk assessment under 45 CFR § 164.402 to demonstrate that a Breach did not occur.

7. CONTRACTOR shall provide to COUNTY all specific and pertinent information about the Breach, including the information listed in Section E.3.b.(1)–(5) above, if not yet provided, to permit COUNTY to meet its notification obligations under Subpart D of 45 CFR Part 164 as soon as practicable, but in no event later than fifteen (15) calendar days after CONTRACTOR's initial report of the Breach to COUNTY pursuant to Subparagraph F.2 above.

8. CONTRACTOR shall continue to provide all additional pertinent information about the Breach to COUNTY as it may become available, in reporting increments of five (5) business days after the last report to COUNTY. CONTRACTOR shall also respond in good faith to any reasonable requests for further information, or follow–up information after report to COUNTY, when such request is made by COUNTY.

9. If the Breach is the fault of CONTRACTOR, CONTRACTOR shall bear all expense or other costs associated with the Breach and shall reimburse COUNTY for all expenses COUNTY incurs in addressing the Breach and consequences thereof, including costs of investigation, notification, remediation, documentation or other costs associated with addressing the Breach.

G. PERMITTED USES AND DISCLOSURES BY CONTRACTOR

1. CONTRACTOR may use or further disclose PHI COUNTY discloses to CONTRACTOR as

necessary to perform functions, activities, or services for, or on behalf of, COUNTY as specified in the 1 Agreement, provided that such use or Disclosure would not violate the HIPAA Privacy Rule if done by 2 COUNTY except for the specific Uses and Disclosures set forth below. 3

a. CONTRACTOR may use PHI COUNTY discloses to CONTRACTOR, if necessary, for the proper management and administration of CONTRACTOR.

b. CONTRACTOR may disclose PHI COUNTY discloses to CONTRACTOR for the proper management and administration of CONTRACTOR or to carry out the legal responsibilities of CONTRACTOR, if:

4

1) The Disclosure is required by law; or

2) CONTRACTOR obtains reasonable assurances from the person to whom the PHI is disclosed that it will be held confidentially and used or further disclosed only as required by law or for the purposes for which it was disclosed to the person and the person immediately notifies CONTRACTOR of any instance of which it is aware in which the confidentiality of the information has been breached.

c. CONTRACTOR may use or further disclose PHI COUNTY discloses to CONTRACTOR to provide Data Aggregation services relating to the Health Care Operations of CONTRACTOR.

2. CONTRACTOR may use PHI COUNTY discloses to CONTRACTOR, if necessary, to carry out legal responsibilities of CONTRACTOR.

3. CONTRACTOR may use and disclose PHI COUNTY discloses to CONTRACTOR consistent with the minimum necessary policies and procedures of COUNTY.

4. CONTRACTOR may use or disclose PHI COUNTY discloses to CONTRACTOR as required by law.

H. PROHIBITED USES AND DISCLOSURES

1. CONTRACTOR shall not disclose PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY about an individual to a health plan for payment or health care operations purposes if the PHI pertains solely to a health care item or service for which the health care provider involved has been paid out of pocket in full and the individual requests such restriction, in accordance with 42 USC § 17935(a) and 45 CFR § 164.522(a).

2. CONTRACTOR shall not directly or indirectly receive remuneration in exchange for PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY, except with the prior written consent of COUNTY and as permitted by 42 USC § 17935(d)(2).

I. OBLIGATIONS OF COUNTY

1. COUNTY shall notify CONTRACTOR of any limitation(s) in COUNTY's notice of privacy practices in accordance with 45 CFR § 164.520, to the extent that such limitation may affect 35 CONTRACTOR's Use or Disclosure of PHI. 36

2. COUNTY shall notify CONTRACTOR of any changes in, or revocation of, the permission

12	Any reference to statutory, regulatory, or contractual language herein shall be to such language as in

14	A. DEFINITIONS
15	1. "Breach" shall have the meaning given to such term under the IEA and CMPPA. It shall
16	include a "PII loss" as that term is defined in the CMPPA.
17	2. "Breach of the security of the system" shall have the meaning given to such term under the
18	CIPA, CCC § 1798.29(d).
19	3. "CMPPA Agreement" means the CMPPA Agreement between the SSA and CHHS.
20	4. "DHCS PI" shall mean Personal Information, as defined below, accessed in a database
21	maintained by the COUNTY or DHCS, received by CONTRACTOR from the COUNTY or DHCS or
22	acquired or created by CONTRACTOR in connection with performing the functions, activities and
23	services specified in the Agreement on behalf of the COUNTY.
24	5. "IEA" shall mean the IEA currently in effect between the SSA and DHCS.
25	6. "Notice-triggering PI" shall mean the PI identified in CCC § 1798.29(e) whose unauthorized

27	identity shall include, but not be limited to, name, identifying number, symbol, or other identifying

30	7. "PII" shall have the meaning given to such term in the IEA and CMPPA.

B. TERMS OF AGREEMENT

1. Permitted Uses and Disclosures of DHCS PI and PII by CONTRACTOR. Except as otherwise indicated in this Exhibit, CONTRACTOR may use or disclose DHCS PI only to perform functions, activities, or services for or on behalf of the COUNTY pursuant to the terms of the Agreement provided that such use or disclosure would not violate the CIPA if done by the COUNTY.

2. Responsibilities of CONTRACTOR

CONTRACTOR agrees:

a. Nondisclosure. Not to use or disclose DHCS PI or PII other than as permitted or required by this Personal Information Privacy and Security Contract or as required by applicable state and federal law.

b. Safeguards. To implement appropriate and reasonable administrative, technical, and physical safeguards to protect the security, confidentiality and integrity of DHCS PI and PII, to protect against anticipated threats or hazards to the security or integrity of DHCS PI and PII, and to prevent use or disclosure of DHCS PI or PII other than as provided for by this Personal Information Privacy and Security Contract. CONTRACTOR shall develop and maintain a written information privacy and security program that include administrative, technical and physical safeguards appropriate to the size and complexity of CONTRACTOR's operations and the nature and scope of its activities, which incorporate the requirements of Subparagraph (c), below. CONTRACTOR will provide COUNTY with its current policies upon request.

c. Security. CONTRACTOR shall ensure the continuous security of all computerized data systems containing DHCS PI and PII. CONTRACTOR shall protect paper documents containing DHCS PI and PII. These steps shall include, at a minimum:

Complying with all of the data system security precautions listed in Subparagraph E
 of the Business Associate Contract, Exhibit E to the Agreement; and

2) Providing a level and scope of security that is at least comparable to the level and scope of security established by the Office of Management and Budget in OMB Circular No. A–130,
 Appendix III–Security of Federal Automated Information Systems, which sets forth guidelines for automated information systems in Federal agencies.

34 3) If the data obtained by CONTRACTOR from COUNTY includes PII,
35 CONTRACTOR shall also comply with the substantive privacy and security requirements in the CMPPA
36 Agreement between the SSA and the CHHS and in the Agreement between the SSA and DHCS, known
37 as the IEA. The specific sections of the IEA with substantive privacy and security requirements to be

complied with are sections E, F, and G, and in Attachment 4 to the IEA, Electronic Information Exchange
 Security Requirements, Guidelines and Procedures for Federal, State and Local Agencies Exchanging
 Electronic Information with the SSA. CONTRACTOR also agrees to ensure that any of

d. Mitigation of Harmful Effects. To mitigate, to the extent practicable, any harmful effect that is known to CONTRACTOR of a use or disclosure of DHCS PI or PII by CONTRACTOR or its subcontractors in violation of this Personal Information Privacy and Security Contract.

e. CONTRACTOR's Agents and Subcontractors. To impose the same restrictions and conditions set forth in this Personal Information and Security Contract on any subcontractors or other agents with whom CONTRACTOR subcontracts any activities under the Agreement that involve the disclosure of DHCS PI or PII to such subcontractors or other agents.

f. Availability of Information. To make DHCS PI and PII available to the DHCS and/or COUNTY for purposes of oversight, inspection, amendment, and response to requests for records, injunctions, judgments, and orders for production of DHCS PI and PII. If CONTRACTOR receives DHCS PII, upon request by COUNTY and/or DHCS, CONTRACTOR shall provide COUNTY and/or DHCS with a list of all employees, contractors and agents who have access to DHCS PII, including employees, contractors and agents of its subcontractors and agents.

g. Cooperation with COUNTY. With respect to DHCS PI, to cooperate with and assist the COUNTY to the extent necessary to ensure the DHCS's compliance with the applicable terms of the CIPA including, but not limited to, accounting of disclosures of DHCS PI, correction of errors in DHCS PI, production of DHCS PI, disclosure of a security Breach involving DHCS PI and notice of such Breach to the affected individual(s).

h. Breaches and Security Incidents. During the term of the Agreement, CONTRACTOR agrees to implement reasonable systems for the discovery of any Breach of unsecured DHCS PI and PII or security incident. CONTRACTOR agrees to give notification of any beach of unsecured DHCS PI and PII or security incident in accordance with Subparagraph F, of the Business Associate Contract, Exhibit E to the Agreement.

i. Designation of Individual Responsible for Security. CONTRACTOR shall designate an individual, (e.g., Security Officer), to oversee its data security program who shall be responsible for carrying out the requirements of this Personal Information Privacy and Security Contract and for communicating on security matters with the COUNTY.
