10 THIS AGREEMENT entered into this 1st day of July 2020 (effective date), is by and between the  
11 COUNTY OF ORANGE, a political subdivision of State of California (COUNTY), and CLEAN PATH  
12 RECOVERY, LLC a limited liability company (CONTRACTOR). COUNTY and CONTRACTOR  
13 may sometimes be referred to herein individually as “Party” or collectively as “Parties.” This  
14 Agreement shall be administered by the County of Orange Health Care Agency (ADMINISTRATOR).

### 7 **II. ALTERATION OF TERMS**

8 A. This Agreement, together with Exhibits A, B, C, and D attached hereto and incorporated herein,  
9 fully expresses the complete understanding of COUNTY and CONTRACTOR with respect to the  
10 subject matter of this Agreement.

11 B. Unless otherwise expressly stated in this Agreement, no addition to, or alteration of the terms of  
12 this Agreement or any Exhibits, whether written or verbal, made by the parties, their officers, employees  
13 or agents shall be valid unless made in the form of a written amendment to this Agreement, which has  
14 been formally approved and executed by both parties.

### 15

### 16 **III. ASSIGNMENT OF DEBTS**

17 Unless this Agreement is followed without interruption by another Agreement between the Parties  
18 hereto for the same services and substantially the same scope, at the termination of this Agreement,  
19 CONTRACTOR shall assign to COUNTY any debts owing to CONTRACTOR by or on behalf of  
20 persons receiving services pursuant to this Agreement. CONTRACTOR shall immediately notify by  
21 mail each of the respective Parties, specifying the date of assignment, the County of Orange as assignee,  
22 and the address to which payments are to be sent. Payments received by CONTRACTOR from or on  
23 behalf of said persons, shall be immediately given to COUNTY.

### 25 **IV. COMPLIANCE**

26 A. COMPLIANCE PROGRAM - ADMINISTRATOR has established a Compliance Program for  
27 the purpose of ensuring adherence to all rules and regulations related to federal and state health care  
28 programs.

29 1. ADMINISTRATOR shall provide CONTRACTOR with a copy of the policies and  
30 procedures relating to ADMINISTRATOR's Compliance Program, Code of Conduct and access to  
31 General Compliance and Annual Provider Trainings.

32 2. CONTRACTOR has the option to provide ADMINISTRATOR with proof of its own  
33 compliance program, code of conduct and any compliance related policies and procedures.  
34 CONTRACTOR's compliance program, code of conduct and any related policies and procedures shall  
35 be verified by ADMINISTRATOR's Compliance Department to ensure they include all required  
36 elements by ADMINISTRATOR's Compliance Officer as described in this Compliance Paragraph to  
37 this Agreement. These elements include:



- 1 a. Designation of a Compliance Officer and/or compliance staff.
- 2 b. Written standards, policies and/or procedures.
- 3 c. Compliance related training and/or education program and proof of completion.
- 4 d. Communication methods for reporting concerns to the Compliance Officer.
- 5 e. Methodology for conducting internal monitoring and auditing.
- 6 f. Methodology for detecting and correcting offenses.
- 7 g. Methodology/Procedure for enforcing disciplinary standards.

8 3. If CONTRACTOR does not provide proof of its own compliance program to  
 9 ADMINISTRATOR, CONTRACTOR shall internally comply with ADMINISTRATOR's Compliance  
 10 Program and Code of Conduct, the CONTRACTOR shall submit to the ADMINISTRATOR within  
 11 thirty (30) calendar days of execution of this Agreement a signed acknowledgement that  
 12 CONTRACTOR will internally comply with ADMINISTRATOR's Compliance Program and Code of  
 13 Conduct. CONTRACTOR shall have as many Covered Individuals it determines necessary complete  
 14 ADMINISTRATOR's annual compliance training to ensure proper compliance.

15 4. If CONTRACTOR elects to have its own compliance program, code of conduct and any  
 16 Compliance related policies and procedures reviewed by ADMINISTRATOR, then CONTRACTOR  
 17 shall submit a copy of its compliance program, code of conduct and all relevant policies and procedures  
 18 to ADMINISTRATOR within thirty (30) calendar days of execution of this Agreement.  
 19 ADMINISTRATOR's Compliance Officer, or designee, shall review said documents within a  
 20 reasonable time, which shall not exceed forty-five (45) calendar days, and determine if contractor's  
 21 proposed compliance program and code of conduct contain all required elements to the  
 22 ADMINISTRATOR's satisfaction as consistent with the HCA's Compliance Program and Code of  
 23 Conduct. ADMINISTRATOR shall inform CONTRACTOR of any missing required elements and  
 24 CONTRACTOR shall revise its compliance program and code of conduct to meet  
 25 ADMINISTRATOR's required elements within thirty (30) calendar days after ADMINISTRATOR's  
 26 Compliance Officer's determination and resubmit the same for review by the ADMINISTRATOR.

27 5. Upon written confirmation from ADMINISTRATOR's compliance officer that the  
 28 CONTRACTOR's compliance program, code of conduct and any compliance related policies and  
 29 procedures contain all required elements, CONTRACTOR shall ensure that all Covered Individuals  
 30 relative to this Agreement are made aware of CONTRACTOR's compliance program, code of conduct,  
 31 related policies and procedures and contact information for the ADMINISTRATOR's Compliance Program.

32 ~~B. SANCTION SCREENING—CONTRACTOR shall screen all Covered Individuals employed or~~  
 33 ~~retained to provide services related to this Agreement monthly to ensure that they are not designated as~~  
 34 ~~Ineligible Persons, as pursuant to this Agreement. Screening shall be conducted against the General~~  
 35 ~~Services Administration's Excluded Parties List System or System for Award Management, the Health~~  
 36 ~~and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the~~  
 37 ~~California Medi-Cal Suspended and Ineligible Provider List, the Social Security Administration's Death~~

~~Master File at date of employment, and/or any other list or system as identified by ADMINISTRATOR.~~

B. SANCTION SCREENING – CONTRACTOR must screen all Covered Individuals employed or retained to provide services related to this Agreement to ensure that they are not designated as Ineligible Persons, as pursuant to this Agreement. Screening must be conducted against the Social Security Administration’s Death Master File at the date of employment. Screening must be conducted monthly against the General Services Administration's Excluded Parties List System or System for Award Management, the Health and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the California Medi-Cal Suspended and Ineligible Provider List, and/or any other list or system as identified by ADMINISTRATOR.

1. For purposes of this Compliance Paragraph, Covered Individuals includes all employees, interns, volunteers, contractors, subcontractors, agents, and other persons who provide health care items or services or who perform billing or coding functions on behalf of ADMINISTRATOR. CONTRACTOR shall ensure that all Covered Individuals relative to this Agreement are made aware of ADMINISTRATOR’s Compliance Program, Code of Conduct and related policies and procedures (or CONTRACTOR’s own compliance program, code of conduct and related policies and procedures if CONTRACTOR has elected to use its own).

2. An Ineligible Person shall be any individual or entity who:

- a. is currently excluded, suspended, debarred or otherwise ineligible to participate in federal and state health care programs; or
- b. has been convicted of a criminal offense related to the provision of health care items or services and has not been reinstated in the federal and state health care programs after a period of exclusion, suspension, debarment, or ineligibility.

3. CONTRACTOR shall screen prospective Covered Individuals prior to hire or engagement. CONTRACTOR shall not hire or engage any Ineligible Person to provide services relative to this Agreement.

4. CONTRACTOR shall screen all current Covered Individuals and subcontractors monthly to ensure that they have not become Ineligible Persons. CONTRACTOR shall also request that its subcontractors use their best efforts to verify that they are eligible to participate in all federal and State of California health programs and have not been excluded or debarred from participation in any federal or state health care programs, and to further represent to CONTRACTOR that they do not have any Ineligible Person in their employ or under contract.

5. Covered Individuals shall be required to disclose to CONTRACTOR immediately any debarment, exclusion or other event that makes the Covered Individual an Ineligible Person. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual providing services directly relative to this Agreement becomes debarred, excluded or otherwise becomes an Ineligible Person.

6. CONTRACTOR acknowledges that Ineligible Persons are precluded from providing

1 federal and state funded health care services by contract with COUNTY in the event that they are  
 2 currently sanctioned or excluded by a federal or state law enforcement regulatory or licensing agency.  
 3 If CONTRACTOR becomes aware that a Covered Individual has become an Ineligible Person,  
 4 CONTRACTOR shall remove such individual from responsibility for, or involvement with, COUNTY  
 5 business operations related to this Agreement.

6 7. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual or  
 7 entity is currently excluded, suspended or debarred, or is identified as such after being sanction  
 8 screened. Such individual or entity shall be immediately removed from participating in any activity  
 9 associated with this Agreement. ADMINISTRATOR will determine appropriate repayment from, or  
 10 sanction(s) to CONTRACTOR for services provided by ineligible person or individual.  
 11 CONTRACTOR shall promptly return any overpayments within forty-five (45) business days after the  
 12 overpayment is verified by ADMINISTRATOR.

13 C. GENERAL COMPLIANCE TRAINING - ADMINISTRATOR shall make General  
 14 Compliance Training available to Covered Individuals.

15 1. CONTRACTORS that have acknowledged to comply with ADMINISTRATOR's  
 16 Compliance Program shall use its best efforts to encourage completion by all Covered Individuals;  
 17 provided, however, that at a minimum CONTRACTOR shall assign at least one (1) designated  
 18 representative to complete the General Compliance Training when offered.

19 2. Such training will be made available to Covered Individuals within thirty (30) calendar  
 20 days of employment or engagement.

21 3. Such training will be made available to each Covered Individual annually.

22 4. ADMINISTRATOR will track training completion while CONTRACTOR shall provide  
 23 copies of training certification upon request.

24 5. Each Covered Individual attending a group training shall certify, in writing, attendance at  
 25 compliance training. ADMINISTRATOR shall provide instruction on group training completion while  
 26 CONTRACTOR shall retain the training certifications. Upon written request by ADMINISTRATOR,  
 27 CONTRACTOR shall provide copies of the certifications.

28 D. SPECIALIZED PROVIDER TRAINING – ADMINISTRATOR shall make Specialized  
 29 Provider Training, where appropriate, available to Covered Individuals.

30 1. CONTRACTOR shall ensure completion of Specialized Provider Training by all Covered  
 31 Individuals relative to this Agreement. This includes compliance with federal and state healthcare  
 32 program regulations and procedures or instructions otherwise communicated by regulatory agencies;  
 33 including the Centers for Medicare and Medicaid Services or their agents.

34 2. Such training will be made available to Covered Individuals within thirty (30) calendar  
 35 days of employment or engagement.

36 3. Such training will be made available to each Covered Individual annually.

37 4. ADMINISTRATOR will track online completion of training while CONTRACTOR shall

1 provide copies of the certifications upon request.

2 5. Each Covered Individual attending a group training shall certify, in writing, attendance at  
3 compliance training. ADMINISTRATOR shall provide instructions on completing the training in a  
4 group setting while CONTRACTOR shall retain the certifications. Upon written request by  
5 ADMINISTRATOR, CONTRACTOR shall provide copies of the certifications.

6 E. MEDI-CAL BILLING, CODING, AND DOCUMENTATION COMPLIANCE STANDARDS

7 1. CONTRACTOR shall take reasonable precaution to ensure that the coding of health care  
8 claims, billings and/or invoices for same are prepared and submitted in an accurate and timely manner  
9 and are consistent with federal, state and county laws and regulations. This includes compliance with  
10 federal and state health care program regulations and procedures or instructions otherwise  
11 communicated by regulatory agencies including the Centers for Medicare and Medicaid Services or  
12 their agents.

13 2. CONTRACTOR shall not submit any false, fraudulent, inaccurate and/or fictitious claims  
14 for payment or reimbursement of any kind.

15 3. CONTRACTOR shall bill only for those eligible services actually rendered which are also  
16 fully documented. When such services are coded, CONTRACTOR shall use proper billing codes which  
17 accurately describes the services provided and must ensure compliance with all billing and  
18 documentation requirements.

19 4. CONTRACTOR shall act promptly to investigate and correct any problems or errors in  
20 coding of claims and billing, if and when, any such problems or errors are identified.

21 5. CONTRACTOR shall promptly return any overpayments within forty-five (45) business  
22 days after the overpayment is verified by the ADMINISTRATOR.

23 ~~6. CONTRACTOR shall meet the HCA MHP Quality Management Program Standards and~~  
24 ~~participate in the quality improvement activities developed in the implementation of the Quality~~  
25 ~~Management Program.~~

26 6. CONTRACTOR shall meet the HCA Quality Assessment and Performance Improvement  
27 Standards established by Authority and Quality Improvement Services (AQIS) and participate in the  
28 quality improvement activities developed in the implementation of the DMC-ODS Quality Management  
29 Program. CONTRACTOR shall establish an internal Quality Management program and appoint  
30 designated Quality Improvement (QI) staff consisting of at least one dedicated QI  
31 coordinator/professional to participate in QI activities with ADMINISTRATOR and to ensure service  
32 delivery and support program staff implement QI initiatives and requirements appropriately at the  
33 program site.

34 7. CONTRACTOR shall comply with the provisions of the ADMINISTRATOR's Cultural  
35 Competency Plan submitted and approved by the state. ADMINISTRATOR shall update the Cultural  
36 Competency Plan and submit the updates to the State for review and approval annually. (CCR, Title 9,  
37 §1810.410.subds.(c)-(d).

1 F. Failure to comply with the obligations stated in this Compliance Paragraph shall constitute a  
 2 breach of the Agreement on the part of CONTRACTOR and grounds for COUNTY to terminate the  
 3 Agreement. Unless the circumstances require a sooner period of cure, CONTRACTOR shall have thirty  
 4 (30) calendar days from the date of the written notice of default to cure any defaults grounded on this  
 5 Compliance Paragraph prior to ADMINISTRATOR's right to terminate this Agreement on the basis of  
 6 such default.

### 8 **V. CONFIDENTIALITY**

9 A. CONTRACTOR shall maintain the confidentiality of all records, including billings and any  
 10 audio and/or video recordings, in accordance with all applicable federal, state and county codes and  
 11 regulations, including 42 USC §290dd-2 (Confidentiality of Records), as they now exist or may  
 12 hereafter be amended or changed.

13 B. Prior to providing any services pursuant to this Agreement, all members of the Board of  
 14 Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and  
 15 interns of the CONTRACTOR shall agree, in writing, with CONTRACTOR to maintain the  
 16 confidentiality of any and all information and records which may be obtained in the course of providing  
 17 such services. This Agreement shall specify that it is effective irrespective of all subsequent  
 18 resignations or terminations of CONTRACTOR members of the Board of Directors or its designee or  
 19 authorized agent, employees, consultants, subcontractors, volunteers and interns.

20 C. CONTRACTOR shall have in effect a system to protect patient records from inappropriate  
 21 disclosure in connection with activity funded under this Agreement. This system shall include  
 22 provisions for employee education on the confidentiality requirements, and the fact that disciplinary  
 23 action may occur upon inappropriate disclosure. CONTRACTOR agrees to implement administrative,  
 24 physical, and technical safeguards that reasonably and appropriately protect the confidentiality,  
 25 integrity, and availability of all confidential information that it creates, receives, maintains or transmits.  
 26 CONTRACTOR shall provide ADMINISTRATOR with information concerning such safeguards.

27 D. CONTRACTOR agrees to mitigate, to the extent practicable, any harmful effect that is known  
 28 to CONTRACTOR, or its subcontractors or agents in violation of the applicable state and federal  
 29 regulations regarding confidentiality.

30 E. CONTRACTOR shall monitor compliance with the above provisions on confidentiality and  
 31 security, and shall include them in all subcontracts.

32 F. CONTRACTOR shall notify ADMINISTRATOR within twenty-four (24) hours during a work  
 33 week, of any suspected or actual breach of its computer system.

### 35 **VI. CONFLICT OF INTEREST**

36 CONTRACTOR shall exercise reasonable care and diligence to prevent any actions or conditions  
 37 that could result in a conflict with COUNTY interests. In addition to CONTRACTOR, this obligation

1 shall apply to CONTRACTOR's employees, agents, and subcontractors associated with the provision of  
 2 goods and services provided under this Agreement. CONTRACTOR's efforts shall include, but not be  
 3 limited to establishing rules and procedures preventing its employees, agents, and subcontractors from  
 4 providing or offering gifts, entertainment, payments, loans or other considerations which could be  
 5 deemed to influence or appear to influence COUNTY staff or elected officers in the performance of  
 6 their duties.

## 7 8 **VII. COST REPORT**

9 ~~A. CONTRACTOR shall submit an individual and/or consolidated Cost Report for Period One,~~  
 10 ~~Period Two and Period Three, or for a portion thereof to COUNTY no later than forty five (45)~~  
 11 ~~calendar days following the period for which they are prepared or termination of this Agreement.~~  
 12 ~~CONTRACTOR shall prepare the individual and/or consolidated Cost Report in accordance with all~~

23 A. CONTRACTOR shall submit an individual and/or consolidated Cost Report for each Period, or  
 24 for a portion thereof to COUNTY no later than forty-five (45) calendar days following the period for  
 25 which they are prepared or termination of this Agreement. CONTRACTOR shall prepare the individual  
 26 and/or consolidated Cost Report in accordance with all applicable federal, state and COUNTY  
 27 requirements, GAAP and the Special Provisions Paragraph of this Agreement. CONTRACTOR shall  
 28 allocate direct and indirect costs to and between programs, cost centers, services, and funding sources in  
 29 accordance with such requirements and consistent with prudent business practice, which costs and  
 30 allocations shall be supported by source documentation maintained by CONTRACTOR, and available at  
 31 any time to ADMINISTRATOR upon reasonable notice. In the event CONTRACTOR has multiple  
 32 Agreements for mental health services that are administered by HCA, consolidation of the individual  
 33 Cost Reports into a single consolidated Cost Report may be required, as stipulated by  
 34 ADMINISTRATOR. CONTRACTOR shall submit the consolidated Cost Report to COUNTY no later  
 35 than five (5) business days following approval by ADMINSTRATOR of all individual Cost Reports to  
 36 be incorporated into a consolidated Cost Report.

37 1. If CONTRACTOR fails to submit an accurate and complete Cost Report within the time

1 period specified above, ADMINISTRATOR shall have sole discretion to impose one or both of the  
2 following:

3 a. CONTRACTOR may be assessed a late penalty of five hundred dollars (\$500) for each  
4 business day after the above specified due date that the accurate and complete Cost Report is not  
5 submitted. Imposition of the late penalty shall be at the sole discretion of the ADMINISTRATOR. The  
6 late penalty shall be assessed separately on each outstanding Cost Report due COUNTY by  
7 CONTRACTOR.

8 b. ADMINISTRATOR may withhold or delay any or all payments due CONTRACTOR  
9 pursuant to any or all agreements between COUNTY and CONTRACTOR until such time that the  
10 accurate and complete Cost Report is delivered to ADMINISTRATOR.

11 2. CONTRACTOR may request, in advance and in writing, an extension of the due date of the  
12 Cost Report setting forth good cause for justification of the request. Approval of such requests shall be  
13 at the sole discretion of ADMINISTRATOR and shall not be unreasonably denied. In no case shall  
14 extensions be granted for more than seven (7) calendar days.

15 3. In the event that CONTRACTOR does not submit an accurate and complete Cost Report  
16 within one hundred and eighty (180) calendar days following the termination of this Agreement, and  
17 CONTRACTOR has not entered into a subsequent or new agreement for any other services with  
18 COUNTY, then all amounts paid to CONTRACTOR by COUNTY during the term of the Agreement  
19 shall be immediately reimbursed to COUNTY.

20 B. The individual and/or consolidated Cost Report prepared for each period shall be the final  
21 financial and statistical report submitted by CONTRACTOR to COUNTY, and shall serve as the basis  
22 for final settlement to CONTRACTOR for that period. CONTRACTOR shall document that costs are  
23 reasonable and allowable and directly or indirectly related to the services to be provided hereunder. The  
24 Cost Report shall be the final financial record for subsequent audits, if any.

25 C. Final settlement shall be based upon the actual and reimbursable costs for services hereunder,  
26 less applicable revenues and any late penalty, not to exceed the negotiated rate as specified in the  
27 Agreement. CONTRACTOR shall not claim expenditures to COUNTY which are not reimbursable  
28 pursuant to applicable federal, state and COUNTY laws, regulations and requirements. Any payment  
29 made by COUNTY to CONTRACTOR, which is subsequently determined to have been for an  
30 unreimbursable expenditure or service, shall be repaid by CONTRACTOR to COUNTY in cash, or  
31 other authorized form of payment, within thirty (30) calendar days of submission of the Cost Report or  
32 COUNTY may elect to reduce any amount owed CONTRACTOR by an amount not to exceed the  
33 reimbursement due COUNTY.

34 D. Costs of Medi-Cal services shall not exceed the negotiated rate as specified in this Agreement.

35 E. If the Cost Report indicates the actual and reimbursable costs of services provided pursuant to  
36 this Agreement, less applicable revenues and any late penalty, are higher than the aggregate of interim  
37 monthly payments to CONTRACTOR, then COUNTY shall pay CONTRACTOR the difference,

1 provided such payment does not exceed the COUNTY's Total Aggregate Maximum Obligation and  
2 separate non-Medi-Cal Aggregate Maximum Obligation and Aggregate Medi-Cal Maximum Obligation.

3 F. All Cost Reports shall contain the following attestation, which may be typed directly on or  
4 attached to the Cost Report:

20 **VIII. DEBARMENT AND SUSPENSION CERTIFICATION**

21 A. CONTRACTOR certifies that it and its principals:

22 1. Are not presently debarred, suspended, proposed for debarment, declared ineligible, or  
23 voluntarily excluded by any federal department or agency.

24 2. Have not within a three-year period preceding this Agreement been convicted of or had a  
25 civil judgment rendered against them for commission of fraud or a criminal offense in connection with  
26 obtaining, attempting to obtain, or performing a public (federal, state, or local) transaction or contract  
27 under a public transaction; violation of federal or state antitrust statutes or commission of  
28 embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or  
29 receiving stolen property.

30 3. Are not presently indicted for or otherwise criminally or civilly charged by a federal, state,  
31 or local governmental entity with commission of any of the offenses enumerated in Subparagraph A.2.  
32 above.

33 4. Have not within a three-year period preceding this Agreement had one or more public  
34 transactions (federal, state, or local) terminated for cause or default.

35 5. Shall not knowingly enter into any lower tier covered transaction with a person who is  
36 proposed for debarment under federal regulations (i.e., 48 CFR Part 9, Subpart 9.4), debarred,  
37 suspended, declared ineligible, or voluntarily excluded from participation in such transaction unless



1 authorized by the State of California.

2 6. Shall include without modification, the clause titled "Certification Regarding Debarment,  
3 Suspension, Ineligibility, and Voluntary Exclusion Lower Tier Covered Transaction," (i.e., transactions  
4 with sub-grantees and/or contractors) and in all solicitations for lower tier covered transactions in  
5 accordance with 2 CFR Part 376.

6 B. The terms and definitions of this paragraph have the meanings set out in the Definitions and  
7 Coverage sections of the rules implementing 51 F.R. 6370.

## 8 9 **IX. DELEGATION, ASSIGNMENT, AND SUBCONTRACTS**

10 A. CONTRACTOR may not delegate the obligations hereunder, either in whole or in part, without  
11 prior written consent of COUNTY. CONTRACTOR shall provide written notification of  
12 CONTRACTOR's intent to delegate the obligations hereunder, either in whole or part, to  
13 ADMINISTRATOR not less than sixty (60) calendar days prior to the effective date of the delegation.  
14 Any attempted assignment or delegation in derogation of this paragraph shall be void.

15 B. CONTRACTOR agrees that if there is a change or transfer in ownership of CONTRACTOR's  
16 business prior to completion of this Agreement, and COUNTY agrees to an assignment of the  
17 Agreement, the new owners shall be required under the terms of sale or other instruments of transfer to  
18 assume CONTRACTOR's duties and obligations contained in this Agreement and complete them to the  
19 satisfaction of COUNTY. CONTRACTOR may not assign the rights hereunder, either in whole or in  
20 part, without the prior written consent of COUNTY.

21 1. If CONTRACTOR is a nonprofit organization, any change from a nonprofit corporation to  
22 any other corporate structure of CONTRACTOR, including a change in more than fifty percent (50%)  
23 of the composition of the Board of Directors within a two (2) month period of time, shall be deemed an  
24 assignment for purposes of this paragraph, unless CONTRACTOR is transitioning from a community  
25 clinic/health center to a Federally Qualified Health Center and has been so designated by the Federal  
26 Government. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

27 2. If CONTRACTOR is a for-profit organization, any change in the business structure,  
28 including but not limited to, the sale or transfer of more than ten percent (10%) of the assets or stocks of  
29 CONTRACTOR, change to another corporate structure, including a change to a sole proprietorship, or a  
30 change in fifty percent (50%) or more of Board of Directors or any governing body of CONTRACTOR  
31 at one time shall be deemed an assignment pursuant to this paragraph. Any attempted assignment or  
32 delegation in derogation of this subparagraph shall be void.

33 3. If CONTRACTOR is a governmental organization, any change to another structure,  
34 including a change in more than fifty percent (50%) of the composition of its governing body (i.e. Board  
35 of Supervisors, City Council, School Board) within a two (2) month period of time, shall be deemed an  
36 assignment for purposes of this paragraph. Any attempted assignment or delegation in derogation of  
37 this subparagraph shall be void.

1           4. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization,  
2 CONTRACTOR shall provide written notification of CONTRACTOR's intent to assign the obligations  
3 hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to  
4 the effective date of the assignment.

5           5. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization,  
6 CONTRACTOR shall provide written notification within thirty (30) calendar days to  
7 ADMINISTRATOR when there is change of less than fifty percent (50%) of Board of Directors or any  
8 governing body of CONTRACTOR at one time.

9           6. COUNTY reserves the right to immediately terminate the Agreement in the event  
10 COUNTY determines, in its sole discretion, that the assignee is not qualified or is otherwise  
11 unacceptable to COUNTY for the provision of services under the Agreement.

12           C. CONTRACTOR's obligations undertaken pursuant to this Agreement may be carried out by  
13 means of subcontracts, provided such subcontractors are approved in advance by ADMINISTRATOR,  
14 meet the requirements of this Agreement as they relate to the service or activity under subcontract,  
15 include any provisions that ADMINISTRATOR may require, and are authorized in writing by  
16 ADMINISTRATOR prior to the beginning of service delivery.

17           1. After approval of the subcontractor, ADMINISTRATOR may revoke the approval of the  
18 subcontractor upon five (5) calendar days' written notice to CONTRACTOR if the subcontractor  
19 subsequently fails to meet the requirements of this Agreement or any provisions that  
20 ADMINISTRATOR has required. ADMINISTRATOR may disallow subcontractor expenses reported  
21 by CONTRACTOR.

22           2. No subcontract shall terminate or alter the responsibilities of CONTRACTOR to COUNTY  
23 pursuant to this Agreement.

24           3. ADMINISTRATOR may disallow, from payments otherwise due CONTRACTOR,  
25 amounts claimed for subcontracts not approved in accordance with this paragraph.

26           4. This provision shall not be applicable to service agreements usually and customarily  
27 entered into by CONTRACTOR to obtain or arrange for supplies, technical support, and professional  
28 services provided by consultants.

29           D. CONTRACTOR shall notify COUNTY in writing of any change in the CONTRACTOR's  
30 status with respect to name changes that do not require an assignment of the Agreement.  
31 CONTRACTOR is also obligated to notify COUNTY in writing if the CONTRACTOR becomes a party  
32 to any litigation against COUNTY, or a party to litigation that may reasonably affect the  
33 CONTRACTOR's performance under the Contract, as well as any potential conflicts of interest between  
34 CONTRACTOR and County that may arise prior to or during the period of Agreement performance.  
35 While CONTRACTOR will be required to provide this information without prompting from COUNTY  
36 any time there is a change in CONTRACTOR's name, conflict of interest or litigation status,  
37 CONTRACTOR must also provide an update to COUNTY of its status in these areas whenever

1 requested by COUNTY.  
2

### 3 **X. DISPUTE RESOLUTION**

4 A. The Parties shall deal in good faith and attempt to resolve potential disputes informally. If the  
5 dispute concerning a question of fact arising under the terms of this Agreement is not disposed of in a  
6 reasonable period of time by the CONTRACTOR and the ADMINISTRATOR, such matter shall be  
7 brought to the attention of the COUNTY Purchasing Agency by way of the following process:

8 1. CONTRACTOR shall submit to the COUNTY Purchasing Agency a written demand for a  
9 final decision regarding the disposition of any dispute between the Parties arising under, related to, or  
10 involving this Agreement, unless COUNTY, on its own initiative, has already rendered such a final  
11 decision.

12 2. CONTRACTOR's written demand shall be fully supported by factual information, and, if  
13 such demand involves a cost adjustment to the Agreement, CONTRACTOR shall include with the  
14 demand a written statement signed by an authorized representative indicating that the demand is made in  
15 good faith, that the supporting data are accurate and complete, and that the amount requested accurately  
16 reflects the Agreement adjustment for which CONTRACTOR believes COUNTY is liable.

17 B. Pending the final resolution of any dispute arising under, related to, or involving this  
18 Agreement, CONTRACTOR agrees to proceed diligently with the performance of services secured via  
19 this Agreement, including the delivery of goods and/or provision of services. CONTRACTOR's failure  
20 to proceed diligently shall be considered a material breach of this Agreement.

21 C. Any final decision of COUNTY shall be expressly identified as such, shall be in writing, and  
22 shall be signed by a COUNTY Deputy Purchasing Agent or designee. If COUNTY fails to render a  
23 decision within ninety (90) calendar days after receipt of CONTRACTOR's demand, it shall be deemed  
24 a final decision adverse to CONTRACTOR's contentions.

25 D. This Agreement has been negotiated and executed in the State of California and shall be  
26 governed by and construed under the laws of the State of California. In the event of any legal action to  
27 enforce or interpret this Agreement, the sole and exclusive venue shall be a court of competent  
28 jurisdiction located in Orange County, California, and the Parties hereto agree to and do hereby submit  
29 to the jurisdiction of such court, notwithstanding Code of Civil Procedure Section 394. Furthermore, the  
30 Parties specifically agree to waive any and all rights to request that an action be transferred for  
31 adjudication to another county.

### 32 **XI. EMPLOYEE ELIGIBILITY VERIFICATION**

33 CONTRACTOR attests that it shall fully comply with all federal and state statutes and regulations  
34 regarding the employment of aliens and others and to ensure that employees, subcontractors, and  
35 consultants performing work under this Agreement meet the citizenship or alien status requirements set  
36 forth in federal statutes and regulations. CONTRACTOR shall obtain, from all employees,  
37

1 subcontractors, and consultants performing work hereunder, all verification and other documentation of  
 2 employment eligibility status required by federal or state statutes and regulations including, but not  
 3 limited to, the Immigration Reform and Control Act of 1986, 8 USC §1324 et seq., as they currently  
 4 exist and as they may be hereafter amended. CONTRACTOR shall retain all such documentation for all  
 5 covered employees, subcontractors, and consultants for the period prescribed by the law.

## 7 **XII. EQUIPMENT**

8 A. Unless otherwise specified in writing by ADMINISTRATOR, Equipment is defined as all  
 9 property of a Relatively Permanent nature with significant value, purchased in whole or in part by  
 10 ADMINISTRATOR to assist in performing the services described in this Agreement. “Relatively  
 11 Permanent” is defined as having a useful life of one (1) year or longer. Equipment which costs \$5,000  
 12 or over, including freight charges, sales taxes, and other taxes, and installation costs are defined as  
 13 Capital Assets. Equipment which costs between \$600 and \$5,000, including freight charges, sales taxes  
 14 and other taxes, and installation costs, or electronic equipment that costs less than \$600 but may  
 15 contained PHI or PII, are defined as Controlled Equipment. Controlled Equipment includes, but is not  
 16 limited to phones, tablets, audio/visual equipment, computer equipment, and lab equipment. The cost of  
 17 Equipment purchased, in whole or in part, with funds paid pursuant to this Agreement shall be  
 18 depreciated according to GAAP.

19 B. CONTRACTOR shall obtain ADMINISTRATOR’s written approval prior to purchase of any  
 20 Equipment with funds paid pursuant to this Agreement. Upon delivery of Equipment, CONTRACTOR  
 21 shall forward to ADMINISTRATOR, copies of the purchase order, receipt, and other supporting  
 22 documentation, which includes delivery date, unit price, tax, shipping and serial numbers.  
 23 CONTRACTOR shall request an applicable asset tag for said Equipment and shall include each  
 24 purchased asset in an Equipment inventory.

25 C. Upon ADMINISTRATOR’s prior written approval, CONTRACTOR may expense to  
 26 COUNTY the cost of the approved Equipment purchased by CONTRACTOR. To “expense,” in  
 27 relation to Equipment, means to charge the proportionate cost of Equipment in the fiscal year in which it  
 28 is purchased. Title of expensed Equipment shall be vested with COUNTY.

29 D. CONTRACTOR shall maintain an inventory of all Equipment purchased in whole or in part  
 30 with funds paid through this Agreement, including date of purchase, purchase price, serial number,  
 31 model and type of Equipment. Such inventory shall be available for review by ADMINISTRATOR,  
 32 and shall include the original purchase date and price, useful life, and balance of depreciated Equipment  
 33 cost, if any.

34 E. CONTRACTOR shall cooperate with ADMINISTRATOR in conducting periodic physical  
 35 inventories of all Equipment. Upon demand by ADMINISTRATOR, CONTRACTOR shall return any  
 36 or all Equipment to COUNTY.

37 F. CONTRACTOR must report any loss or theft of Equipment in accordance with the procedure

1 approved by ADMINISTRATOR and the Notices Paragraph of this Agreement. In addition,  
 2 CONTRACTOR must complete and submit to ADMINISTRATOR a notification form when items of  
 3 Equipment are moved from one location to another or returned to COUNTY as surplus.

4 G. Unless this Agreement is followed without interruption by another agreement between the  
 5 Parties for substantially the same type and scope of services, at the termination of this Agreement for  
 6 any cause, CONTRACTOR shall return to COUNTY all Equipment purchased with funds paid through  
 7 this Agreement.

8 H. CONTRACTOR shall maintain and administer a sound business program for ensuring the  
 9 proper use, maintenance, repair, protection, insurance, and preservation of COUNTY Equipment.

### 10 **XIII. FACILITIES, PAYMENTS AND SERVICES**

11 CONTRACTOR agrees to provide the services, staffing, facilities, and supplies in accordance with  
 12 this Agreement. COUNTY shall compensate, and authorize, when applicable, said services.  
 13 CONTRACTOR shall operate continuously throughout the term of this Agreement with at least the  
 14 minimum number and type of staff which meet applicable federal and state requirements, and which are  
 15 necessary for the provision of the services hereunder.  
 16

### 17 **XIV. INDEMNIFICATION AND INSURANCE**

18 A. CONTRACTOR agrees to indemnify, defend with counsel approved in writing by COUNTY,  
 19 and hold COUNTY, its elected and appointed officials, officers, employees, agents and those special  
 20 districts and agencies for which COUNTY's Board of Supervisors acts as the governing Board  
 21 ("COUNTY INDEMNITEES") harmless from any claims, demands or liability of any kind or nature,  
 22 including but not limited to personal injury or property damage, arising from or related to the services,  
 23 products or other performance provided by CONTRACTOR pursuant to this Agreement. If judgment is  
 24 entered against CONTRACTOR and COUNTY by a court of competent jurisdiction because of the  
 25 concurrent active negligence of COUNTY or COUNTY INDEMNITEES, CONTRACTOR and  
 26 COUNTY agree that liability will be apportioned as determined by the court. Neither Party shall  
 27 request a jury apportionment.  
 28

29 B. Prior to the provision of services under this Agreement, CONTRACTOR agrees to purchase all  
 30 required insurance at CONTRACTOR's expense, including all endorsements required herein, necessary  
 31 to satisfy COUNTY that the insurance provisions of this Agreement have been complied with.  
 32 CONTRACTOR agrees to keep such insurance coverage, Certificates of Insurance (COI), and  
 33 endorsements on deposit with COUNTY during the entire term of this Agreement. In addition, all  
 34 subcontractors performing work on behalf of CONTRACTOR pursuant to this Agreement shall obtain  
 35 insurance subject to the same terms and conditions as set forth herein for CONTRACTOR.

36 C. CONTRACTOR shall ensure that all subcontractors performing work on behalf of  
 37 CONTRACTOR pursuant to this Agreement shall be covered under CONTRACTOR's insurance as an

1 Additional Insured or maintain insurance subject to the same terms and conditions as set forth herein for  
2 CONTRACTOR. CONTRACTOR shall not allow subcontractors to work if subcontractors have less  
3 than the level of coverage required by COUNTY from CONTRACTOR under this Agreement. It is the  
4 obligation of CONTRACTOR to provide notice of the insurance requirements to every subcontractor  
5 and to receive proof of insurance prior to allowing any subcontractor to begin work. Such proof of  
6 insurance must be maintained by CONTRACTOR through the entirety of this Agreement for inspection  
7 by COUNTY representative(s) at any reasonable time.

8 D. All SIRs shall be clearly stated on the COI. Any SIR in an amount in excess of fifty thousand  
9 dollars (\$50,000) shall specifically be approved by the CEO/Office of Risk Management upon review of  
10 CONTRACTOR's current audited financial report. If CONTRACTOR's SIR is approved,  
11 CONTRACTOR, in addition to, and without limitation of, any other indemnity provision(s) in this  
12 Agreement, agrees to all of the following:

13 1. In addition to the duty to indemnify and hold the COUNTY harmless against any and all  
14 liability, claim, demand or suit resulting from CONTRACTOR's, its agents, employee's or  
15 subcontractor's performance of this Agreement, CONTRACTOR shall defend the COUNTY at its sole  
16 cost and expense with counsel approved by Board of Supervisors against same; and

17 2. CONTRACTOR's duty to defend, as stated above, shall be absolute and irrespective of any  
18 duty to indemnify or hold harmless; and

19 3. The provisions of California Civil Code Section 2860 shall apply to any and all actions to  
20 which the duty to defend stated above applies, and the CONTRACTOR's SIR provision shall be  
21 interpreted as though the CONTRACTOR was an insurer and the COUNTY was the insured.

22 E. If CONTRACTOR fails to maintain insurance acceptable to the COUNTY for the full term of  
23 this Agreement, the COUNTY may terminate this Agreement.

24 F. QUALIFIED INSURER

25 1. The policy or policies of insurance must be issued by an insurer with a minimum rating of  
26 A- (Secure A.M. Best's Rating) and VIII (Financial Size Category as determined by the most current  
27 edition of the Best's Key Rating Guide/Property-Casualty/United States or ambest.com). It is preferred,  
28 but not mandatory, that the insurer be licensed to do business in the state of California (California  
29 Admitted Carrier).

30 2. If the insurance carrier does not have an A.M. Best Rating of A-/VIII, the CEO/Office of  
31 Risk Management retains the right to approve or reject a carrier after a review of the company's  
32 performance and financial ratings.

33 G. The policy or policies of insurance maintained by CONTRACTOR shall provide the minimum  
34 limits and coverage as set forth below:

#### H. REQUIRED COVERAGE FORMS

1. The Commercial General Liability coverage shall be written on ISO form CG 00 01, or a substitute form providing liability coverage at least as broad.

2. The Business Automobile Liability coverage shall be written on ISO form CA 00 01, CA 00 05, CA 00 12, CA 00 20, or a substitute form providing coverage at least as broad.

#### I. REQUIRED ENDORSEMENTS

1. The Commercial General Liability policy shall contain the following endorsements, which shall accompany the COI:

a. An Additional Insured endorsement using ISO form CG 20 26 04 13 or a form at least as broad naming the County of Orange, its elected and appointed officials, officers, agents and employees as Additional Insureds, or provide blanket coverage, which will state AS REQUIRED BY WRITTEN AGREEMENT.

b. A primary non-contributing endorsement using ISO form CG 20 01 04 13, or a form at

1 least as broad evidencing that the CONTRACTOR's insurance is primary and any insurance or self-  
2 insurance maintained by the County of Orange shall be excess and non-contributing.

3 2. The Network Security and Privacy Liability policy shall contain the following  
4 endorsements, which shall accompany the COI:

5 a. An Additional Insured endorsement naming the County of Orange, its elected and  
6 appointed officials, officers, agents and employees as Additional Insureds for its vicarious liability.

7 b. A primary and non-contributing endorsement evidencing that the Contractor's  
8 insurance is primary and any insurance or self-insurance maintained by the County of Orange shall be  
9 excess and non-contributing.

10 J. The Workers' Compensation policy shall contain a waiver of subrogation endorsement waiving  
11 all rights of subrogation against the County of Orange, its elected and appointed officials, officers,  
12 agents and employees, or provide blanket coverage, which will state AS REQUIRED BY WRITTEN  
13 AGREEMENT.

14 K. All insurance policies required by this Agreement shall waive all rights of subrogation against  
15 the County of Orange, its elected and appointed officials, officers, agents and employees when acting  
16 within the scope of their appointment or employment.

17 L. CONTRACTOR shall notify COUNTY in writing within thirty (30) days of any policy  
18 cancellation and within ten (10) days for non-payment of premium and provide a copy of the  
19 cancellation notice to COUNTY. Failure to provide written notice of cancellation shall constitute a  
20 breach of CONTRACTOR's obligation hereunder and ground for COUNTY to suspend or terminate  
21 this Agreement.

22 M. If CONTRACTOR's Professional Liability, Technology Errors & Omissions and/or Network  
23 Security & Privacy Liability are "Claims -Made" policies, CONTRACTOR shall agree to maintain  
24 coverage for two (2) years following the completion of the Agreement.

25 N. The Commercial General Liability policy shall contain a "severability of interests" clause also  
26 known as a "separation of insureds" clause (standard in the ISO CG 0001 policy).

27 O. COUNTY expressly retains the right to require CONTRACTOR to increase or decrease  
28 insurance of any of the above insurance types throughout the term of this Agreement. Any increase or  
29 decrease in insurance will be as deemed by County of Orange Risk Manager as appropriate to  
30 adequately protect COUNTY.

31 P. COUNTY shall notify CONTRACTOR in writing of changes in the insurance requirements. If  
32 CONTRACTOR does not deposit copies of acceptable COI and endorsements with COUNTY  
33 incorporating such changes within thirty (30) calendar days of receipt of such notice, this Agreement  
34 may be in breach without further notice to CONTRACTOR, and COUNTY shall be entitled to all legal  
35 remedies.

36 Q. The procuring of such required policy or policies of insurance shall not be construed to limit  
37 CONTRACTOR's liability hereunder nor to fulfill the indemnification provisions and requirements of



1 this Agreement, nor act in any way to reduce the policy coverage and limits available from the insurer.

2 **R. SUBMISSION OF INSURANCE DOCUMENTS**

3 1. The COI and endorsements shall be provided to COUNTY as follows:  
 4 a. Prior to the start date of this Agreement.  
 5 b. No later than the expiration date for each policy.  
 6 c. Within thirty (30) calendar days upon receipt of written notice by COUNTY regarding  
 7 changes to any of the insurance requirements as set forth in the Coverage Subparagraph above.

8 2. The COI and endorsements shall be provided to the COUNTY at the address as specified in  
 9 the Referenced Contract Provisions of this Agreement.

10 3. If CONTRACTOR fails to submit the COI and endorsements that meet the insurance  
 11 provisions stipulated in this Agreement by the above specified due dates, ADMINISTRATOR shall  
 12 have sole discretion to impose one or both of the following:

13 a. ADMINISTRATOR may withhold or delay any or all payments due CONTRACTOR  
 14 pursuant to any and all Agreements between COUNTY and CONTRACTOR until such time that the  
 15 required COI and endorsements that meet the insurance provisions stipulated in this Agreement are  
 16 submitted to ADMINISTRATOR.

17 b. CONTRACTOR may be assessed a penalty of one hundred dollars (\$100) for each late  
 18 COI or endorsement for each business day, pursuant to any and all Agreements between COUNTY and  
 19 CONTRACTOR, until such time that the required COI and endorsements that meet the insurance  
 20 provisions stipulated in this Agreement are submitted to ADMINISTRATOR.

21 c. If CONTRACTOR is assessed a late penalty, the amount shall be deducted from  
 22 CONTRACTOR's monthly invoice.

23 4. In no cases shall assurances by CONTRACTOR, its employees, agents, including any  
 24 insurance agent, be construed as adequate evidence of insurance. COUNTY will only accept valid COIs  
 25 and endorsements, or in the interim, an insurance binder as adequate evidence of insurance coverage.  
 26

27 **XV. INSPECTIONS AND AUDITS**

28 A. ADMINISTRATOR, any authorized representative of COUNTY, any authorized representative  
 29 of the State of California, the Secretary of the United States Department of Health and Human Services,  
 30 the Comptroller General of the United States, or any other of their authorized representatives, shall to  
 31 the extent permissible under applicable law have access to any books, documents, and records, including  
 32 but not limited to, financial statements, general ledgers, relevant accounting systems, medical and Client  
 33 records, of CONTRACTOR that are directly pertinent to this Agreement, for the purpose of responding  
 34 to a beneficiary complaint or conducting an audit, review, evaluation, or examination, or making  
 35 transcripts during the periods of retention set forth in the Records Management and Maintenance  
 36 Paragraph of this Agreement. Such persons may at all reasonable times inspect or otherwise evaluate  
 37 the services provided pursuant to this Agreement, and the premises in which they are provided.

1 B. CONTRACTOR shall actively participate and cooperate with any person specified in  
 2 Subparagraph A. above in any evaluation or monitoring of the services provided pursuant to this  
 3 Agreement, and shall provide the above-mentioned persons adequate office space to conduct such  
 4 evaluation or monitoring.

5 C. AUDIT RESPONSE

6 1. Following an audit report, in the event of non-compliance with applicable laws and  
 7 regulations governing funds provided through this Agreement, COUNTY may terminate this Agreement  
 8 as provided for in the Termination Paragraph or direct CONTRACTOR to immediately implement  
 9 appropriate corrective action. A CAP shall be submitted to ADMINISTRATOR in writing within thirty  
 10 (30) calendar days after receiving notice from ADMINISTRATOR.

11 2. If the audit reveals that money is payable from one Party to the other, that is,  
 12 reimbursement by CONTRACTOR to COUNTY, or payment of sums due from COUNTY to  
 13 CONTRACTOR, said funds shall be due and payable from one Party to the other within sixty (60)  
 14 calendar days of receipt of the audit results. If reimbursement is due from CONTRACTOR to  
 15 COUNTY, and such reimbursement is not received within said sixty (60) calendar days, COUNTY may,  
 16 in addition to any other remedies provided by law, reduce any amount owed CONTRACTOR by an  
 17 amount not to exceed the reimbursement due COUNTY.

18 D. CONTRACTOR shall retain a licensed certified public accountant, who will prepare an  
 19 annual Single Audit as required by 31 USC 7501 – 7507, as well as its implementing regulations under  
 20 2 CFR Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for  
 21 Federal Awards. CONTRACTOR shall forward the Single Audit to ADMINISTRATOR within  
 22 fourteen (14) calendar days of receipt.

23 E. ADMINISTRATOR shall inform providers and CONTRACTOR, at the time they enter into a  
 24 contract, of the following:

25 1. Beneficiary grievance, appeal, and fair hearing procedures and timeframes as specified in  
 26 42 C.F.R. 438.400 through 42 C.F.R. 438.424.

27 2. The beneficiary's right to file grievances and appeals and the requirements and timeframes  
 28 for filing.

29 3. The availability of assistance to the beneficiary with filing grievances and appeals.

30 4. The beneficiary's right to request continuation of benefits that the ADMINISTRATOR  
 31 seeks to reduce or terminate during an appeal or state fair hearing filing, if filed within the allowable  
 32 timeframes, although the beneficiary may be liable for the cost of any continued benefits while the  
 33 appeal or state fair hearing is pending if the final decision is adverse to the beneficiary.

34 5. The conduction of random reviews to ensure beneficiaries are being notified in a timely  
 35 manner.

36 F. CONTRACTOR shall make all of its premises, physical facilities, equipment, books, records,  
 37 documents, contracts, computers, or other electronic systems pertaining to Medi-Cal/Drug Medi-Cal

1 enrollees, Medi-Cal/Drug Medi-Cal-related activities, services and activities furnished under the terms  
 2 of the Agreement or determinations of amounts payable available at any time for inspection,  
 3 examination of copying by the State, CMS, HHS Inspector General, the United States Comptroller  
 4 General, their designees, and other authorized federal and state agencies. (42 CFR §438.3(h)) This audit  
 5 right will exist for ten (10) years from the final date of the contract period or from the date of

 7 Inspector General may inspect, evaluate, and audit the CONTRACTOR at any time if there is a

6 **XVII. LITERATURE, ADVERTISEMENTS, AND SOCIAL MEDIA**

7 A. Any written information or literature, including educational or promotional materials,  
8 distributed by CONTRACTOR to any person or organization for purposes directly or indirectly related  
9 to this Agreement must be approved at least thirty (30) days in advance and in writing by  
10 ADMINISTRATOR before distribution. For the purposes of this Agreement, distribution of written  
11 materials shall include, but not be limited to, pamphlets, brochures, flyers, newspaper or magazine ads,  
12 and electronic media such as the Internet.

13 B. Any advertisement through radio, television broadcast, or the Internet, for educational or  
14 promotional purposes, made by CONTRACTOR for purposes directly or indirectly related to this  
15 Agreement must be approved in advance at least thirty (30) days and in writing by ADMINISTRATOR.

16 C. If CONTRACTOR uses social media (such as Facebook, Twitter, YouTube or other publicly  
17 available social media sites) in support of the services described within this Agreement,  
18 CONTRACTOR shall develop social media policies and procedures and have them available to  
19 ADMINISTRATOR upon reasonable notice. CONTRACTOR shall inform ADMINISTRATOR of all  
20 forms of social media used to either directly or indirectly support the services described within this  
21 Agreement. CONTRACTOR shall comply with COUNTY Social Media Use Policy and Procedures as  
22 they pertain to any social media developed in support of the services described within this Agreement.  
23 CONTRACTOR shall also include any required funding statement information on social media when  
24 required by ADMINISTRATOR.

25 D. Any information as described in Subparagraphs A. and B. above shall not imply endorsement  
26 by COUNTY, unless ADMINISTRATOR consents thereto in writing.

27 E. CONTRACTOR shall also clearly explain through these materials that there shall be no  
28 unlawful use of drugs or alcohol associated with the services provided pursuant to this Agreement, as  
29 specified in HSC, §11999-11999.3.

30  
31 **XVIII. MAXIMUM OBLIGATION**

32 A. The Total Aggregate Maximum Obligation of COUNTY for services provided in accordance  
33 with this Agreement, and the separate Aggregate Maximum Obligations for each period under this  
34 Agreement, are as specified in the Referenced Contract Provisions of this Agreement, except as allowed  
35 for in Subparagraph B. below.

36 B. ADMINISTRATOR may amend the Aggregate Maximum Obligation by an amount not to  
37 exceed ten percent (10%) of Period One funding for this Agreement.



**XIX. MINIMUM WAGE LAWS**

2 A. Pursuant to the United States of America Fair Labor Standards Act of 1938, as amended, and  
3 State of California Labor Code, §1178.5, CONTRACTOR shall pay no less than the greater of the  
4 federal or California Minimum Wage to all its Covered Individuals (as defined within the “Compliance”  
5 paragraph of this Agreement) that directly or indirectly provide services pursuant to this Agreement, in  
6 any manner whatsoever. CONTRACTOR shall require and verify that all of its Covered Individuals

9 B. CONTRACTOR shall comply and verify that its Covered Individuals comply with all other  
10 federal and State of California laws for minimum wage, overtime pay, record keeping, and child labor  
11 standards pursuant to providing services pursuant to this Agreement.

12 C. Notwithstanding the minimum wage requirements provided for in this clause, CONTRACTOR,  
13 where applicable, shall comply with the prevailing wage and related requirements, as provided for in  
14 accordance with the provisions of Article 2 of Chapter 1, Part 7, Division 2 of the Labor Code of the  
15 State of California (§§1770, et seq.), as it now exists or may hereafter be amended.

**XIX. NONDISCRIMINATION**

32 for training, including apprenticeship.

33 3. CONTRACTOR shall not discriminate between employees with spouses and employees  
34 with domestic partners, or discriminate between domestic partners and spouses of those employees, in  
35 the provision of benefits.

36 4. CONTRACTOR shall post in conspicuous places, available to employees and applicants for  
37 employment, notices from ADMINISTRATOR and/or the United States Equal Employment

2 5. All solicitations or advertisements for employees placed by or on behalf of

20 4, Chapter 6, Article 1 (§10800, et seq.) of the CCR; and Title II of the Genetic Information  
21 Nondiscrimination Act of 2008, 42 USC 2000ff, et seq. as applicable, and all other pertinent rules and  
22 regulations promulgated pursuant thereto, and as otherwise provided by state law and regulations, as all  
23 may now exist or be hereafter amended or changed. For the purpose of this Nondiscrimination  
24 paragraph, discrimination includes, but is not limited to the following based on one or more of the  
25 factors identified above:

- 26 1. Denying a Client or potential Client any service, benefit, or accommodation.
- 27 2. Providing any service or benefit to a Client which is different or is provided in a different  
28 manner or at a different time from that provided to other Clients.
- 29 3. Restricting a Client in any way in the enjoyment of any advantage or privilege enjoyed by  
30 others receiving any service and/or benefit.
- 31 4. Treating a Client differently from others in satisfying any admission requirement or  
32 condition, or eligibility requirement or condition, which individuals must meet in order to be provided  
33 any service and/or benefit.
- 34 5. Assignment of times or places for the provision of services.

35 C. COMPLAINT PROCESS – CONTRACTOR shall establish procedures for advising all Clients  
36 through a written statement that CONTRACTOR's and/or subcontractor's Clients may file all  
37 complaints alleging discrimination in the delivery of services with CONTRACTOR, subcontractor, and

1 ADMINISTRATOR or the U.S. Department of Health and Human Services' OCR.

2 1. Whenever possible, problems shall be resolved at the point of service. CONTRACTOR  
3 shall establish an internal problem resolution process for Clients not able to resolve such problems at the  
4 point of service. Clients may initiate a grievance or complaint directly with CONTRACTOR either

13 implemented in 45 CFR 84.1 et seq.), and the Americans with Disabilities Act of 1990 as amended (42  
14 USC 12101 et seq.; as implemented in 29 CFR 1630), as applicable, pertaining to the prohibition of  
15 discrimination against qualified persons with disabilities in all programs or activities, and if applicable  
16 as implemented in Title 45, CFR, §84.1 et seq., as they exist now or may be hereafter amended together  
17 with succeeding legislation.

18 E. RETALIATION – Neither CONTRACTOR nor subcontractor, nor its employees or agents shall  
19 intimidate, coerce or take adverse action against any person for the purpose of interfering with rights  
20 secured by federal or state laws, or because such person has filed a complaint, certified, assisted or  
21 otherwise participated in an investigation, proceeding, hearing or any other activity undertaken to  
22 enforce rights secured by federal or state law.

23 F. In the event of non-compliance with this paragraph or as otherwise provided by federal and  
24 state law, this Agreement may be canceled, terminated or suspended in whole or in part and  
25 CONTRACTOR or subcontractor may be declared ineligible for further contracts involving federal,  
26 state or COUNTY funds.

## 27 **XXI. NOTICES**

28 A. Unless otherwise specified, all notices, claims, correspondence, reports and/or statements

 3 transmission confirmed, or when accepted by U.S. Postal Service Express Mail, Federal Express, United  
 4 Parcel Service, or any other expedited delivery service.

5 C. CONTRACTOR shall notify ADMINISTRATOR, in writing, within twenty-four (24) hours of  
 6 becoming aware of any occurrence of a serious nature, which may expose COUNTY to liability. Such  
 7 occurrences shall include, but not be limited to, accidents, injuries, or acts of negligence, or loss or  
 8 damage to any COUNTY property in possession of CONTRACTOR.

9 D. For purposes of this Agreement, any notice to be provided by COUNTY may be given by  
 10 ADMINISTRATOR.

## 11 **XXII. NOTIFICATION OF DEATH**

 14 CONTRACTOR shall immediately notify ADMINISTRATOR.

15 B. All Notifications of Death provided to ADMINISTRATOR by CONTRACTOR shall contain  
 16 the name of the deceased, the date and time of death, the nature and circumstances of the death, and the  
 17 name(s) of CONTRACTOR's officers or employees with knowledge of the incident.

18 1. TELEPHONE NOTIFICATION – CONTRACTOR shall notify ADMINISTRATOR by  
 19 telephone immediately upon becoming aware of the death due to non-terminal illness of any person  
 20 served pursuant to this Agreement; notice need only be given during normal business hours.

### 21 2. WRITTEN NOTIFICATION

22 a. NON-TERMINAL ILLNESS – CONTRACTOR shall hand deliver, fax, and/or send  
 23 via encrypted email to ADMINISTRATOR a written report within sixteen (16) hours after becoming  
 24 aware of the death due to non-terminal illness of any person served pursuant to this Agreement.

25 b. TERMINAL ILLNESS – CONTRACTOR shall notify ADMINISTRATOR by written  
 26 report hand delivered, faxed, sent via encrypted email, within forty-eight (48) hours of becoming aware  
 27 of the death due to terminal illness of any person served pursuant to this Agreement.

28 c. When notification via encrypted email is not possible or practical CONTRACTOR may  
 29 hand deliver or fax to a known number said notification.

30 C. If there are any questions regarding the cause of death of any person served pursuant to this  
 31 Agreement who was diagnosed with a terminal illness, or if there are any unusual circumstances related  
 32 to the death, CONTRACTOR shall immediately notify ADMINISTRATOR in accordance with this  
 33 Notification of Death Paragraph.

34 D. All death reports must be verified by the coroner's office. The information should include date  
 35 of the death as well as the cause of death.

 12 accordance with this Agreement and all applicable requirements.

13 1. CONTRACTOR shall maintain records that are adequate to substantiate the services for  
 14 which claims are submitted for reimbursement under this Agreement and the charges thereto. Such  
 15 records shall include, but not be limited to, individual patient charts and utilization review records.

16 2. CONTRACTOR shall keep and maintain records of each service rendered to each MSN  
 17 Patient, the identity of the MSN Patient to whom the service was rendered, the date the service was  
 18 rendered, and such additional information as ADMINISTRATOR or DHCS may require.

19 3. CONTRACTOR shall maintain books, records, documents, accounting procedures and  
 20 practices, and other evidence sufficient to reflect properly all direct and indirect cost of whatever nature  
 21 claimed to have been incurred in the performance of this Agreement and in accordance with Medicare  
 22 principles of reimbursement and GAAP.

23 4. CONTRACTOR shall ensure the maintenance of medical records required by §70747  
 24 through and including §70751 of the CCR, as they exist now or may hereafter be amended, the medical  
 25 necessity of the service, and the quality of care provided. Records shall be maintained in accordance  
 26 with §51476 of Title 22 of the CCR, as it exists now or may hereafter be amended.

27 B. CONTRACTOR shall implement and maintain administrative, technical and physical  
 28 safeguards to ensure the privacy of PHI and prevent the intentional or unintentional use or disclosure of  
 29 PHI in violation of the HIPAA, federal and state regulations. CONTRACTOR shall mitigate to the  
 30 extent practicable, the known harmful effect of any use or disclosure of PHI made in violation of federal  
 31 or state regulations and/or COUNTY policies.

32 C. CONTRACTOR's participant, client, and/or patient records shall be maintained in a secure  
 33 manner. CONTRACTOR shall maintain participant, client, and/or patient records and must establish  
 34 and implement written record management procedures.

35 D. CONTRACTOR shall retain all financial records for a minimum of ten (10) years from the  
 36 termination of the contract, unless a longer period is required due to legal proceedings such as litigations

1 E. CONTRACTOR shall retain all client and/or patient medical records for ten (10) years  
2 following discharge of the participant, client and/or patient.

3 F. CONTRACTOR shall make records pertaining to the costs of services, participant fees, charges,  
4 billings, and revenues available at one (1) location within the limits of the County of Orange. If  
5 CONTRACTOR is unable to meet the record location criteria above, ADMINISTRATOR may provide  
6 written approval to CONTRACTOR to maintain records in a single location, identified by  
7 CONTRACTOR.

8 G. CONTRACTOR shall notify ADMINISTRATOR of any PRA requests related to, or arising out  
9 of, this Agreement, within forty-eight (48) hours. CONTRACTOR shall provide ADMINISTRATOR  
10 all information that is requested by the PRA request.

11 H. CONTRACTOR shall ensure all HIPAA DRS requirements are met. HIPAA requires that  
12 clients, participants and/or patients be provided the right to access or receive a copy of their DRS and/or  
13 request addendum to their records. Title 45 CFR §164.501, defines DRS as a group of records  
14 maintained by or for a covered entity that is:

15 1. The medical records and billing records about individuals maintained by or for a covered  
16 health care provider;

17 2. The enrollment, payment, claims adjudication, and case or medical management record  
18 systems maintained by or for a health plan; or

19 3. Used, in whole or in part, by or for the covered entity to make decisions about individuals.

20 I. CONTRACTOR may retain client, and/or patient documentation electronically in accordance  
21 with the terms of this Agreement and common business practices. If documentation is retained  
22 electronically, CONTRACTOR shall, in the event of an audit or site visit:

23 1. Have documents readily available within twenty-four (24) hour notice of a scheduled audit  
24 or site visit.

25 2. Provide auditor or other authorized individuals access to documents via a computer  
26 terminal.

27 3. Provide auditor or other authorized individuals a hardcopy printout of documents, if  
28 requested.

29 J. CONTRACTOR shall ensure compliance with requirements pertaining to the privacy and  
30 security of PII and/or PHI. CONTRACTOR shall, upon discovery of a Breach of privacy and/or  
31 security of PII and/or PHI by CONTRACTOR, notify federal and/or state authorities as required by law  
32 or regulation, and copy ADMINISTRATOR on such notifications.

33 K. CONTRACTOR may be required to pay any costs associated with a Breach of privacy and/or  
34 security of PII and/or PHI, including but not limited to the costs of notification. CONTRACTOR shall

36 L. CONTRACTOR shall obtain an NPI for each site identified as a location for providing

 5 each contract provider site and individual staff member that bills Medi-Cal to obtain an NPI from the  
 6 NPES. Each contract site, as well as every staff member that provides billable services, is responsible  
 7 for notifying the NPES within 30 calendar days of any updates to personal information, which may  
 8 include, but is not limited to, worksite address, name changes, taxonomy code changes, etc.

#### 10 **XXIV. RESEARCH AND PUBLICATION**

11 CONTRACTOR shall not utilize information and/or data received from COUNTY, or arising out  
 12 of, or developed, as a result of this Agreement for the purpose of personal or professional research, or  
 13 for publication.

#### 15 **XXV. REVENUE**

16 A. CLIENT FEES – CONTRACTOR shall not charge a fee to DMC beneficiaries to whom  
 17 services are provided pursuant to this Agreement, their estates and/or responsible relatives, unless a  
 18 Share of Cost is determined per Medi-Cal eligibility.

- 27 13. Producing any information that promotes responsible use, if the use is unlawful, of drugs or

b. 3.3 – Clinically Managed Population-Specific High-Intensity Residential Services means a twenty-four (24) hour structured living environment in combination with high-intensity clinical services for clients with significant cognitive impairment

c. 3.5 – Clinically Managed High-Intensity Residential Services means a twenty-four (24) hour residential care for clients who require a twenty-four (24) hour supportive treatment environment in order to develop sufficient recovery skills to avoid relapse or continued AOD use. It will include at least five (5) hours of clinical service/week.

6. Bed Day means one (1) calendar day during which CONTRACTOR provides services as described in this Exhibit A of the Agreement. If admission and discharge occur on the same day, one (1) Bed Day will be charged.

7. CalOMS is a statewide Client-based data collection and outcomes measurement system as required by the State to effectively manage and improve the provision of alcohol and drug treatment

1 services at the State, COUNTY, and provider levels.

2 8. Case Management or Care Coordination means services that assist a Client to access  
 3 needed medical, educational, social, prevocational, vocational, rehabilitative, or other community  
 4 services.

5 9. CESI/CEST are self-administered survey instruments designed to assess Clients'  
 6 motivation for change, engagement in treatment, social and peer support, and other psychosocial  
 7 indicators of progress in recovery.

8 10. Client means a person who has a substance use disorder, for whom a COUNTY-approved  
 9 intake and admission for Residential Treatment Services as appropriate have been completed pursuant to  
 10 this Agreement.

11 11. Clinical Component means services designed to improve a Client's ability to structure and  
 12 organize tasks of daily living and recovery.

13 12. Completion means the completion of the Residential Treatment Services program whereby  
 14 the Client has successfully completed goals and objectives documented in the Client's treatment plan  
 15 and no longer has medical necessity for the Residential Level of Care.

16 13. Co-Occurring is when a person has at least one substance use disorder and one mental  
 17 health disorder that can be diagnosed independently of each other.

18 14. DATAR is the DHCS system used to collect data on SUD treatment capacity and waiting  
 19 lists.

20 15. EPSDT means the federally mandated Medicaid benefit that entitles full-scope Medi-Cal-  
 21 covered beneficiaries less than twenty-one (21) years of age to receive any Medicaid service necessary  
 22 to correct or help to improve a defect, mental illness, or other condition, such as a substance-related  
 23 disorder, that is discovered during a health screening.

24 16. Incidental Medical Services means optional services, approved by DHCS to be provided at  
 25 a licensed adult alcoholism or drug use residential treatment facility by or under the supervision of a  
 26 LPHA that addresses medical issues associated with either detoxification or substance use.

27 17. Intake means the initial face-to-face meeting between a Client and CONTRACTOR staff in  
 28 which specific information about the Client is gathered including the ability to pay and standard  
 29 admission forms pursuant to this Agreement.

30 18. IRIS is a collection of applications and databases that serve the needs of programs within  
 31 HCA and includes functionality such as registration and scheduling, laboratory information system,  
 32 invoices and reporting capabilities, compliance with regulatory requirements, electronic medical records  
 33 and other relevant applications.

34 19. Linkage means connecting a Client to ancillary services such as outpatient and/or  
 35 residential treatment and supportive services which may include self-help groups, social services,  
 36 rehabilitation services, vocational services, job training services, or other appropriate services.

37 20. LPHA means any Physician, Nurse Practitioners, Physician Assistants, Registered Nurses,

1 Registered Pharmacists, Licensed Clinical Psychologists, Licensed Clinical Social Worker, Licensed  
 2 Professional Clinical Counselor, Licensed Marriage and Family Therapists, or Licensed Eligible  
 3 Practitioners working under the supervision of Licensed Clinicians, working within their scope of  
 4 practice.

5 21. MAT Services means the use of Federal Drug Administration-approved medications in  
 6 combination with behavioral therapies to provide a whole Client approach to treating substance use  
 7 disorders

8 22. Perinatal means the condition of being pregnant or Postpartum. This condition must be  
 9 documented to apply billing descriptor of perinatal attached to services.

10 23. Perinatal Residential Treatment Services means AOD treatment services that are provided  
 11 to a woman, eighteen (18) years and older, who is pregnant and/or has custody of dependent children up  
 12 to twelve (12) years of age, in her care; who has a primary problem of substance use disorder, and who  
 13 demonstrates a need for perinatal substance use disorder residential treatment services. Services are  
 14 provided in a twenty-four (24) hour residential program. These services are provided in a non-medical,  
 15 residential setting that has been licensed and certified by DHCS to provide perinatal services. These  
 16 treatment services are provided to both perinatal and parenting women in accordance with the Perinatal  
 17 Network Service Guidelines.

18 24. Postpartum means the 60-day period beginning on the last day of pregnancy, regardless of  
 19 whether other conditions of eligibility are met. Eligibility shall end on the last day of the calendar month  
 20 in which the 60th day occurs.

21 25. Recovery Services means billable services available after the client has completed a course  
 22 of treatment. Recovery services emphasize the client's central role in managing their health, use  
 23 effective self-management support strategies, and organize internal and community resources to provide  
 24 ongoing self-management support to patients.

25 26. Residential Treatment Authorization means the approval that is provided by the HCA ART  
 26 Team for a Client to receive residential services to ensure that the beneficiary meets the requirements for  
 27 the service. Decisions for service authorization are provided by the ART team for admission with  
 28 exception determined by the CONTRACTOR.

29 27. RTS means alcohol and other drug treatment services that are provided to Clients at a  
 30 twenty-four (24) hour residential program. Services are provided in an alcohol and drug free  
 31 environment and support recovery from alcohol and/or other drug related problems. These services are  
 32 provided in a non-medical, residential setting that has been licensed and certified by DHCS.

33 28. Self-Help Meetings means a non-professional, peer participatory meeting formed by people  
 34 with a common problem or situation offering mutual support to each other towards a goal or healing or  
 35 recovery.

36 29. Structured Therapeutic Activities means organized program activities that are designed to  
 37 meet treatment goals and objectives for increased social responsibility, self-motivation, and integration

1 into the larger community. Such activities would include participation in the social structure of the  
 2 residential program. It also includes the Client's progression, with increasing levels of responsibility and  
 3 independence through job and other assignments culminating in employment seeking and employment-  
 4 initiation activities in the community.

5 30. SUD means a condition in which the use of one or more substances leads to a clinically  
 6 significant impairment or distress per the DSM-5.

7 31. Token means the security device which allows an individual user to access IRIS.

8 32. Unfunded means individuals that are eligible for Medi-Cal but their benefits may not be  
 9 current for Orange County.

10 B. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the  
 11 Common Terms and Definitions Paragraph of this Exhibit A to the Agreement.

2 A. MEETINGS – CONTRACTOR’s Executive Director or designee shall participate, when

5 1. Active participation in regular SUD Quality Improvement (QI) Coordinators' meetings  
 6 organized by the Authority and Quality Improvement Services (AQIS) Quality Management program is  
 7 required for at least one dedicated program QI coordinator/professional

8 B. ALCOHOL AND/OR DRUG SCREENING

9 1. CONTRACTOR shall have a written policy and procedure statement regarding drug  
 10 screening that includes random drug and/or alcohol screen at a minimum of one (1) time per month for  
 11 the first thirty (30) calendar days and two (2) times per month for the remaining term of the agreement  
 12 for all Clients. All urine specimen collections shall be observed by same-sex or sex congruent staff.  
 13 This policy shall be approved by ADMINISTRATOR. A Client shall not be denied admittance to  
 14 treatment for a positive alcohol and/or drug screen at admission if they meet all other criteria for  
 15 admission. CONTRACTOR shall:

16 a. Establish procedures that protect against the falsification and/or contamination of any  
 17 body specimen sample collected for drug screening; and,

18 b. Assure that all urine specimen collections shall be observed by same-sex or sex

21 2. In the event CONTRACTOR wishes to utilize a COUNTY-contracted laboratory for drug  
 22 screening purposes, CONTRACTOR shall collect and label samples from Clients. Such testing shall be  
 23 provided at COUNTY’s expense. For tests not already covered in the County-contracted laboratory  
 24 agreement, CONTRACTOR must receive approval from ADMINISTRATOR prior to using COUNTY-  
 25 contracted laboratory for drug screenings.

26 3. In the event that any Client receives a drug test result indicating any substance abuse,  
 27 CONTRACTOR shall formulate and implement a plan of corrective action which shall be documented

 29 receipt of such test results via an incident report indicating the corrective action to be taken by the Client  
 30 if the Client is allowed to remain in the program.

31 C. CESI/CEST – CONTRACTOR shall have all Clients complete the CESI at the time of intake.  
 32 The CEST shall be completed at mid-point and at completion, and information incorporated in the  
 33 formulation of treatment plan.

34 1. CONTRACTOR shall ensure that surveys are completed as designated by  
 35 ADMINISTRATOR and accurately by designated Clients. This includes, but is not limited to, ensuring  
 36 surveys contain CONTRACTOR number, Client ID number, responses to all psychosocial questions,  
 37 along with other important Client and CONTRACTOR information, and fields filled and/or marked

1 appropriately.

2 2. CONTRACTOR shall photocopy the CESI and CEST surveys, place them in Client files,  
3 and submit the originals to ADMINISTRATOR once a month, by the tenth (10th) calendar day of each  
4 month.

5 3. CONTRACTOR shall adhere to all COUNTY CESI and CEST, reporting, and any other  
6 guidelines, as stipulated by ADMINISTRATOR, as they may now exist or as they may be revised  
7 and/or amended in the future, for the review, use and analysis of the CESI and CEST.

8 D. CULTURAL COMPETENCY – CONTRACTOR shall provide culturally competent services.  
9 CONTRACTORS must ensure that their policies, procedures, and practices are consistent with the  
10 principles outlined and are embedded in the organizational structure, as well as being upheld in day-to-  
11 day operations. Translation services must be available for beneficiaries, as needed. CONTRACTOR  
12 shall maintain documentation of such efforts which may include; but not be limited to: records of  
13 participation in COUNTY-sponsored or other applicable training; recruitment and hiring policies and  
14 procedures; copies of literature in multiple languages and formats, as appropriate; and descriptions of  
15 measures taken to enhance accessibility for, and sensitivity to, individuals who are physically  
16 challenged.

17 E. CONTRACTOR shall include bilingual/bicultural services to meet the needs of threshold  
18 languages as determined by COUNTY. Whenever possible, bilingual/bicultural staff should be retained.  
19 Any clinical vacancies occurring at a time when bilingual and bicultural composition of the clinical  
20 staffing does not meet the above requirement must be filled with bilingual and bicultural staff unless  
21 ADMINISTRATOR consents, in writing, to the filling of those positions with non-bilingual staff.  
22 Salary savings resulting from such vacant positions may not be used to cover costs other than salaries  
23 and employees benefits unless otherwise authorized in writing, in advance, by ADMINISTRATOR.

24 F. POSTINGS – CONTRACTOR shall post the following in a prominent place within the facility:

- 25 1. State Licensure and Certification
- 26 2. Business License
- 27 3. Conditional Use Permit (if applicable)
- 28 4. Fire clearance
- 29 5. Client rights
- 30 6. Grievance procedure
- 31 7. Employee Code of Conduct
- 32 8. Evacuation floor plan
- 33 9. Equal Employment Opportunity notices
- 34 10. Name, address, telephone number for fire department, crisis program, local law  
35 enforcement, and ambulance service.
- 36 11. List of resources within community which shall include medical, dental, mental health,  
37 public health, social services and where to apply for determination of eligibility for Federal, State, or

1 County entitlement programs.

2 12. Information on self-help meetings. AA, NA, and non-12 step meetings shall be included.

3 G. NO PROSELYTIZING POLICY – CONTRACTOR shall not conduct any proselytizing  
4 activities, regardless of funding sources, with respect to any person who has been referred to  
5 CONTRACTOR by COUNTY under the terms of this Agreement. Further, CONTRACTOR agrees that  
6 the funds provided hereunder shall not be used to promote, directly or indirectly, any religion, religious  
7 creed or cult, denomination or sectarian institution, or religious belief.

8 H. AUTHORITY – CONTRACTOR shall recognize the authority of OCPD as officers of the  
9 court, and shall extend cooperation to OCPD within the constraints of CONTRACTOR’s program of  
10 substance use disorder residential services.

11 I. NON-SMOKING POLICY – CONTRACTOR shall establish a written non-smoking policy  
12 which shall be reviewed and approved by ADMINISTRATOR. At a minimum, the non-smoking policy  
13 shall specify that the facility is “smoke free” and that designated smoking areas are outside the visiting  
14 areas at the facility.

15 J. CLIENT SIGN IN/OUT LOG AND SCHEDULE – CONTRACTOR shall maintain a resident  
16 sign in/out log for all residents, which shall include, but not be limited to, the following:

- 17 1. Client’s schedule for treatment, work, education or other activities;
- 18 2. Location and telephone number where the Client may be reached; and
- 19 3. Requirement for all Clients to notify the program of any change in his/her schedule.

20 K. GOOD NEIGHBOR POLICY – ADMINISTRATOR has established a Good Neighbor Policy  
21 for the purpose of identifying community impacts and measures to mitigate those impacts. The Good  
22 Neighbor Policy is a set of principles and activities designed to provide a consistent means of  
23 communication between facilities that provide client services and their respective neighbors. The Good  
24 Neighbor Policy is applicable for Residential Programs when CONTRACTOR provides service to  
25 County residents and the services have a potential impact including but not limited to community safety,  
26 cleanliness, and security in the surrounding neighborhood(s).

27 a. ADMINISTRATOR shall provide CONTRACTOR with a copy of the Good Neighbor Policy,  
28 attached hereto as Exhibit D.

29 b. CONTRACTOR agrees to adhere to the Good Neighbor Policy to the fullest extent possible. In  
30 addition, each facility shall develop a written procedure for the handling of neighborhood complaints  
31 which shall be approved by ADMINISTRATOR. Approved procedure must be available onsite, readily  
32 accessible upon request, and include ADMINISTRATOR’s contact information as provided.

33 c. Non-compliance with this Paragraph and Exhibit D shall constitute a material breach of this  
34 Agreement and constitute cause for immediate termination of this Agreement.

35 L. VISITATION POLICY – CONTRACTOR shall establish a written Visitation Policy, which  
36 shall be reviewed and approved by ADMINISTRATOR, which shall include, but not be limited to, the  
37 following:



1. Sign in logs;
2. Visitation hours; and
3. Designated visiting areas at the Facility.

M. TRANSGENDER POLICY – CONTRACTOR shall establish a written Transgender Policy, which shall be reviewed and approved by ADMINISTRATOR. The policy shall include, but not limited to, the following:

1. Admission
2. Housing arrangement
3. Bathroom privacy
4. Drug testing

~~N. MEDICATION POLICY – CONTRACTOR shall establish a written Medication Policy, which shall be reviewed and approved by ADMINISTRATOR. The policy shall include but not be limited to the securing, handling, and administration of medication(s) prescribed to the Client. The policy shall address Medications that are prescribed for substance and mental health disorders and medications disallowed by CONTRACTOR. Clients shall be allowed to have Medications during their stay with the program, and/or to have the ability to get refill(s).~~

~~— O. OPIOID OVERDOSE EMERGENCY TREATMENT – CONTRACTOR shall have available at each program site at minimum one (1) Naloxone Nasal Spray for the treatment of known or suspected opioid overdose. At least one (1) staff per shift shall be trained in administering the Naloxone Nasal Spray. Naloxone Nasal Spray is not a substitute for emergency medical care. CONTRACTOR shall always seek emergency medical assistance in the event of a suspected, potentially life-threatening opioid emergency.~~

N. MEDICATION POLICY – CONTRACTOR shall establish a written Medication Policy, which shall be reviewed and approved by ADMINISTRATOR. The policy shall include but not be limited to the securing, handling, and administration of medication(s) prescribed to the Client. The policy shall address Medications that are prescribed for substance and mental health disorders. Clients shall be allowed to have Medications during their stay with the program, and/or to have the ability to get refill(s).

O. OPIOID OVERDOSE EMERGENCY TREATMENT – CONTRACTOR shall have available at each program site at minimum two (2) unexpired Naloxone doses for the treatment of known or suspected opioid overdose. At least one (1) staff per shift shall be trained in administering the Naloxone. Naloxone is not a substitute for emergency medical care. CONTRACTOR shall always seek emergency medical assistance in the event of a suspected, potentially life-threatening opioid emergency.

P. TOKENS – ADMINISTRATOR will provide CONTRACTOR the necessary number of Tokens for appropriate individual staff to access IRIS at no cost to the CONTRACTOR.

1. CONTRACTOR recognizes that a Token is assigned to a specific individual staff member with a unique password. Tokens and passwords shall not be shared with anyone.

1 2. CONTRACTOR shall maintain an inventory of the Tokens, by serial number, and the staff  
2 member to whom each is assigned.

3 3. CONTRACTOR shall indicate in the monthly staffing report, the serial number of the  
4 Token for each staff member assigned a Token.

5 4. CONTRACTOR shall return to ADMINISTRATOR all Tokens under the following  
6 conditions:

- 7 a. Token of each staff member who no longer supports this Agreement.
- 8 b. Token of each staff member who no longer requires access to IRIS.
- 9 c. Token of each staff member who leaves employment of CONTRACTOR.
- 10 d. Tokens malfunctioning.

11 5. ADMINISTRATOR will issue Tokens for CONTRACTOR's staff members who require  
12 access to the IRIS upon initial training or as a replacement for malfunctioning Tokens. CONTRACTOR  
13 shall reimburse the COUNTY for Tokens lost, stolen, or damaged through acts of negligence.

17 ~~A. BASIS FOR REIMBURSEMENT—As compensation to CONTRACTOR for services provided

A. BASIS FOR REIMBURSEMENT – As compensation to CONTRACTOR for services provided pursuant to the Agreement, COUNTY shall pay CONTRACTOR monthly in arrears at the following rates of reimbursement; provided, however, the total of all such payments to CONTRACTOR and all other COUNTY CONTRACTORS for all substance use disorder treatment services for substance users shall not exceed COUNTY’S Maximum Obligation as set forth in the Referenced Contract Provisions of the Agreement; and provided further, that CONTRACTOR’S costs are allowable pursuant to applicable COUNTY, federal, and state regulations. Furthermore, if CONTRACTOR is ineligible to provide services due to non-compliance with licensure and/or certification standards of the state, COUNTY or OCPD, ADMINISTRATOR may elect to reduce COUNTY’S maximum obligation proportionate to the length of time that CONTRACTOR is ineligible to provide services. CONTRACTOR shall ensure compliance with all DMC billing and documentation requirements when entering Units of Service into COUNTY IRIS system. ADMINISTRATOR may reduce, withhold or delay any payment associated with non-compliant billing practices. If CAPs are not completed within timeframes as determined by ADMINISTRATOR, payments may be reduced accordingly.

1. For Medi-Cal services provided pursuant to the Agreement, COUNTY shall claim reimbursement to the State Medi-Cal unit on behalf of CONTRACTOR to the extent these services are eligible.

2. Proper DMC certification and enrollment with the Provider Enrollment Division (PED) of DHCS, through the Provider Application and Validation for Enrollment (PAVE) system is required.

1 CONTRACTOR shall submit proof of enrollment for each new rendering provider as required by  
 2 regulations. Failure to demonstrate provider enrollment within six months of services being rendered  
 3 shall result in disallowance of those services by pending providers.

4 3. CONTRACTOR shall submit appropriate Medi-Cal billing to ADMINISTRATOR on a  
 5 monthly basis. ADMINISTRATOR shall review billing and remit to Accounting for submission to the  
 6 State Medi-Cal unit.

7 4. CONTRACTOR shall assume responsibility for any audit disallowances or penalties  
 8 imposed on COUNTY by the State related to amounts or services claimed by COUNTY on behalf of  
 9 CONTRACTOR. CONTRACTOR shall reimburse COUNTY for any such disallowances or penalties  
 10 within thirty (30) days of written notification by COUNTY.

27 B. PAYMENT METHOD – COUNTY shall pay CONTRACTOR monthly in arrears,  
 28 however, that the total of such payments shall not exceed the COUNTY's Maximum Obligation.  
 29 CONTRACTOR's invoices shall be on a form approved or provided by ADMINISTRATOR and shall  
 30 provide such information as is required by ADMINISTRATOR. Invoices are due by the twentieth  
 31 (20th) calendar day of each month, and payments to CONTRACTOR should be released by COUNTY

10 ADMINISTRATOR. Additionally, to assist in the protection of data integrity, CONTRACTOR shall

25 A. FINANCIAL RECORDS – CONTRACTOR shall prepare and maintain accurate and complete  
26 financial records of its costs and operating expenses. Such records shall reflect the actual costs of the  
27 type of service for which payment is claimed in accordance with generally accepted accounting  
28 principles.

37 coverage, share of cost, and co-payments. Drug Medi-Cal is payment in full for treatment services

1 rendered for Medi-Cal beneficiaries.

2 B. CLIENT RECORDS – CONTRACTOR shall maintain adequate records in accordance with the  
3 licensing authority, DHCS, the COUNTY Guidelines, and CCR, Title 22, related to DMC on each  
4 individual Client in sufficient detail to permit an evaluation of services, which shall include, but not  
5 limited to:

6 1. Documentation of ADMINISTRATOR’s Residential Treatment Authorization for  
7 Residential Treatment Services.

8 2. Documentation that RTS for substance use disorders are appropriate for the Client. This  
9 shall include initial medical necessity determination for the DMC-ODS benefit performed through a  
10 face-to-face review by a LPHA. Additionally the ASAM Criteria assessment will be applied to  
11 determine placement into the level of assessed services and documented in the Client record.

12 3. Intake and admission data, including, if applicable, a physical examination;

13 4. Treatment plans;

14 5. Reassessments of client functioning based on ASAM criteria;

15 6. Progress notes;

16 7. Continuing services justifications;

17 8. Laboratory test orders and results;

18 9. Referrals;

19 10. Discharge plan;

20 11. Discharge summary;

21 12. Any other information relating to the treatment services rendered to the Client; and

22 13. A sign-in sheet for every group counseling session.

23 C. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the  
24 Records Paragraph of this Exhibit A to the Agreement.

## 25 26 **V. REPORTS**

### 27 **A. MONTHLY PROGRAMMATIC**

28 1. CONTRACTOR shall submit a monthly programmatic report to ADMINISTRATOR,  
29 including information required and on a form approved or provided by ADMINISTRATOR. These  
30 monthly programmatic reports should be submitted to ADMINISTRATOR no later than the tenth (10th)

~~intervals designated by ADMINISTRATOR. ADMINISTRATOR shall provide information/questions to CONTRACTOR for follow up. CONTRACTOR shall track data on Client functioning which at minimum shall include current substance use.~~

#### B. FISCAL

1. In support of the monthly invoice, CONTRACTOR shall submit monthly Expenditure and Revenue Reports to ADMINISTRATOR. These reports shall be on a form acceptable to, or provided by ADMINISTRATOR and shall report actual costs and revenues for each of the CONTRACTOR's program(s) or cost center(s) described in the Services Paragraph of Exhibit A to the Agreement. CONTRACTOR shall submit these reports by no later than twenty (20) calendar days following the end of the month reported.

2. CONTRACTOR shall submit Year-End Projection Reports to ADMINISTRATOR. These reports shall be on a form acceptable to, or provided by, ADMINISTRATOR and shall report anticipated year-end actual costs and revenues for CONTRACTOR's program(s) or cost center(s) described in the Services Paragraph of Exhibit A to the Agreement. Such reports shall include actual monthly costs and revenue to date and anticipated monthly costs and revenue to the end of the fiscal year. Year-End Projection Reports shall be submitted at the same time as the monthly Expenditure and Revenue Reports

C. MONTHLY IRIS – CONTRACTOR shall input all Units of Service provided in COUNTY's IRIS database for the preceding month no later than the fifth (5th) calendar day of the month following the report month.

D. CalOMS – CONTRACTOR shall complete a CalOMS encounter and a CalOMS admission record in IRIS within seven (7) calendar days of Client admission. CONTRACTOR shall complete a CalOMS discharge record in IRIS within seven (7) calendar days of Client discharge. CONTRACTOR shall run a CalOMS error report and correct any errors within two (2) business days of submitting the CalOMS admission or discharge, and continue to recheck until error free.

E. MONTHLY DATAR – CONTRACTOR shall provide reports under the DATAR, and/or any other State reporting system in a manner prescribed by ADMINISTRATOR, no later than the fifth (5th) calendar day of the month following the report month.

F. Access Log – CONTRACTOR shall track and enter information on requests for services into IRIS.

G. Level of Care Summaries – CONTRACTOR shall enter ASAM level of care information into IRIS on each ASAM level of care assessment completed.

H. ADDITIONAL REPORTS – CONTRACTOR shall make additional reports as required by ADMINISTRATOR concerning CONTRACTOR's activities as they affect the services hereunder. ADMINISTRATOR will be specific as to the nature of the information requested and the timeframe the information is needed.

I. CONTRACTOR agrees to enter psychometrics into COUNTY's EHR system as requested by

ADMINISTRATOR. Said psychometrics are for the COUNTY's analytical uses only, and shall not be relied upon by CONTRACTOR to make clinical decisions. CONTRACTOR agrees to hold COUNTY harmless, and indemnify pursuant to Section XI, from any claims that arise from non-COUNTY use of said psychometrics.

J. CONTRACTOR agrees to submit reports as required by the ADMINISTRATOR and/or the State.

K. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the Reports Paragraph of this Exhibit A to the Agreement.

## VI. SERVICES

A. FACILITY – CONTRACTOR shall operate a DHCS licensed substance use disorder residential treatment facility in accordance with the standards established by COUNTY and the State within the specifications stated below, unless otherwise authorized by the ADMINISTRATOR. Program shall have DMC certification and must be designated by DHCS as capable of delivering care consistent with ASAM treatment criteria. Residential services may be provided in facilities with no bed capacity limit. The environment shall be healthy and safe and the facility shall be clean and in good repair. Unless otherwise authorized in writing by ADMINISTRATOR, CONTRACTOR shall maintain regularly scheduled service hours, seven (7) days a week, twenty-four (24) hours per day, three hundred sixty-five (365) days a year. The facility will have, at a minimum: a kitchen, dining room, and laundry facilities, with enough space for leisure time and group activities. Services shall be provided at the following locations, or at any other location approved in advance, in writing, by ADMINISTRATOR:

 6 day average in the residential level of care based on medical necessity. At CONTRACTOR'S discretion,  
 7 CONTRACTOR may hold a Client's bed during a temporary absence. A temporary absence will be  
 8 seven (7) days or less during which the Client is absent from the program due to a brief hospitalization

C. PERSONS TO BE SERVED – In order to receive services through the DMC-ODS, the Client must be enrolled in Medi-Cal or plan to enroll in Medi-Cal, reside in Orange County, and meet medical necessity criteria, as outlined below.

D. MEDI-CAL ELIGIBILITY - MEDICAL NECESSITY

1. CONTRACTOR must verify the Medi-Cal eligibility determination of potential Clients.

2. ADMINISTRATOR will reimburse up to thirty (30) calendar days of treatment for unfunded Clients with realignment funding while CONTRACTOR assists Client in applying for benefits or transferring Medi-Cal benefits to Orange County. Exceptions to the thirty (30) calendar day maximum must be approved by ADMINISTRATOR. The Heath plan in IRIS will be assigned as “Self Pay”. When applying for Medi-Cal, client shall request that Medi-Cal coverage is retroactively applied to date of admission. If current Medi-Cal is assigned to a different county (not Orange County), Client must initiate transfer within ten (10) calendar days of admission. If county of responsibility is other than Orange County and county of residence in Medical Eligibility Data System is Orange County and Medi-Cal transfer has been initiated, CONTRACTOR shall enter Health plan as “Medi-Cal” in IRIS. These claims will be accepted by the State. If both county of responsibility and county of residence are other than Orange County, Contractor shall assign the Health plan as “Self-Pay”. CONTRACTOR shall review Self Pay Health Plan claims from the previous month and recheck eligibility status. If claims dates are covered by Medi-Cal, CONTRACTOR shall update the Health Plan and these claims will be automatically credited and re-dropped by the IRIS system.

3. Medical necessity for an adult [an individual age twenty-one (21) and over] is determined using the following criteria:

a. The individual must have received at least one diagnosis from the DSM for Substance-Related and Addictive Disorders with the exception of Tobacco-Related Disorders and Non-Substance-Related Disorders;

b. The individual must meet the ASAM Criteria definition of medical necessity for services based on the ASAM Criteria.

4. Individuals under age twenty-one (21) are eligible to receive Medicaid services pursuant to the EPSDT mandate. Under the EPSDT mandate, beneficiaries under the age twenty-one (21) are eligible to receive all appropriate and medically necessary services needed to correct and ameliorate health conditions that are coverable under section 1905(a) Medicaid authority. For individuals under 21

years of age, a service is “medically necessary” or a “medical necessity” if the service is necessary to correct or ameliorate screened health conditions. Consistent with federal guidance, services need not be curative or completely restorative to ameliorate a health condition, including substance misuse and SUDs. Services that sustain, support, improve, or make more tolerable substance misuse or a SUD are considered to ameliorate the condition and are thus covered as EPSDT services.

CONTRACTOR shall not admit any Client with outstanding warrants. Staff shall review OC Sheriff Department website for any warrants in Orange County, prior to admission.~~

~~7. CONTRACTOR shall initial services within reasonable promptness and shall have a documented system for monitoring and evaluating the quality, appropriateness, and accessibility of care, including a system for addressing problems that develop regarding admission wait times.~~

~~1. All residential treatment admissions require prior authorization from the ADMINISTRATOR.~~

~~2. Prior to requesting authorization CONTRACTOR shall conduct a brief ASAM screening provided by ADMINISTRATOR to predetermine level of care needed.~~

~~3. CONTRACTOR will notify the HCA BHS RPC if the initial brief screening indicates residential treatment is appropriate. HCA BHS maintains a centralized referral list and a daily count of available beds. The RPC will ensure the Client enters treatment as quickly as possible by designating placement at the program with an available bed (unless the Client is requesting a specific program). CONTRACTOR shall maintain a list of individuals who have been screened with the brief ASAM and are appropriate for residential treatment.~~

~~4. Admission into a residential bed shall require a LPHA to verify medical necessity once placed with CONTRACTOR. CONTRACTOR shall complete the DSM diagnosis and ASAM criteria assessment level of care determination to ensure that the Client meets the requirements for residential treatment.~~

10 2. CONTRACTOR shall have policies and procedures in place to screen for emergency  
 11 medical conditions and immediately refer beneficiaries to emergency medical care.

12 3. CONTRACTOR shall have a policy that requires a Client who shows signs of any  
 13 communicable disease or through medical disclosure during the intake process admits to a health-related  
 14 problem that would put others at risk, to be cleared medically before services are provided.

15 4. Admission Policy – CONTRACTOR shall establish and make available to the public a  
 16 written Admission Policy. ADMINISTRATOR may revise Admission Policy due to funding.  
 17 Admission Policy shall recognize the following specialty populations:

18 a. pregnant injection drug users.

19 b. pregnant substance abusers.

20 c. injection drug users.

21 5. CONTRACTOR's Admission Policy shall reflect all applicable federal, state, and county  
 22 regulations. CONTRACTOR shall have the right to refuse admission of a person only in accordance  
 23 with its written Admission Policy; provided, however, CONTRACTOR complies with the  
 24 Nondiscrimination provisions of this Agreement.

25 6. CONTRACTOR shall initiate services within reasonable promptness and shall have a  
 26 documented system for monitoring and evaluating the quality, appropriateness, and accessibility of care.

### 27 F. RESIDENTIAL TREATMENT AUTHORIZATION

28 1. Beneficiaries will be authorized and referred to CONTRACTOR by the ART Team.  
 29 Beneficiaries who contact CONTRACTOR directly to request services shall be referred by  
 30 CONTRACTOR to the ART Team. If Beneficiary is pregnant or an intravenous drug user who meets  
 31 medical necessity for Residential Treatment, CONTRACTOR may admit to treatment bypassing the  
 32 ART Team if provider has available bed slot. In this instance CONTRACTOR will complete a SUD  
 33 assessment and establish medical necessity for residential level of care. Assessment and authorization  
 34 request must be submitted to the ART team for authorization within 72 hours of beneficiary admission.  
 35 CONTRACTOR shall enter data regarding request for service into IRIS access log established by  
 36 ADMINISTRATOR for these beneficiaries who access provider directly and bypass the ART team.

37 2. If it is determined after assessing the beneficiary that the medical necessity criteria,

1 pursuant to DMC-ODS STCs 128 (e), has not been met, then a written Notice of Adverse Benefit  
 2 Determination shall be issued in accordance with 42 CFR 438.404 and 42 CFR Part 431, subpart E.

3 G. INFORMING MATERIALS – CONTRACTOR is responsible to distribute informing  
 4 materials and provider lists that meet the content requirements of 42 CRF 438.100 to beneficiaries when  
 5 they first access SUD services through the DMC-ODS and on request. Informing materials will be  
 6 provided by ADMINISTRATOR.

7 H. INTERIM SERVICES – All persons who are not admitted into RTS shall be referred to Interim  
 8 Services by CONTRACTOR. Interim Services shall be provided until an individual is admitted to  
 9 residential treatment program. The purposes of the services are to reduce the adverse health effects of  
 10 such abuse, promote the health of the individual, and reduce the risk of transmission of disease. At a  
 11 minimum, Interim Services include counseling and education about HIV and TB, about the risks of  
 12 needle-sharing, the risks of transmission to sexual partners and infants, and about steps that can be taken  
 13 to ensure that HIV and TB transmission does not occur, as well as referral for HIV or TB treatment  
 14 services if necessary. CONTRACTOR shall provide Clients, especially opiate users, with drug overdose  
 15 education/information. For pregnant women, Interim Services include counseling on the effects of  
 16 alcohol and drug use on the fetus, as well as referrals for prenatal care. Provision of Interim Services  
 17 shall be documented on the DATAR and reported monthly to the State.

18 I. SERVICES – CONTRACTOR shall provide a non-institutional, twenty-four (24) hour non-  
 19 medical, short-term residential program that provides rehabilitation services to beneficiaries in  
 20 accordance with an individualized treatment plan. These services are intended to be individualized to  
 21 treat the functional deficits identified in the ASAM Criteria. In the residential treatment environment, an  
 22 individual's functional cognitive deficits may require treatment that is primarily slower paced, more  
 23 concrete and repetitive in nature. The daily regimen and structured patterns of activities are intended to  
 24 restore cognitive functioning and build behavioral patterns within a community. Each Client shall live  
 25 on the premises and shall be supported in their efforts to restore, maintain and apply interpersonal and  
 26 independent living skills and access community support systems. CONTRACTORS and residents work  
 27 collaboratively to define barriers, set priorities, establish goals, create treatment plans, and solve  
 28 problems. Goals include sustaining abstinence, preparing for relapse triggers, improving personal health  
 29 and social functioning, and engaging in continuing care. Residential Treatment program shall consist  
 30 of the following:

31 1. Intake: The process of determining that a Client meets the medical necessity criteria and a  
 32 Client is admitted into a substance use disorder treatment program. Intake includes the evaluation or  
 33 analysis of substance use disorders; the diagnosis of substance use disorders; and the assessment of  
 34 treatment needs to provide medically necessary services. Intake may include a physical examination and  
 35 laboratory testing necessary for substance use disorder treatment.

36 2. Individual Counseling: Contacts between a Client and a therapist or counselor.

37 3. Group Counseling: Face-to-face contacts in which one or more therapists or counselors

1 treat two or more Clients at the same time with a maximum of twelve (12) in the group, focusing on the  
2 needs of the individuals served.

3 ~~4. Family Therapy: Family members can provide social support to the Client, help motivate  
4 their loved one to remain in treatment, and receive help and support for their own family recovery as  
5 well.~~

6 4. Family Therapy: When clinically appropriate, family members can provide social support  
7 to the Client, help motivate their loved one to remain in treatment, and receive help and support for their  
8 own family recovery as well.

9 5. Client Education: Provide research based education on addiction, treatment, recovery and  
10 associated health risks.

11 6. Medication Storage: Facilities will store all Client medication and facility staff members  
12 will oversee resident's self-administration of medication.

13 7. Collateral Services: Sessions with therapists or counselors and significant persons in the life  
14 of the Client, focused on the treatment needs of the Client in terms of supporting the achievement of the  
15 Client's treatment goals. Significant persons are individuals that have a personal, not official or  
16 professional, relationship with the Client.

17 8. Crisis Intervention Services: Contact between a therapist or counselor and a Client in crisis.  
18 Services shall focus on alleviating crisis problems. "Crisis" means an actual relapse or an unforeseen  
19 event or circumstance which presents to the Client an imminent threat of relapse. Crisis intervention  
20 services shall be limited to the stabilization of the Client's emergency situation.

21 9. Treatment Planning: The CONTRACTOR shall prepare an individualized written treatment  
22 plan, based upon information obtained in the intake and assessment process. The treatment plan will be  
23 completed within ten (10) days of admission and then updated every subsequent ninety (90) days unless  
24 there is a change in treatment modality or significant event that would then require a new treatment plan.

25 The treatment plan shall include:

- 26 a. A statement of problems to be addressed;
- 27 b. Goals to be reached which address each problem;
- 28 c. Action steps which will be taken by the CONTRACTOR and/or Client to accomplish  
29 identified goals;
- 30 d. Target dates for accomplishment of action steps and goals, and a description of services  
31 including the type of counseling to be provided and the frequency thereof;
- 32 e. Treatment plans have specific quantifiable goal/treatment objectives related to the  
33 Client's substance use disorder diagnosis and multidimensional assessment;
- 34 f. The treatment plan will identify the proposed type(s) of interventions/modality that  
35 includes a proposed frequency and duration; and
- 36 g. The treatment plan will be consistent with the qualifying diagnosis and will be signed  
37 by the Client and the LPHA.

1 10. Structured Therapeutic Activities: Residential Treatment Services shall consist of a  
2 minimum of twenty (20) hours of structured activity per week.

3 11. EBPs: CONTRACTORs will implement at least two of the following EBPs. The two EBPs  
4 are per CONTRACTOR per service modality. The required EBP include:

5 a. Motivational Interviewing: A Client-centered, empathetic, but directive counseling  
6 strategy designed to explore and reduce a person's ambivalence toward treatment. This approach  
7 frequently includes other problem-solving or solution-focused strategies that build on Clients' past  
8 successes.

9 b. Cognitive-Behavioral Therapy: Based on the theory that most emotional and behavioral  
10 reactions are learned and that new ways of reacting and behaving can be learned.

11 c. Relapse Prevention: A behavioral self-control program that teaches individuals with  
12 substance addiction how to anticipate and cope with the potential for relapse. Relapse prevention can be  
13 used as a stand-alone substance use treatment program or as an aftercare program to sustain gains  
14 achieved during initial substance use treatment.

15 d. Trauma-Informed Treatment: Services must take into account an understanding of  
16 trauma, and place priority on trauma survivors' safety, choice and control.

17 e. Psycho-Education: Psycho-educational groups are designed to educate Clients about  
18 substance abuse, and related behaviors and consequences. Psycho-educational groups provide  
19 information designed to have a direct application to Clients' lives; to instill self-awareness, suggest  
20 options for growth and change, identify community resources that can assist Clients in recovery,  
21 develop an understanding of the process of recovery, and prompt people using substances to take action  
22 on their own behalf.

23 12. ~~Case Management~~ Case Management or Care Coordination: Case Management or Care  
24 Coordination services may be provided by a LPHA or registered/ certified counselor and will be  
25 provided based on the frequency documented in the individualized treatment plan. Case management  
26 shall provide advocacy and care coordination to physical health, mental health, transportation, housing,  
27 vocational, educational, and transition services for reintegration into the community. CONTRACTOR  
28 shall provide Case Management services for the Client during treatment, transition to other levels of  
29 care and follow ups, to encourage the Client to engage and participate in an appropriate level of care or  
30 Recovery Services after discharge. Case Management or Care Coordination becomes the responsibility  
31 of the next treating provider after successful transition to a different level of care. Contractor shall  
32 ensure that Case Management or Care Coordination services focus on coordination of SUD care,  
33 integration around primary care especially for beneficiaries with a chronic SUD, and interaction with the  
34 criminal justice system, if needed. Case Management services may be provided face-to-face, by  
35 telephone, or by telehealth with the Client and may be provided anywhere in the community.

36 ~~13. MAT: CONTRACTORs will have procedures for linkage/integration for beneficiaries~~  
37 ~~requiring MAT. CONTRACTOR staff will regularly communicate with physicians of Clients who are~~



~~prescribed these medications in compliance with 42 CFR part 2.~~

13. Medication Assisted Treatment - MAT services may be provided onsite with approval for Incidental Medical Services from DHCS. Medically necessary MAT services must be provided in accordance with an individualized treatment plan determined by a licensed physician or LPHA working within their scope of practice.

a. MAT services must be provided in compliance with Policy and Procedures submitted to DHCS for IMS designation. CONTRACTOR must ensure ability to continue MAT after discharge through linkage to appropriate prescriber. MAT shall include the assessment, treatment planning, ordering, prescribing, administering, and monitoring of all medications for SUDs.

b. CONTRACTOR shall provide administration of buprenorphine, naltrexone (oral and injectable), acamprosate, disulfiram, and vivitrol. Other approved medications in the treatment of SUDs may also be prescribed and administered, as medically necessary.

c. CONTRACTOR must provide care coordination with treatment and ancillary service providers and facilitate transitions between levels of care. Clients may simultaneously participate in MAT services and other ASAM LOCs.

d. CONTRACTOR must participate in ADMINISTRATOR'S Medication Monitoring practices process as a quality assurance measure. Medication Monitoring is to assure the appropriateness of medication prescriptions for Mental Health and Recovery (MHRS) Clients and to establish practices for monitoring the safety and effectiveness of medication practices in MHRS.

14. Care Coordination for Mental and Physical Health: Programs must screen for mental health issues and provide or refer for needed services. CONTRACTOR shall notify Client's medical home provider of Client's admission to treatment within seven (7) days of admission and request medical records/ physical exam. If Client does not have a medical home, identifying one shall be on the treatment plan.

15. Physician Consultation: Physician Consultation Services include DMC physicians' consulting with addiction medicine physicians, addiction psychiatrists or clinical pharmacists. Physician consultation services are designed to assist DMC physicians by allowing them to seek expert advice with regards to designing treatment plans for specific DMC-ODS beneficiaries. Physician consultation services may address medication selection, dosing, side effect management, adherence, drug interactions, or level of care considerations. ADMINISTRATOR will provide one or more physicians or pharmacists to provide consultation services.

16. Discharge Services: The process to prepare the Client for referral into another level of care, post treatment return or reentry into the community, and/or the linkage of the individual to essential community treatment, housing and human services. CONTRACTOR shall provide or arrange for transportation of Clients to aftercare destination. CONTRACTOR shall begin discharge planning immediately after enrollment.

a. Discharge Plan – CONTRACTOR shall develop a formal discharge plan within fourteen

1 (14) calendar days prior to Client's planned discharge from the program. A discharge plan is to be  
 2 completed for each Client, except a Client with whom the provider loses contact. The discharge  
 3 plan shall be completed and signed by the LPHA or counselor and the Client. A copy of the discharge  
 4 plan shall be provided to the Client and retained in the Client's record. The discharge plan shall include,  
 5 but not be limited to, all of the following:

- 6 1) A description of each of the Client's relapse triggers;
- 7 2) A plan to assist the Client to avoid relapse when confronted with each trigger;
- 8 3) A support plan;
- 9 4) Goals identified in the treatment plan; and

10 ~~5) Referrals to appropriate resources.~~

11 5) Referrals and linkages to appropriate resources.

12 b. Discharge Summary – The discharge summary is to be completed by the LPHA or  
 13 counselor within thirty (30) calendar days of the date of the last face-to-face treatment contact with the  
 14 Client. The discharge summary shall include all of the following:

- 15 1) The duration of the Client's treatment as determined by the dates of admission and  
 16 discharge from treatment;
- 17 2) The reason for discharge, including whether the discharge was voluntary or  
 18 involuntary and whether the client successfully completed the program;
- 19 3) A narrative summary of the treatment episode;
- 20 4) The Client's prognosis;
- 21 5) Current alcohol and/or drug usage;
- 22 6) Vocational and educational achievements;
- 23 7) Legal status;
- 24 8) Linkages and referrals made;
- 25 9) Clients comments; and
- 26 10) A description of the Client's goals and achievement towards those goals as  
 27 described in the Client's treatment plan.

28 17. Recovery Services: Clients may access recovery services after completing their course of  
 29 treatment to prevent relapse. Recovery services may be provided face-to-face, by telephone, or by  
 30 telehealth with the Client and may be provided anywhere in the community. Recovery services shall be  
 31 made available to DMC-ODS beneficiaries when a Medical Director or LPHA has determined that  
 32 recovery services are medically necessary in accordance with their individualized treatment plan. The  
 33 components of Recovery Services are:

- 34 a. Outpatient counseling services in the form of individual or group counseling to stabilize  
 35 the Client and then reassess if the Client needs further care;
- 36 b. Recovery Monitoring: Recovery coaching, monitoring via telephone and internet;
- 37 c. Substance Abuse Assistance: Peer-to-peer services and relapse prevention;

1 d. Education and Job Skills: Linkages to life skills, employment services, job training, and  
2 education services;

3 e. Family Support: Linkages to childcare, parent education, child development support  
4 services, family/marriage education;

5 f. Support Groups: Linkages to self-help and support, spiritual and faith-based support;

6 g. Ancillary Services: Linkages to housing assistance, transportation, case management,  
7 individual services coordination.

8 18. Food and Other Services: CONTRACTOR shall provide a clean, safe environment,  
9 toiletries, clean linen, and food service.

10 19. Support Services: CONTRACTOR shall provide housekeeping, which may be done by  
11 Clients; laundry access; and maintenance.

12 20. Health, Medical, Psychiatric and Emergency Services – CONTRACTOR shall ensure that  
13 all persons admitted for Residential Treatment services have a health questionnaire completed using  
14 form DHCS 5103 form, or may develop their own form provided it contains, at a minimum, the  
15 information requested in the DHCS 5103 form.

16 a. The health questionnaire is a Client's self-assessment of his/her current health status  
17 and shall be completed by Client.

18 1) CONTRACTOR shall review and approve the health questionnaire form prior to  
19 Client's admission to the program. The completed health questionnaire shall be signed and dated by  
20 CONTRACTOR and Client, prior to admission.

21 2) A copy of the questionnaire shall be filed in the Client's record.

22 b. CONTRACTOR shall, based on information provided by Client on the health  
23 questionnaire form, refer Client to licensed medical professionals for physical and laboratory  
24 examinations as appropriate.

25 1) CONTRACTOR shall obtain a copy of Client's medical clearance or release prior  
26 to Client's admission to the program when applicable.

27 2) A copy of the referral and clearance shall be filed in the Client's file.

28 3) CONTRACTOR shall provide directly or by referral: HIV education, voluntary,  
29 HIV antibody testing and risk assessment and disclosure counseling.

30 4) The programs shall have written procedures for obtaining medical or psychiatric  
31 evaluation and emergency and non-emergency services.

32 5) The programs shall post the name, address, and telephone number for the fire  
33 department, a crisis program, local law enforcement, and ambulance service.

34 6) CONTRACTOR shall provide TB services to the Clients by referral to the  
35 COUNTY or another appropriate provider. TB services shall be provided within seven (7) calendar  
36 days of admission. These TB services shall consist of the following:

37 a) Counseling with respect to TB;

1                   b) Testing to determine whether the individual has been infected and to determine  
2 the appropriate form of treatment;

3                   c) Provision for, or referral of, infected Clients for medical evaluation, treatment  
4 and clearance. CONTRACTOR shall ensure that a TB-infected Client is medically cleared prior to  
5 commencing treatment.

6                   21. Transportation Services

7                   a. COUNTY shall only pay for medical ambulance or medical van transportation to and  
8 from designated residential substance use disorder treatment programs or health facilities through the  
9 COUNTY's Medical Transportation Agreement under the following conditions:

10                   1) Ambulance transportation shall be used for services requiring immediate attention  
11 for a Client due to any sudden or serious illness or injury requiring immediate medical attention, where  
12 delay in providing such services may aggravate the medical condition or cause the loss of life.

13                   2) When any Client needs non-emergency transportation as identified in  
14 Subparagraph 22.b below, and CONTRACTOR cannot transport Client due to unforeseen circumstances  
15 including, but not limited to, staffing constraints, CONTRACTOR vehicle access within a timely  
16 manner or Client's physical condition and/or limitations.

17                   3) CONTRACTOR shall utilize the COUNTY's Ambulance Monthly Rotation Call  
18 Log to request transportation services from Ambulance Providers designated for transportation within  
19 the city of the CONTRACTOR's facility for each said month as identified on the log.

20                   4) CONTRACTOR shall use its best efforts to contact Ambulance Providers  
21 identified on the Monthly Rotation Call Log as those providers who offer van transportation services if  
22 and when an ambulance is not required.

23                   5) CONTRACTOR shall be held liable and may be billed by the Ambulance Provider  
24 for services requested by CONTRACTOR that are deemed inappropriate for use and not a covered  
25 service under this section by the COUNTY.

26                   b. Non-Emergency Transportation – CONTRACTOR shall transport Client to locations  
27 that are considered necessary and/or important to the Client's recovery plan including, but not limited to,  
28 Social Security Administration offices for Supplemental Security Income benefits and for non-  
29 emergency medical or mental health services not identified in Subparagraph 22.a. above, that require  
30 treatment at a physician office, urgent care, or emergency room when an ambulance provider is not  
31 necessary or required for transportation based on the level of severity and/or services required by the  
32 Client.

33                   J. RESIDENTIAL LEVELS OF CARE – CONTRACTOR shall provide services in accordance  
34 with one of the following ~~ASAM-Designated~~ DHCS Levels of Care:

35                   1. 3.1 – Clinically Managed Low-Intensity Residential Services: Services provided under a  
36 level 3.1 designation includes the following:

37                   a. Clinical Component:

1 1) Planned clinical program activities (at least five (5) hours/week) directed to  
2 stabilize the Client's SUD symptoms, increase motivation, and develop recovery skills;

3 2) Counseling and clinical monitoring to support involvement in productive daily  
4 living activities;

5 3) Drug Screening and monitoring of medication adherence;

6 4) Recovery support services, including support for the affected family addiction  
7 pharmacotherapy; and

8 5) Residential Component:

9 a) Structured recovery environment with twenty-four (24) hour staffing;

10 b) Community house meetings and responsibilities to promote community  
11 recovery concepts and norms; and

12 c) Introduction of Client to local recovery community and resources

13 b. Support Systems:

14 1) Telephone or in-person consultation with a physician and emergency services  
15 available twenty-four (24) hours/day, seven (7) days/week;

16 2) Direct affiliations with other levels of care with close coordination of transfer to  
17 more intensive levels of care, medication management, and housing services; and

18 3) Ability to arrange for needed procedures as appropriate to the severity and urgency  
19 of the Client's condition—to include obtaining pharmacotherapy for psychiatric and anti-addiction  
20 medications.

21 2. 3.3 – Clinically Managed Population Specific High-Intensity Residential Services: Services  
22 provided under a Level 3.3 designation includes the following:

23 a. Clinical Component:

24 1) Daily clinical services to improve Client's ability to structure and organize adult  
25 daily living tasks and succeed in productive daily activities such as work or school;

26 2) Clinical programming to stabilize Client's addiction symptoms and develop  
27 recovery skills, which may include a range of cognitive and/or behavioral therapies administered on an  
28 individual and group basis;

29 3) Drug Screening and monitoring of medication adherence; and

30 4) Recovery support services, including support for the affected family.

31 b. Assessment: Level 3.3 programs are to provide a thorough biopsychosocial assessment

32 c. Treatment Planning and Documentation

33 d. Support Systems:

34 1) Telephone or in-person consultation with a physician and emergency services  
35 available twenty-four (24) hours/day, seven (7) days/week;

36 2) Direct affiliations with other levels of care with close coordination of transfer to  
37 more intensive levels of care, medication management, and housing services; and

1 3) Medical, psychiatric, psychological, laboratory and toxicology services available  
2 through consultation or referral.

3 3. 3.5 – Clinically Managed High-Intensity Residential Services: Services provided under a  
4 Level 3.5 designation includes the following:

- 5 a. Planned, evidence-based clinical program activities (at least five (5) hours a week) and  
6 professional services to stabilize addiction symptoms and develop recovery skills;
- 7 b. Daily organized programming to improve Client’s ability to structure and organize  
8 tasks of daily living and recovery;
- 9 c. Counseling and clinical monitoring to support involvement in productive daily living  
10 activities;
- 11 d. Drug Screening and monitoring of medication adherence;
- 12 e. Planned community reinforcement designed to foster prosocial values and community  
13 living skills;
- 14 f. Recovery support services, including support for the affected family; and
- 15 g. Addiction pharmacotherapy

#### 16 K. PERFORMANCE OUTCOMES

17 1. CONTRACTOR shall achieve performance objectives, tracking and reporting Performance  
18 Outcome Objective statistics in monthly programmatic reports, as appropriate. ADMINISTRATOR  
19 recognizes that alterations may be necessary to the following services to meet the objectives, and,  
20 therefore, revisions to objectives and services may be implemented by mutual agreement between  
21 CONTRACTOR and ADMINISTRATOR.

#### 22 2. Performance Outcome Objectives

23 a. Objective 1: CONTRACTOR shall provide effective residential substance abuse  
24 assessment, treatment, and counseling to Clients with identified alcohol and/or drug problems as  
25 measured by Retention and Completion Rates:

26 1) Retention Rates shall be calculated by using the number of Clients currently  
27 enrolled in or successfully completing the treatment program divided by the total number of Clients  
28 served during the evaluation period.

29 2) Completion Rates shall be calculated by using the number of Clients successfully  
30 completing the treatment program divided by the total number of Clients discharged during the  
31 evaluation period. Fifty percent (50%) of Clients will complete residential treatment program.

32 b. Objective 2: CEST scores at midpoint and completion will be higher than national  
33 norms in perceived social support, peer support, counseling rapport, and treatment participation. CEST  
34 scores for treatment readiness and desire for help will exceed national norms and will be equal to or  
35 higher than CESI scores at intake;

36 ~~e. Objective 3: Ninety percent (90%) of Clients who complete satisfaction survey will~~  
37 ~~agree or strongly agree that they are “overall satisfied with the services received” and ninety percent~~

~~(90%) or Clients surveyed will agree or strongly agree that they would recommend the program to someone they know; and~~

~~d. Objective 4: Upon successful completion of treatment, seventy-five percent (75%) of Clients will report at thirty (30) days that their life is more manageable than it was when they entered treatment.~~

c. Objective 3: CONTRACTOR shall provide linkage to the next level of care for Clients upon discharge. Twenty percent (20%) of Clients who have discharged will be linked with a lower level of care within seven (7) days, as measured by charge data entered into the IRIS. Linkage rates for Clients who discharge will include all CalOMS standard discharge dispositions. All CalOMS administrative discharge dispositions will be excluded.

L. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the Services paragraph of this Exhibit A to the Agreement.

## VII. STAFFING

A. CONTRACTOR shall provide twenty-four (24) hour supervision with at least one (1) staff member on-site at all times. Residential programs shall require twenty-four (24)-hour awake supervision.

B. Professional staff shall undergo the HCA credentialing process by the AQIS Managed Care Support Team (MCST) prior to rendering any Medi-Cal covered services.

1. The Contractor shall comply with the requirements of the state's established uniform credentialing and re-credentialing policy that addresses behavioral and substance use disorders, outlined in DHCS Information Notice 18-019.

2. The Contractor shall follow the county's process for credentialing and re-credentialing of network providers and shall ensure that all registered, licensed or certified staff who deliver Medi-Cal covered services are properly credentialed by the county before delivering any Medi-Cal covered services.

C. Professional staff shall be licensed, registered, certified or recognized under California scope of practice statutes. Professional staff shall provide services within their individual scope of practice and receive supervision required under their scope of practice laws.

D. Non-professional staff shall receive appropriate onsite orientation and training prior to performing assigned duties. Non-professional staff shall be supervised by professional and/or administrative staff.

F. Registered and certified SUD counselors shall adhere to all requirements in the CCR, Title 9, Division 4, Chapter 8.

12 A. GENERAL PROVISIONS AND RECITALS

13 1. The parties agree that the terms used, but not otherwise defined in the Common Terms and  
 14 Definitions Paragraph of Exhibit B to the Agreement or in Subparagraph B below, shall have the same  
 15 meaning given to such terms under HIPAA, the HITECH Act, and their implementing regulations at 45  
 16 CFR Parts 160 and 164 (the HIPAA regulations) as they may exist now or be hereafter amended.

17 2. The parties agree that a business associate relationship under HIPAA, the HITECH Act,  
 18 and the HIPAA regulations between the CONTRACTOR and COUNTY arises to the extent that  
 19 CONTRACTOR performs, or delegates to subcontractors to perform, functions or activities on behalf of  
 20 COUNTY pursuant to, and as set forth in, the Agreement that are described in the definition of  
 21 “Business Associate” in 45 CFR § 160.103.

22 3. The COUNTY wishes to disclose to CONTRACTOR certain information pursuant to the  
 23 terms of the Agreement, some of which may constitute PHI, as defined below in Subparagraph B.10, to  
 24 be used or disclosed in the course of providing services and activities pursuant to, and as set forth, in the  
 25 Agreement.

26 4. The parties intend to protect the privacy and provide for the security of PHI that may be  
 27 created, received, maintained, transmitted, used, or disclosed pursuant to the Agreement in compliance  
 28 with the applicable standards, implementation specifications, and requirements of HIPAA, the HITECH  
 29 Act, and the HIPAA regulations as they may exist now or be hereafter amended.

30 5. The parties understand and acknowledge that HIPAA, the HITECH Act, and the HIPAA  
 31 regulations do not pre-empt any state statutes, rules, or regulations that are not otherwise pre-empted by  
 32 other Federal law(s) and impose more stringent requirements with respect to privacy of PHI.

33 6. The parties understand that the HIPAA Privacy and Security rules, as defined below in  
 34 Subparagraphs B.9 and B.14, apply to the CONTRACTOR in the same manner as they apply to the  
 35 covered entity (COUNTY). CONTRACTOR agrees therefore to be in compliance at all times with the  
 36 terms of this Business Associate Contract as it exists now or be hereafter updated with notice to  
 37 CONTRACTOR, and the applicable standards, implementation specifications, and requirements of the

1 Privacy and the Security rules, as they may exist now or be hereafter amended, with respect to PHI and  
2 electronic PHI created, received, maintained, transmitted, used, or disclosed pursuant to the Agreement.

3 B. DEFINITIONS

4 1. "Administrative Safeguards" are administrative actions, and policies and procedures, to  
5 manage the selection, development, implementation, and maintenance of security measures to protect  
6 electronic PHI and to manage the conduct of CONTRACTOR's workforce in relation to the protection

8 2. "Breach" means the acquisition, access, use, or disclosure of PHI in a manner not permitted

22 b. Except as provided in paragraph (a) of this definition, an acquisition, access, use, or  
23 disclosure of PHI in a manner not permitted under the HIPAA Privacy Rule is presumed to be a breach  
24 unless CONTRACTOR demonstrates that there is a low probability that the PHI has been compromised  
25 based on a risk assessment of at least the following Factors:

26 1) The nature and extent of the PHI involved, including the types of identifiers and the

28 2) The unauthorized person who used the PHI or to whom the disclosure was made;

29 3) Whether the PHI was actually acquired or viewed; and

30 4) The extent to which the risk to the PHI has been mitigated.

32 Rule in 45 CFR § 164.501.

33 4. "DRS" shall have the meaning given to such term under the HIPAA Privacy Rule in 45

35 5. "Disclosure" shall have the meaning given to such term under the HIPAA regulations in 45  
36 CFR § 160.103.

1           6. “Health Care Operations” shall have the meaning given to such term under the HIPAA

3           7. “Individual” shall have the meaning given to such term under the HIPAA Privacy Rule in

6           8. “Physical Safeguards” are physical measures, policies, and procedures to protect

8 and environmental hazards, and unauthorized intrusion.

9           9. “The HIPAA Privacy Rule” shall mean the Standards for Privacy of Individually  
10 Identifiable Health Information at 45 CFR Part 160 and Part 164, Subparts A and E.

11           10. “PHI” shall have the meaning given to such term under the HIPAA regulations in 45 CFR §  
12 160.103.

13           11. “Required by Law” shall have the meaning given to such term under the HIPAA Privacy  
14 Rule in 45 CFR § 164.103.

15           12. “Secretary” shall mean the Secretary of the Department of Health and Human Services or  
16 his or her designee.

17           13. “Security Incident” means attempted or successful unauthorized access, use, disclosure,  
18 modification, or destruction of information or interference with system operations in an information  
19 system. “Security incident” does not include trivial incidents that occur on a daily basis, such as scans,  
20 “pings”, or unsuccessful attempts to penetrate computer networks or servers maintained by  
21 CONTRACTOR.

22           14. “The HIPAA Security Rule” shall mean the Security Standards for the Protection of ePHI at  
23 45 CFR Part 160, Part 162, and Part 164, Subparts A and C.

24           15. “Subcontractor” shall have the meaning given to such term under the HIPAA regulations in  
25 45 CFR § 160.103.

26           16. “Technical safeguards” means the technology and the policy and procedures for its use that  
27 protect ePHI and control access to it.

28           17. “Unsecured PHI” or “PHI that is unsecured” means PHI that is not rendered unusable,  
29 unreadable, or indecipherable to unauthorized individuals through the use of a technology or  
30 methodology specified by the Secretary of HHS in the guidance issued on the HHS Web site.

31           18. “Use” shall have the meaning given to such term under the HIPAA regulations in 45 CFR §  
32 160.103.

33           C. OBLIGATIONS AND ACTIVITIES OF CONTRACTOR AS BUSINESS ASSOCIATE:

34           1. CONTRACTOR agrees not to use or further disclose PHI COUNTY discloses to  
35 CONTRACTOR other than as permitted or required by this Business Associate Contract or as required  
36 by law.

12 not provided for by this Business Associate Contract of which CONTRACTOR becomes aware.  
13 CONTRACTOR must report Breaches of Unsecured PHI in accordance with Subparagraph E below and  
14 as required by 45 CFR § 164.410.

15           6. CONTRACTOR agrees to ensure that any Subcontractors that create, receive, maintain, or  
16 transmit PHI on behalf of CONTRACTOR agree to the same restrictions and conditions that apply  
17 through this Business Associate Contract to CONTRACTOR with respect to such information.

18           7. CONTRACTOR agrees to provide access, within fifteen (15) calendar days of receipt of a  
19 written request by COUNTY, to PHI in a DRS, to COUNTY or, as directed by COUNTY, to an  
20 Individual in order to meet the requirements under 45 CFR § 164.524. If CONTRACTOR maintains an  
21 EHR with PHI, and an individual requests a copy of such information in an electronic format,  
22 CONTRACTOR shall provide such information in an electronic format.

23           8. CONTRACTOR agrees to make any amendment(s) to PHI in a DRS that COUNTY directs  
24 or agrees to pursuant to 45 CFR § 164.526 at the request of COUNTY or an Individual, within thirty  
25 (30) calendar days of receipt of said request by COUNTY. CONTRACTOR agrees to notify COUNTY  
26 in writing no later than ten (10) calendar days after said amendment is completed.

27           9. CONTRACTOR agrees to make internal practices, books, and records, including P&Ps,  
28 relating to the use and disclosure of PHI received from, or created or received by CONTRACTOR on  
29 behalf of, COUNTY available to COUNTY and the Secretary in a time and manner as determined by  
30 COUNTY or as designated by the Secretary for purposes of the Secretary determining COUNTY's  
31 compliance with the HIPAA Privacy Rule.

32           10. CONTRACTOR agrees to document any Disclosures of PHI COUNTY discloses to  
33 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY,  
34 and to make information related to such Disclosures available as would be required for COUNTY to  
35 respond to a request by an Individual for an accounting of Disclosures of PHI in accordance with 45  
36 CFR § 164.528.

37 //

1 11. CONTRACTOR agrees to provide COUNTY or an Individual, as directed by COUNTY, in  
2 a time and manner to be determined by COUNTY, that information collected in accordance with the  
3 Agreement, in order to permit COUNTY to respond to a request by an Individual for an accounting of  
4 Disclosures of PHI in accordance with 45 CFR § 164.528.

5 12. CONTRACTOR agrees that to the extent CONTRACTOR carries out COUNTY's  
6 obligation under the HIPAA Privacy and/or Security rules CONTRACTOR will comply with the  
7 requirements of 45 CFR Part 164 that apply to COUNTY in the performance of such obligation.

8 13. If CONTRACTOR receives Social Security data from COUNTY provided to COUNTY by  
9 a state agency, upon request by COUNTY, CONTRACTOR shall provide COUNTY with a list of all  
10 employees, subcontractors, and agents who have access to the Social Security data, including  
11 employees, agents, subcontractors, and agents of its subcontractors.

12 14. CONTRACTOR will notify COUNTY if CONTRACTOR is named as a defendant in a  
13 criminal proceeding for a violation of HIPAA. COUNTY may terminate the Agreement, if  
14 CONTRACTOR is found guilty of a criminal violation in connection with HIPAA. COUNTY may  
15 terminate the Agreement, if a finding or stipulation that CONTRACTOR has violated any standard or  
16 requirement of the privacy or security provisions of HIPAA, or other security or privacy laws are made  
17 in any administrative or civil proceeding in which CONTRACTOR is a party or has been joined.  
18 COUNTY will consider the nature and seriousness of the violation in deciding whether or not to  
19 terminate the Agreement.

20 15. CONTRACTOR shall make itself and any subcontractors, employees or agents assisting  
21 CONTRACTOR in the performance of its obligations under the Agreement, available to COUNTY at  
22 no cost to COUNTY to testify as witnesses, or otherwise, in the event of litigation or administrative  
23 proceedings being commenced against COUNTY, its directors, officers or employees based upon  
24 claimed violation of HIPAA, the HIPAA regulations or other laws relating to security and privacy,  
25 which involves inactions or actions by CONTRACTOR, except where CONTRACTOR or its  
26 subcontractor, employee, or agent is a named adverse party.

27 16. The Parties acknowledge that federal and state laws relating to electronic data security and  
28 privacy are rapidly evolving and that amendment of this Business Associate Contract may be required to  
29 provide for procedures to ensure compliance with such developments. The Parties specifically agree to  
30 take such action as is necessary to implement the standards and requirements of HIPAA, the HITECH  
31 Act, the HIPAA regulations and other applicable laws relating to the security or privacy of PHI. Upon  
32 COUNTY's request, CONTRACTOR agrees to promptly enter into negotiations with COUNTY  
33 concerning an amendment to this Business Associate Contract embodying written assurances consistent  
34 with the standards and requirements of HIPAA, the HITECH Act, the HIPAA regulations or other  
35 applicable laws. COUNTY may terminate the Agreement upon thirty (30) days written notice in the  
36 event:

37 //

1 a. CONTRACTOR does not promptly enter into negotiations to amend this Business  
2 Associate Contract when requested by COUNTY pursuant to this Subparagraph F; or

3 b. CONTRACTOR does not enter into an amendment providing assurances regarding the  
4 safeguarding of PHI that COUNTY deems are necessary to satisfy the standards and requirements of  
5 HIPAA, the HITECH Act, and the HIPAA regulations.

6 17. CONTRACTOR shall work with COUNTY upon notification by CONTRACTOR to  
7 COUNTY of a Breach to properly determine if any Breach exclusions exist as defined in Subparagraph  
8 B.2.a above.

9 D. SECURITY RULE

10 1. CONTRACTOR shall comply with the requirements of 45 CFR § 164.306 and establish  
11 and maintain appropriate Administrative, Physical and Technical Safeguards in accordance with 45 CFR  
12 § 164.308, § 164.310, and § 164.312, with respect to electronic PHI COUNTY discloses to  
13 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY.  
14 CONTRACTOR shall develop and maintain a written information privacy and security program that  
15 includes Administrative, Physical, and Technical Safeguards appropriate to the size and complexity of  
16 CONTRACTOR's operations and the nature and scope of its activities.

17 2. CONTRACTOR shall implement reasonable and appropriate policies and procedures to  
18 comply with the standards, implementation specifications and other requirements of 45 CFR Part 164,  
19 Subpart C, in compliance with 45 CFR § 164.316. CONTRACTOR will provide COUNTY with its  
20 current and updated policies upon request.

21 3. CONTRACTOR shall ensure the continuous security of all computerized data systems  
22 containing electronic PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives,  
23 maintains, or transmits on behalf of COUNTY. CONTRACTOR shall protect paper documents  
24 containing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives,  
25 maintains, or transmits on behalf of COUNTY. These steps shall include, at a minimum:

26 a. Complying with all of the data system security precautions listed under Subparagraphs  
27 E, below;

28 b. Achieving and maintaining compliance with the HIPAA Security Rule, as necessary in  
29 conducting operations on behalf of COUNTY;

30 c. Providing a level and scope of security that is at least comparable to the level and scope  
31 of security established by the OMB in OMB Circular No. A-130, Appendix III – Security of Federal  
32 Automated Information Systems, which sets forth guidelines for automated information systems in  
33 Federal agencies;

34 4. CONTRACTOR shall ensure that any subcontractors that create, receive, maintain, or  
35 transmit ePHI on behalf of CONTRACTOR agree through a contract with CONTRACTOR to the same  
36 restrictions and requirements contained in this Subparagraph D of this Business Associate Contract.

37 //

1           5. CONTRACTOR shall report to COUNTY immediately any Security Incident of which it  
2 becomes aware. CONTRACTOR shall report Breaches of Unsecured PHI in accordance with  
3 Subparagraph E below and as required by 45 CFR § 164.410.

4           6. CONTRACTOR shall designate a Security Officer to oversee its data security program who  
5 shall be responsible for carrying out the requirements of this paragraph and for communicating on  
6 security matters with COUNTY.

#### 7           E. DATA SECURITY REQUIREMENTS

##### 8           1. Personal Controls

9           a. Employee Training. All workforce members who assist in the performance of  
10 functions or activities on behalf of COUNTY in connection with Agreement, or access or disclose PHI  
11 COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on  
12 behalf of COUNTY, must complete information privacy and security training, at least annually, at  
13 CONTRACTOR's expense. Each workforce member who receives information privacy and security  
14 training must sign a certification, indicating the member's name and the date on which the training was  
15 completed. These certifications must be retained for a period of six (6) years following the termination  
16 of Agreement.

17           b. Employee Discipline. Appropriate sanctions must be applied against workforce  
18 members who fail to comply with any provisions of CONTRACTOR's privacy P&Ps, including  
19 termination of employment where appropriate.

20           c. Confidentiality Statement. All persons that will be working with PHI COUNTY  
21 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of  
22 COUNTY must sign a confidentiality statement that includes, at a minimum, General Use, Security and  
23 Privacy Safeguards, Unacceptable Use, and Enforcement Policies. The statement must be signed by the  
24 workforce member prior to access to such PHI. The statement must be renewed annually. The  
25 CONTRACTOR shall retain each person's written confidentiality statement for COUNTY inspection  
26 for a period of six (6) years following the termination of the Agreement.

27           d. Background Check. Before a member of the workforce may access PHI COUNTY  
28 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of  
29 COUNTY, a background screening of that worker must be conducted. The screening should be  
30 commensurate with the risk and magnitude of harm the employee could cause, with more thorough  
31 screening being done for those employees who are authorized to bypass significant technical and  
32 operational security controls. The CONTRACTOR shall retain each workforce member's background  
33 check documentation for a period of three (3) years.

##### 34           2. Technical Security Controls

35           a. Workstation/Laptop encryption. All workstations and laptops that store PHI COUNTY  
36 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of  
37 COUNTY either directly or temporarily must be encrypted using a FIPS 140-2 certified algorithm

1 | which is 128bit or higher, such as AES. The encryption solution must be full disk unless approved by  
2 | the COUNTY.

3 |         b. Server Security. Servers containing unencrypted PHI COUNTY discloses to  
4 | CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
5 | must have sufficient administrative, physical, and technical controls in place to protect that data, based  
6 | upon a risk assessment/system security review.

7 |         c. Minimum Necessary. Only the minimum necessary amount of PHI COUNTY discloses  
8 | to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
9 | required to perform necessary business functions may be copied, downloaded, or exported.

10 |         d. Removable media devices. All electronic files that contain PHI COUNTY discloses to  
11 | CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
12 | must be encrypted when stored on any removable media or portable device (i.e. USB thumb drives,  
13 | floppies, CD/DVD, Blackberry, backup tapes etc.). Encryption must be a FIPS 140-2 certified  
14 | algorithm which is 128bit or higher, such as AES. Such PHI shall not be considered “removed from the  
15 | premises” if it is only being transported from one of CONTRACTOR’s locations to another of  
16 | CONTRACTOR’s locations.

17 |         e. Antivirus software. All workstations, laptops and other systems that process and/or  
18 | store PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or  
19 | transmits on behalf of COUNTY must have installed and actively use comprehensive anti-virus  
20 | software solution with automatic updates scheduled at least daily.

21 |         f. Patch Management. All workstations, laptops and other systems that process and/or  
22 | store PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or  
23 | transmits on behalf of COUNTY must have critical security patches applied, with system reboot if  
24 | necessary. There must be a documented patch management process which determines installation  
25 | timeframe based on risk assessment and vendor recommendations. At a maximum, all applicable  
26 | patches must be installed within thirty (30) days of vendor release. Applications and systems that  
27 | cannot be patched due to operational reasons must have compensatory controls implemented to  
28 | minimize risk, where possible.

29 |         g. User IDs and Password Controls. All users must be issued a unique user name for  
30 | accessing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains,  
31 | or transmits on behalf of COUNTY. Username must be promptly disabled, deleted, or the password  
32 | changed upon the transfer or termination of an employee with knowledge of the password, at maximum  
33 | within twenty-four (24) hours. Passwords are not to be shared. Passwords must be at least eight  
34 | characters and must be a non-dictionary word. Passwords must not be stored in readable format on the  
35 | computer. Passwords must be changed every ninety (90) days, preferably every sixty (60) days.  
36 | Passwords must be changed if revealed or compromised. Passwords must be composed of characters  
37 | from at least three (3) of the following four (4) groups from the standard keyboard:

- 1) Upper case letters (A–Z)
- 2) Lower case letters (a–z)
- 3) Arabic numerals (0–9)
- 4) Non–alphanumeric characters (punctuation symbols)

5 h. Data Destruction. When no longer needed, all PHI COUNTY discloses to  
6 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
7 must be wiped using the Gutmann or US DoD 5220.22–M (7 Pass) standard, or by degaussing. Media  
8 may also be physically destroyed in accordance with NIST Special Publication 800–88. Other methods  
9 require prior written permission by COUNTY.

10 i. System Timeout. The system providing access to PHI COUNTY discloses to  
11 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
12 must provide an automatic timeout, requiring re–authentication of the user session after no more than  
13 twenty (20) minutes of inactivity.

14 j. Warning Banners. All systems providing access to PHI COUNTY discloses to  
15 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
16 must display a warning banner stating that data is confidential, systems are logged, and system use is for  
17 business purposes only by authorized users. User must be directed to log off the system if they do not  
18 agree with these requirements.

19 k. System Logging. The system must maintain an automated audit trail which can  
20 identify the user or system process which initiates a request for PHI COUNTY discloses to  
21 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY,  
22 or which alters such PHI. The audit trail must be date and time stamped, must log both successful and  
23 failed accesses, must be read only, and must be restricted to authorized users. If such PHI is stored in a  
24 database, database logging functionality must be enabled. Audit trail data must be archived for at least  
25 three (3) years after occurrence.

26 l. Access Controls. The system providing access to PHI COUNTY discloses to  
27 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
28 must use role based access controls for all user authentications, enforcing the principle of least privilege.

29 m. Transmission encryption. All data transmissions of PHI COUNTY discloses to  
30 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
31 outside the secure internal network must be encrypted using a FIPS 140–2 certified algorithm which is  
32 128bit or higher, such as AES. Encryption can be end to end at the network level, or the data files  
33 containing PHI can be encrypted. This requirement pertains to any type of PHI in motion such as  
34 website access, file transfer, and E–Mail.

35 n. Intrusion Detection. All systems involved in accessing, holding, transporting, and  
36 protecting PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains,

37 //

1 or transmits on behalf of COUNTY that are accessible via the Internet must be protected by a  
2 comprehensive intrusion detection and prevention solution.

3 3. Audit Controls

4 a. System Security Review. CONTRACTOR must ensure audit control mechanisms that  
5 record and examine system activity are in place. All systems processing and/or storing PHI COUNTY  
6 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of  
7 COUNTY must have at least an annual system risk assessment/security review which provides  
8 assurance that administrative, physical, and technical controls are functioning effectively and providing  
9 adequate levels of protection. Reviews should include vulnerability scanning tools.

10 b. Log Reviews. All systems processing and/or storing PHI COUNTY discloses to  
11 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
12 must have a routine procedure in place to review system logs for unauthorized access.

13 c. Change Control. All systems processing and/or storing PHI COUNTY discloses to  
14 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY  
15 must have a documented change control procedure that ensures separation of duties and protects the  
16 confidentiality, integrity and availability of data.

17 4. Business Continuity/Disaster Recovery Control

18 a. Emergency Mode Operation Plan. CONTRACTOR must establish a documented plan  
19 to enable continuation of critical business processes and protection of the security of PHI COUNTY  
20 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of  
21 COUNTY kept in an electronic format in the event of an emergency. Emergency means any  
22 circumstance or situation that causes normal computer operations to become unavailable for use in  
23 performing the work required under this Agreement for more than twenty-four (24) hours.

24 b. Data Backup Plan. CONTRACTOR must have established documented procedures to  
25 backup such PHI to maintain retrievable exact copies of the PHI. The plan must include a regular  
26 schedule for making backups, storing backup offsite, an inventory of backup media, and an estimate of  
27 the amount of time needed to restore DHCS PHI or PI should it be lost. At a minimum, the schedule  
28 must be a weekly full backup and monthly offsite storage of DHCS data. BCP for contractor and  
29 COUNTY (e.g. the application owner) must merge with the DRP.

30 5. Paper Document Controls

31 a. Supervision of Data. PHI COUNTY discloses to CONTRACTOR or CONTRACTOR  
32 creates, receives, maintains, or transmits on behalf of COUNTY in paper form shall not be left  
33 unattended at any time, unless it is locked in a file cabinet, file room, desk or office. Unattended means  
34 that information is not being observed by an employee authorized to access the information. Such PHI  
35 in paper form shall not be left unattended at any time in vehicles or planes and shall not be checked in  
36 baggage on commercial airplanes.

37 //

1 b. Escorting Visitors. Visitors to areas where PHI COUNTY discloses to  
2 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY is  
3 contained shall be escorted and such PHI shall be kept out of sight while visitors are in the area.

4 c. Confidential Destruction. PHI COUNTY discloses to CONTRACTOR or  
5 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY must be disposed of  
6 through confidential means, such as cross cut shredding and pulverizing.

7 d. Removal of Data. PHI COUNTY discloses to CONTRACTOR or CONTRACTOR  
8 creates, receives, maintains, or transmits on behalf of COUNTY must not be removed from the premises  
9 of the CONTRACTOR except with express written permission of COUNTY.

10 e. Faxing. Faxes containing PHI COUNTY discloses to CONTRACTOR or  
11 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall not be left  
12 unattended and fax machines shall be in secure areas. Faxes shall contain a confidentiality statement  
13 notifying persons receiving faxes in error to destroy them. Fax numbers shall be verified with the  
14 intended recipient before sending the fax.

15 f. Mailing. Mailings containing PHI COUNTY discloses to CONTRACTOR or  
16 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall be sealed and  
17 secured from damage or inappropriate viewing of PHI to the extent possible. Mailings which include  
18 five hundred (500) or more individually identifiable records containing PHI COUNTY discloses to  
19 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY in  
20 a single package shall be sent using a tracked mailing method which includes verification of delivery  
21 and receipt, unless the prior written permission of COUNTY to use another method is obtained.

## 22 F. BREACH DISCOVERY AND NOTIFICATION

23 1. Following the discovery of a Breach of Unsecured PHI, CONTRACTOR shall notify  
24 COUNTY of such Breach, however both parties agree to a delay in the notification if so advised by a  
25 law enforcement official pursuant to 45 CFR § 164.412.

26 a. A Breach shall be treated as discovered by CONTRACTOR as of the first day on which  
27 such Breach is known to CONTRACTOR or, by exercising reasonable diligence, would have been  
28 known to CONTRACTOR.

29 b. CONTRACTOR shall be deemed to have knowledge of a Breach, if the Breach is  
30 known, or by exercising reasonable diligence would have known, to any person who is an employee,  
31 officer, or other agent of CONTRACTOR, as determined by federal common law of agency.

32 2. CONTRACTOR shall provide the notification of the Breach immediately to the COUNTY  
33 Privacy Officer. CONTRACTOR's notification may be oral, but shall be followed by written  
34 notification within twenty-four (24) hours of the oral notification.

35 3. CONTRACTOR's notification shall include, to the extent possible:

36 a. The identification of each Individual whose Unsecured PHI has been, or is reasonably  
37 believed by CONTRACTOR to have been, accessed, acquired, used, or disclosed during the Breach;



1           b. Any other information that COUNTY is required to include in the notification to  
2 Individual under 45 CFR §164.404 (c) at the time CONTRACTOR is required to notify COUNTY or  
3 promptly thereafter as this information becomes available, even after the regulatory sixty (60) day  
4 period set forth in 45 CFR § 164.410 (b) has elapsed, including:

5           1) A brief description of what happened, including the date of the Breach and the date  
6 of the discovery of the Breach, if known;

7           2) A description of the types of Unsecured PHI that were involved in the Breach (such  
8 as whether full name, social security number, date of birth, home address, account number, diagnosis,  
9 disability code, or other types of information were involved);

10          3) Any steps Individuals should take to protect themselves from potential harm  
11 resulting from the Breach;

12          4) A brief description of what CONTRACTOR is doing to investigate the Breach, to  
13 mitigate harm to Individuals, and to protect against any future Breaches; and

14          5) Contact procedures for Individuals to ask questions or learn additional information,  
15 which shall include a toll-free telephone number, an e-mail address, Web site, or postal address.

16          4. COUNTY may require CONTRACTOR to provide notice to the Individual as required in  
17 45 CFR § 164.404, if it is reasonable to do so under the circumstances, at the sole discretion of the  
18 COUNTY.

19          5. In the event that CONTRACTOR is responsible for a Breach of Unsecured PHI in violation  
20 of the HIPAA Privacy Rule, CONTRACTOR shall have the burden of demonstrating that  
21 CONTRACTOR made all notifications to COUNTY consistent with this Subparagraph F and as  
22 required by the Breach notification regulations, or, in the alternative, that the acquisition, access, use, or  
23 disclosure of PHI did not constitute a Breach.

24          6. CONTRACTOR shall maintain documentation of all required notifications of a Breach or  
25 its risk assessment under 45 CFR § 164.402 to demonstrate that a Breach did not occur.

26          7. CONTRACTOR shall provide to COUNTY all specific and pertinent information about the  
27 Breach, including the information listed in Section E.3.b.(1)–(5) above, if not yet provided, to permit  
28 COUNTY to meet its notification obligations under Subpart D of 45 CFR Part 164 as soon as  
29 practicable, but in no event later than fifteen (15) calendar days after CONTRACTOR's initial report of  
30 the Breach to COUNTY pursuant to Subparagraph F.2 above.

31          8. CONTRACTOR shall continue to provide all additional pertinent information about the  
32 Breach to COUNTY as it may become available, in reporting increments of five (5) business days after  
33 the last report to COUNTY. CONTRACTOR shall also respond in good faith to any reasonable  
34 requests for further information, or follow-up information after report to COUNTY, when such request  
35 is made by COUNTY.

36          9. If the Breach is the fault of CONTRACTOR, CONTRACTOR shall bear all expense or  
37 other costs associated with the Breach and shall reimburse COUNTY for all expenses COUNTY incurs

1 in addressing the Breach and consequences thereof, including costs of investigation, notification,  
2 remediation, documentation or other costs associated with addressing the Breach.

### 3 G. PERMITTED USES AND DISCLOSURES BY CONTRACTOR

4 1. CONTRACTOR may use or further disclose PHI COUNTY discloses to CONTRACTOR  
5 as necessary to perform functions, activities, or services for, or on behalf of, COUNTY as specified in  
6 the Agreement, provided that such use or Disclosure would not violate the HIPAA Privacy Rule if done  
7 by COUNTY except for the specific Uses and Disclosures set forth below.

8 a. CONTRACTOR may use PHI COUNTY discloses to CONTRACTOR, if necessary,  
9 for the proper management and administration of CONTRACTOR.

10 b. CONTRACTOR may disclose PHI COUNTY discloses to CONTRACTOR for the  
11 proper management and administration of CONTRACTOR or to carry out the legal responsibilities of  
12 CONTRACTOR, if:

13 1) The Disclosure is required by law; or

14 2) CONTRACTOR obtains reasonable assurances from the person to whom the PHI  
15 is disclosed that it will be held confidentially and used or further disclosed only as required by law or for  
16 the purposes for which it was disclosed to the person and the person immediately notifies  
17 CONTRACTOR of any instance of which it is aware in which the confidentiality of the information has  
18 been breached.

19 c. CONTRACTOR may use or further disclose PHI COUNTY discloses to  
20 CONTRACTOR to provide Data Aggregation services relating to the Health Care Operations of  
21 CONTRACTOR.

22 2. CONTRACTOR may use PHI COUNTY discloses to CONTRACTOR, if necessary, to  
23 carry out legal responsibilities of CONTRACTOR.

24 3. CONTRACTOR may use and disclose PHI COUNTY discloses to CONTRACTOR  
25 consistent with the minimum necessary policies and procedures of COUNTY.

26 4. CONTRACTOR may use or disclose PHI COUNTY discloses to CONTRACTOR as  
27 required by law.

### 28 H. PROHIBITED USES AND DISCLOSURES

29 1. CONTRACTOR shall not disclose PHI COUNTY discloses to CONTRACTOR or  
30 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY about an individual to  
31 a health plan for payment or health care operations purposes if the PHI pertains solely to a health care  
32 item or service for which the health care provider involved has been paid out of pocket in full and the  
33 individual requests such restriction, in accordance with 42 USC § 17935(a) and 45 CFR § 164.522(a).

34 2. CONTRACTOR shall not directly or indirectly receive remuneration in exchange for PHI  
35 COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on  
36 behalf of COUNTY, except with the prior written consent of COUNTY and as permitted by  
37 42 USC § 17935(d)(2).

I. OBLIGATIONS OF COUNTY

1. COUNTY shall notify CONTRACTOR of any limitation(s) in COUNTY's notice of privacy practices in accordance with 45 CFR § 164.520, to the extent that such limitation may affect CONTRACTOR's Use or Disclosure of PHI.

2. COUNTY shall notify CONTRACTOR of any changes in, or revocation of, the permission by an Individual to use or disclose his or her PHI, to the extent that such changes may affect CONTRACTOR's Use or Disclosure of PHI.

3. COUNTY shall notify CONTRACTOR of any restriction to the Use or Disclosure of PHI that COUNTY has agreed to in accordance with 45 CFR § 164.522, to the extent that such restriction may affect CONTRACTOR's Use or Disclosure of PHI.

4. COUNTY shall not request CONTRACTOR to use or disclose PHI in any manner that would not be permissible under the HIPAA Privacy Rule if done by COUNTY.

J. BUSINESS ASSOCIATE TERMINATION

1. Upon COUNTY's knowledge of a material Breach or violation by CONTRACTOR of the requirements of this Business Associate Contract, COUNTY shall:

a. Provide an opportunity for CONTRACTOR to cure the material Breach or end the violation within thirty (30) business days; or

b. Immediately terminate the Agreement, if CONTRACTOR is unwilling or unable to cure the material Breach or end the violation within thirty (30) days, provided termination of the Agreement is feasible.

2. Upon termination of the Agreement, CONTRACTOR shall either destroy or return to COUNTY all PHI CONTRACTOR received from COUNTY or CONTRACTOR created, maintained, or received on behalf of COUNTY in conformity with the HIPAA Privacy Rule.

a. This provision shall apply to all PHI that is in the possession of Subcontractors or agents of CONTRACTOR.

b. CONTRACTOR shall retain no copies of the PHI.

c. In the event that CONTRACTOR determines that returning or destroying the PHI is not feasible, CONTRACTOR shall provide to COUNTY notification of the conditions that make return or destruction infeasible. Upon determination by COUNTY that return or destruction of PHI is infeasible, CONTRACTOR shall extend the protections of this Business Associate Contract to such PHI and limit further Uses and Disclosures of such PHI to those purposes that make the return or destruction infeasible, for as long as CONTRACTOR maintains such PHI.

3. The obligations of this Business Associate Contract shall survive the termination of the Agreement.

**I. PERSONAL INFORMATION PRIVACY AND SECURITY CONTRACT**

Any reference to statutory, regulatory, or contractual language herein shall be to such language as in effect or as amended.

A. DEFINITIONS

1. "Breach" shall have the meaning given to such term under the IEA and CMPPA. It shall include a "PII loss" as that term is defined in the CMPPA.

2. "Breach of the security of the system" shall have the meaning given to such term under the CIPA, CCC § 1798.29(d).

3. "CMPPA Agreement" means the CMPPA Agreement between the SSA and CHHS.

4. "DHCS PI" shall mean Personal Information, as defined below, accessed in a database maintained by the COUNTY or DHCS, received by CONTRACTOR from the COUNTY or DHCS or acquired or created by CONTRACTOR in connection with performing the functions, activities and services specified in the Agreement on behalf of the COUNTY.

5. "IEA" shall mean the IEA currently in effect between the SSA and DHCS.

6. "Notice-triggering PI" shall mean the PI identified in CCC § 1798.29(e) whose unauthorized access may trigger notification requirements under CCC § 1709.29. For purposes of this provision, identity shall include, but not be limited to, name, identifying number, symbol, or other identifying particular assigned to the individual, such as a finger or voice print, a photograph or a biometric identifier. Notice-triggering PI includes PI in electronic, paper or any other medium.

7. "PII" shall have the meaning given to such term in the IEA and CMPPA.

8. "PI" shall have the meaning given to such term in CCC § 1798.3(a).

9. "Required by law" means a mandate contained in law that compels an entity to make a use or disclosure of PI or PII that is enforceable in a court of law. This includes, but is not limited to, court orders and court-ordered warrants, subpoenas or summons issued by a court, grand jury, a governmental or tribal inspector general, or an administrative body authorized to require the production of information, and a civil or an authorized investigative demand. It also includes Medicare conditions of participation with respect to health care providers participating in the program, and statutes or

1 regulations that require the production of information, including statutes or regulations that require such  
2 information if payment is sought under a government program providing public benefits.

3 10. "Security Incident" means the attempted or successful unauthorized access, use, disclosure,  
4 modification, or destruction of PI, or confidential data utilized in complying with this Agreement; or  
5 interference with system operations in an information system that processes, maintains or stores PI.

## 6 B. TERMS OF AGREEMENT

7 1. Permitted Uses and Disclosures of DHCS PI and PII by CONTRACTOR. Except as  
8 otherwise indicated in this Exhibit, CONTRACTOR may use or disclose DHCS PI only to perform  
9 functions, activities, or services for or on behalf of the COUNTY pursuant to the terms of the  
10 Agreement provided that such use or disclosure would not violate the CIPA if done by the COUNTY.

### 11 2. Responsibilities of CONTRACTOR

12 CONTRACTOR agrees:

13 a. Nondisclosure. Not to use or disclose DHCS PI or PII other than as permitted or  
14 required by this Personal Information Privacy and Security Contract or as required by applicable state  
15 and federal law.

16 b. Safeguards. To implement appropriate and reasonable administrative, technical, and  
17 physical safeguards to protect the security, confidentiality and integrity of DHCS PI and PII, to protect  
18 against anticipated threats or hazards to the security or integrity of DHCS PI and PII, and to prevent use  
19 or disclosure of DHCS PI or PII other than as provided for by this Personal Information Privacy and  
20 Security Contract. CONTRACTOR shall develop and maintain a written information privacy and  
21 security program that include administrative, technical and physical safeguards appropriate to the size  
22 and complexity of CONTRACTOR's operations and the nature and scope of its activities, which  
23 incorporate the requirements of Subparagraph (c), below. CONTRACTOR will provide COUNTY with  
24 its current policies upon request.

25 c. Security. CONTRACTOR shall ensure the continuous security of all computerized data  
26 systems containing DHCS PI and PII. CONTRACTOR shall protect paper documents containing  
27 DHCS PI and PII. These steps shall include, at a minimum:

28 1) Complying with all of the data system security precautions listed in Subparagraph  
29 E of the Business Associate Contract, Exhibit E to the Agreement; and

30 2) Providing a level and scope of security that is at least comparable to the level and  
31 scope of security established by the Office of Management and Budget in OMB Circular No. A-130,  
32 Appendix III-Security of Federal Automated Information Systems, which sets forth guidelines for  
33 automated information systems in Federal agencies.

34 3) If the data obtained by CONTRACTOR from COUNTY includes PII,  
35 CONTRACTOR shall also comply with the substantive privacy and security requirements in the  
36 CMPPA Agreement between the SSA and the CHHS and in the Agreement between the SSA and  
37 DHCS, known as the IEA. The specific sections of the IEA with substantive privacy and security

1 requirements to be complied with are sections E, F, and G, and in Attachment 4 to the IEA, Electronic  
2 Information Exchange Security Requirements, Guidelines and Procedures for Federal, State and Local  
3 Agencies Exchanging Electronic Information with the SSA. CONTRACTOR also agrees to ensure that  
4 any of CONTRACTOR’s agents or subcontractors, to whom CONTRACTOR provides DHCS PII agree  
5 to the same requirements for privacy and security safeguards for confidential data that apply to  
6 CONTRACTOR with respect to such information.

7 d. Mitigation of Harmful Effects. To mitigate, to the extent practicable, any harmful effect  
8 that is known to CONTRACTOR of a use or disclosure of DHCS PI or PII by CONTRACTOR or its  
9 subcontractors in violation of this Personal Information Privacy and Security Contract.

10 e. CONTRACTOR's Agents and Subcontractors. To impose the same restrictions and  
11 conditions set forth in this Personal Information and Security Contract on any subcontractors or other  
12 agents with whom CONTRACTOR subcontracts any activities under the Agreement that involve the  
13 disclosure of DHCS PI or PII to such subcontractors or other agents.

14 f. Availability of Information. To make DHCS PI and PII available to the DHCS and/or  
15 COUNTY for purposes of oversight, inspection, amendment, and response to requests for records,  
16 injunctions, judgments, and orders for production of DHCS PI and PII. If CONTRACTOR receives  
17 DHCS PII, upon request by COUNTY and/or DHCS, CONTRACTOR shall provide COUNTY and/or  
18 DHCS with a list of all employees, contractors and agents who have access to DHCS PII, including  
19 employees, contractors and agents of its subcontractors and agents.

20 g. Cooperation with COUNTY. With respect to DHCS PI, to cooperate with and assist the  
21 COUNTY to the extent necessary to ensure the DHCS’s compliance with the applicable terms of the  
22 CIPA including, but not limited to, accounting of disclosures of DHCS PI, correction of errors in DHCS  
23 PI, production of DHCS PI, disclosure of a security Breach involving DHCS PI and notice of such  
24 Breach to the affected individual(s).

25 h. Breaches and Security Incidents. During the term of the Agreement, CONTRACTOR  
26 agrees to implement reasonable systems for the discovery of any Breach of unsecured DHCS PI and PII  
27 or security incident. CONTRACTOR agrees to give notification of any beach of unsecured DHCS PI  
28 and PII or security incident in accordance with Subparagraph F, of the Business Associate Contract,  
29 Exhibit E to the Agreement.

30 i. Designation of Individual Responsible for Security. CONTRACTOR shall designate an  
31 individual, (e.g., Security Officer), to oversee its data security program who shall be responsible for  
32 carrying out the requirements of this Personal Information Privacy and Security Contract and for  
33 communicating on security matters with the COUNTY.

Preface

The COUNTY as a political subdivision of the State of California, is mandated by state and federal law to provide certain services to all County residents. In addition, the COUNTY provides certain other non-mandated services to enhance the well-being and quality of life for its residents. The COUNTY is committed to ensuring positive relations through this Good Neighbor Policy in the neighborhoods and communities in which its Residential Program contractors provide services to its residents.

Following effective date of this Agreement, but no later than thirty (30) days after the start of services, CONTRACTOR shall conduct reasonable outreach to cities, neighborhoods and communities that could be affected by services provided by CONTRACTOR.

Good Neighbor Policy

This Policy applies only to the extent CONTRACTOR provides direct services to County clients pursuant to this Agreement. The intent of this Policy is to identify community impacts and measures to mitigate those impacts to be an integral part of the neighborhood and community the COUNTY serves.

CONTRACTOR shall establish a policy that includes all of the following elements:

- Ensure staff and clients conduct themselves in a manner that demonstrates respect for the community and consideration of neighbors when entering/exiting the facility or outdoors.
- Establish and maintain early communication with cities, neighborhoods and communities as a way to identify potential impacts to neighborhoods and mitigate as needed.
- Establish cooperative relationships with cities, neighborhoods and communities where services are being rendered and mitigate impact as needed.
- Collaborate with cities, neighborhoods and communities as a way to promote integration of facilities into the community and determine the effectiveness of established good neighbor practices.
- Develop written procedures to track, respond and mitigate neighborhood complaints. Procedures should include identification of a contact person for complaint resolution and identification of COUNTY contact if complaint is not adequately resolved. The procedures must also identify how

1 these incidents will be reported to the appropriate COUNTY contact in a timely manner.

- 2 • Establish generalized good neighbor practices for services and facility(ies) that include:
  - 3 - Adequate parking
  - 4 - Adequate waiting and visiting areas
  - 5 - Adequate restroom facilities
  - 6 - Property maintenance and appearance
  - 7 - Community safety
  - 8 - Congregation guidelines
  - 9 - Security provisions

11 CONTRACTOR shall submit its policy to COUNTY for review and approval prior to the commencing  
12 of services.
