

**AMENDMENT NUMBER FIVE
TO CONTRACT MA-012-16011742
WITH BELLFREE CONTRACTORS INC.
FOR ON-CALL TRAIL MAINTENANCE AND REPAIR SERVICES**

This Amendment to Contract MA-012-16011742, herein referred to as "Amendment Five", is made and entered into upon execution of all necessary signatures between the County of Orange, OC Community Resources, OC Parks, a political subdivision of the State of California, hereinafter referred to as "County" and Bellfree Contractors Inc., with a place of business at 11716 Babbitt Ave., Granada Hills, CA 91344-2437, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

RECITALS

WHEREAS, County and Contractor entered into Contract Number MA-012-16011742, hereinafter referred to as "Contract", for On-Call Trail Maintenance and Repair Services, commencing on July 1, 2016 through and including June 30, 2017, in an amount not to exceed \$400,000.00; and

WHEREAS, Parties executed Amendment One to renew Contract for one additional year effective July 1, 2017 through June 30, 2018, in an amount not to exceed \$400,000.00; and

WHEREAS, Parties executed Amendment Two to renew Contract for one additional year effective July 1, 2018 through June 30, 2019, in an amount not to exceed \$400,000.00; and

WHEREAS, Parties executed Amendment Three to revise Contract Terms and Conditions and renew Contract for one additional year effective July 1, 2019 through June 30, 2020, in an amount not to exceed \$500,000.00; and

WHEREAS, Parties executed Amendment Four to revise Contract Terms and Conditions and renew Contract for one additional year effective July 1, 2020 through June 30, 2021, in an amount not to exceed \$500,000.00; and

WHEREAS, County now desires to extend Contract for one additional year; and

NOW THEREFORE, in consideration of the mutual obligations set forth herein, the Parties mutually agree as follows:

1. Contract shall be extended for its sixth year term effective from July 1, 2021 through June 30, 2022, in an amount not to exceed \$500,000.00.
2. Except as otherwise expressly set forth herein, all terms and conditions contained in the Original Contract, including any amendments/modifications, are hereby incorporated herein by this reference as if fully set forth herein and shall remain in full force and effect.
