RECITALS:

WHEREAS, CITY wishes to contract with COUNTY for law enforcement services; and

WHEREAS, COUNTY is agreeable to the rendering of such services, as authorized in Government Code Sections 51301 and 55632, on the terms and conditions hereinafter set forth,

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1 **A. TERM:**

2 The term of this Agreement shall commence July 1, 20~~20~~¹⁹ and terminate
3 June 30, 202~~1~~⁰ unless earlier terminated by either party or extended in the
4 manner set forth herein.

5 **B. OPTIONAL TERMINATION OR EXTENSION:**

- 6 1. COUNTY or CITY may terminate this Agreement, without cause, upon one-
7 hundred and eighty (180) days written notice to the other party.
- 8 2. If COUNTY and CITY have not entered into a written agreement by
9 June 30, 202~~1~~⁰ for COUNTY to provide to CITY, during all or part of the
10 period between July 1, 202~~1~~⁰ and June 30, 202~~2~~⁴, law enforcement
11 services similar to those specified herein, then SHERIFF, on behalf of
12 COUNTY, and CITY's Manager, on behalf of CITY, are authorized to
13 execute a written amendment to this Agreement that provides as follows and
14 does not materially alter other terms of the Agreement: SHERIFF shall
15 continue to provide to CITY all or a designated part of the law enforcement
16 services specified herein, for a specified time period between July 1, 202~~1~~⁰
17 and August 31, 202~~1~~⁰, and CITY shall pay COUNTY the full costs of
18 providing such services. Such full costs may be greater than those listed
19 herein for the period July 1, 20~~20~~¹⁹ through June 30, 202~~1~~⁰. SHERIFF and
20 CITY Manager shall file copies of any such amendments to this Agreement
21 with the Clerk of COUNTY's Board of Supervisors and CITY's Clerk.

22 **C. REGULAR SERVICES BY COUNTY:**

- 23 1. COUNTY, through its Sheriff-Coroner and deputies, officers and employees,
24 hereinafter referred to as "SHERIFF", shall render to CITY law enforcement
25 services as hereinafter provided. Such services shall include the
26 enforcement of lawful State statutes and lawful municipal ordinances of
27 CITY other than licensing ordinances.

1 **C. REGULAR SERVICES BY COUNTY: (Continued)**

- 2 2. The night, day and evening patrol and supervisory shifts will be established
3 by SHERIFF. Personnel of each shift may work varying and different times
4 and may be deployed to other shifts when, in the opinion of SHERIFF and
5 CITY Manager, the need arises. Any long-term shift deployment change will
6 be reported to the CITY's Council.
- 7 3. The level of service, other than for licensing, to be provided by the COUNTY
8 for the period July 1, 20~~20~~19 through June 30, 20~~20~~19, is set forth in
9 Attachment A and incorporated herein by this reference.
- 10 4. For any service listed in Attachment A of this Agreement that is provided to
11 CITY at less than 100% of a full-time SHERIFF position, COUNTY retains
12 the option to terminate such service in the event the other city or cities that
13 contract(s) for the balance of the time of the employee providing the service
14 no longer pay(s) for such service and CITY does not request the Agreement
15 be amended to provide for payment of 100% of the cost of the employee
16 providing such service. The Maximum Obligation of CITY set forth in
17 Subsection G-2 will be adjusted accordingly.
- 18 5. All services contracted for in this Agreement may not be operational on the
19 precise date specified in this Agreement. In those instances, SHERIFF shall
20 notify CITY Manager of the date or dates such service or services are to be
21 implemented. COUNTY shall reduce the monthly charges to CITY, based
22 on the actual date of implementation of the service or services. Charges
23 shall be reduced on the next monthly billing tendered in accordance with
24 Subsection G-3 of this Agreement.
- 25 6. During emergencies, such as mutual aid situations, SHERIFF will attempt to
26 leave in CITY the Lieutenant in charge of CITY Police Services. If SHERIFF
27 determines that the Lieutenant is needed elsewhere, SHERIFF will notify
28 CITY's Manager within four (4) hours. SHERIFF will return the Lieutenant to

2 CITY as soon as possible once the emergency situation is under control.

3 7. With respect to the licensing ordinances of CITY listed in Attachment B
4 hereto, which is incorporated herein by this reference, SHERIFF shall
5 receive applications for CITY licenses pursuant to said ordinances and
6 complete investigations relating to such applications. Said investigations
7 shall be forwarded to CITY Manager. COUNTY shall not provide any
8 advisory, administrative, hearing or litigation attorney support or services
9 related to licensing. COUNTY shall not provide any administrative or
10 investigatory services related to the licensing ordinances listed in Attachment
11 B hereto, except the investigations relating to initial applications for which
12 this subsection provides.

13 8. With the limitations set forth below, SHERIFF, on behalf of COUNTY, and
14 CITY Manager, on behalf of CITY, are authorized to execute written
15 amendments to this Agreement to increase or decrease the level of service
16 set forth in Attachment A, when SHERIFF and CITY Manager mutually agree
17 that such increase or decrease in the level of service is appropriate. Any
18 such amendment to the Agreement shall concomitantly increase or decrease
19 the cost of services payable by CITY set forth in Attachment C and
20 incorporated herein by this reference, and the Maximum Obligation of CITY
21 set forth in Subsection G-2, in accordance with the current year's COUNTY
22 law enforcement cost study. SHERIFF and CITY Manager shall file copies
23 of any such amendments to this Agreement with the Clerk of COUNTY's
24 Board of Supervisors and CITY's Clerk. Amendments to this Agreement
25 executed by SHERIFF and CITY Manager may not, in the aggregate,
26 increase or decrease the cost of services payable by CITY by more than one
27 percent (1%) of the total cost originally set forth in Attachment C and the
28 Maximum Obligation originally set forth in Subsection G-2.

1 **C. REGULAR SERVICES BY COUNTY: (Continued)**

2 Prior approval by COUNTY's Board of Supervisors and CITY's Council is
3 required before execution of any amendment that brings the aggregate total
4 of changes in costs payable by CITY to more than one percent (1%) of the
5 total cost originally set forth in Attachment C and the Maximum Obligation
6 originally set forth in Subsection G-2 of this Agreement.

7 **D. ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY:**

8 1. Enhanced services for events on CITY property. At the request of CITY,
9 through its City Manager, SHERIFF may provide enhanced law enforcement
10 services for functions, such as community events, conducted on property
11 that is owned, leased or operated by CITY. SHERIFF shall determine
12 personnel and equipment needed for such enhanced services. To the
13 extent the services provided at such events are at a level greater than that
14 specified in Attachment A of this Agreement, CITY shall reimburse COUNTY
15 for such additional services, at an amount computed by SHERIFF, based on
16 the current year's COUNTY law enforcement cost study. The cost of these
17 enhanced services shall be in addition to the Maximum Obligation of CITY
18 set forth in Subsection G-2 of this Agreement. SHERIFF shall bill CITY
19 immediately after each such event.

20 2. Supplemental services for occasional events operated by private individuals
21 and entities on non-CITY property. At the request of CITY, through its City
22 Manager, and within the limitations set forth in this Subsection D-2,
23 SHERIFF may provide supplemental law enforcement services to preserve
24 the peace at special events or occurrences that occur on an occasional
25 basis and are operated by private individuals or private entities on non-CITY
26 property. SHERIFF shall determine personnel and equipment needed for
27 such supplemental services, and will provide such supplemental services
28 only if SHERIFF is able to do so without reducing the normal and regular

1 **D. ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY: (Continued)**

2 ongoing services that SHERIFF otherwise would provide to CITY pursuant to
3 this Agreement. Such supplemental services shall be provided only by
4 regularly appointed full-time peace officers, at rates of pay governed by a
5 Memorandum of Understanding between COUNTY and the bargaining unit
6 representing the peace officers providing the services. Such supplemental
7 services shall include only law enforcement duties and shall not include
8 services authorized to be provided by a private patrol operator, as defined in
9 Section 7582.1 of the Business and Professions Code. Law enforcement
10 support functions, including, but not limited to, clerical functions and forensic
11 science services, may be performed by non-peace officer personnel if the
12 services do not involve patrol or keeping the peace and are incidental to the
13 provision of law enforcement services. CITY shall reimburse COUNTY its
14 full, actual costs of providing such supplemental services at an amount
15 computed by SHERIFF, based on the current year's COUNTY law
16 enforcement cost study. The cost of these supplemental services shall be in
17 addition to the Maximum Obligation of CITY set forth in Subsection G-2 of
18 this Agreement. SHERIFF shall bill CITY immediately after each such event.

- 19 3. Supplemental services for events operated by public entities on non-CITY
20 property. At the request of CITY, through its City Manager, and within the
21 limitations set forth in this Subsection D-3, SHERIFF may provide
22 supplemental law enforcement services to preserve the peace at special
23 events or occurrences that occur on an occasional basis and are operated
24 by public entities on non-CITY property. SHERIFF shall determine personnel
25 and equipment needed for such supplemental services, and will provide
26 such supplemental services only if SHERIFF is able to do so without
27 reducing services that SHERIFF otherwise would provide to CITY pursuant
28 to this Agreement. CITY shall reimburse COUNTY its full, actual costs of

1 **D. ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY:** (Continued)

2 providing such supplemental services at an amount computed by SHERIFF,
3 based on the current year's COUNTY law enforcement cost study. The cost
4 of these supplemental services shall be in addition to the Maximum
5 Obligation of CITY set forth in Subsection G-2 of this Agreement. SHERIFF
6 shall bill CITY immediately after each such event.

7 4. Notwithstanding the foregoing, CITY, through its permit process, may utilize
8 the services of SHERIFF at events, for which CITY issues permits, that are
9 operated by private individuals or entities or public entities. SHERIFF shall
10 determine personnel and equipment needed for said events. If said events
11 are in addition to the level of services listed in Attachment A of this
12 Agreement, CITY shall reimburse COUNTY for such additional services at
13 an amount computed by SHERIFF, based upon the current year's COUNTY
14 law enforcement cost study. The cost of these services shall be in addition
15 to the Maximum Obligation of CITY set forth in Subsection G-2 of this
16 Agreement. SHERIFF shall bill CITY immediately after said services are
17 rendered.

18 5. In accordance with Government Code Section 51350, COUNTY has
19 adopted Board Resolution 89-1160 which identifies Countywide services,
20 including but not limited to helicopter response. SHERIFF through this
21 contract provides enhanced helicopter response services. The cost of
22 enhanced helicopter response services is included in the cost of services set
23 forth in Attachment C and in the Maximum Obligation of CITY set forth in
24 Subsection G-2. COUNTY shall not charge any additional amounts for
25 enhanced helicopter services after the cost of services set forth in
26 Attachment C and in the Maximum Obligation set forth in Subsection G-2
27 has been established without written notification to the CITY.

1 **E. PATROL VIDEO SYSTEMS:**

- 2 1. As part of the law enforcement services to be provided to CITY, COUNTY
- 3 has provided, or will provide, patrol video systems (hereinafter called "PVS")
- 4 that are or will be mounted in patrol vehicles designated by COUNTY for use
- 5 within CITY service area.
- 6 2. SHERIFF has the exclusive right to use said PVS for law enforcement
- 7 services related to this Agreement.
- 8 3. CITY shall pay COUNTY the full costs to COUNTY of a) the acquisition and
- 9 installation of Patrol Video Systems that are or will be mounted in patrol
- 10 vehicles assigned to CITY, and b) recurring costs, as deemed necessary by
- 11 COUNTY, including the costs of maintenance and contributions to a fund for
- 12 replacement and upgrade of such PVS when they become functionally or
- 13 technologically obsolete.

14 The costs to be paid by CITY for recurring costs, including maintenance and

15 replacement/upgrade of PVS, are included in the costs set forth in

16 Attachment C and the Maximum Obligation of CITY set forth in Subsection

17 G-2 of this Agreement unless CITY has already paid such costs. CITY shall

18 not be charged additional amounts for maintenance or replacement/upgrade

19 of said PVS during the period July 1, 20~~20~~¹⁹ through June 30, 202~~19~~¹⁹.

- 20 4. If, following the initial acquisition of PVS referenced above, CITY requires
- 21 PVS for additional patrol cars designated for use in the CITY service area,
- 22 COUNTY will purchase said additional PVS. Upon demand by COUNTY,
- 23 CITY will pay to COUNTY a) the full costs of acquisition and installation of
- 24 said additional PVS, and b) the full recurring costs for said PVS, as deemed
- 25 necessary by COUNTY, including the costs of maintenance, and
- 26 contributions to a fund for replacement and upgrade of such PVS when they
- 27 become functionally or technologically obsolete. Said costs related to
- 28 additional PVS are not included in, and are in addition to, the costs set forth

1 **E. PATROL VIDEO SYSTEMS: (Continued)**

2 in Attachment C and the Maximum Obligation of CITY set forth in
3 Subsection G-2 of this Agreement.

- 4 5. COUNTY will replace and/or upgrade PVS as needed. The costs of
5 replacing/upgrading PVS shall be paid by COUNTY from the
6 replacement/upgrade funds to be paid by CITY in accordance with the
7 foregoing. CITY shall not be charged any additional charge to replace or
8 upgrade PVS.

9 **F. LICENSING SERVICES BY CITY:**

10 Upon receipt from COUNTY of investigations of applications for licenses
11 referred to in Subsection C-7 of this Agreement, CITY Manager shall determine
12 whether to grant or deny the licenses and will issue the licenses or notify the
13 applicants of denial. CITY shall provide all attorney services related to the
14 granting, denial, revocation and administration of said licenses and the
15 enforcement of CITY ordinances pertaining to said licenses.

16 **G. PAYMENT:**

- 17 1. Pursuant to Government Code Section 51350, CITY agrees to pay to
18 COUNTY the full costs of performing the services mutually agreed upon in
19 this Agreement. The costs of services include salaries, wages, benefits,
20 mileage, services, supplies, equipment, and divisional, departmental and
21 COUNTY General overhead.
- 22 2. Unless the level of service set forth in Attachment A is increased or
23 decreased pursuant to mutual agreement of the parties, or CITY is required
24 to pay for increases as set forth in Subsection G-4, the Maximum Obligation
25 of CITY for full cost of services, other than Licensing Services, set forth in
26 Attachment A of this Agreement, to be provided by the COUNTY for the
27 period July 1, 20~~2019~~ through June 30, 20~~2120~~, shall be
28 \$8,901,9229,090,112 as set forth in Attachment C.

1 **G. PAYMENT: (Continued)**

2 The overtime costs included in the Agreement are only an estimate.
3 SHERIFF shall notify CITY of actual overtime worked during each fiscal
4 year. If actual overtime worked is above or below budgeted amounts,
5 billings will be adjusted accordingly at the end of the fiscal year. Actual
6 overtime costs may exceed CITY's Maximum Obligation.

7 3. COUNTY shall invoice CITY monthly. During the period July 1, 20~~2019~~
8 through June 30, 20~~2120~~, said invoices will require payment by CITY of one-
9 twelfth (1/12) of the Maximum Obligation of CITY set forth in Subsection G-2
10 of this Agreement, as said Maximum Obligation may have been increased or
11 decreased pursuant to mutual agreement of the parties. In addition, if a
12 determination is made that increases described in Subsection G-4 must be
13 paid, COUNTY thereafter shall include the pro-rata charges for such
14 increases in its monthly invoices to CITY for the balance of the period
15 between July 1, 20~~2019~~ and June 30, 20~~2120~~.

16 4a. At the time this Agreement is executed, there may beare unresolved issues
17 pertaining to potential changes in salaries and benefits for COUNTY
18 employees. The costs of such potential changes are not included in the
19 Fiscal Year 20~~20-2119-20~~ costs set forth in Attachment C nor in the Fiscal
20 Year 20~~20-2119-20~~ Maximum Obligation of City set forth in Subsection G-2
21 of this Agreement. If the changes result in the COUNTY incurring or
22 becoming obligated to pay for increased costs for or on account of personnel
23 whose costs are included in the calculations of costs charged to CITY
24 hereunder, CITY shall pay COUNTY, in addition to the Maximum Obligation
25 set forth in Subsection G-2 of this Agreement, the full costs of said increases
26 to the extent such increases are attributable to work performed by such
27 personnel after July 1, 20~~2019~~, and CITY's Maximum Obligation hereunder
28 shall be deemed to have increased accordingly. CITY shall pay COUNTY in

1 **G. PAYMENT:** (Continued)

2 full for such increases on a pro-rata basis over the portion of the period
3 between July 1, 20~~2019~~ and June 30, 20~~2120~~ remaining after COUNTY
4 notifies CITY that increases are payable. If the changes result in the
5 COUNTY incurring or becoming obligated to pay for decreased costs for or
6 on account of personnel whose costs are included in the calculations of
7 costs charged to CITY hereunder, COUNTY shall reduce the amount owed
8 by the CITY to the extent such decreases are attributable to work performed
9 by such personnel during the period July 1, 20~~2019~~ through June 30,
10 20~~2120~~, and CITY's Maximum Obligation hereunder shall be deemed to
11 have decreased accordingly. COUNTY shall reduce required payment by
12 CITY in full for such decreases on a pro-rata basis over the portion of the
13 period between July 1, 20~~2019~~ and June 30, 20~~2120~~ remaining after
14 COUNTY notifies CITY that the Maximum Obligation has decreased.

- 15 4b. If CITY is required to pay for increases as set forth in Subsection G-4a
16 above, COUNTY, at the request of CITY, will thereafter reduce the level of
17 service to be provided to CITY as set forth in Attachment A of this
18 Agreement to a level that will make the Maximum Obligation of CITY
19 hereunder for the period July 1, 20~~2019~~ through June 30, 20~~2120~~ an amount
20 specified by CITY that is equivalent to or higher or lower than the Maximum
21 Obligation set forth in Subsection G-2 for said period at the time this
22 Agreement originally was executed. The purpose of such adjustment of
23 service levels will be to give CITY the option of keeping its Maximum
24 Obligation hereunder at the pre-increase level or at any other higher or lower
25 level specified by CITY. In the event of such reduction in level of service
26 and adjustment of costs, the parties shall execute an amendment to this
27 Agreement so providing. Decisions about how to reduce the level of service
28 provided to CITY shall be made by SHERIFF with the approval of CITY.

1 **G. PAYMENT:** (Continued)

- 2 5. CITY shall pay COUNTY in accordance with COUNTY Board of Supervisors'
- 3 approved County Billing Policy, which is attached hereto as Attachment D
- 4 and incorporated herein by this reference.
- 5 6. COUNTY shall charge CITY late payment penalties in accordance with
- 6 County Billing Policy.
- 7 7. As payment for the Licensing Services described in Subsection C-7 of this
- 8 Agreement, COUNTY shall retain all fees paid by applicants for licenses
- 9 pursuant to CITY ordinances listed in Attachment B hereto. Retention of
- 10 said fees by COUNTY shall constitute payment in full to COUNTY for costs
- 11 incurred by COUNTY in performing the functions related to licensing
- 12 described in Subsection C-7; provided, however, that if any of said fees are
- 13 waived or reduced by CITY, CITY shall pay to COUNTY the difference
- 14 between the amount of fees retained by COUNTY and the fees that were set
- 15 forth in the ordinances listed in Attachment B at the time this Agreement was
- 16 executed. If CITY increases the fee schedule for the licensing ordinances
- 17 set forth in Attachment B, either party shall have the right to seek
- 18 amendment of this Agreement with respect to the division of the increased
- 19 fees between CITY and COUNTY.
- 20 8. Fees generated or collected by SHERIFF contract personnel for copying of
- 21 documents related to the services provided in this Agreement will be at
- 22 COUNTY established rates and will be credited to CITY on an annual basis.
- 23 9. Narcotic asset forfeitures will be handled pursuant to Attachment E hereto,
- 24 which is incorporated herein by this reference.

25 **H. NOTICES:**

- 26 1. Except for the notices provided for in Subsection 2 of this Section, all notices
- 27 authorized or required by this Agreement shall be effective when written and
- 28 deposited in the United States mail, first class postage prepaid and

- 10 2. Termination notices shall be effective when written and deposited in the
11 United States mail, certified, return receipt requested and addressed as
12 above.

13 **I. STATUS OF COUNTY:**

14 COUNTY is, and at all times shall be deemed to be, an independent contractor.
15 Nothing herein contained shall be construed as creating the relationship of
16 employer and employee, or principal and agent, between CITY and COUNTY or
17 any of COUNTY's agents or employees. COUNTY and its SHERIFF shall retain
18 all authority for rendition of services, standards of performance, control of
19 personnel, and other matters incident to the performance of services by
20 COUNTY pursuant to this Agreement. COUNTY, its agents and employees
21 shall not be entitled to any rights or privileges of CITY employees and shall not
22 be considered in any manner to be CITY employees.

23 **J. STATE AUDIT:**

24 Pursuant to Government Code Section 8546.7, CITY and COUNTY shall be
25 subject to examination and audit by the State Auditor for a period of three (3)
26 years after final payment by CITY to COUNTY under this Agreement. CITY and
27 COUNTY shall retain all records relating to the performance of this Agreement
28 for said three-year period, except that those records pertaining to any audit then

1 **J. STATE AUDIT: (Continued)**

2 in progress, or to any claims or litigation, shall be retained beyond said three-
3 year period, until final resolution of said audit, claim or litigation.

4 **K. ALTERATION OF TERMS:**

5 This Agreement fully expresses all understanding of CITY and COUNTY with
6 respect to the subject matter of this Agreement and shall constitute the total
7 Agreement between the parties for these purposes. No addition to, or alteration
8 of, the terms of this Agreement shall be valid unless made in writing, formally
9 approved and executed by duly authorized agents of both parties.

10 **L. INDEMNIFICATION:**

11 1. COUNTY, its officers, agents, employees, subcontractors and independent
12 contractors shall not be deemed to have assumed any liability for the
13 negligence or any other act or omission of CITY or any of its officers, agents,
14 employees, subcontractors or independent contractors, or for any dangerous
15 or defective condition of any public street or work or property of CITY, or for
16 any illegality or unconstitutionality of CITY's municipal ordinances. CITY
17 shall indemnify and hold harmless COUNTY, and its elected and appointed

24 independent contractors related to this Agreement, including, but not limited
25 to, any act or omission related to the maintenance or condition of any vehicle
26 or motorcycle that is owned or possessed by CITY and used by COUNTY
27 personnel in the performance of this Agreement, for property damage, bodily
28 injury or death or any other element of damage of any kind or nature, and

1 **L. INDEMNIFICATION: (Continued)**

2 CITY shall defend at its expense including attorney fees, and with counsel
3 approved in writing by COUNTY, COUNTY and its elected and appointed
4 officials, officers, agents, employees, subcontractors and independent
5 contractors in any legal action or claim of any kind based upon or asserted
6 upon such condition of public street or work or property, or illegality or
7 unconstitutionality of a municipal ordinance, or alleged acts or omissions. If
8 judgment is entered against CITY and COUNTY by a court of competent

2 Vehicle Code and related safety issues with regard to driver licensing,

6 without regard to jurisdictional boundaries, because an area-wide approach
7 to reduction of traffic accidents and driver education is most effective in
8 preventing traffic accidents. In order for CITY to participate in the Program,
9 CITY has adopted a fee pursuant to Vehicle Code Section 22850.5, in the
10 amount and under the terms and conditions set forth in the resolution that is
11 attached hereto as Attachment F and incorporated into this Agreement by

15 TVAP resolution that is attached hereto as Attachment F. In the event CITY
16 1) amends said TVAP resolution, or rescinds said TVAP resolution and
17 adopts a new resolution TVAP pertaining to the above-referenced fee and
18 the Program, and 2) remains a participant in the Program thereafter, CITY's
19 Manager, on behalf of CITY, and SHERIFF, on behalf of COUNTY, have
20 authority to execute an amendment of this Agreement to substitute CITY's
21 amended or new TVAP resolution for Attachment F hereto, as long as said
22 amendment to this Agreement does not materially change any other
23 provision of this Agreement.

- 24 2. COUNTY will make available for review, at the request of CITY, all financial
25 data related to the Program as may be requested by CITY.
- 26 3. Fee revenue generated by COUNTY and participating cities will be used to

8 4. Fee revenue generated by CITY may be used to reimburse CITY for

11 eligible for reimbursement, CITY shall submit a request for and obtain pre-
12 approval of the expenditure by using the form as shown in Attachment G.

13 The request shall be submitted within the budget schedule established by
14 SHERIFF. SHERIFF shall approve the expenditure only if both of the
15 following conditions are satisfied: 1) there are sufficient Program funds,
16 attributable to revenue generated by CITY's fee, to pay for the requested
17 purchase, and 2) CITY will use the equipment and/or supplies, during their

ATTACHMENT E**POLICY FOR DISTRIBUTION OF FORFEITED AND SEIZED ASSETS****BACKGROUND**

The Orange County Sheriff's Department provides contract law enforcement services to cities in Orange County. Because of the increased likelihood that contracted patrol or investigation personnel may become involved in significant narcotic seizures, which could affect law enforcement services provided by the Sheriff's Department to contract cities, the following policy is in effect.

1. ~~NON-RNSP~~ CONTRACTED PATROL AND INVESTIGATION OFFICERS

When assets (cash or property) are seized in CITY by contracted patrol or investigation personnel ~~other than RNSP personnel~~, and subsequently forfeited to ~~COUNTY~~ COUNTY'S Sheriff Department, hereinafter referred to as "SHERIFF", the forfeited assets shall be shared with CITY as set forth below, for the purpose of augmenting law enforcement services in CITY, subject to approval guidelines by the forfeiting agency (~~U.S. Attorney or State~~) of such sharing and use of forfeited assets. A portion of forfeited assets may be retained by COUNTY'S Sheriff Department, hereinafter referred to as "SHERIFF", to pay for departmental expenses not recovered through law enforcement contracts.

In such cases, pursuant to the forfeiting agency's guidelines, SHERIFF shall apply to the forfeiting agency for the return of a share of ~~the assets to COUNTY~~. In his application, SHERIFF shall specify the percentage of shared assets returned to COUNTY SHERIFF that will be used to augment law enforcement services in CITY and the use of said assets by CITY.

In those cases in which assets are seized within CITY by ~~non-RNSP~~ personnel assigned to CITY pursuant to this Agreement, without the involvement of other law enforcement personnel, and in which the seizure is a result solely of activities self-initiated by ~~non-RNSP~~ SHERIFF personnel assigned to CITY or initiated by said personnel in response to calls for service within CITY, SHERIFF shall apply to have all of the assets used to augment CITY law enforcement services.

In those cases in which ~~non-RNSP~~ SHERIFF personnel assigned to CITY pursuant to this Agreement play an ancillary role in a seizure or in which other law enforcement personnel are involved in a seizure, SHERIFF shall determine the percentage of the total forfeited assets for which he will apply to augment CITY's law enforcement services. This determination will be based on the circumstances of the seizure, including the pro-rata involvement of all personnel, including those assigned to CITY.

Each seizure will be evaluated on an individual and independent basis, and said evaluations will be available for review to CITY's manager. Examples of those incidents which would be evaluated as set forth in this section include situations in which a contract patrol deputy provides uniformed backup at a SHERIFF's Narcotic Bureau search warrant location or in which contract investigators participate in the service of a search warrant that was initiated by non-contract law enforcement personnel.

~~NON-RNSP CONTRACTED PATROL AND INVESTIGATION OFFICERS (Continued)~~

Assets (cash or property) that are returned to COUNTY SHERIFF by the forfeiting agency with the understanding that they will be used to augment CITY law enforcement services shall be used by CITY and COUNTY SHERIFF only for such purposes. If the forfeiting agency attaches additional or more specific conditions to the use of said assets, CITY and COUNTY SHERIFF shall also abide by those conditions. SHERIFF and CITY's manager shall determine the specific use of said assets within the conditions imposed by the forfeiting agency.

~~Subject to conditions imposed by the forfeiting agency and to the requirement that forfeited assets be used to augment law enforcement services, COUNTY shall place forfeited cash, or cash from the sale of forfeited assets in an interest-bearing account for use in CITY in compliance with the forfeiting agency's regulations.~~

~~2. CONTRACTED REGIONAL NARCOTICS SUPPRESSION PROGRAM (RNSP) OFFICERS~~

~~Assets forfeited as a result of activities conducted by contracted RNSP officers will be used to augment CITY's law enforcement services. Because activities of this type result from the efforts of both contracted officers and other RNSP officers, the percentage of sharing will be determined pursuant to the RNSP Memorandum of Understanding in effect at the time of the seizure. Said Memorandum of Understanding provides that assets are distributed according to percentage amounts based on the number of sworn personnel participating in the RNSP at the time of the seizure. The number of personnel in RNSP, as well as the number of participating agencies in RNSP, may fluctuate during the course of a contract year, thereby affecting the percentage amounts distributed to participating agencies. The percentage amounts distributed to participating agencies may also be affected by action taken by the RNSP Executive Board.~~

~~CITY will use RNSP forfeited assets only to augment CITY's law enforcement services. If the forfeiting agency or applicable RNSP Memorandum of Understanding attaches any additional or more specific conditions on the use of said assets, CITY shall abide by those conditions. SHERIFF and CITY's manager shall determine the specific use of said assets within the conditions imposed by the forfeiting agency and the RNSP Memorandum of Understanding.~~

~~Subject to conditions imposed by the forfeiting agency and the RNSP Memorandum of Understanding and to the requirement that RNSP forfeited assets be used to augment law enforcement services, COUNTY shall place forfeited cash or cash from the sale of forfeited assets in an interest-bearing account for use in CITY in compliance with the forfeiting agency's regulations and the RNSP Memorandum of Understanding.~~
