KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the Board of Supervisors of the County of Orange, State of California, and RMV PA3 Development, LLC, a Delaware Limited Liability Company and DMB San Juan Investments North, LLC a Delaware Limited Liability Company (hereinafter designated as the "PRINCIPAL) have entered into an Agreement whereby PRINCIPAL agrees to install and complete certain designated public improvements, which said Agreement dated and identified as project: Tract Map 17933 Agreement No. S24-011014, Recycled Water Improvements is hereby referred to and made a part of hereof; and WHEREAS, said PRINCIPAL is required under the terms of said Agreement to furnish a bond guaranteeing the faithful performance of said Agreement, and WHEREAS, Atlantic Specialty Insurance Company _____as "SURETY" agrees to be held firmly bound unto PRINCIPAL in the sum of One Hundred Ninety-Eight Thousand One Hundred Forty-Nine Dollars (\$198,149) which is 100% of the total Agreement amount for the installation of the recycled water improvements (as defined in the Agreement), for the payment of which sums PRINCIPAL and SURETY agree to be bound jointly and severally, and firmly by the presents;

NOW THEREFORE, We, the PRINCIPAL and SURETY, are held and firmly bound unto the County of Orange (hereinafter called "COUNTY"), in the sum of <u>One Hundred Ninety-Eight Thousand One Hundred Forty-Nine Dollars (\$198,149)</u> lawful money of the United States, for payment of which sum well and truly made, we bind ourselves, our heirs, successors, executors

and administrators, jointly and severally, firmly by these presents. The condition of this obligation is such that if the above-bounded PRINCIPAL, his or its heirs, executors, administrators, successors or assigns, shall in all things stand to and abide by, and well and truly keep and perform the covenants, conditions and provisions in the said Agreement relative to the recycled water improvements, and any alteration thereof made as therein provided, on his or their part, to be kept and performed at the time and in a manner therein specified and in all respects according to their true intent and meaning, and shall indemnify, defend with counsel approved in writing by COUNTY, and save harmless COUNTY, its officers, agents, employees, as therein stipulated, then this obligation shall become null and void; otherwise it shall be and remain in full force and effect.

As part of the obligation secured hereby and in addition to the face amount specified therefore, there shall be included cost and reasonable expenses and fees incurred by COUNTY in successfully enforcing such obligation, all to be taxed as cost and included in any judgment rendered.

The Surety hereby stipulates and agrees that no change, extension of time, alteration or addition to the terms of the Agreement or to the work to be performed thereunder with respect to the recycled water improvements or the specifications accompanying the same shall in any way affect its obligations on this bond, and it does hereby waive notice of any such change, extension of time, alteration or addition to the terms of the Agreement, or to the work, or to the specifications relative to the recycled water improvements.


