RESOLUITON OF THE BOARD SUPERVISORS OF THE COUNTY  
OF ORANGE AUTHORIZING THE COUNTY TREASURER TO  
ESCHEAT INDIVIDUAL ITEMS IN THE AMOUNT OF \$5,000 ORLESS  
AND REPORT TO THE COUNTY AUDITOR-CONTROLLER EACH  
ACT PERFORMED, WITHOUT FURTHER ACTION OF THE BOARD  
OF SUPERVISORS

WHEREAS, California Government Code section 50050 et seq. ("the Escheatment Law") authorizes the County to escheat to the County General Fund all unclaimed property in the County treasury or in the official custody of County officers for a period of three years, following notice and provided that the property in not claimed; and

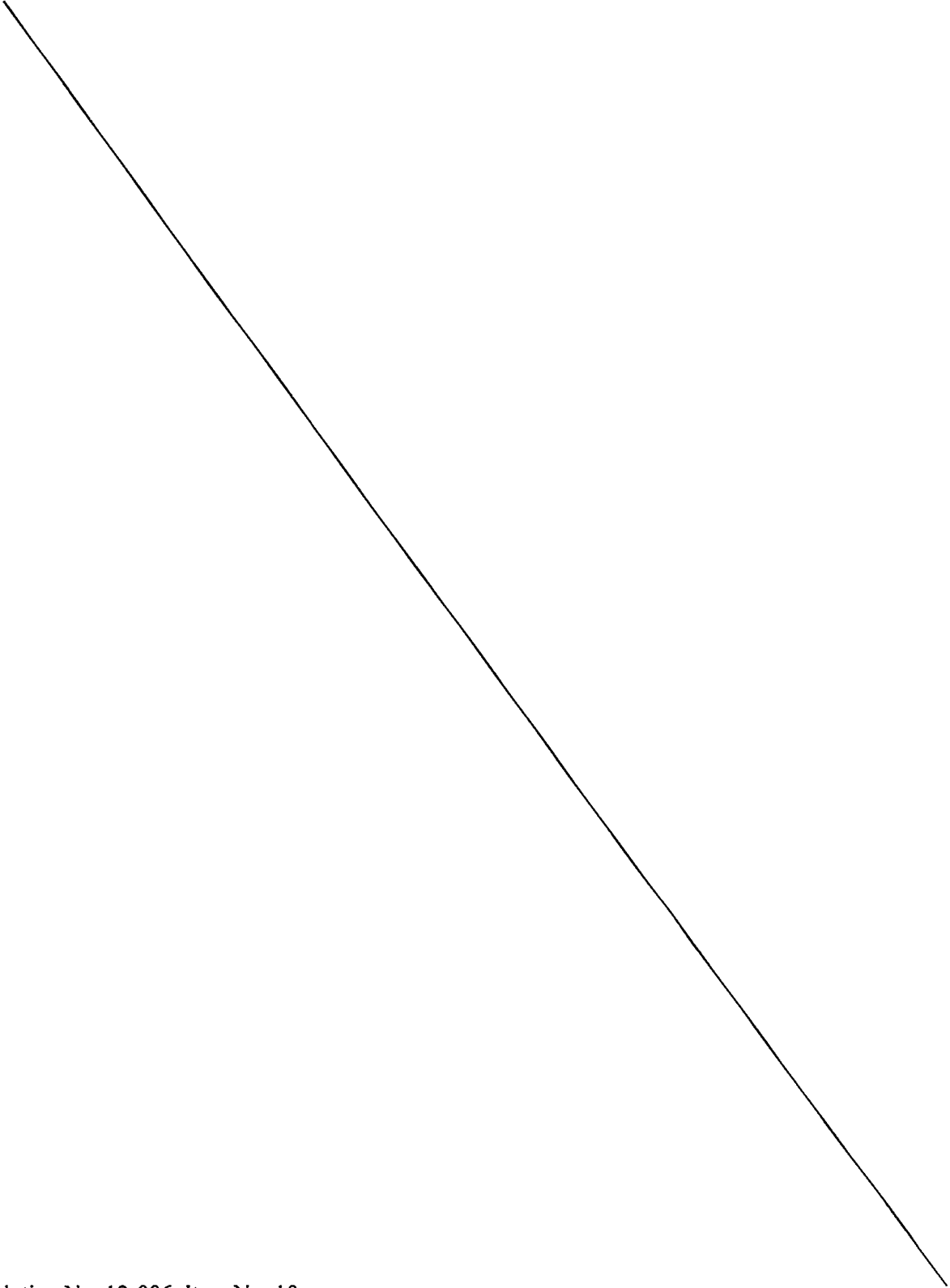
WHEREAS, the County Treasurer historically conducts an annual escheatment process, including publication and claims processing in accordance with the Escheatment Law; and

WHEREAS, the Escheatment Law, Government Code section 50057, permits this Board of Supervisors, by resolution, to authorize the County Treasurer to perform on the Board's behalf, any act required or authorized to be performed by the Board under Government Code Sections 50050, 50053 and 50055 for individual items in the amount of five thousand dollars (\$5,000) or less, and to require the Treasurer to report to the County Auditor-Controller each act performed in accordance with such Resolution;

NOW, THEREFORE

1. This Board of Supervisors hereby authorizes the County Treasurer, in accordance with California Government Section 50057, to perform on the Board's behalf, any act required or authorized to be performed by this Board under Government Code Sections 50050, 50053, and 5055 for individual items in the amount of five thousand dollars (\$5,000) or less, and to require the Treasurer to

report to the County Auditor-Controller each act performed in accordance with this Resolution.
