WHEREAS, the Board of Supervisors of the County of Orange, State of California, and RMV PA3 Development, LLC, a Delaware Limited Liability Company and DMB San Juan Investments North, LLC a Delaware Limited Liability Company, (hereinafter designated as "PRINCIPAL) have entered into an Agreement whereby PRINCIPAL agrees to install and complete certain designated public improvements, which said Agreement dated \_\_\_\_\_ and identified as project: Tract Map 17933 - Monumentation is hereby referred to and made a part of hereof; and

Should the condition of this bond be fully performed, then this obligation shall become null and void; otherwise, it shall be and remain in full force and effect.


