

#### AMENDMENT NO. 1

### TO MASTER AGREEMENT NO. MA-042-22011537 FOR MEDI-CAL MENTAL HEALTH MANAGED CARE PSYCHIATRIC INPATIENT HOSPITAL SERVICES

This Amendment ("Amendment No. 1") to Contract No. MA-042-22011537 for Medi-Cal Mental Health Managed Care Psychiatric Inpatient Hospital Services is made and entered into on September 9, 2022 ("Effective Date") between Anaheim Community Hospital, LLC, ("Contractor"), with a place of business at 3350 West Ball Road, Anaheim, CA 92804, a political subdivision of the State of California ("County"), through its Health Care Agency, with a place of business at 405 W. 5th St., Ste. 600, Santa Ana, CA 92701. Contractor and County may sometimes be referred to individually as "Party" or collectively as "Parties".

### **RECITALS**

WHEREAS, the Parties executed Contract No. MA-042-22011537 with various providers for Medi-Cal Mental Health Managed Care Psychiatric Inpatient Hospital Services, effective July 1, 2022 through June 30, 2025, for negotiated rates that are paid directly by the California Department of Health Care Services (DHCS) through the annual state allocations for Orange County, renewable for two additional periods ("Contract"); and

WHEREAS, the Parties now desire to enter into this Amendment No. 1 to amend Exhibit A of the Contract to modify the payment rates.

NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

1. Exhibit A, Paragraph IV. Payments, subparagraph A. (but not including subparagraphs A.1 through A.6), of the Contract is deleted in its entirety and replaced with the following:

"A. CONTRACTOR shall be reimbursed by DHCS for services provided at the following

all-inclusive rates per client day for acute Psychiatric Inpatient Hospital Services and based on the following accommodation codes.
