

**Amendment No. 9 to Agreement MA #074-13010138  
With Wells Fargo Bank Payment Gateway User Agreement**

This Amendment No. 9 to Agreement No. MA 074-13010138 is entered into by the County of Orange, a political subdivision of the State of California on behalf of Office of the Treasurer-Tax Collector, with a place of business at 601 N. Ross St., ~~Second~~ 2<sup>nd</sup> Floor, Santa Ana, CA 92701 (hereinafter referred to as "County") and Wells Fargo Bank, NA, a California corporation, having its principal place of business at 707 Wilshire Blvd., 11<sup>th</sup> Floor, Los Angeles, CA 90017 (hereinafter referred to as "Wells Fargo").

WHEREAS, the parties entered into Agreement No. MA 074-13010138 to provide internet payment gateway services required for accepting and processing credit and debit cards and eChecks via the internet ("ORIGINAL AGREEMENT") effective August 14, 2012 through August 13, 2013 renewable for an additional one-year term with the written consent of both parties; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 1 to renew the Agreement for an additional one-year term, effective August 14, 2013 through August 13, 2014 in the amount not to exceed \$2,300.00.

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 2 to add Tokenization Subscription services; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 3 to renew the Agreement effective August 14, 2014 through August 13, 2015; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 4 to renew the Agreement effective August 14, 2015 through August 13, 2016; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 5 to renew the Agreement effective August 14, 2016 through August 13, 2017; ~~and-~~

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 6 to renew the Agreement effective August 14, 2017 through August 13, 2018; ~~and-~~

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 7 to renew the Agreement effective August 14, 2018 through August 13, 2019; ~~and-~~

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 8 to renew the Agreement effective August 14, 2019 through August 13, 2021; and;

WHEREAS, the parties desires to extend the Agreement for an additional two-year term, effective August 14, 2021 through August 13, 2023, for an amount not-to-exceed \$20,000 over the two-year term.

NOW, THEREFORE, the parties mutually agree:

1. **Term of Agreement.** The term of the ORIGINAL Agreement is hereby extended for an additional two-year term effective August 14, 2021 through August 13, 2023, for an amount not-to-exceed \$20,000 over the two-year term.
2. The remaining provisions of the ORIGINAL AGREEMENT with Amendments shall remain the same and in full effect and force.
