This AMENDMENT NUMBER ~~ONE~~ TWO to Contract Number MA-060-21010113 (hereinafter "AMENDMENT NUMBER ~~ONE-TWO~~") between the County of Orange, a political subdivision of the State of California, operating through its Sheriff-Coroner Department (hereinafter "COUNTY"), and PVP Communications Inc, (hereinafter referred to as "CONTRACTOR") with a place of business at 2310 W. 205<sup>th</sup> Street, Torrance, CA 90501 is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Helmet Communication Kits and Installation Services on November 16, 2020, for a three (3) year term of November 16, 2020 through and including November 15, 2023, in an amount not to exceed \$465,000 renewable for two (2) additional one (1) year terms (hereinafter "ORIGINAL CONTRACT");

WHEREAS, COUNTY ~~desires to renew~~ and CONTRACTOR renewed the ORIGINAL CONTRACT on October 31, 2023 on for a one (1) year term of November 16, 2023 through and including November 15, 2024 in an amount not to exceed \$132,000 ~~and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT~~ (hereinafter 'AMENDMENT NUMBER ONE');

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term of November 16, 2024 through and including November 15, 2025 in an amount not to exceed \$132,000 and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in AMENDMENT NUMBER ONE;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

- a. Additional Terms and Conditions, Section 2 - Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:
  2. Term of Contract:  
 This Contract shall commence upon execution of all necessary signatures, and continue in effect from ~~11/16/20~~ November 16, 2020 through and including ~~11/15/24~~ November 15, 2025, unless otherwise terminated by COUNTY.
- b. Additional Terms and Conditions, Section 3 – Renewals, of the ORIGINAL CONTRACT is amended in its entirety as follows:
  3. Renewal: ~~This Contract may be renewed by mutual written agreement of both Parties for one (1) additional one (1) year term. The County does not have to give reason if it elects~~

~~not to renew. Renewal periods may be subject to approval by the County of Orange Board of Supervisors.~~ This Contract may not be renewed
