AMENDMENT NO. 2
TO CONTRACT MA-060-22010953
FOR
ON-CALL ARCHITECT/ENGINEER (A-E) ARCHITECTURAL SERVICES

This Amendment hereinafter referred to as "AMENDMENT NO. 2" to Agreement Number MA-060-22010953, hereinafter referred to as "CONTRACT", is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("COUNTY") and Lionakis ("A-E"), with COUNTY and A-E sometimes individually referred to as "PARTY" or collectively referred to as "PARTIES".

RECITALS

WHEREAS, COUNTY and A-E entered into CONTRACT for On-Call Architect/Engineer (A-E) Architectural Services, effective April 26, 2022 to April 25, 2025, in an amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000); with the option to renew for two (2) additional years with Board approval; and

WHEREAS, the PARTIES previously amended the CONTRACT to increase the Contract Amount by Two Hundred Thousand Dollars (\$200,000) for a new Total Contract Amount of One Million Seven Hundred Thousand Dollars (\$1,700,000); and,

WHEREAS, the PARTIES now desire to amend the CONTRACT to extend the term by two (2) additional years through and including April 25, 2027; and

NOW THEREFORE, the PARTIES agree as follows:

ARTICLES

1. Subsection 1.4.1 shall be amended to read in its entirety:

1.4.1 The term of this CONTRACT is for five (5) years, commencing upon approval by the Board of Supervisors (sometimes referred to as "Board"), with a maximum allowable compensation of One Million Seven Hundred Thousand Dollars (\$1,700,000),

2. Except as amended herein by this AMENDMENT NO. 2, all other terms and conditions of the CONTRACT, as amended, shall remain unchanged and in full force and effect. In the event of a conflict between the terms of this AMENDMENT NO. 2 and the Contract, as amended, this AMENDMENT NO. 2 shall control.


