



**AMENDMENT NO. 4  
TO  
CONTRACT NO. MA-042-23010987  
FOR  
ON-SITE PSYCHIATRY AND TELEPSYCHIATRY SERVICES**

This Amendment (“Amendment No. 4”) to Contract No. MA-042-23010987 for On-Site Psychiatry and Telepsychiatry Services is made and entered into on October 1, 2025 by the Parties (“Effective Date”) between Lavaca Street Ventures, LLC (“Contractor”), with a place of business at 7514 N. Mopac Expressway, Suite 100, Austin, TX 78731, and the County of Orange, a political subdivision of the State of California (“County”), through its Health Care Agency, with a place of business at 405 W. 5th St., Ste. 600, Santa Ana, CA 92701. Contractor and County may sometimes be referred to individually as “Party” or collectively as “Parties”.

**RECITALS**

WHEREAS, the Parties executed Contract No. MA-042-23010987 for Provision of On-Site Psychiatry and Telepsychiatry Services for Correctional Health Services Programs, effective April 1, 2023 through March 31, 2026, in an amount not to exceed \$22,673,460 (“Contract”); and

WHEREAS, the Parties executed Amendment No. 1 to amend the Contract, effective on the full date of execution, to modify the Referenced Contract Provisions; and

WHEREAS, the Parties executed Amendment No. 2 to amend the Contract, effective September 1, 2024, to increase the Aggregate Maximum Obligation by \$830,200 from \$22,673,460 to \$23,503,660, to modify Paragraph II., Paragraph XIV. and Exhibit A, to add Paragraph XXXIII., Exhibit D and Exhibit E, and to change the title of the Contract; and

WHEREAS, the Parties executed Amendment No. 3 to amend the Contract, effective May 21, 2025, to modify the County rules and regulations related to Information Technology Security in Exhibit A of the Contract; and

WHEREAS, the Parties now desire to enter into this Amendment No. 4 to amend the Contract, effective October 1, 2025, to increase the Aggregate Maximum Obligation by \$12,725,915 from \$23,503,660 to \$36,229,575 and to renew the Contract for one (1) year, effective April 1, 2026 through March 31, 2027.

NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

1. The Contract is renewed for a one (1) year term, effective April 1, 2026 through March 31, 2027.
2. The Contract’s Aggregate Maximum Obligation is increased by \$12,725,915 from \$23,503,660 to \$36,229,575.

3. Page 4, Referenced Contract Provisions, Aggregate Maximum Obligation provision, of the Contract is deleted in its entirety and replaced with the following:

**“Aggregate Maximum Obligation:**

Total Aggregate Maximum Obligation: \$36,229,575”

This Amendment No. 4 modifies the Contract, including all previous amendments, only as expressly set forth herein. Wherever there is a conflict in the terms or conditions between this Amendment No. 4 and the Contract, including all previous amendments, the terms and conditions of this Amendment No. 4 shall prevail. In all other respects, the terms and conditions of the Contract, including all previous amendments, not specifically changed by this Amendment No. 4 remain in full force and effect.
