

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
ORANGE COUNTY FLOOD CONTROL DISTRICT OF  
ORANGE COUNTY, CALIFORNIA

October 8, 1968

On motion of Supervisor Phillips, duly seconded and carried,  
the following Resolution was adopted:

WHEREAS, the Chief Engineer of the Orange County Flood  
Control District, in conjunction with the County Administrative Officer,  
County Road Commissioner, and the Planning Director, has prepared a  
Comprehensive Plan for Local Storm Drainage Financing in the County of  
Orange in order to help alleviate the problem of flooding of residential  
streets in the unincorporated areas of this County; and

WHEREAS, the establishment of a drainage fee program has been  
urged by the Orange County Division of the League of California Cities  
and the Building Industry Association; and

WHEREAS, Chapter 538 (Assembly Bill 1137), Statutes 1968, has  
been adopted by the State Legislature to be effective November 13, 1968,  
permitting the use of a portion of fines and forfeitures for County  
General Fund projects; and

WHEREAS, this Board finds it in the public interest to proceed  
with the proposed drainage fee program for unincorporated areas;

NOW, THEREFORE, BE IT RESOLVED that said Comprehensive Plan  
is hereby approved in principle and ordered filed.

BE IT FURTHER RESOLVED that the hereinafter referred to  
District and County officers are authorized and directed as follows:

1. The Chief Engineer and the County Administrative Officer  
are authorized to provide for:

- (a) the development and administration of a local drainage fee program within the unincorporated area;
- (b) financing and preparation of master drainage plans in geographic increments;
- (c) the drafting of a drainage fee ordinance under the direction of County Counsel; and
- (d) the drafting of appropriate revisions of the County's Subdivision Code.
