This AMENDMENT NUMBER ONE to Contract Number CT-060-22010016 (hereinafter "AMENDMENT NUMBER ONE") between the County of Orange, a political subdivision of the State of California with a place of business at 320 N. Flower Street, 2nd Floor, Santa Ana, CA 92703 (hereinafter "COUNTY") and Waterfowler Gear, Inc. dba Evans Gun World (hereinafter "CONTRACTOR") with a place of business at 1637 N Brian St., Orange, CA 92867-3423, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract Number CT-060-22010016 on September 15, 2021 for the Use of Shooting Range Facilities, for a one (1) year term of October 1, 2021 through and including September 30, 2022 (hereinafter "ORIGINAL CONTRACT") in an amount not to exceed \$135,000.00;

WHEREAS, COUNTY desires to extend the ORIGINAL CONTRACT through September 30, 2023 as CT-060-23010158, as well as to increase the contract amount by \$135,000.00 for a new not to exceed amount of \$270,000.00 and the CONTRACTOR has agreed to provide these services at the rates set forth in this AMENDMENT NUMBER ONE;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

- a. ATTACHMENT B, Compensation and Pricing Provisions, Section 2, Fees and Charges is amended in its entirety to read as follows:
2. Fees and Charges: County will pay the following fees in accordance with the provisions of the Contract. Payment shall be as follows:

Description	Rate
Hourly Rate for Tactical Range/Classroom	\$65.00/Hour

Contract shall not exceed \$270,000.00 (10/1/21-9/30/23)

2. A true and correct copy of the ORIGINAL CONTRACT (Contract Number CT-060-22010016) is attached hereto as Exhibit A and incorporated by this reference.
3. All other provisions of the ORIGINAL CONTRACT except as amended herein and to the extent they are not inconsistent with this AMENDMENT NUMBER ONE, remain unchanged and in full force and effect.
