## AMENDMENT NO. 1 TO CONTRACT MA-080-20011017 FOR JOB ORDER CONTRACT (JOC) FOR ELECTRICAL SERVICES

This Amendment is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County"), and Baker Electric, Inc. ("Contractor"), with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties."

## **RECITALS**

WHEREAS, the County and Contractor entered into Contract MA-080-20011017 for Electrical Services, effective April 12, 2020 through April 11, 2021, with a maximum allowable compensation of \$4,900,000; and

**WHEREAS,** the Parties, pursuant to DCPM Section 5.7-103(2), extended the term of the Contract for a period of six (6) months, effective April 12, 2021 to October 11, 2021, for the sole purpose of completing work already ordered prior to the expiration of the original term of the Contract; and

WHEREAS, the Parties now desire to extend the term of the Contract for three (3) additional months, effective October 12, 2021 to January 11, 2022, to allow completion of a project for the Data Center; and

NOW, THEREFORE, the Parties agree as follows:

## ARTICLES

1. Article 2 shall be amended to read as follows:

Following the Contract's award by the Board of Supervisors, this Contract shall become effective April 12, 2020 if executed with all necessary signatures by this date, or upon the date of execution of all necessary signatures if execution occurs after April 12, 2020 ("Date of Commencement"); and shall be effective through January 11, 2022.

2. All other terms and conditions of the Contract shall remain unchanged and with full force and effect.
