I am writing to express my enthusiastic support for the following contracts:

As a pediatrician, lung disease specialist, and research leader at UC Irvine, I am cognizant of the enormous impact of physical and social environments on the health of children and adults. During the pandemic, our group has worked tirelessly with Orange County agencies to keep our schools open. The collaboration led to new awareness of the importance of keeping kids in school and has beneficial effects on schools here in our region and across the country.

I cannot overemphasize the importance of understanding health and health policy issues from the perspective of a particular region or county. All to often, "one-size-fits-all" and governmental or state mandates attempt to dictate local health policies, and, in so doing, miss the key regional factors that can contribute to the success or failure of thee proposed policies. The contracts in question here are designed to avoid these problems and to ensure that the real needs of people in Orange County shape the implementation and execution of health policies.
