Dear Chairman Do:

The City of Laguna Beach City Council voted unanimously on November 10, 2021, to communicate our desire to keep the City within a contiguous coastal community of interest to include Newport Beach, Costa Mesa, and portions, if not all, of Huntington Beach, and portions of Irvine.

We understand the final maps for consideration related to the potential Supervisorial districts are not yet set and may not reflect the three maps advanced at the November 2, 2021, Board of Supervisors' meeting. However, we believe that maintaining the entire City of Laguna Beach with our coastal neighbors and portions of Irvine, based on our shared interest in the Laguna Coast Wilderness Park and Laguna Canyon entrance, meets the five stated criteria followed for drawing boundaries. As evidenced by the recent Orange County oil spill, the coastal communities share a unique bond. This bond goes beyond concern for our ocean to similar shared interests from loud vehicle noise, impacts of tourism, water quality impacts from inland sources, and sea-level rise, to name a few.

The Board of Supervisors' consideration to keep Laguna Beach in the same supervisorial district with our coastal neighbors as outlined is greatly appreciated.

Dear Members of the Orange County Board of Supervisors and Members of the 2021 Redistricting Team:

At its meeting on November 2, 2021, the Orange County Board of Supervisors conducted a public hearing on the proposed 2021 County of Orange Redistricting Maps, received public testimony on the proposed maps, and provided direction to staff to return the maps for consideration by the Board for final adoption as soon as November 9, 2021. These district maps must include a Latino-majority district in order to comply with federal law.

A district where Latinos constitute a majority of citizen voting age population is required to satisfy Section 2 of the Federal Voting Rights Act. Under Section 2, local governments are prohibited from conducting elections in a manner where members of a racial group “have less opportunity than other members of the electorate to participate in the political process and to elect representatives of their choice.” 52 U.S.C. § 10301. Section 2 guards against voter dilution and serves to ensure that communities of color have an equal opportunity to elect candidates of choice.


The demographics of Orange County clearly indicate that a compact and contiguous Latino-majority district can be drawn. A Latino-majority district is necessary to preserve this identifiable community of shared interests that would benefit from cohesive representation.

Accordingly, we strongly urge the Board to adopt a Latino-majority district map. This is necessary to comply with the requirement of Section 2 affording Latino voters the opportunity to elect their candidate of choice.

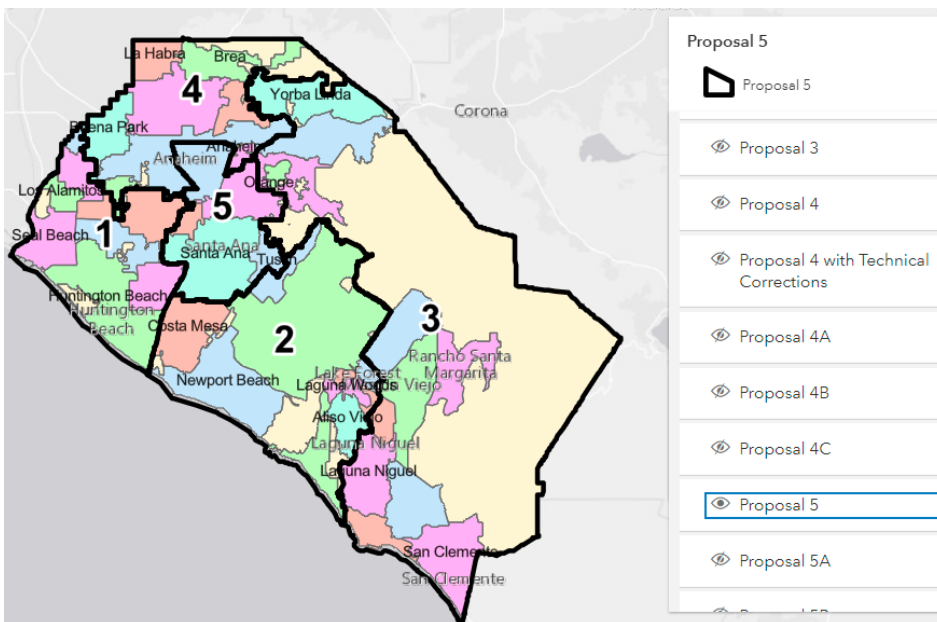

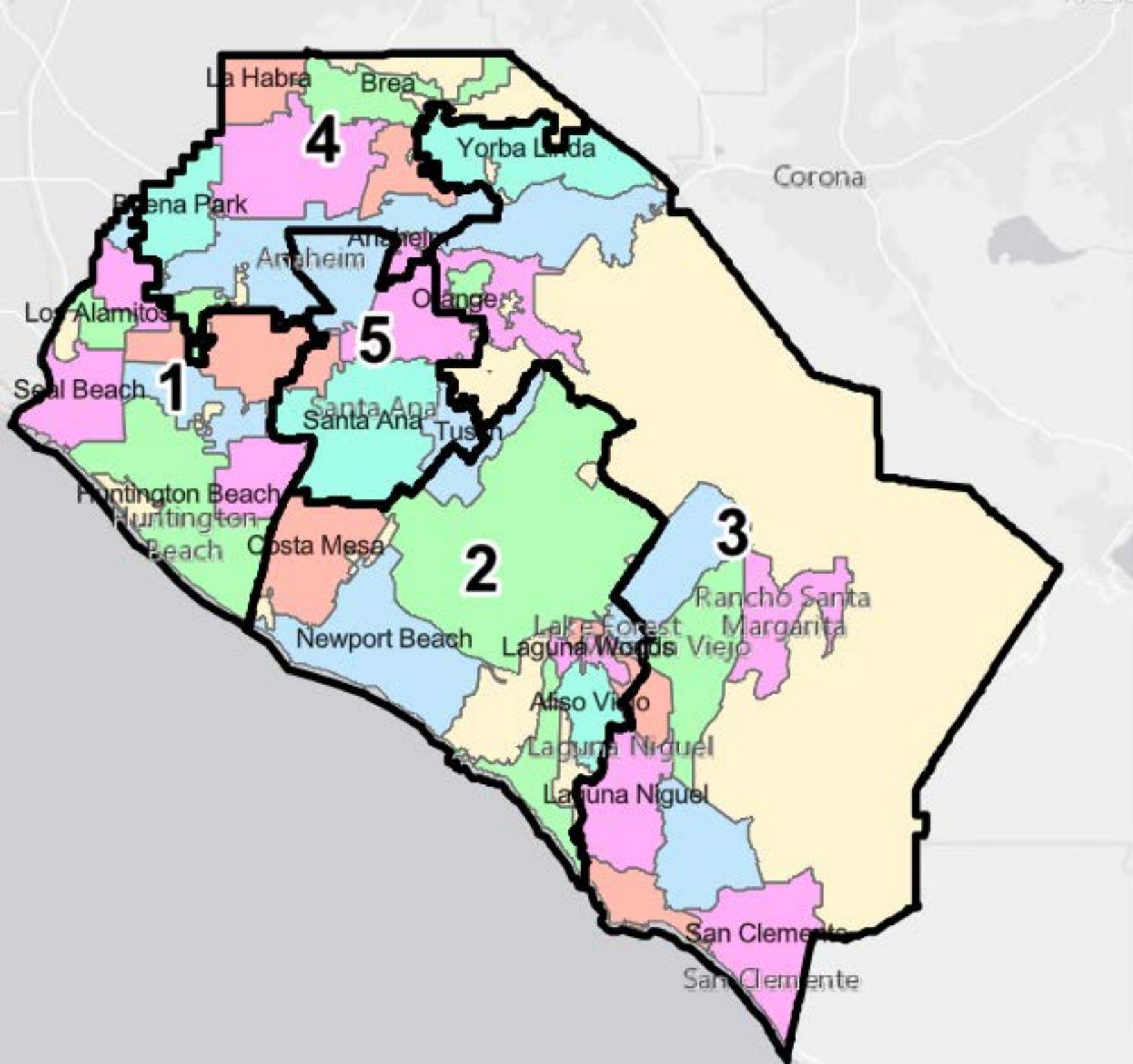

Dear OC Supervisors and relevant Staff:

Orange County must eliminate the current Republican gerrymander that has disenfranchised many OC residents for years.

I generally support the map put forward by the OC People's Redistricting Alliance, which makes a genuine effort to balance the needs of all OC residents.

At the heart of the current problem are the legacy gerrymandered supervisor districts, created by the supervisors themselves. If these gerrymandered districts continue, the process will violate the law and be subject to litigation.

Clearly the past process has been unfair in favoring one political party. To wit:

Two years ago, registered Democrats finally outnumbered registered Republicans in Orange County. Current OC data show that Dems make up 37.1% of the voter roles, Republicans 33.5%, and NPP 23.8%. (In 2016, Hillary Clinton bested Donald Trump, 51% to 42%, and Biden did even better last year, 53.5% to 44.4%.)

Going back to 2013, Dems accounted for about 33.1% of county registrations, Republicans about 43.7%, and NPPs 23.2% (source: L.A. Times, <https://www.latimes.com/politics/story/2019-08-07/orange-county-turns-blue-with-more-registered-democrats-than-republicans>)

Had districts been fairly created over nearly the past decade, we should have seen Republicans and Democrats each hold two to three seats on the Board of Supervisors. Instead, we have seen Republicans consistently hold three to five seats.

Now, with a clear Democratic majority in the county, the three Republican supervisors (and a Democratic supervisor who generally supports the Republican majority) will again carve out their own districts. It is no mystery where this is going.

The County has encouraged input from the public on the redistricting process, but I fear this

will be for naught. The redistricting software you have offered is too complicated for the public to use. And we apparently had only a week or two to figure it out and submit our own map. The maps provided for the process, and separately available from the county, generally don't identify the streets that divide districts, making it impossible to see if current (and probably the supervisor-drawn maps) comport with state law requirements that districts should be reasonably contiguous and not carved out for political purposes. A cursory viewing of current districts shows numerous squiggles and indents along district borders, on unnamed streets, possibly to capture or eliminate certain blocks of voters. It is also unclear who drew the current proposed maps on display on your website.

As you know, in the end, the current supervisors will draw their own districts. To this skeptical OC resident, the result will be yet more gerrymandering to entrench Republican supervisors.

The existing gerrymandered districts are illegal and must be corrected. The map produced by the OC People's Redistricting Alliance seems to comply with the law and ensure fair representation for all residents.

Introduction

The UCLA Voting Rights Project offers this analysis on the existence of racially polarized voting patterns in Orange County, California, that have made it difficult for Latino preferred candidates to be elected to the County Board of Supervisors. In this particular study, we look at the degree of racially polarized voting within County Board of Supervisor elections and statewide and national races to examine the support received by different Latino preferred candidates across 11 elections ranging from 2008 to 2021. The focus on this inquiry is the issue of whether or not Latinos vote different from Anglo or Non-Latino voters in Orange County.

Additionally, this report will also be analyzing the “performance” or ability to elect candidates of choice for both Latino and Asian Americans and Pacific Islander (AAPI) populations for all of the currently proposed maps being considered in Orange County. We endorse Proposal Map 5 which is currently being considered by the Orange County Board of Supervisors as the map that should be adopted.

Racially Polarized Voting and Why it is Important

All redistricting plans for every jurisdiction must comply with the Federal Voting Rights Act (VRA). Redistricting plans cannot decrease, crack, diminish or dilute, or retrogress the voting strength of racial or ethnic minorities’ ability to elect candidates of their choice. *See League of United Latin Am. Citizens v. Perry*, 548 U.S. 399, 403, 126 S. Ct. 2594, 2601, 165 L. Ed. 2d 609 (2006); *Luna v. County of Kern*, 291 F.Supp.3d 1088 (E.D. Cal. 2018); *Garza v. County of Los Angeles*, 918 F.2d 763 (9th Cir. 1990).

Specifically, Section 2b of the VRA states a violation has occurred if minority voters “have less opportunity than other members of the electorate to participate in the political process and to elect representatives of their choice.” 52 U.S.C. 10301.

When a racial, ethnic, or language minority group is sufficiently large in a political subdivision, that subdivision may be required to draw Section 2 compliant districts during the redistricting process. When determining whether to draw a Section 2 district, the political subdivision must inquire as to (1) whether the minority group is sufficiently large and geographically compact to constitute a majority in a single-member district; (2) if the minority group is political cohesive; and (3) that the majority group votes sufficiently as a bloc to cancel out or defeat the minority’s preferred candidate. *Thornburg v. Gingles*, 478 U.S. 30 (1986). The latter two questions are called the “racially polarized voting” or “RPV” analysis.

Racial polarization in voting means simply that voters of different groups are voting in polar opposite directions, rather than in a coalition. Racially polarized voting does not necessarily mean there is racist voting and the presence of RPV does not mean that voters are racist. RPV only measures outcomes of voting patterns.

If there is RPV in a jurisdiction and the presence of a sufficiently large minority population, the political subdivision must be very careful when drawing districts to ensure that districts are not

dilutive of minority populations. What this means in practice is that jurisdictions that have both RPV and large minority populations will be required to draw districts that allow minority groups to elect candidates of choice in compliance with the Voting Rights Act.

Racially Polarized Voting Analysis

The UCLA VRP has conducted analysis on voter behavior in Orange County, utilizing elections that occurred in 2021, 2020, 2018, 2016, and 2014. UCLA VRP experts have used a number of methods to examine the issue of racial polarization in Orange County. Each has been used in several previous court cases, and, as such have passed Court muster in a variety of settings. These methods produce both statistical estimates of the level of support for Latino-preferred candidates and include a graphical representation as well.

The first method is simply the examination of a series of bivariate correlations between proportions of voter preference for the Latino preferred candidate and the proportion of Latino registered voter population within the same precinct. This is meant to primarily be an instructive device, as the presence of high and statistically significant correlations suggest, but may not be in isolation, conclusive evidence of racially polarized voting. It is important to note that consistently *positive* correlations between the proportion of Latino voters and vote preference for Latino preferred candidates, resulting in by definition a *negative* correlation between the proportion of non-Latino voters and votes for Latino preferred candidates provides evidence of polarization.

The second approach to the issue of polarized voting uses ecological inference. Ecological Inference (EI) “has been the benchmark in evaluating racial polarization in voting rights lawsuits and has been used widely in comparative politics research on group and ethnic voting patterns.”¹ Two variations of EI that have emerged are referred to as King’s EI and EI: Rx C.² The two methods are closely related, and Professor Gary King, the creator of King’s EI,³ was a co-author and collaborator on the Rx C method.⁴ Generally speaking, both methods take ecological data in

the aggregate—such as precinct vote totals and racial demographics—and use Bayesian statistical methods to find voting patterns by regressing candidate choice against racial demographics within the aggregate precinct.⁵ Kings EI is sometimes referred to as the iterative approach, in that it runs an analysis of each candidate and each racial group in iterations,⁶ whereas the RxC method allows multiple rows (candidates) and multiple columns (racial groups) to be estimated simultaneously in one model.⁷

The third approach as shown below is a graphical presentation that plots the vote choice and percentage of Latino voter population of each and every precinct within Orange County. This allows the reader to easily determine whether or not difference exist between Latino and non-Latino precincts by comparing the left to right side of the scatter plot/graph. Further, by mapping out the vote results for all precincts, we can judge the consistency or inconsistency of the Latino vote and whether or not any “outlier” precincts exist. Consistent difference between Latinos and non-Latino voters in the levels of support demonstrated here augment similar findings that emerge through the correlations and homogenous precinct analysis.

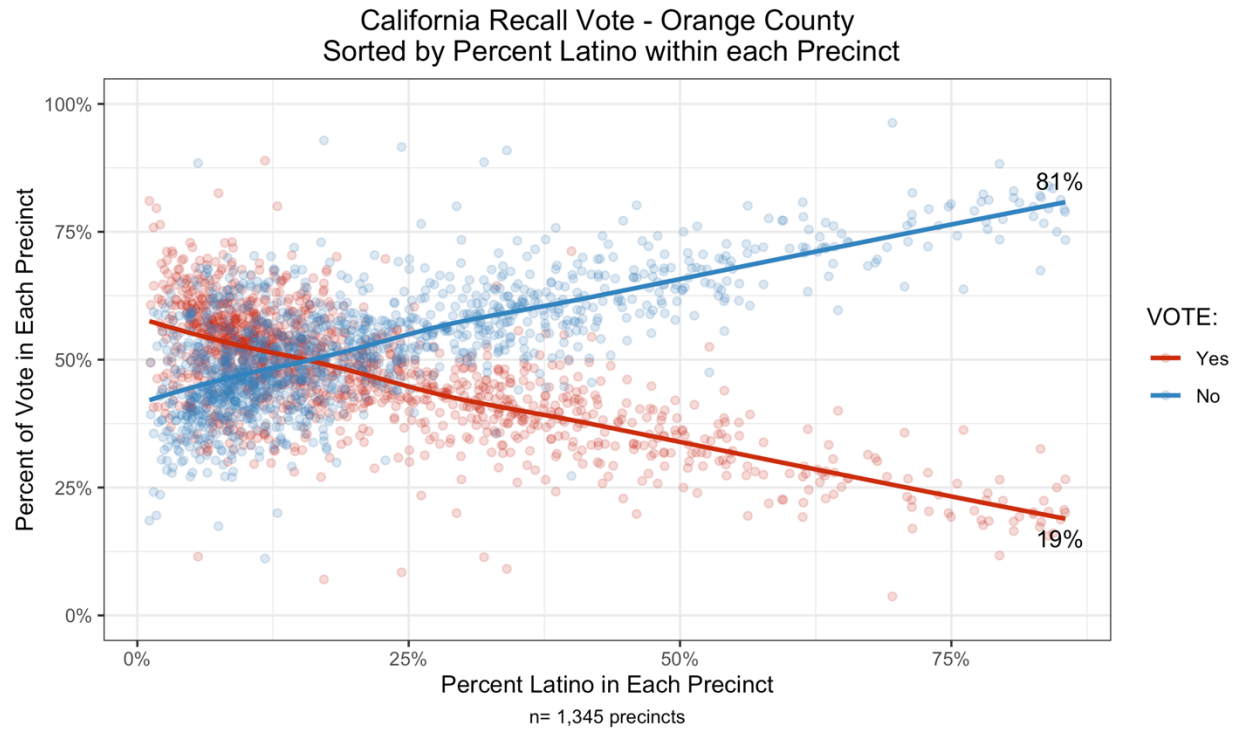
From this analysis, it is clear that voters in majority-Latino precincts vote in a different manner than precincts with majority non-Latino voters. UCLA VRP experts have determined that racially polarized voting is exhibited in Orange County elections.

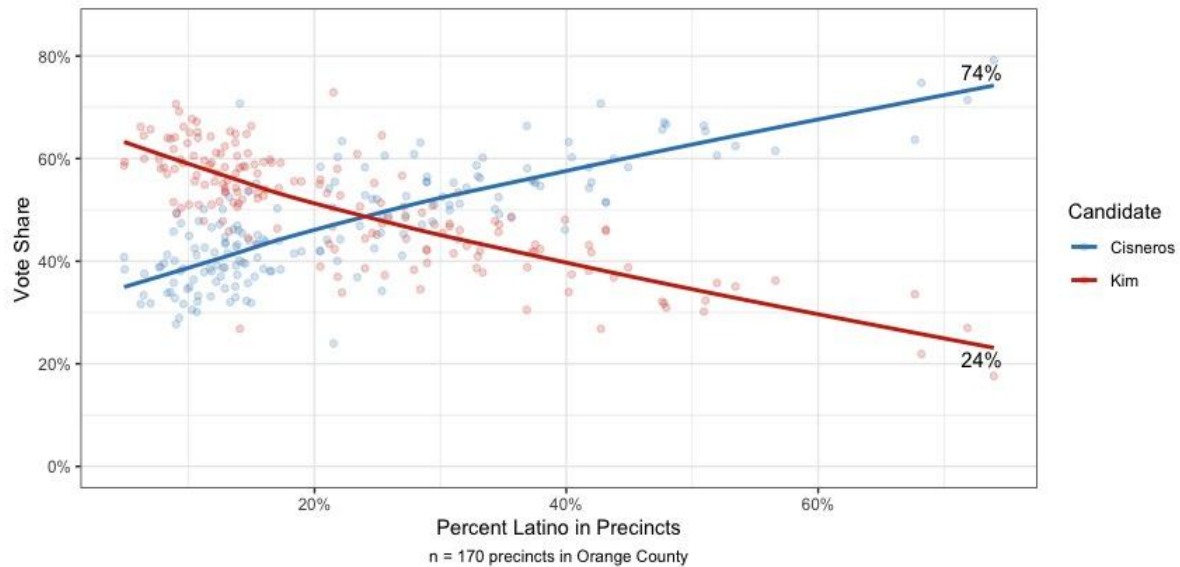

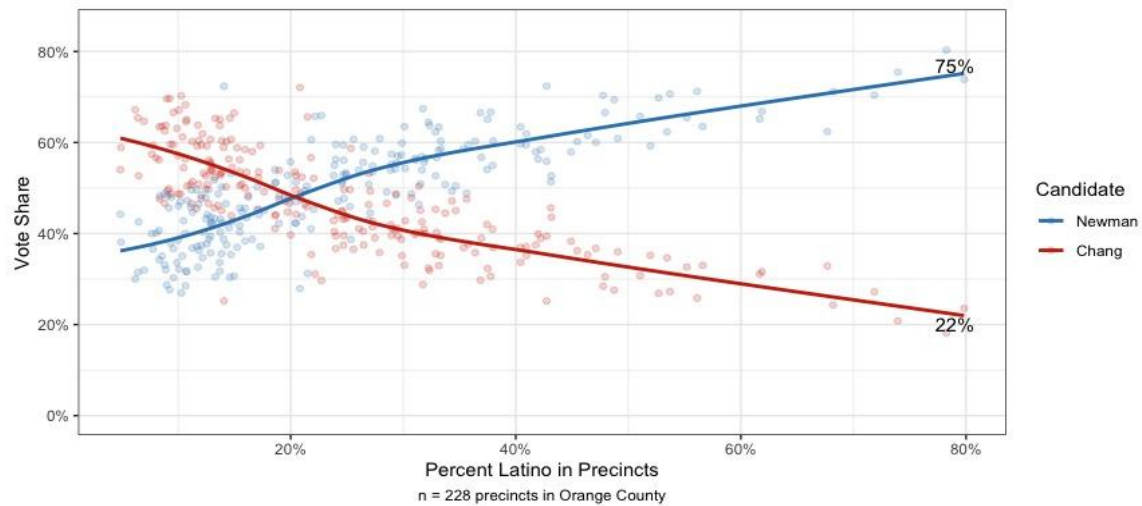

Figure 1: 2020 United States Representative 39th District Vote Choice by Percent of Latino Registered Voters in Orange County



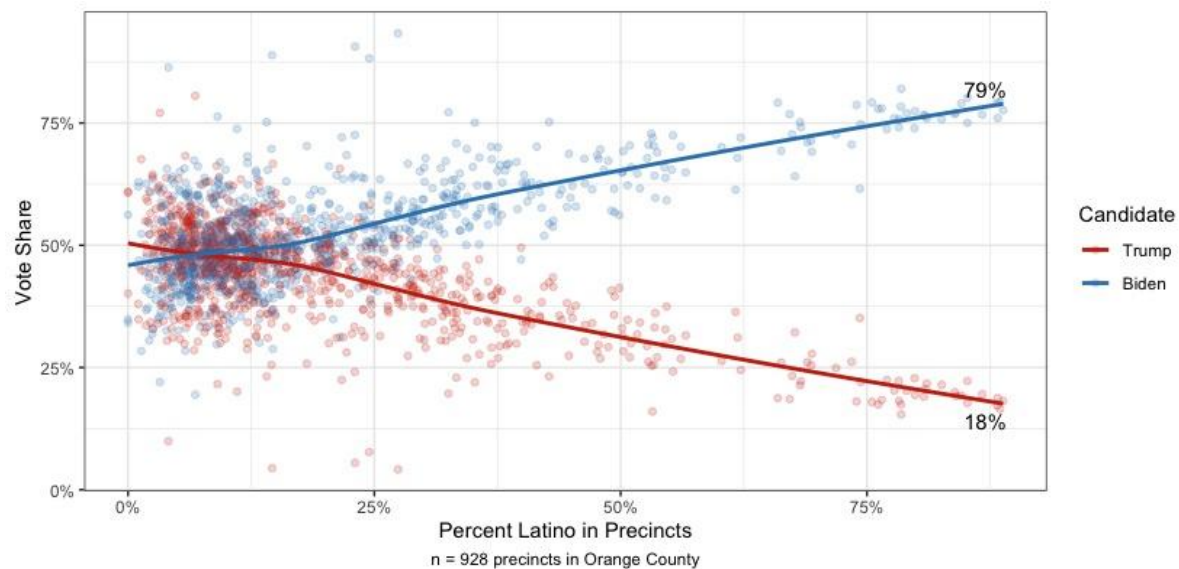

Figure 2: 2020 State Senator 29th District Vote Choice by Percent of Latino Registered Voters in Orange County



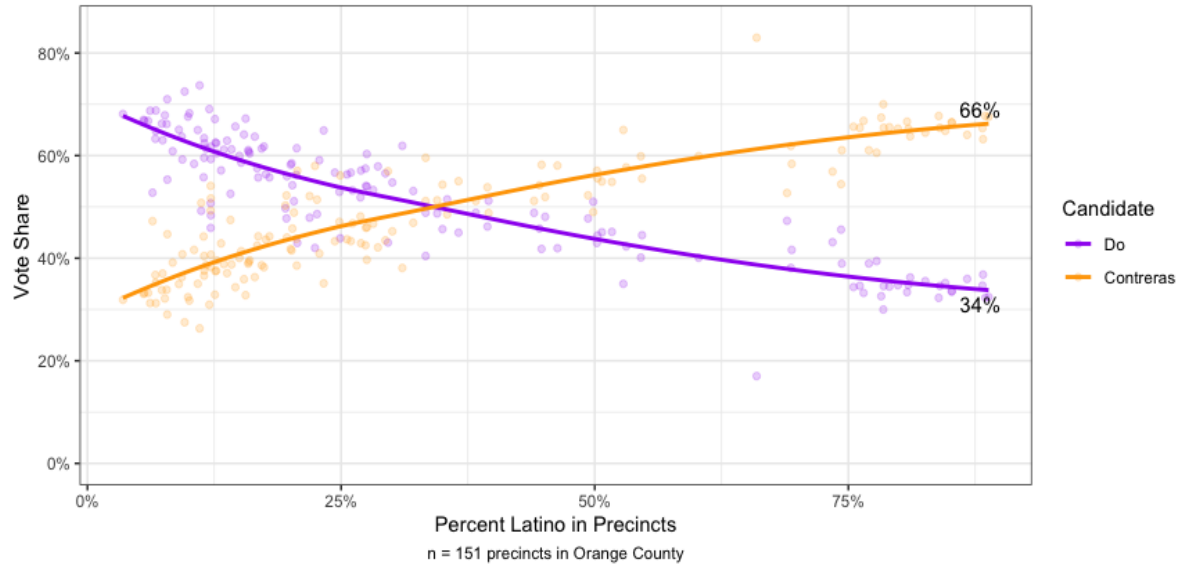

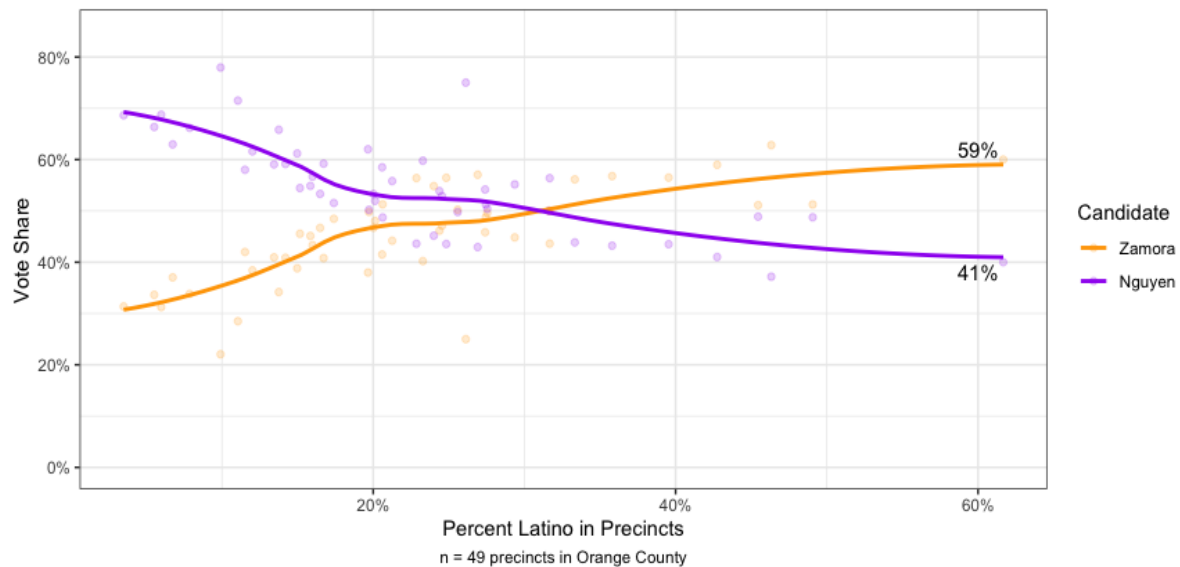
Figure 4: 2020 County Supervisor, 1st District Vote Choice by Percent of Latino Registered Voters in Orange County

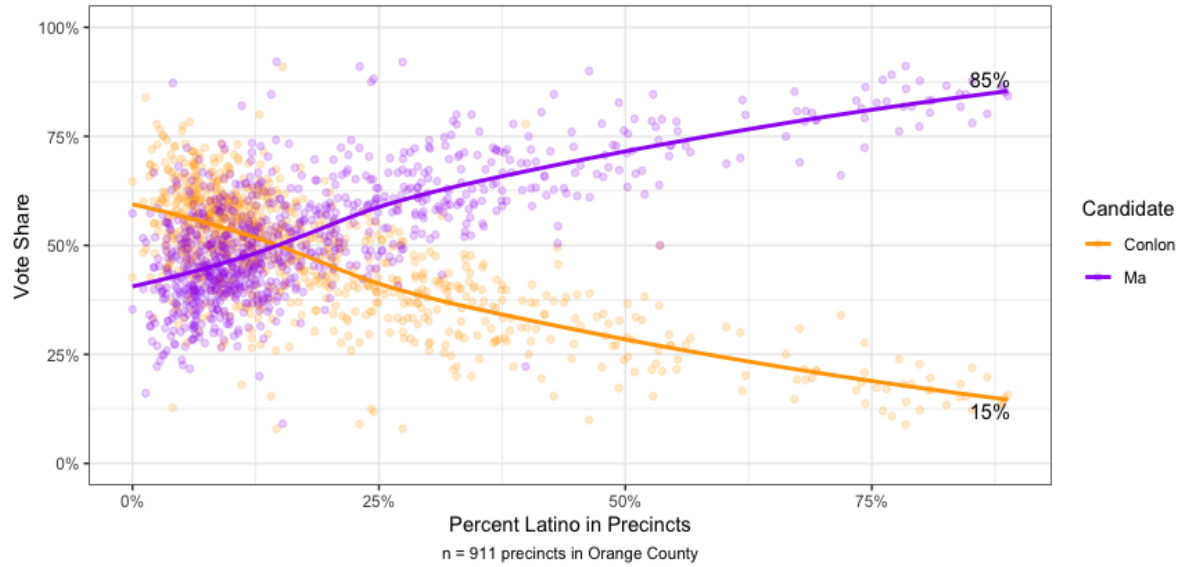

Figure 5: 2018 OC Water District Director, Division 1 Vote Choice by Percent of Latino Registered Voters in Orange County



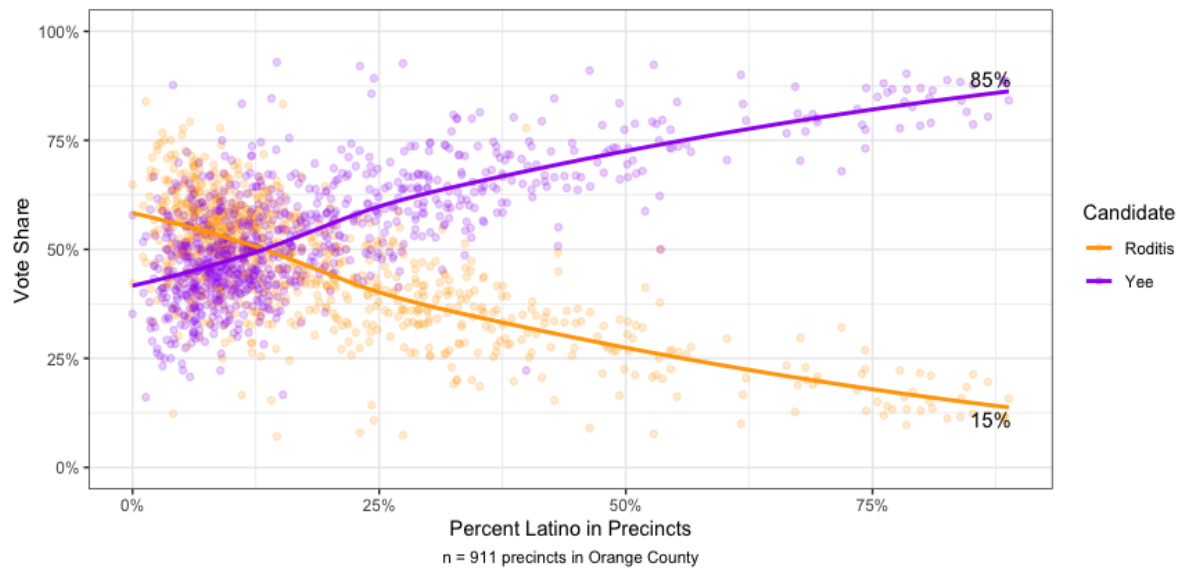

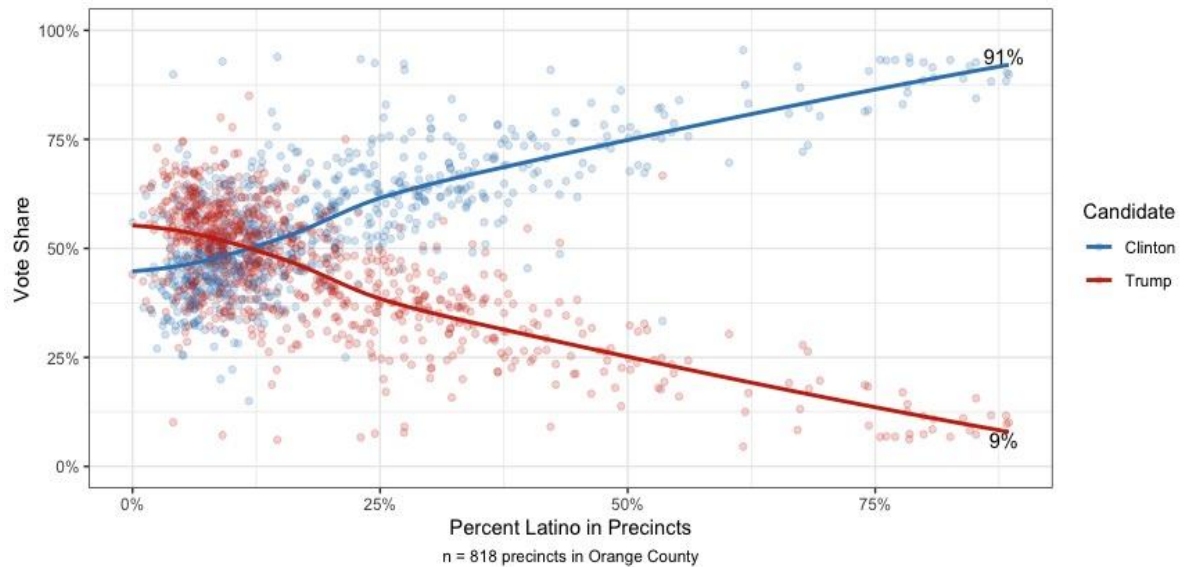
Figure 7: 2018 Controller Vote Choice by Percent of Latino Registered Voters in Orange County

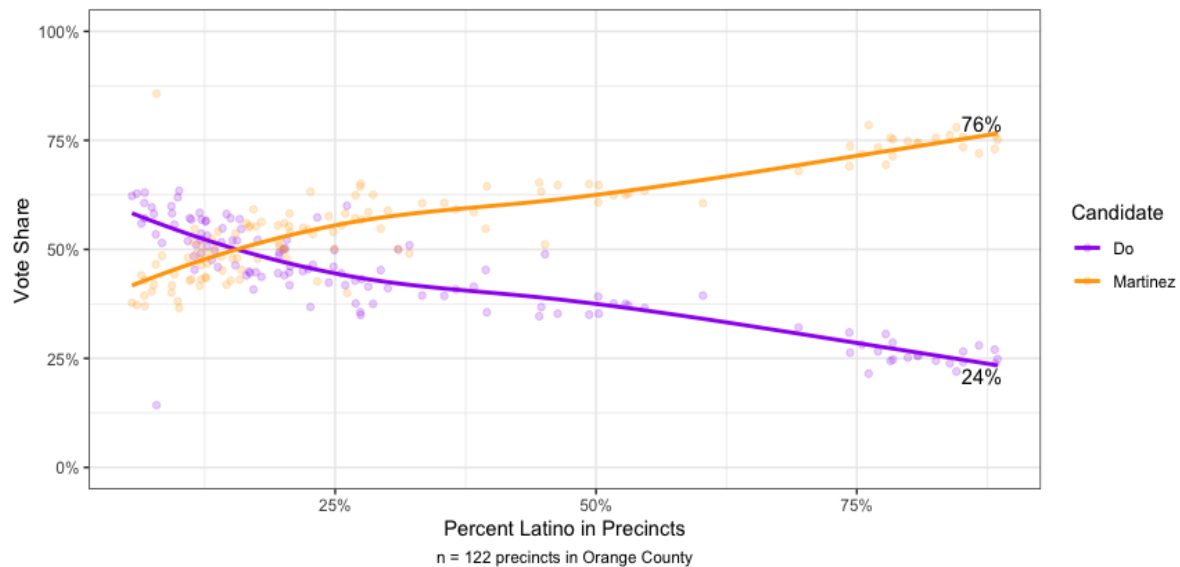

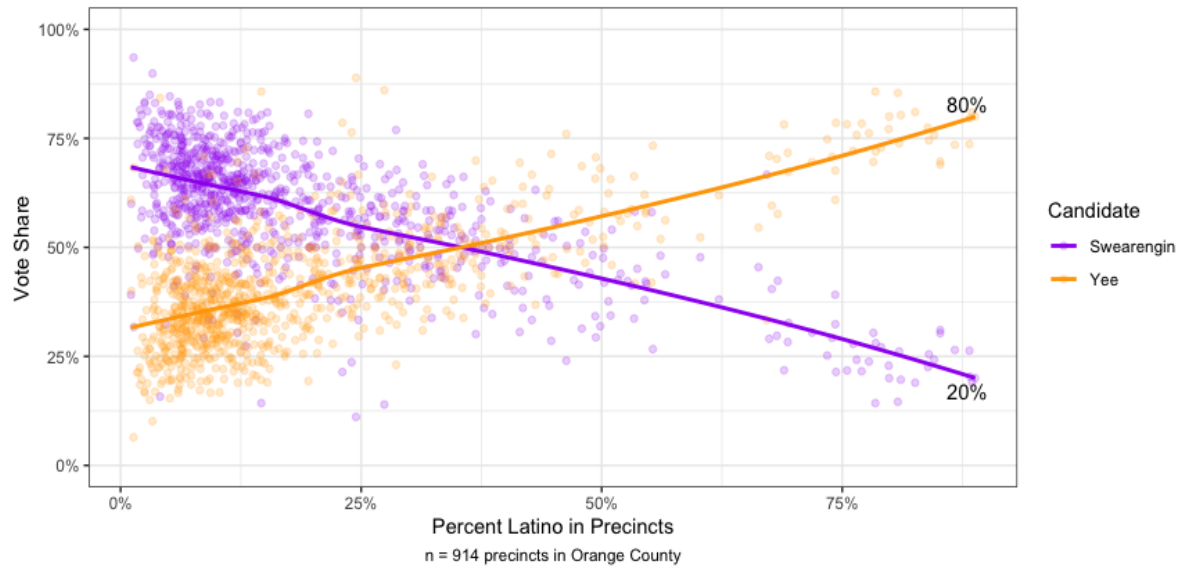
Figure 9: 2016 County Supervisor 1st District Vote Choice by Percent of Latino Registered Voters in Orange County

Performance Analysis

The UCLA Voting Rights Project conducted what is called a performance analysis or a reconstituted precinct analysis to determine whether the proposed maps being considered in practice elect candidates of choice for Latino and AAPI voters. UCLA VRP experts have determined that Proposal 5's Districts 5 and 4 preform for Latino preferred candidates, in compliance with the law.

Dear Orange County Board of Supervisors:

On November 1, 2021, the UCLA Voting Rights Project (VRP) published a report analyzing redistricting for the Orange County Board of Supervisors and detailed the necessary steps the County would need to take to ensure full compliance with the United States Constitution, federal law, and the California Constitution. On November 2, 2021, Sonni Waknin, Managing Attorney and Voting Rights Counsel at the UCLA Voting Rights Project, and Michael Rios, Data Analyst at the UCLA Voting Rights Project, offered public comment on the existence of racially polarized voting in Orange County and submitted our report to the Board of Supervisors.

After our testimony, on November 5, 2021, the Orange County Board of Supervisors released revised proposals and technical corrections for the maps that they will be considering on November 9, 2021.

The UCLA Voting Rights Project reviewed the other proposals being considered by the Orange County Board of Supervisors to assess whether or not those maps would comply with the law and not dilute the Latino population in the County. It is the view of UCLA VRP experts that Map 5 or 5A should be adopted by the County.

First, the proposed Map 4C is in violation of Section 2 of the Voting Rights Act because it does not create a Latino-majority district. The largest Latino CVAP district in Map 4C is District 2, which has a Latino CVAP of 49.8%. The next highest is District 4 at 34.1%. This map clearly dilutes Latino voters and would not perform because the map does not have a district with Latino CVAP higher than 50.1%, which is considered the benchmark threshold for the creation of a new Section 2 district. *See Bartlett v. Strickland*, 556 U.S. 1 (2009). Beyond mere CVAP size, the map must also be shown to perform to elect minority candidates of choice, through a combination of minority voting strength and some cross-over voting from other racial groups.

More troublesome is that in proposal map 4A, the map attempts to ensure that Latinos do not elect candidates of choice by drawing a district that on its fact appears to be compliant with Section 2 of the VRA, but in practice does not elect Latino candidates of choice because the Latino CVAP is the bare minimum benchmark. Additionally, 4A egregiously cracks the Latino majority city of Anaheim into **four** different districts. This map should not be adopted by the Board of Supervisors.

Additionally, proposed Maps 2, 2A, 4, 4B all have similar problems with diluting and cracking the Latino populations in Orange County. Maps 2 creates one Latino-Majority districts, but then

ensures that there is no ability for Latinos to have influence in other districts. It is dilutive in that it splits the Latino populations of Fullerton and La Habra into Districts 3 and 4. Map 2A also creates one Latino-Majority district in District 4, but then similarly cracks and dilutes the Latino populations between Districts 1 and Districts 3 by splitting Anaheim, Fullerton, and La Habra between the two districts in a manner to ensure that Latinos could not be successful in influencing elections in either district. Map 4B is similar to Map 4 in that it creates one Latino-Majority district, but then cracks the Latino population into two different districts to lessen their influence.

UCLA Voting Rights Project experts have analyzed Proposed Map 5 and have found that the map complies with Section 2 of the Voting Rights Act and performs for Latino preferred candidates. Map 5 and Map 5A both create a majority-Latino district and have a second minority-opportunity district which both perform to elect candidates of choice. Either of these maps are viable options for adoption because they ensure that Latino voters are not diluted.

Compliance with the Voting Rights Act is not optional, and Orange County must adopt a map that does not dilute the Latino population and creates districts that empower minority voters to elect candidates of choice.
