AMENDMENT NO. 2 (RENEWAL) TO CONTRACT MA-080-18010603 FOR ON-CALL FLOOD CONTROL SERVICES

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County"), and Tetra Tech, Inc. ("A-E"), with County and A-E sometimes individually referred to as "Party" or collectively referred to as "Parties."

RECITALS

WHEREAS, County and A-E entered into Contract MA-080-18010603 for On-Call Flood Control Services, effective December 12, 2017 through December 11, 2020, in an amount not to exceed \$2,500,000 (the "Contract"); and

WHEREAS, on July 22, 2019, pursuant to Amendment No. 1, the Parties amended the Contract to update A-E Key Personnel and add three additional Classification Titles for services required under this Contract; and

WHEREAS, on July 22, 2020, pursuant to Amendment No. 1, the Parties amended the Contract to update provisions of the Contract to conform with County standard language; and

WHEREAS, the Parties now desire to renew the Contract for two (2) additional years, effective December 12, 2020 to December 11, 2022, in an amount not to exceed \$1,000,000; and

NOW THEREFORE, the Parties agree as follows:

ARTICLES

- 1. Subsection 1.4.1 shall be amended to read in its entirety as follows:
 - **1.4.1** The term of this CONTRACT is for two (2) years, commencing upon approval by the COUNTY Board of Supervisors, effective December 12, 2020 through December 11, 2022, with a maximum allowable compensation of one million (\$1,000,000), except as permitted in Paragraph 1.5 below.
- 2. Attachment B, Section II, Paragraph B shall be amended to read in its entirety as follows:
 - B. Total AGREEMENT Amount Shall Not Exceed: \$1,000,000
- 4. All other terms and conditions of the Contract shall remain unchanged and with full force and effect.
