This Amendment ("Amendment No. 42") to Contract No. MA-042-22010466 for Unarmed Security Guard Services is made and entered into on—22nd 1st day of March January, 20223 ("Effective Date") between AG Coast Corporation ("Contractor"), with a place of business at 3374 Thistlewood Lane, Perris, CA 925715777 W. Century Blvd, Ste. 1601, Los Angeles, CA 90045, and the County of Orange, a political subdivision of the State of California ("County"), through its Health Care Agency, with a place of business at 200 W. Santa Ana Blvd., Ste. 650, Santa Ana, CA 92701. Contractor and County may sometimes be referred to individually as "Party" or collectively as "Parties".

RECITALS

WHEREAS, the Parties executed Contract No. MA-042-22010466 for Unarmed Security Guard Services, effective September 30, 2021 through June 30, 2022, in an amount not to exceed \$199,000 ("Contract"); and

WHEREAS, the Parties now desire to enter into this executed Amendment No. 1 to increase the Contract's amount not to exceed amount by \$250,000 and to renew the Contract for six (6) months.

NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

- 1. The Contract's amount not to exceed is increased by \$250,000, for a revised total amount not to exceed \$449,000.
- 2. The Contract is renewed for six (6) months, effective July 1, 2022 through December 31, 2022, in an amount not to exceed \$350,000 for this renewal term, for a revised cumulative contract total amount not to exceed \$799,000 and

WHEREAS, the Parties now desire to enter into this Amendment No. 2 to renew the Contract for one (1) year.

NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

 The Contract is renewed for one (1) year, effective January 1, 2023 through December 31, 2023, in an amount not to exceed \$549,000 for this renewal term, for a revised cumulative contract total amount not to exceed \$1,348,000; on the amended terms and conditions.

This Amendment No. 42 modifies the Contract, including all previous amendments, only as expressly set forth herein. Wherever there is a conflict in the terms or conditions between this

In all other respects, the terms and conditions of the Contract, including all previous amendments, not specifically changed by this Amendment No. 42 remain in full force and effect.
