

AMENDMENT NUMBER ONE TO CONTRACT NUMBER MA-080-21010806

WITH

ANSER ADVISORY MANAGEMENT, LLC FOR

ON-CALL LANDFILL CONSTRUCTION SUPPORT SERVICES

THIS Amendment Number One ("Amendment") to Contract Number MA-080-21010806 for On-Call Landfill Construction Support Services ("Contract") is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California, through its OC Waste & Recycling Department ("County") and Anser Advisory Management LLC, ("A-E"). County and Contractor are collectively referred to as "Parties."

RECITALS

WHEREAS, the County and A-E entered into Contract MA-080-21010806 ("Contract") for On-Call Landfill Construction Support Services, effective January 26, 2021 through January 25, 2024, with a maximum allowable compensation of one million seven hundred fifty thousand (\$1,750,000); and

WHEREAS, County now desires to renew Contract Number MA-080-21010806, for two (2) years effective January 26, 2024 through January 25, 2026, with a maximum allowable compensation of one million four hundred thousand (\$1,400,000);

NOW, THEREFORE, the Parties mutually agree as follows:

ARTICLES

1. Article 1.4. shall be amended to include:

The term of this Contract is renewed for two (2) years, commencing upon Board of Supervisor approval, January 26, 2024, through January 25, 2026, with a maximum allowable compensation of one million four hundred thousand (\$1,400,000), except as permitted in Paragraph 1.5.

2. Attachment B, Section II, Paragraph B shall be amended to include the following:

Renewal Contract Amount Shall Not Exceed: \$1,400,000

3. Except as amended herein, all remaining terms and conditions of the Contract shall remain unchanged, in full force and effect.
