AMENDMENT NUMBER THREE FOUR TO CONTRACT MA-060-13011794 BETWEEN THE COUNTY OF ORANGE AND L-3 COMMUNICATIONS MOBILE-VISION INC

This AMENDMENT NUMBER THREE FOUR to Contract number MA-060-13011794 (hereinafter "AMENDMENT NUMBER THREE FOUR") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and L3 Communications Mobile-Vision, Inc. (hereinafter "CONTRACTOR") with a business address of 400 Commons Way, Ste. F, Rockaway, NJ 07866-2030, is made and entered upon execution of all necessary signatures.

RECITALS

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Digital In-Car Video System (PVS) Maintenance and Support on June 17, 2013, as Contract Number MA-060-13011794 (hereinafter "ORIGINAL CONTRACT"), for a one-year term of June 24, 2013 through and including June 23, 2014 with a not to exceed amount of \$11,000 renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on June 17, 2014, as Contract Number MA-060-14011791 (hereinafter "AMENDMENT NUMBER ONE") for a one (1) year term of June 24, 2014 through and including June 23, 2015 and increased the not to exceed amount of the contract from \$11,000.00 to \$63,000.00 to cover maintenance services for the additional equipment purchased on June 17, 2013 that is no longer covered under the initial one-year manufacturer's warranty;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on June 23, 2015, as Contract Number MA-060-15011953 (hereinafter "AMENDMENT NUMBER TWO") for a one (1) year term of June 24, 2015 through and including June 23, 2016;

WHEREAS, COUNTY desires to renew and CONTRACTOR renewed the ORIGINAL CONTRACT on May 24, 2016, as Contract Number MA-060-16011829 (hereinafter "AMENDMENT NUMBER THREE") for a one (1) year term of June 24, 2016 through and including June 23, 2017 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT;

WHEREAS, COUNTY desires to amend the ORIGINAL CONTRACT to revise Attachment A Scope of Work to add Saddleback Station to item D Locations and increase the not to exceed amount by \$17,668.45 for a new not to exceed contract amount of \$80,668.45 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. <u>ARTICLES</u>

a. Additional Terms and Conditions, Section 2 - Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 6/24/13 through and including 6/23/17, unless otherwise terminated by COUNTY. The period of 6/24/13 through and including 6/23/14 shall be known as Contract number MA 060-13011794. The period of 6/24/14 through and including 6/23/15 shall be known as Contract number MA 060-14011791. The period of 6/24/15 through and including 6/23/16 shall be known as Contract number MA 060-15011953. The period of 6/24/16 through and including 6/23/17 shall be known as Contract number MA 060-16011829. This Contract may be renewed for one (1) additional one year term and upon mutual agreement of both parties. The County is not required to provide a reason in the event it elects not to renew the Contract.
