RESOLUTION OF THE BOARD OF SUPERVISORS OF ORANGE COUNTY, CALIFORNIA January 15, 2013

WHEREAS, the County of Orange desires to undertake its project designated "The Alcohol and Drug Impaired Driver Vertical Prosecution Program" to be funded in part from funds made available through California Office of Traffic Safety (hereafter referred to as OTS).

NOW, THEREFORE, BE IT RESOLVED that this Board does hereby:

- Find that the proposed project is exempt from CEQA pursuant to 14 C.C.R.
 15061(b)(3) because it does not impose a significant effect on the environment.
- Find that pursuant to Section 711.4 of the California Fish and Game Code, the
 proposed project is exempt from the required fees as it has been determined that
 no adverse impacts to wildlife resources will result from the project.
- 3. Authorize the District Attorney, or his designee, to sign and execute, on behalf of the County of Orange, a Grant Agreement with OTS for the Alcohol and Drug Impaired Driver Vertical Prosecution Program, effective from October 1, 2013 through September 30, 2014, in the amount not to exceed \$628,326.
- 4. Authorize the District Attorney, or his designee, to execute, on behalf of the County of Orange, any extensions or amendments that do not materially alter the terms of the grant award.
