WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on January 29, 2013, as Contract number MA-060-13011062 (hereinafter "AMENDMENT NUMBER TWO"), for a one (1) year term of February 1, 2013 through and including January 31, 2014 and amended the CONTRACT to increase the annual contract amount to \$1,800,445.00;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on January 29, 2014, as Contract number MA-060-14010789 (hereinafter "AMENDMENT NUMBER THREE"), for a one (1) year term of February 1, 2014 through and including January 31, 2015 and added an additional one (1) year renewal to the ORIGINAL CONTRACT;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on January 27, 2015, as Contract number MA-060-15010996 (hereinafter "AMENDMENT NUMBER FOUR"), for a one (1) year term of February 1, 2015 through and including January 31, 2016 and added an additional one (1) year renewal to the ORIGINAL CONTRACT:

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on January 12, 2016 as Contract number MA-060-16010998 ("hereinafter AMENDMENT NUMBER FIVE"), for a one (1) year term of February 1, 2016 through and including January 31, 2017;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on December 13, 2016 as Contract number MA-060-17010667 (hereinafter "AMENDMENT NUMBER SIX") for a one (1) year term of February 1, 2017 through and including January 31, 2018 in an amount not to exceed \$1,800,445 desires to renew the ORIGINAL CONTRACT as Contract number MA-060-17010667 for a one (1) year term of February 1, 2017 through and including January 31, 2018 in an amount not to exceed \$1,800,445.00 and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-18010907 for a one year term of February 1, 2018 through and including January 31, 2019 and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

a. Section 1 – Term of Contract of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 2/1/11 through and including 1/31/18 1/31/19, unless otherwise terminated by County. The period of 2/1/11 through and including 1/31/12 shall be known as Contract number MA-060-11011428. The period of 2/1/12 through and including 1/31/13 shall be known as Contract number MA-060-12011039. The period of 2/1/13 through and including 1/31/14 shall be known as Contract number MA-060-13011062. The period of 2/1/14 through and including 1/31/15 shall be known as Contract number MA-060-14010789. The period of 2/1/15 through and including 1/31/16 shall be known as Contract number MA-060-15010996. The period of 2/1/16 through and including 1/31/17 shall be known as Contract number MA-060-16010998. The period of 2/1/17 through and including 1/31/18 shall be known as Contract number MA-060-17010667. The period of 2/1/18 through and including 1/31/19 shall be known as Contract number MA-060-18010907. This Contract is non-renewable. This Contract may be renewed for one (1) additional one (1) year term by mutual agreement of both Parties.

The COUNTY is not under any obligation to provide CONTRACTOR with a reason should it elect not to renew this Contract, nor is the COUNTY obligated to provide any prior notice to Contractor of its intent not to renew the Contract.
