This AMENDMENT to Contract #15-27-0028, hereinafter referred to as "First Amendment," is made and entered into upon execution of all necessary signatures between the County of Orange, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Alzheimer's Family Services Center, a non-profit corporation, with a place of business at 9451 Indianapolis Avenue, Huntington Beach, California 92646, hereinafter referred to as "CONTRACTOR" which are sometimes referred to as "PARTY," or collectively referred to as "PARTIES."

## **RECITALS:**

WHEREAS, COUNTY and CONTRACTOR entered into Contract Number 15-27-0028 (hereinafter referred to as "Original Contract"), for the provision of Adult Day Care Services, commencing July 1, 2015 and ending June 30, 2016 in the amount of \$81.211.00 and

WHEREAS, the PARTIES now desire to increase the CONTRACT by the monetary amount of \$10,260.00, for a new maximum obligation of \$91,471.00 and replace Attachment A, Units of Service, with Attachment A - Revision 1; and replace Attachment B, Budget Proposal Summary & Match, with Attachment B - Revision 1; and

**WHEREAS**, CONTRACTOR's performance is satisfactory as required by the CONTRACT;

# **NOW THEREFORE**, the PARTIES agree as follows:

- 1. Article 3 "Payments" "A" of the CONTRACT shall be amended to read as follows:
  - 3. Payments:
    - A. <u>Maximum obligation of COUNTY</u>. COUNTY will pay CONTRACTOR for the cost of the services provided up to a maximum obligation of \$91,471.00. Minimum Required Match is reflected in Attachment B Revision 1.
- 2. Attachment A, Scope of Services, is replaced with Attachment A Revision 1. Attachment B, Budget, is replaced with Attachment B Revision 1.
- Except as otherwise expressly set forth herein, all terms and conditions contained in the Original Contract, including any amendments/modifications, are hereby incorporated herein by this reference as if fully set forth herein and shall remain in full force and effect.
