This AMENDMENT NUMBER ~~TWO~~ THREE to Contract number MA-060-11011428 (hereinafter "AMENDMENT NUMBER ~~TWO~~ THREE") between the County of Orange, a political subdivision of the state of California (hereinafter "COUNTY") and **Juguilon Medical Corp.** (hereinafter "CONTRACTOR") with a place of business at 19241 Redford ~~Ln.~~ Lane, Huntington Beach, CA 92648-2135, is made and entered upon execution of all necessary signatures.

WHEREAS, COUNTY and CONTRACTOR executed a Contract to provide **Forensic Pathology Autopsy Services**, Contract Number MA-060-11011428 (hereinafter "ORIGINAL AGREEMENT"), for a one (1) year term of February 1, 2011 through and including January 31, 2012 renewable for four (4) additional one (1) year term;

~~**WHEREAS**, COUNTY and CONTRACTOR extended ORIGINAL CONTRACT term for one (1) additional one (1) year term of February 1, 2012 through and including January 31, 2013 (hereinafter "AMENDMENT NUMBER ONE") at the rates set forth in the ORIGINAL AGREEMENT;~~

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL AGREEMENT, as Contract number MA-060-12011039 (hereinafter "AMENDMENT NUMBER ONE"), for a one (1) year term of February 1, 2012 through and including January 31, 2013;

~~**WHEREAS**, The Parties desires to extend the ORIGINAL CONTRACT term for an additional one (1) year term from February 1, 2012 through and including January 31, 2014 and to increase Contract annual amount to \$1,800,445.00 ;~~

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL AGREEMENT, as Contract number MA-060-13011062 (hereinafter "AMENDMENT NUMBER TWO"), for a one (1) year term of February 1, 2013 through and including January 31, 2014 and amended the AGREEMENT to increase the annual contract amount to \$1,800,445.00;

WHEREAS, COUNTY desires to renew the ORIGINAL AGREEMENT for another one (1) year term and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL AGREEMENT, AMENDMENT ONE and TWO; provided that an additional one year renewal is added to the Contract: and

FURTHERMORE, COUNTY desire to change the Contract number from MA-060-13011062 to become Contract number MA-060-14010789.

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

a. ~~Section 1 -~~ **Term of Contract** of the ORIGINAL AGREEMENT is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 2/1/11 through and including 1/31/~~14~~15, unless otherwise terminated by COUNTY. The period of 2/1/11 through and including 1/31/12 shall be known as Contract number MA-060-11011428. The period of 2/1/12 through and including 1/31/13 shall be known as Contract number MA-060-12011039. The period of 2/1/13 through and including 1/31/14 shall be known as Contract number MA-060-13011062. ~~The period of 2/1/14 through and including 1/31/15 shall be known as Contract number MA-060-14010789.~~ This Contract may be renewed for three (3) separate additional one (1) year terms by mutual agreement of both Parties. ~~The County does not have to give reason if it elects not to renew.~~

The COUNTY is not under any obligation to provide CONTRACTOR with a reason should it elect not to renew this Contract, nor is the COUNTY obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

~~2. Attachment C of the ORIGINAL AGREEMENT is hereby amended by substituting the Contract Yearly Fee of \$1,699,000.00 with \$1,800,445.00.~~

All other provisions of the ORIGINAL AGREEMENT, and AMENDMENT NUMBER ~~S~~ ONE ~~to the extent they are not inconsistent with this AMENDMENT NUMBER~~ and TWO, ~~remain unchanged and in full force and effect. All obligations of the Parties that would have been terminated on January 31, 2013 are hereby extended to January 31, 2014.~~ to the extent they are not inconsistent with this AMENDMENT NUMBER THREE, remain unchanged and in full force and effect.
