SECTION 25022 CA Gov't Code Art 2 Chap 1 Part 2 Div 2 Title 3

In any emergency affecting the interest of the County or when any defalcation or official misconduct comes to his knowledge, the Chairman shall forthwith call a special meeting of the board to consider the matter in the board is not then in session.

SECTION 25042 CA Gov't Code Art 3 Chap 1 Part 2 Div 2 Title 3

Any supervisor who (a) refuses or neglects to perform any duty imposed on him, without just cause, or (b) willfully violates any law provided for his government as a supervisor or (c) fraudulently or corruptly performs any duty imposed on him or (d) willfully, fraudulently, or corruptly attempts to perform an act as a supervisor which is authorized by law, in addition to any other penalty prescribed by law, forfeits to the County five hundred dollars for every such act, to be recovered on his official bond, and is further liable on his official bond to any person injured thereby for all damages sustained

SECTION 25303 CA Gov't Code Chap 4 Part 2 Div 2 Title 3

The Board of Supervisors shall supervise the official conduct of all County officers ... it shall see that they faithfully perform their duties ... The Board of Supervisors shall not obstruct the investigative function of the sheriff of the County nor shall it obstruct the investigative and prosecutorial function of the district attorney of a county.
