AMENDMENT NUMBER ONE TWO TO AGREEMENT MA-060-11011428 BETWEEN THE COUNTY OF ORANGE AND JUGUILON MEDICAL CORPORATION

This AMENDMENT NUMBER ONE—TWO to Contract number MA-060-11011428 (hereinafter "AMENDMENT NUMBER ONE"TWO) between the County of Orange, a political subdivision of the state of California (hereinafter "COUNTY") and **Juguilon Medical Corp**. (hereinafter "CONTRACTOR") with a place of business at 19241 Redford Ln., Huntington Beach, CA 92648-2135, is made and entered upon execution of all necessary signatures.

WHEREAS, COUNTY desires to continue receiving services from CONTRACTOR for an additional one (1) year term and the CONTRACTOR has agreed to provide those goods/services at the rates set forth in the ORIGINAL AGREEMENT, provided that an additional one year renewal is added to the Contract;

WHEREAS, The Parties desires to extend the ORIGINAL CONTRACT term for an additional one (1) year term from February 1, 2012 through and including January 31, 2014 and to increase Contract annual amount to \$1,800,445.00;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. <u>ARTICLES</u>

a. Section **Term of Contract** of the ORIGINAL AGREEMENT is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 2/1/11 through and including 1/31/13,14 unless otherwise terminated by COUNTY. The period of 2/1/11 through and including 1/31/12 shall be known as Contract number MA-060-11011428. The period of 2/1/12 through and including 1/31/13 shall be known as Contract number MA-060-12011039. The period of 2/1/13 through and including 1/31/14 shall be known as Contract number MA-

060-13011062. This Contract may be renewed for four (4) separate additional one (1) year terms by mutual agreement of both Parties. The County does not have to give reason if it elects not to renew.

- 4. All other provisions of the ORIGINAL AGREEMENT, to the extent they are not inconsistent with this AMENDMENT NUMBER ONE, remain unchanged and in full force and effect. All obligations of the Parties that would have been terminated on January 31, 2012 are hereby extended to January 31, 2013.
