AMENDMENT NUMBER THREE TO SUBORDINATE CONTRACT MA-012-17011816 WITH CLEAN HARBORS ENVIRONMENTAL SERVICES INC. FOR ON-CALL ENVIRONMENTAL CLEAN-UP SERVICES

This Amendment Number Three, hereinafter referred to as "Amendment" is made and entered into upon execution of all necessary signatures between the County of Orange, a political subdivision of the State of California, hereinafter referred to as "County" and Clean Harbors Environmental Services Inc., with a place of business at 42 Longwater Drive, Norwell, MA 02061, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party", or collectively referred to as "Parties".

RECITALS

WHEREAS, the County and Contractor entered into Subordinate Contract MA-012-17011816 for On-Call Environmental Clean-Up Services, hereinafter referred to as "Subordinate Contract", commencing on June 13, 2017 through March 26, 2018, in an amount not to exceed \$275,000; and

WHEREAS, the Parties issued Amendment Number One to renew Subordinate Contract for one (1) year, commencing March 27, 2018 through March 26, 2019, in an amount not to exceed \$275,000; and

WHEREAS, the Parties issued Amendment Number Two to increase by \$48,492.55, for a not to exceed amount of \$323,492.55.

WHEREAS, the Parties are desirous to renew Subordinate Contract; and

NOW, THEREFORE, the Parties mutually agree as follows:

- 1. **Contract is REVISED:** The term of Subordinate Contract MA-012-17011816 is renewed for one year, effective March 27, 2019 through and including March 26, 2020, in an amount not to exceed \$275,000. This Subordinate Contract is renewable for two (2) additional years, upon mutual agreement of both parties. The County is not obligated to give a reason or notice if it elects no to renew.
- 2. All other Contract Terms and Conditions remain unchanged: This Amendment modifies the Subordinate Contract only as expressly set forth above. This Amendment Number Three does not modify, alter or amend the Subordinate Contract in any other way whatsoever. Except as amended herein, all other terms and conditions of the Subordinate Contract remain unchanged. Except as otherwise expressly set forth herein, all terms and conditions contained in the Contract, including its Amendments are incorporated by this reference as if fully set forth herein and shall remain in full force and effect as amended herein.
