This AMENDMENT NUMBER ~~TWO~~ THREE to Contract number MA-060-15011324 for Septic Tank Pumping, Cleaning and Maintenance (hereinafter "AMENDMENT NUMBER ~~TWO~~ THREE") by and between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Orange County Pumping Inc., (hereinafter "CONTRACTOR") with a place of business at 630 S. Hathaway St., Santa Ana, CA 92705, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Septic Tank Pumping, Cleaning and Maintenance, Contract number MA-060-15011324 (hereinafter "ORIGINAL AGREEMENT"), for a one-year term of March 3, 2015 through and including March 2, 2016;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on February 23, 2016 as Contract number MA-060-16011341 (hereinafter "AMENDMENT NUMBER ONE") for a one year term of March 3, 2016 through and including March 2, 2017;

WHEREAS, COUNTY and CONTRACTOR ~~desires to~~ renewed the ORIGINAL CONTRACT on February 14, 2017 as Contract Number MA-060-17011163 (hereinafter "AMENDMENT NUMBER TWO") for a one year term of March 3, 2017 through and including March 2, 2018 and amended Attachment B, Pricing to include a Contract not to exceed amount of \$120,000/year ~~and the CONTRACTOR has agreed to provide those goods/services at the rates set forth in the ORIGINAL CONTRACT;~~

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-18010809 for a one year term of March 3, 2018 through and including March 2, 2019 and the CONTRACTOR has agreed to provide those goods/services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

ARTICLES

- a. Additional Terms and Conditions, Section 2 Term of Contract of the ORIGINAL CONTRACT is amended in its entirety as follows:

1. **Term of Contract:**

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 3/3/15 through and including 3/2/~~18~~19, unless otherwise terminated by COUNTY. The period of 3/3/15 through and including 3/2/16 shall be known as Contract number MA-060-15011324. The period of 3/3/16 through and including 3/2/17 shall be known as Contract number MA-060-16011341. The period of 3/3/17 through and including 3/2/18 shall be known as Contract number MA-060-17011163. The period of 3/3/18 through and including 3/2/19 shall be known as Contract number MA-060-18010809. This Contract may be renewed for ~~two~~ one (2) separate additional one-year terms by mutual written agreement of both Parties. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

~~b. Attachment B, Pricing of the ORIGINAL CONTRACT is amended to add the following:~~

~~Contract shall not exceed: \$120,000/year~~

5. All other provisions of the ORIGINAL CONTRACT, ~~and~~ AMENDMENT NUMBER ONE and AMENDMENT NUMBER TWO ~~except as amended~~ herein and to the extent they are not inconsistent with this AMENDMENT NUMBER THREE, remain unchanged and in full force and effect.

In the alternative, a single corporate signature is acceptable when accompanied by a corporate document demonstrating the legal authority of the signature to bind the company.~~

**If the contracting party is a corporation, (2) two signatures are required: (1) signature by the Chairman of the Board, the President or any Vice President; and one (1) signature by the Secretary, any Assistant Secretary, the Chief Financial Officer or any Assistant Treasurer. The signature of one person alone is sufficient to bind a corporation, as long as he or she holds corporate offices in each of the two categories described above. For County purposes, proof of such dual office holding will be satisfied by having the individual sign the instrument twice, each time indicating his or her office that qualifies under the above described provision.*

In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signature to bind the company.
