# AMENDMENT NUMBER TWO THREE TO CONTRACT MA-060-15011162 BETWEEN THE COUNTY OF ORANGE AND FUJITEC AMERICA INC.

This AMENDMENT NUMBER TWO THREE to Contract number MA-060-15011162 for Elevator Maintenance and Repair Services, (hereinafter "AMENDMENT NUMBER TWO THREE") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Fujitec America Inc., (hereinafter "CONTRACTOR") with a place of business at 19840 Hamilton Avenue, Torrance, CA 90502, is made and entered upon execution of all necessary signatures.

### **RECITALS:**

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Elevator Maintenance and Repair Services on March 24, 2015, Contract Number MA-060-15011162 (hereinafter "ORIGINAL CONTRACT") for a one-year term of April 1, 2015 through and including March 31, 2016, renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on March 4, 2016 as Contract Number MA-060-16011495 (hereinafter "AMENDMENT NUMBER ONE") for a one-year term of April 1, 2016 through and including March 31, 2017;

WHEREAS, COUNTY and CONTRACTOR desires to renew the ORIGINAL CONTRACT ON March 14, 2017, as Contract Number MA-060-17011165 for a one-year term of April 1, 2017 through and including March 31, 2018 and amend Attachment B, Pricing to add a Contract not to exceed amount of \$32,000/year (hereinafter "AMENDMENT NUMBER TWO") and the CONTRACTOR has agreed to provide the goods/services at the rates set forth in the ORIGINAL CONTRACT;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-18010757 for a one-year term of April 1, 2018 through and including March 31, 2019 and the CONTRACTOR has agreed to provide the goods/services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

## 1. **ARTICLES**

a. Original Contract, Additional Terms and Conditions, Section2, Term of Contract, is amended to read in its entirety as follows:

### 1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 4/1/15 through and including 3/31/189, unless otherwise terminated by COUNTY. The period of 4/1/15 through and including 3/31/16 shall be known as Contract number MA-060-15011162. The period of 4/1/16 through and including 3/31/17 shall be known as Contract number MA-060-16011495. The period of 4/1/17 through and including 3/31/18 shall be known as Contract number MA-060-17011165. The period of 4/1/18 through and including 3/31/19 shall be known as Contract number MA-060-18010757. This Contract may be renewed for two one (1) (2) additional one-year terms by mutual written agreement of both Parties. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

b. Attachment B, Pricing of the ORIGINAL CONTRACT is amended to add the following:

Contract shall not exceed: \$32,000/year
