# AMENDMENT NUMBER FOUR TO SUBORDINATE CONTRACT NUMBER MA-012-17011816 WITH CLEAN HARBORS ENVIRONMENTAL SERVICES INC. FOR ON-CALL ENVIRONMENTAL CLEAN-UP SERVICES

This Amendment to Contract MA-012-17011816, herein referred to as "Amendment", is made and entered into upon execution of all necessary signatures between the County of Orange, OC Community Resources, OC Parks, a political subdivision of the State of California, hereinafter referred to as "County" and Clean Harbors Environmental Services Inc., with a place of business at 42 Longwater Drive, Norwell MA 02061, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

### **RECITALS**

WHEREAS, County and Contractor entered into Subordinate Contract Number MA-012-17011816, hereinafter referred to as "Subordinate Contract", for On-Call Environmental Clean-Up Services, commencing on June 13, 2017 through and including March 26, 2018, in an amount not to exceed \$275,000.00; and

WHEREAS, Parties executed Amendment One to renew Contract for one additional year effective March 27, 2018 through March 26, 2019, in an amount not to exceed \$275,000.00; and

WHEREAS, Parties executed Amendment Two to increase Contract by \$48,492.55 for the period effective June 13, 2017 through March 26, 2018, for a revised amount not to exceed \$323,493.00; and

WHEREAS, Parties executed Amendment Three to renew Contract for one additional year effective March 27, 2019 through March 26, 2020, in an amount not to exceed \$275,000.00; and

WHEREAS, County now desires to renew Contract for one additional year and revise Contract Terms and Conditions; and

NOW THEREFORE, in consideration of the mutual obligations set forth herein, the Parties mutually agree as follows:

- 1. Contract shall be renewed for its fourth year term effective from March 27, 2020 through March 26, 2021, in an amount not to exceed \$275,000.00.
- 2. Revise Articles, Section 4, Notices, to delete the existing "cc" addressee, address and contact information and replace it with the following:

3. Revise Articles, Section 5, Invoicing and Payment Instruction, in its entirety and replace it with the following:

"5. Invoicing and Payment Instructions: Invoices shall reference Subordinate Contract MA-012-17011816 and are to be submitted electronically to <a href="mailto:einvoice@occr.ocgov.com">einvoice@occr.ocgov.com</a>.

Payment will be net 30 days after receipt of an invoice in a format acceptable to the County of Orange and verified and approved by the agency/department and subject to routine processing requirements. *The responsibility for providing an acceptable invoice rests with the contractor.*"

4. Except as otherwise expressly set forth herein, all terms and conditions contained in the Original Contract, including any amendments/modifications, are hereby incorporated herein by this reference as if fully set forth herein and shall remain in full force and effect.
