**SUBORDINATE CONTRACT MA-012-17011816
WITH CLEAN HARBORS ENVIRONMENTAL SERVICES INC.
FOR ON-CALL ENVIRONMENTAL CLEAN-UP SERVICES**

THIS Subordinate Contract, (hereinafter referred to as "Contract"), for On-Call Environmental Clean-Up Services, is made and entered into as of the date fully executed by and between the County of Orange, OC Community Resources, a political subdivision of the State of California, (hereinafter referred to as "County") and Clean Harbors Environmental Services Inc., a State of Massachusetts corporation, (hereinafter referred to as "Contractor"), with County and Contractor sometimes individually referred to as "Party", or collectively referred to as "Parties".

RECITALS

WHEREAS, the County of Orange, OC Public Works has issued Contract MA-080-17011161 ("Cooperative Contract") for On-Call Environmental Clean-Up Services, effective March 27, 2017 through March 26, 2018; and

WHEREAS, County of Orange, OC Community Resources, desires to enter into a Subordinate Contract for On-Call Environmental Clean-Up Services;

WHEREAS, Contractor agrees to provide On-Call Environmental Clean-Up Services to the County in accordance with the terms, conditions and pricing of Cooperative Contract, incorporated herein by this reference; and,

NOW, THEREFORE, in consideration of the mutual obligations as set forth herein, the Parties mutually agree as follows:

ARTICLES

1. **Scope of Contract:** This Contract, including Attachment A, specifies the contractual terms and conditions by which the Contractor will provide On-Call Environmental Clean-Up Services under a fixed- price Contract.
2. **Term:** The term of Contract MA-012-17011816 is renewed for a period of one (1) year, effective March 27, 2019 ~~20~~ through and including March 26, 2020, ~~21~~, in an amount not to exceed \$275,000. This Contract is renewable for ~~two (2)~~ **one (1)** additional year, upon mutual agreement of both parties. The County is not obligated to give a reason or notice if it elects not to renew. Renewal amendments may require approval of the County Board of Supervisors.
3. **Compensation:** Contractor agrees to provide the goods/services as set forth in Attachment A, at the fixed rates specified in Contract. Total compensation under this Contract shall not exceed \$275,000.
4. **Notices:** Any and all notices, requests demands and other communications contemplated, called for, permitted, or required to be given hereunder shall be in writing, except through the course of

the Parties' Project Managers' routine exchange of information and cooperation during the terms of the work and services. Any written communications shall be deemed to have been duly given upon actual in-person delivery, if delivery is by direct hand, or upon delivery on the actual day of receipt or no greater than four calendar days after being mailed by US certified or registered mail, return receipt requested, postage prepaid, whichever occurs first. The date of mailing shall count as the first day. All communications shall be addressed to the appropriate Party at the address stated herein or such other address as the Parties hereto may designate by written notice from time to time in the manner aforesaid.
