DBA The Genesis Group (hereinafter "CONTRACTOR") with a place of business at 601 Shelley Drive, Ste 101, Tyler, TX 75701-9437 is made and entered upon execution of all necessary signatures.

RECITALS

WHEREAS, COUNTY and CONTRACTOR executed a Contract for GenGET, GW3 NetVista and Data Warehouse Offsite Support & Maintenance on April 8, 2014, as Contract Number MA-060-14011360 (hereinafter "ORIGINAL CONTRACT"), for a one-year term of April 23, 2014 through and including April 22, 2015, renewable for four (4), additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on March 14, 2015, as Contract Number MA-060-15011390 (hereinafter "AMENDMENT NUMBER ONE"), for a one-year term of April 23, 2015 through and including April 22, 2016;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on March 29, 2016, as Contract Number MA-060-16011141 (hereinafter "AMENDMENT NUMBER TWO"), for a one-year term of April 23, 2016 through and including April 22, 2017;

WHEREAS, COUNTY and CONTRACTOR ~~desires to~~ renewed the ORIGINAL CONTRACT on March 28, 2017 as Contract Number MA-060-17011485, for a one-year term of April 23, 2017 through and including April 22, 2018; ~~and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT;~~

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-18011178, for a one-year term of April 23, 2018 through and including April 22, 2019 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

a. Additional Terms and Conditions, Section Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 4/23/14 through and including 4/22/18, unless otherwise terminated by COUNTY. The period of 4/23/14 through and including 4/22/15 shall be known as Contract number MA-060-14011360. The period of 4/23/15 through and including 4/22/16 shall be known as Contract number MA-060-15011390. The period of 4/23/16 through and including 4/22/17 shall be known as Contract number MA-060-16011141. The period of 4/23/17 through and including 4/22/18 shall be known as Contract number MA-060-17011485. The period of 4/23/18 through and including 4/22/19 shall be known as Contract number MA-060-18011178. This Contract may not be renewed. ~~This Contract may be renewed for one (1) additional, one-year term by mutual written agreement of both Parties. Each renewal of this Contract may require approval by the County of Board of Supervisors. The County does not have to give a reason if it decides not to renew.~~
