This AMENDMENT NUMBER ~~TWO~~ THREE to CONTRACT number MA-060-13011549 (hereinafter “AMENDMENT NUMBER ~~TWO~~ THREE”) between the County of Orange, a political subdivision of the State of California, operating through its Sheriff’s Department, (hereinafter “COUNTY”) and **Traditional Funeral Services, Inc.**, (hereinafter “CONTRACTOR”) with a place of business at **24000 Alicia Parkway, Building 17, Suite 265, Mission Viejo, CA 92691**, is made and entered upon execution of all necessary signatures.

RECITALS

WHEREAS, COUNTY and CONTRACTOR executed ORIGINAL CONTRACT on April 9, 2013 for Body Transportation Services, as Contract number MA-060-13011549 (hereinafter “ORIGINAL CONTRACT”), for a one (1) year term of April 15, 2013 through and including April 14, 2014, renewable for four (4) additional one (1) year terms;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on April 8, 2014 for a one (1) year term of April 15, 2014 through and including April 14, 2015, as Contract number MA-060-14011458 (hereinafter “AMENDMENT NUMBER ONE”);

WHEREAS, COUNTY ~~desires to renew~~ and CONTRACTOR renewed the ORIGINAL CONTRACT on March 10, 2015 for a one (1) year term of April 15, 2015 through and including April 14, 2016, as Contract number MA-060-15011132 and the CONTRACTOR ~~has agreed to provide those services at the rates set forth in AMENDMENT NUMBER ONE~~ (hereinafter “AMENDMENT NUMBER TWO”);

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term of April 15, 2016 through and including April 14, 2017, as Contract number MA-060-16011404 and the CONTRACTOR has agreed to provide those services at the rates set forth in AMENDMENT NUMBER ONE;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

- a. Additional Terms and Conditions, Section 2 - Term of Contract of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 4/15/13 through and including 4/14/~~16~~17, unless otherwise terminated by COUNTY. The period of 4/15/13 through and including 4/14/14 shall be known as Contract MA-060-13011549. The period of 4/15/14 through and including 4/14/15 shall be known as Contract number MA-060-14011458. The period of 4/15/15 through and including 4/14/16 shall be known as Contract number MA-060-15011132. The period of 4/15/16 through and including 4/14/17 shall be known as Contract number MA-060-16011404. This Contract may be renewed for ~~two (2) separate~~ one (1) additional one (1) year term by mutual agreement of both Parties.

The COUNTY is not under any obligation to provide CONTRACTOR with a reason should it elect not to renew this Contract, nor is the COUNTY obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

2. A true and correct copy of the ORIGINAL CONTRACT (Contract number MA-060-13011549) is attached hereto as Exhibit A and incorporated by this reference.
3. A true and correct copy of AMENDMENT NUMBER ONE (Contract number MA-060-14011458) is attached hereto as Exhibit B and incorporated by this reference.
4. A true and correct copy of AMENDMENT NUMBER TWO (Contract number MA-060-15011132) is attached hereto as Exhibit C and incorporated by this reference.
5. All other provisions of the ORIGINAL CONTRACT, AMENDMENT NUMBER ONE and AMENDMENT NUMBER TWO to the extent they are not inconsistent with this AMENDMENT NUMBER ~~ONE~~ THREE, remain unchanged and in full force and effect.
