8 THIS FIRST AMENDMENT, entered into this 1st day of March, 2014, which
9 date is particularized for reference purposes only, is to that certain
10 AGREEMENT Number CMJ2112 between the parties hereto, dated May 22, 2012,
11 hereinafter referred to as the "Agreement" and is by and between the COUNTY OF
12 ORANGE, hereinafter referred to as "COUNTY," and Aspiranet, a California non-
13 profit corporation, hereinafter referred to as "CONTRACTOR." This Amendment
14 shall be administered by the County of Orange Social Services Agency,
15 hereinafter referred to as "ADMINISTRATOR."

19 WHEREAS, COUNTY desires to modify the terms of the Agreement to increase
20 funding for counseling and parent education services to clients referred to
21 CONTRACTOR by COUNTY; and

23 services under the terms and conditions set forth in the Agreement, as
24 modified herein;

1 1. Subparagraph 17.1 of the Agreement is hereby amended to read as follows:

2 "17.1 Maximum Contractual Obligation:

3 The maximum obligation of COUNTY under this Agreement shall be \$100,000
4 for the period of July 1, 2012 through June 30, 2013; \$100,000 for the period
5 of July 1, 2013 through June 30, 2014; and \$120,000 for the period of July 1,
6 2014 through June 30, 2015, for an aggregate total maximum obligation of
7 \$320,000 for the term of the Agreement, or actual allowable costs, whichever
8 is less."

9 2. All other terms and conditions of the Agreement not modified herein shall
10 remain in full force and effect.
