

**AMENDMENT #1
TO CONTRACT MA-080-17010934
FOR**

ON-CALL ARCHITECT-ENGINEER (A-E) SERVICES - CONTRACT ADMINISTRATION - PROJECT MANAGEMENT (CAPITAL PROJECTS) SUPPORT SERVICES

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Psomas, with a place of business at 3 Hutton Centre, Suite 200, Santa Ana, CA 92707 (hereinafter referred to as "A-E"), with COUNTY and A-E sometimes individually referred to as ("Party") or collectively referred to as ("Parties").

RECITALS

WHEREAS, the COUNTY and A-E entered into CONTRACT MA-080-17010934 (hereinafter referred to as "CONTRACT") for On-Call Architect-Engineer (A-E) Services - Contract Administration - Project Management (Capital Projects) Support Services, effective December 20, 2016, in the amount of \$100,000; and,

WHEREAS, both Parties now desire to increase the CONTRACT amount by one million four hundred thousand dollars (\$1,400,000); and,

NOW THEREFORE, the Parties agree as follows:

ARTICLES

1. **Article 1.4** – “Term and Maximum Compensation” of the CONTRACT shall be amended and shall read in its entirety as follows:

- 1.4.1** The term of this CONTRACT is for **five (5) years**, commencing upon execution of all authorized signatures, with a maximum allowable compensation of **one million five hundred thousand dollars (\$1,500,000)**, except as permitted in Paragraph 1.5 below.

2. Attachment B “Cost/Compensation”, Section II “Pricing”, B. shall be amended and shall read in its entirety as follows:

B. Total CONTRACT Amount Shall Not Exceed: \$1,500,000

3. All other terms and conditions contained in the CONTRACT shall remain unchanged and with full force and effect.






