This AMENDMENT NUMBER ~~ONE~~ TWO to Contract Number MA-060-16011987 for Packaging of Food and Personal Care Items for Resale (hereinafter "AMENDMENT NUMBER ~~ONE~~ TWO") by and between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Goodwill Industries of Orange County, (hereinafter "CONTRACTOR") with a place of business at 410 North Fairview Street, Santa Ana, CA 92703-3412, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for the Packaging of Food and Personal Care Items for Resale, Contract #Number MA-060-16011987 (hereinafter "ORIGINAL AGREEMENT"), for a two-year term of May 18, 2016 through and including May 17, 2018, renewable for three (3) additional one-year terms; and

WHEREAS, COUNTY ~~desires to~~ and CONTRACTOR renewed the ORIGINAL CONTRACT on May 10, 2018, as Contract Number MA-060-18011353 for a one year term of May 18, 2018 through and including May 17, 2019 in an amount not to exceed \$169,000.00; ~~and the CONTRACTOR has agreed to provide those goods/services at the rates set forth in the ORIGINAL CONTRACT;~~

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-19010980 for a one year term of May 18, 2019 through and including May 17, 2020 and the CONTRACTOR has agreed to provide those goods/services at the rates set forth in the ORIGINAL CONTRACT;

WHEREAS, COUNTY desires to amend Paragraph S., Change of Ownership/Name, Litigation Status, Conflict with County Interests of the ORIGINAL CONTRACT in its entirety and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT;

FURTHERMORE, Contractor has confirmed in writing that they understand and are in compliance with the County's Conflict of Interest Policy as stated in article S herein.

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

## ARTICLES

- a. Additional Terms and Conditions, Section 2, Term of Contract of the ORIGINAL CONTRACT is amended in its entirety as follows:

~~2.~~ Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 5/18/16 through and including 5/17/~~19~~20, unless otherwise terminated by COUNTY. The period of 5/18/16 through and including 5/17/18 shall be known as Contract number MA-060-16011987. The period of 5/18/18 through and including 5/17/19 shall be known as Contract number MA-060-18011353. The period of 5/18/19 through and including 5/17/20 shall be known as Contract number MA-060-19010980. This Contract may be renewed for ~~two~~ one (1) ~~separate~~ additional one-year terms by mutual written agreement of both Parties. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

- b. General Terms and Conditions, Paragraph S, Change of Ownership/Name, Litigation Status, Conflict with County Interests, is amended in its entirety as follows:

- S. Change of Ownership/Name, Litigation Status, Conflict with County Interests: Contractor agrees that if there is a change or transfer in ownership of Contractor's business prior to completion of this Contract, and the County agrees to an assignment of the Contract, the new owners shall be required under the terms of sale or other instruments of transfer to assume Contractor's duties and Contractor obligations contained in this Contract and complete them to the satisfaction of the County.

County reserves the right to immediately terminate the Contract in the event the County determines that the assignee is not qualified or is otherwise unacceptable to the County for the provision of services under the Contract. In addition, Contractor has the duty to notify the County in writing of any change in the Contractor's status with respect to name changes that do not require an assignment of the Contract. The Contractor is also obligated to notify the County in writing if the Contractor becomes a party to any litigation against the County, or a party to litigation that may reasonably affect the Contractor's performance under the Contract, as well as any potential conflicts of interest between Contractor and County that may arise prior to or during the period of Contract performance. While Contractor will be required to provide this information without prompting from the County any time there is a change in Contractor's name, conflict of interest or litigation status, Contractor must

also provide an update to the County of its status in these areas whenever requested by the County.

The Contractor shall exercise reasonable care and diligence to prevent any actions or conditions that could result in a conflict with County interests. In addition to the Contractor, this obligation shall apply to the Contractor's employees, agents, and subcontractors associated with the provision of goods and services provided under this Contract. The Contractor's efforts shall include, but not be limited to establishing rules and procedures preventing its employees, agents, and subcontractors from providing or offering gifts, entertainment, payments, loans or other considerations which could be deemed to influence or appear to influence County staff or elected officers in the performance of their duties.

2. A true and correct copy of the ORIGINAL CONTRACT (Contract Number MA-060-16011987) is attached hereto as Exhibit A and incorporated by this reference.
3. A true and correct copy of the AMENDMENT NUMBER ONE (Contract Number MA-060-18011353) is attached hereto as Exhibit B and incorporated by this reference.
3. All other provisions of the ORIGINAL CONTRACT and AMENDMENT NUMBER ONE herein and to the extent they are not inconsistent with this AMENDMENT NUMBER ~~ONE~~ TWO, remain unchanged and in full force and effect.

*In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signature to bind the company.*
