WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term as Contract Number MA-060-16011444 in the amount of \$400,000 and CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

- a. Additional Terms and Conditions, Section 2, **Term of Contract,** of the ORIGINAL CONTRACT, is amended in its entirety to read as follows:
 - 1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 7/1/14 through and including 6/30/16, unless otherwise terminated by COUNTY. The period of 7/1/14 through and including 6/30/15 shall be known as Contract number MA 060-14011457. The period of 7/1/15 through and including 6/30/16 shall be known as Contract number MA-060-15011321. This Contract may be renewed for three (3) separate additional one-year terms by written mutual agreement of both Parties. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 7/1/14 through and including 6/30/17, unless otherwise terminated by COUNTY. The period of 7/1/14 through and including 6/30/15 shall be known as Contract number MA-060-14011457. The period of 7/1/15 through and including 6/30/16 shall be known as Contract number MA-060-15011321. The period of 7/1/16 through and including 6/30/17 shall be known as Contract number MA-060-15011321. This Contract may be renewed for two (2) separate additional one-year terms by written mutual agreement of both Parties. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.
