# AMENDMENT NUMBER ONE TWO TO CONTRACT MA-060-12011305 BETWEEN THE COUNTY OF ORANGE AND

MORPHOTRUST USA, INC., DBA MORPHOTRUST USA LLC (FORMERLY KNOWN AS IDENTIX, INC.)

This AMENDMENT NUMBER ONE TWO to Contract Number MA-060-12011305 (hereinafter "AMENDMENT NUMBER ONE TWO") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and MorphoTrust USA, INC., DBA MORPHOTRUST USA LLC (Formerly known as Identix, Inc.) (hereinafter "CONTRACTOR") with a place of business at 296 Concord Road, Billerica, MA 018201, is made and entered upon execution of all necessary signatures.

#### **RECITALS:**

WHEREAS, COUNTY and CONTRACTOR executed a Subordinate Contract for the purchase of Live Scan Equipment, Accessories, Training, Supplies, Software and Maintenance as Contract Number MA-060-11012605 (hereinafter "ORIGINAL CONTRACT"), for a two-year term of April 17, 2012 through and including April 30, 2014; renewable for one (1) additional one-year term; and

WHEREAS, the State of California issued California Multiple Award Schedule (CMAS) Agreement Number 3-11-70-1090B, upon which the ORIGINAL CONTRACT is based, and which is attached as Attachment B;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term in the amount of \$450,000.00 and the CONTRACTOR has agreed to provide those services at the rates set forth in the ORIGINAL CONTRACT; and

#### 1. ASSIGNMENT OF CONTRACT

Effective on December 31, 2013:

a. COUNTY hereby approves the assignment of the ORIGINAL CONTRACT, as amended, from Identix, Inc. to CONTRACTOR.

b. CONTRACTOR accepts the assignment of the ORIGINAL CONTRACT, as amended, agrees to provide all items covered thereunder and assumes the rights, duties and obligations of Identix, Inc. under the ORIGINAL CONTRACT, and accepts and agrees to all terms and conditions of the ORIGINAL CONTRACT as amended herein.

c. Wherever "Identix, Inc." appears in the ORIGINAL CONTRACT, it is hereby replaced with MorphoTrust USA, INC., DBA MORPHOTRUST USA LLC.

#### 2. Term of Contract:

This Subordinate Contract shall commence on 4/17/12, and continue through and including 4/30/15, unless otherwise terminated by the County. The period of 4/17/12 through and including 4/30/14 shall be known as MA-060-12011305. The period of 5/1/14 through and including 4/30/15 shall be known as MA-060-14011100. This Subordinate Agreement is non-renewable.

WHEREAS, the State of California issued California Multiple Award Schedule (CMAS) Agreement Number 3-11-70-1090B, upon which the ORIGINAL CONTRACT is based, and which is attached as Attachment C;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on April 29, 2014 as Contract Number MA-060-14011100 for a one (1) year term of May 1, 2014 through and including April 30, 2015 in the amount of \$450,000.00 and sustained an Assignment of Contract due to merger and the CONTRACTOR has agreed to provide those services at the rates set forth in the ORIGINAL CONTRACT (hereinafter "AMENDMENT NUMBER ONE");

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term as Contract Number MA-060-15011176 and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, and in the ORIGINAL CONTRACT, both COUNTY and CONTRACTOR agree as follows:
